## Requirements For Issuance Of A Residential Driveway – Culvert Installation Permit

- 1. A permit shall be required for all new residential driveway and/or new culvert installations in the parish road right-of-way in the unincorporated areas of Lincoln Parish. Driveways located on state roadways are permitted by the Louisiana Department of Transportation and Development.
- 2. The Parish Road Superintendent or his designee will make a determination whether the proposed driveway location is acceptable and determine the correct culvert size and required grades.
- 3. Property owner or contractor is responsible for purchase and delivery of required culvert.
- 4. Drainage of the roadway and the roadside ditches shall not be altered or impeded. Where the proper size culverts cannot be installed on grade without impeding or altering said drainage, the application shall be denied.
- 5. Any violation of this policy will be enforced by available civil, criminal or administrative remedies allowable under state law. The parish may remove any unpermitted and/or uncompliant driveway.

#### **Highway Department Installed Culverts**

- A. Once the culvert has been purchased and is on site, you are responsible for notifying the Lincoln Parish Highway Department (318-251-5157) to schedule the installation.
- B. The Highway Department provides one (1) load of dirt, and NO additional material.

#### **Contractor Installed Culverts**

- A. Driveways shall be constructed to match the grade of the roadway pavement. The driveway shall be constructed in such a manner as to not impede the flow of water away from the road.
- B. An inspection of culverts shall be made before the backfill operations begin, and it shall be the applicant's responsibility to call for the inspection a minimum of three business (3) days in advance. Failure to obtain a favorable inspection will result in the removal of unapproved culverts by the parish at the owner's expense.
- C. Temporary culverts may be allowed through the completion of new construction. Once construction is completed, the temporary culvert must be removed and replaced with a parish approved and permitted permanent culvert prior to the issuance of a certificate of occupancy.
- D. When hard-surfacing a driveway over a culvert installation with concrete pavement, a construction joint shall be constructed at the right-of-way line.

Note: These Regulations shall become effective upon adoption by the Lincoln Parish Police Jury.
