ORDINANCE NO. 452-21-(6)

AN ORDINANCE AMENDING ORDINANCE 184-98-(4) OF THE PARISH OF LINCOLN STATE OF LOUISIANA PROVIDING THAT THE CODE OF ORDINANCES OF THE PARISH OF LINCOLN, STATE OF LOUISIANA, BE AMENDED BY REVISING CHAPTER 6, MOTOR VEHICLES AND TRAFFIC, TO ADD A SECTION TO BE NUMBERED 6-4.13 AND TO DEFINE THE OFFENSE.

BE IT ORDAINED BY THE POLICE JURY OF LINCOLN PARISH, LOUISIANA, IN REGULAR SESSION CONVENED THIS 9th DAY OF March, 2021:

SECTION 1

That the Code of Ordinances of the Parish of Lincoln, State of Louisiana, be amended by adding a section to be number 6-4.13 to read as follows:

Sec. 6-4.13 Speed Limits – Baxter Road

"No motor vehicle, as defined by Louisiana law, shall be operated at a speed in excess of 25 miles per hour on Baxter Road."

SECTION 2

That the limit of speed referred to hereinabove shall be duly posted and displayed by means of appropriate highway speed limit signs.

SECTION 3

That all ordinances or parts of ordinances in conflict of this ordinance are hereby repealed.

SECTION 4

That this ordinance shall be in full force and effect from and after its promulgation.

WHEREAS, this intersection in Ruston, Lincoln Parish, Louisiana is a dangerous intersection and has been the site of multiple accidents; and


WHEREAS, this intersection is a heavily traveled area; and


WHEREAS, action to provide greater safety to the motoring public at this intersection is needed.

NOW, THEREFORE BE IT RESOLVED that the Lincoln Parish Police Jury does hereby request the Department of Transportation and Development to take action to provide greater safety to the motoring public and to minimize traffic accidents at the intersections of Louisiana Highway 150, and Tarbutton Road in Ruston, Lincoln Parish, Louisiana by means of additional signing or signaling to enhance motorist awareness to impending danger.

SEWER SERVICE SHALL BE PROVIDED BY INDIVIDUAL AERATED TREATMENT SYSTEMS W/ EFFLUENT SPRAY ON EACH LOT FOR CONTAINMENT. PROVISIONS OF SECTION 13-43(a), (b), (c), AND (d) ARE TO ADHERED TO.




