1. Roll Call

2. Approval of Minutes (00:01:14)

Stevens motioned for approval, seconded by Bolt, unanimous approval.

3. New Business (00:02:39)

A. REVIEW OF 2022 ANNUAL REPORT TO THE CITY COMMISSION.

Connor shared highlights from the annual report

B. CONSIDERATION OF LETTER OF SUPPORT FOR 2023 RAISE GRANT (00:15:05)

Gager shared the city is doing a corridor wide analysis that will look at vehicle and pedestrian improvements and what happens with 5th street if another crossing is approved in another location. Submitted a planning grant application this year, if approved will submit a construction grant application.

C. DISCUSSION ON GROWTH POLICY IMPLEMENTATION (00:21:44)

Gager provided update on the current status of growth policy priority implementation

4. Old Business

A. UPDATE ON RESERVOIR PARK PROJECT (00:30:11)

Gager provided update following meeting with Rotary Club and possible improvements to Moja Dog Park. There have been some donations, and grant applications submitted for the park. Intends to start a public engagement process in the spring and conversations with the neighbors.

B. UPDATE ON FLESHMAN CREEK CROSSING PROJECT (00:39:20)

Gager shared he has a meeting set up with the Girl Scouts facilities manager for a future date.

C. UPDATE ON PARKS AND TRAILS MASTER PLAN (00:44:56)

Connor shared that there are funds in this year's budget for an update, but not for a couple of months. Gager share there are a lot of projects going on right now, and he hopes to begin working on it this fall, with a draft plan anticipated in the Spring of 2024.

D. UPDATE ON PARK STREET CROSSING PROJECT (00:52:04)

Gager shared that the TA Grant was applied for and originally due April 18th, the deadline was extended to early May. A few projects were nominated. Anticipates a decision from MDT will be received before the next Parks & Trails Meeting.

E. UPDATE ON CITY OF LIVINGSTON PARKS MAP (00:57:00)

Gager shared he met with Jeanne Marie-Souvigney and discussed revisions to the current map. They discussed new park areas in the Northtown subdivision, and Green Acres Area. Explored ideas about adding Historical/Cultural places and names. Note, author noted Weimar Park is miss-spelled on current map, it should be Weimer Park.

F. UPDATE ON PARK COUNTY ACTIVE TRANSPORTATION PLAN (01:21:32)

Sarah shared status of Active Transportation Plan is slated for an update that will be moving forward.

G. UPDATE ON ALPENGLOW PAVING PROJECT (01:24:30)

Sarah shared a brief history of this project, Jessie Wilcox had submitted a grant prepandemic that was approved, but costs now have almost tripled since that was awarded. Project not eligible for TA grant funding, as it is in the county's jurisdiction. Gager agreed to reach out to Jessie Wilcox to discuss paving.
