Safe and Accessible Streets Policy Outline

Vision/Intent

The City of Livingston is considering a Safe and Accessible Streets Policy to develop safe, reliable, efficient, integrated, and connected multimodal transportation system that promotes access, mobility, and safe alternatives for all users.

All Users and Modes

The City of Livingston will endeavor to ensure the safety and convenience of all users of the transportation system are accommodated, including pedestrians, bicyclists, transit riders, people of all ages and abilities, motorist, emergency responders, freight providers, and adjacent land users. When there are conflicting needs among users and modes, the following prioritization will apply:

- 1. safety is the primary concern, followed by mobility;
- 2. among modes, pedestrians shall come first citywide, followed by the next most vulnerable types of users; and finally,
- 3. seek balance among all modes involved.

It is recognized that all modes cannot receive the same type of accommodation and space on every street, but the overall goal is that everyone can safely, comfortably, and conveniently travel through the City of Livingston.

Projects and Phases

The City of Livingston will take into consideration the opportunity to create safer and more accessible streets for all users during transportation improvement projects. This may include, but is not limited to: planning, programming, design, right-of-way acquisition, construction, construction engineering, reconstruction, operation, and maintenance. Other changes to transportation facilities on streets and rights-of-way, including capital improvements, re-channelization projects, and major maintenance may also be included where appropriate.

Under this policy, permit application for updates to sidewalk, curb, gutter, and street improvements, or for new development, need to demonstrate compliance with this policy.

Policy Elements

The City of Livingston will work with the Active Transportation Coalition and other interested groups through the public involvement process to define the policy elements specific to the City of Livingston. These elements will refine the vision, provide clear direction and intent, are accountable to the community's needs, and grant the flexibility in design and approach necessary to secure an effective "Safe and Accessible Street" policy process and outcome.

PROFESSIONAL SERVICES AGREEMENT

THIS PROFESSIONAL SERVICES AGREEMENT (this "Agreement") is made and entered into as of the _____ day of ______, 2017, by and between the CITY OF LIVINGSTON, MONTANA, a municipal corporation and political subdivision of the state of Montana with its principal business office located at 414 East Callender Street, Livingston, Montana 59047 (hereinafter referred to as the "City"), and THOMAS, DEAN & HOSKINS, INC., a Montana corporation with its principal office located at 1800 River Drive North, Great Falls, Montana 59401 (hereinafter referred to as the "Engineer"; and together with the City, the "Parties").

RECITALS:

- A. The City desires to complete the project commonly known as the Northside Transportation Plan (the "Project"), which Project requires certain professional engineering design services to be performed in connection therewith.
- B. In September 2015, the City and the Engineer entered into a Professional Services Agreement (the "September 2015 Agreement") whereby the Engineer agreed to perform Miscellaneous and Tasked Based services for the City.
- C. The City now desires for Engineer to perform such a Task Based service in the form of design for the Northside Transportation Plan and the Engineer desires to perform the services, all according to the terms and conditions set forth below.
- D. The Engineer is engaged in the business of professional engineering, independent of the City, and has the manpower, knowledge, expertise, skills, means, tools, licenses, if applicable, and equipment necessary to design services for the Project and is ready, willing and able to undertake and perform the same under the terms and conditions contained in this Agreement.

NOW, THEREFORE, in consideration of the foregoing recitals and the terms and conditions contained herein, the Parties agree as follows:

1. <u>INCORPORATION OF RECITALS</u>. The above Recitals are true and correct and are fully incorporated into this Agreement as if fully set forth in this Paragraph 1.

- 2. <u>ENGINEER'S SERVICES.</u> City agrees to retain Engineer to perform all services and comply with all obligations specified or indicated in the Scope of Work attached hereto and incorporated herein as **Exhibit A** (collectively, the "Services").
- <u>NON-DISCRIMINATION</u>. Pursuant to Mont. Code Ann. § 49-3-207, in the performance of this Agreement the Engineer agrees that all hiring will be on the basis of merit and qualifications and that the Engineer will not discriminate on the basis of race, color, religion, creed, political ideas, sex, age, marital status, physical or mental disability, or national origin.

4. NATURE OF RELATIONSHIP.

- a. The Engineer states that it is engaged in an established business or profession which is in no way affiliated with or connected to the City, except by this Agreement and that it uses independent judgment in the performance of services provided hereby free from control or direction of others. The Engineer shall perform the Services as an independent contractor. The Parties agree that the City is only interested in the end result of the Services, not in the method of performance, and as such, the Engineer has been and will continue to be free from the control or direction of the City in the performance of this Agreement. The Engineer shall not be deemed by virtue of this Agreement nor the performance thereof to have entered into any partnership, joint venture, employer/employee or any other legal relationship with the City besides that of an independent contractor. Because Engineer is an independent contractor, Engineer is not entitled to any workers compensation or any benefit of employment with the City.
- b. The Engineer agrees to comply with all applicable laws, rules and regulations adopted or promulgated by any governmental agency or regulatory body, both state and federal, and furthermore agrees to assume full responsibility for the payment of all contributions of all federal and state income or other payroll tax or assessment, social security, worker's compensation insurance, unemployment insurance, selfemployment tax or any other required deduction or contribution for himself or for any employees engaged by the Engineer in performance of this Agreement.
- c. The Engineer, its officers, agents and/or employees shall not have the authority to make representations on behalf of the City, and neither shall the aforementioned entities and persons have the authority to legally bind or otherwise obligate the City to any third person or entity.

5. <u>COMPENSATION</u>.

- a. For the satisfactory completion of the Services, the City will pay the Engineer a sum not to exceed Forty Thousand and three hundred Dollars (\$40,300.00); provided, however, the Parties may agree to additional compensation in an amount not to exceed Four Thousand and No/100 Dollars (\$4,000.00) in the event presently unforeseen circumstances require Engineer to provide additional services or spend additional time on items not contemplated by this Agreement. Each specific service the Engineer provides under this Agreement, and the maximum amount the City will pay the Engineer for each, is set forth in Exhibit A. The total contract amount is \$44,300.00
- b. The Engineer shall submit an invoice every month if it has provided the City with Services during the preceding month. The invoices will include charges for the Services actually performed during the associated billing period. The invoices shall include, at a minimum, the following information: (i) a clear description of the tasks performed; (ii) identification of the project with which all charges are associated; (iii) the contracted dollar amount for the Services, if applicable; (iv) the Services completed to date for the associated project; and (v) the Services that remain to be completed for the associated project. Each invoice shall be accompanied by a monthly summary that provides the following information: (i) all current projects; (ii) the estimated dollar amount of the total project costs for each project; (iii) the amount the City has paid to date on each project; and (iv) the amount the City will likely pay to complete each project shown on that month's invoice.
- c. In connection with obtaining payment under this Agreement, Engineer agrees to familiarize itself with, and agrees to be bound by, the City's claim procedure, including but not limited to deadlines for submitting claims for approval and payment. The Engineer assumes responsibility for the late filing of a claim.
- In the event the Engineer seeks payment or compensation for work, materials or services not included in this Agreement and the exhibits hereto, the Engineer must seek prior written authorization from the City before such expenditure is incurred. If the Engineer fails to obtain prior written authorization, the Engineer shall not be entitled to payment for the unauthorized work, materials or services.

6. <u>ENGINEER'S RESPONSIBILITIES, REPRESENTATIONS AND WARRANTIES.</u> The Engineer represents and warrants as follows:

- a. It and its employees possess all of the necessary qualifications, experience, knowledge, tools and equipment to undertake the performance of the Services.
- b. It is familiar with and is satisfied as to all federal, state and local laws and regulations that may affect costs, progress, performance and furnishing of the Services.
- c. It has reviewed and has entered into this Agreement based solely upon its own knowledge, inspection and judgment, and not upon any representations or warranties made by the City or its officers, employees or agents.
- d. In connection with the Services, it will exercise the standard of care that is ordinarily used by members of the Engineer's profession practicing under similar conditions at the same time and in the same locality.
- 7. <u>OWNERSHIP OF DOCUMENTS</u>. All data, information, work in progress, documents, reports, and intellectual property developed in connection with any work under this Agreement, both in hard-copy form and as may be embodied on computer diskettes or similar information recording and storage media, is deemed the City's property and, upon request, shall be delivered to the City. Following the City's acceptance of materials described in this paragraph, the City shall indemnify and hold Engineer harmless for any changes or revisions to the plans and related documents the Engineer prepares under this Agreement that are made without Engineer's knowledge and written consent.

8. TERMINATION OF THIS AGREEMENT.

a. If the City fails to substantially perform in accordance with the terms of this Agreement, the Engineer shall deliver to the City a written notice specifying the nature of the City's failure to substantially perform. The City shall have a period of ten (10) days after receiving the written notice from the Engineer to cure the failure to perform. If the City fails to cure its failure to perform within the 10-day cure period, the Engineer shall provide the City with a written notice to terminate this Agreement. The Engineer may only terminate this Agreement if it is not at fault for the City's failure to perform. Failure of the City to make payment as provided in this Agreement shall be considered nonperformance and cause for termination, unless the Engineer is at fault for the City's nonpayment.

- b. The City may terminate this Agreement upon not less than thirty (30) days prior written notice to Engineer. If the City terminates this Agreement for a reason other than fault of the Engineer, the Engineer shall receive compensation for the work/services performed prior to termination, together with reasonable expenses incurred up to the date of termination.
- 9. LIMITATION OF LIABILITY. To the fullest extent permitted by law, and notwithstanding any other provision of this Agreement, the total liability, in the aggregate, of Engineer and Engineer's officers, directors, members, partners, agents, employees, and consultants, to City and anyone claiming by, through, or under City for any and all claims, losses, costs, or damages whatsoever arising out of, resulting from, or in any way related to the Services or the Agreement from any cause or causes, including but not limited to the negligence, professional errors or omissions, strict liability, breach of contract, indemnity obligations, or warranty express or implied of Engineer or Engineer's officers, directors, members, partners, agents, employees, or consultants shall not exceed the total compensation received by Engineer under this Agreement. Similarly, to the fullest extent permitted by law, and notwithstanding any other provision of this Agreement, the total liability, in the aggregate, of the City and the City's officers, directors, members, partners, agents, employees, and consultants, to Engineer and anyone claiming by, through, or under Engineer for any and all claims, losses, costs, or damages whatsoever arising out of, resulting from, or in any way related to the Services or the Agreement from any cause or causes, including but not limited to the negligence, strict liability, breach of contract, indemnity obligations, or warranty express or implied of City or City's officers, directors, members, partners, agents, employees, or consultants shall not exceed the total compensation received by Engineer under this Agreement.
- 10. <u>INDEMNIFICATION AND HOLD HARMLESS</u>. To the fullest extent permitted by law, City shall indemnify and hold harmless Engineer and its officers, directors, members, partners, agents, employees, and consultants from and against any and all claims, costs, losses, and damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals, and all court, arbitration, or other dispute resolution costs) arising out of or relating to the Services, provided that any such claim, cost, loss, or damage is attributable to bodily injury, sickness, disease, or death or to injury to or destruction of tangible property, including the loss of use resulting therefrom, but only to the extent caused solely by any negligent act or omission of City or City's officers, directors, members, partners, agents, employees, consultants, or others retained by or under contract to the City with respect to this Agreement or to the Services. Similarly, to the

fullest extent permitted by law, Engineer shall indemnify and hold harmless City and its officers, directors, members, partners, agents, employees, and consultants from and against any and all claims, costs, losses, and damages (including but not limited to all fees and charges of engineers, architects, attorneys, and other professionals, and all court, arbitration, or other dispute resolution costs) arising out of or relating to the Services, provided that any such claim, cost, loss, or damage is attributable to bodily injury, sickness, disease, or death or to injury to or destruction of tangible property, including the loss of use resulting therefrom, but only to the extent caused solely by any negligent act or omission of Engineer or Engineer's officers, directors, members, partners, agents, employees, consultants, or others retained by or under contract to the Engineer with respect to this Agreement or to the Services.

- 11. <u>INSURANCE</u>. In addition to any other insurance which Engineer may choose to carry, the Engineer shall, at its sole expense, maintain in effect during the performance of this Agreement all of the following insurance: (a) workers' compensation as required by state law; (b) comprehensive commercial general liability insurance, including personal injury liability, automobile, blanket contractual liability and broad-form property damage liability coverage with a single limit of \$1,000,000 each occurrence, \$2,000,000 general aggregate and \$5,000,000 excess/umbrella liability; (c) professional liability with a limit of \$1,000,000 per claim and \$1,500,000 aggregate made against Engineer for errors or omissions in the performance of this Agreement. Engineer's certificates of insurance are attached hereto and incorporated herein as **Exhibit B**. Any certificates of insurance shall require at least ten (10) days written notice to the City prior to any cancellation, termination, or non-renewal of coverage.
- 12. <u>COMPLIANCE WITH LAWS</u>. The Engineer agrees it will comply with all federal, state and local laws, rules and regulations.
- 13. <u>SURVIVAL</u>. All express representations, indemnifications, or limitations of liability made in or given in this Agreement shall survive completion of the Services or the termination of this Agreement for any reason.
- 14. <u>FORCE MAJEURE</u>. The Parties shall not hold each other responsible for damages or delay in the performance of this Agreement caused by acts of God, strikes, lockouts, accidents, or other events beyond the control of the other or the other's employees and agents.
- 15. <u>NOTICES.</u> All notices or communications required to be given under this Agreement shall be in writing and shall be deemed to have been duly given by personal delivery or

upon deposit into the United States Postal Service, postage prepaid, for mailing by certified mail, return receipt required, and addressed as follows:

Any change of address shall be made by giving written notice thereof to the other party, providing the new address.

- 16. <u>MODIFICATION AND WAIVER.</u> No amendment, modification or waiver of any condition, provision or term of this Agreement shall be valid or of any effect unless made in writing, signed by the party or parties to be bound and specifying with particularity the nature and extent of such amendment, modification or waiver. Any waiver by any party of any default of the other party shall not effect or impair any right arising from any subsequent default. Nothing herein shall limit the remedies or rights of the parties hereunder and pursuant to this Agreement.
- 17. <u>SEVERABILITY</u>. Each provision of this Agreement is intended to be severable. If any provision of this Agreement is illegal or invalid for any reason whatsoever, such illegality or invalidity of said provision shall not affect the validity of the remainder of this Agreement.
- 18. <u>ENTIRE AGREEMENT.</u> This Agreement contains the entire understanding of the Parties and supersedes all prior agreements and understandings between the Parties.
- 19. <u>INTERPRETATION.</u> All captions, headings, or titles in the paragraphs or sections of this Agreement are inserted for convenience or reference only and shall not constitute a part of this Agreement or act as a limitation of the scope of the particular paragraph or section to which they apply. As used herein, where appropriate, the singular shall include the plural and vice versa and the masculine, feminine or neuter expressions shall be interchangeable.

- 20. <u>COUNTERPARTS.</u> This Agreement may be executed in multiple counterparts, each of which shall be one and the same Agreement and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other party.
- 21. <u>PARTIES IN INTEREST AND ASSIGNMENT</u>. This Agreement shall be binding upon, and the benefits and obligations provided for herein shall inure to and bind, the Parties and their respective successors and assigns, provided that this section shall not be deemed to permit any transfer or assignment otherwise prohibited by this Agreement. This Agreement is for the exclusive benefit of the Parties and it does not create a contractual relationship with or exist for the benefit of an third party, including contractors, subcontractors or their sureties. This Agreement shall not be assigned, or any right or obligation hereunder, in whole or in part, to another without first having prior written consent of the other party. No assignment or transfer of any interest under this Agreement shall be deemed to release the Engineer or the City from any liability or obligation under this Agreement, or to cause any such liability or obligation to be reduced to a secondary liability or obligation.
- 22. <u>VENUE</u>. The parties stipulate and agree that the Montana Sixth Judicial District Court, Park County, has proper venue and jurisdiction to resolve all causes of action which may accrue under this Agreement.
- 23. <u>GOVERNING LAW</u>. This Agreement shall be governed by the law of the State of Montana without respect to its conflicts of law principles.
- 24. <u>LIAISON</u>. The designated liaison with the City is Shannon Holmes, who can be reached at (406) 222-5667. The Engineer's liaison is Keith Waring, who can be reached at (406) 586-0277.
- 25. <u>DISPUTES.</u> It is mutually agreed that the performance or breach of this Agreement and its interpretation shall be governed by the laws of the state of Montana, without regard to its conflicts of law principles.
- 26. <u>COMPUTING TIME.</u> For the purpose of calculating time under this Agreement, the following computation shall be used -- If the period is stated in days or a longer unit of time, exclude the day of the event that triggers the period, count every day, including intermediate Saturdays, Sundays, and legal holidays, and include the last day of the

period, but if the last day is a Saturday, Sunday, or legal holiday, the period continues to run until the end of the next day that is not a Saturday, Sunday, or legal holiday.

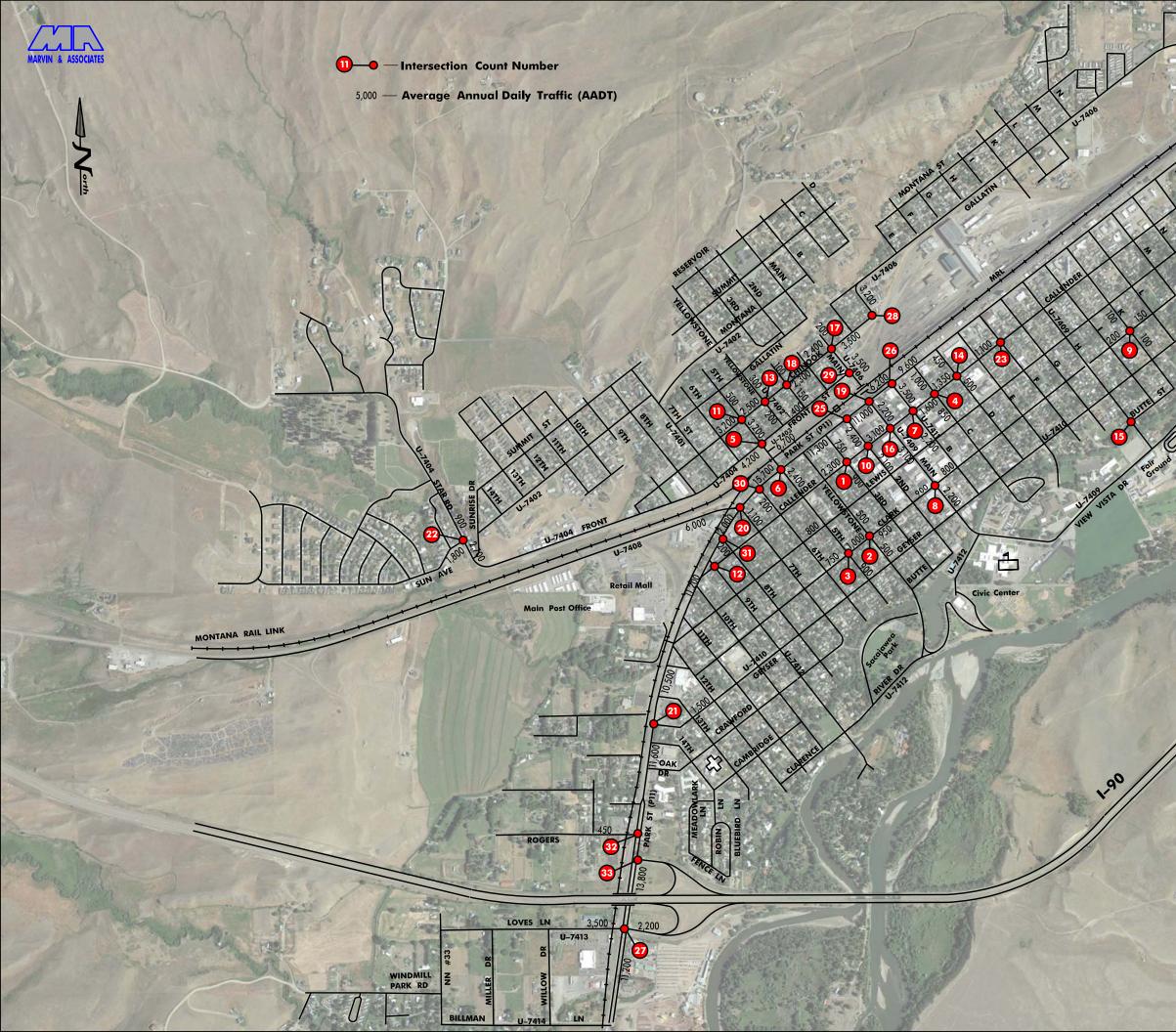

Dear Mr. Kardoes:

Please consider this request for Amendment No. 2 to the Agreement Between Owner and Engineer for Professional Services dated February 16, 2016 for the Livingston Water Reclamation (WRF) Upgrade Project.

The engineering effort required for engineering and bidding phases exceeded the scope that was budgeted for the project. This caused AE2S to incur expenses over the contract budget. The City of Livingston benefitted a great deal from additional Engineering services that were not included in the original scope of the project because these tasks were not foreseeable at the time of the original scope negotiations. This letter summarizes those additional Engineering items and costs, and explains the benefits the City of Livingston is or will realize as a result. As we have discussed, we are not requesting that the City compensate AE2S for our entire overage on the project, only a portion. We have already written off a substantial amount of our current total overage of \$357,548.

The amendment amount requested is itemized below. Additional detail on each category is provided in the following pages.

Funding Pursuit and Procurement

AE2S was originally scoped for \$12,120 for "DEQ, Regulatory and Funding Agency Communications", with the understanding that the project team would provide some funding procurement assistance to the City. The funding sources at the time our contract was negotiated with the City were TSEP, RRGL and SRF.

AE2S' involvement in funding pursuit and procurement subsequently grew into providing full funding procurement services, including pursuit of USDA-RD funding. This brought substantial, additional costs to bear for funding procurement services, impacts to the bidding documents and project management and administration. USDA-RD funding in particular is very onerous, requiring us to re-do our contract with the City as well as adding several layers of oversight and paperwork to pre-selection and construction contracts. USDA-RD has also changed its funding compliance requirements twice in the 20 months that we have been working with them, proving to be a moving target.



We estimate that over 500 hours of out-of-scope time was spent on funding procurement activities, funding and regulatory agency communications, and agency compliance (USDA-RD and DEQ) that was not scoped in our original agreement or included in the design contingency. The final result is an outstanding funding package:

- \$625,000 TSEP grant
 - The project ranking was improved from un-ranked in 2015 biennium to 12th out of 45 projects in the 2017 biennium.
- \$1.715MM USDA-RD grant and \$5MM in low interest (1.375%) loan over 40 years.
 - \$1.715MM in USDA-RD grant is among the highest the program has ever awarded in Montana for water or wastewater infrastructure.
- \$400,000 in loan forgiveness (grant) from SRF.

Procurement of MPDES Permit

When AE2S was retained for the design of the WRF Upgrade, the City's Montana Pollutant Discharge Elimination System permit (discharge permit), issued by Montana DEQ, had been expired for over 18 months. Our understanding during the fee estimate negotiation was that DEQ would release the new permit very soon and that it would have a new ammonia limit, but no total nitrogen or phosphorus limits. The City was motivated to move forward with design because DEQ had already informed them that a new ammonia limit was coming, the existing Rotating Biological Contactor's were failing, and the existing disinfection system was not meeting performance criteria.

Our team began preliminary design work in February of 2016, but by April it became apparent that DEQ was not going to issue a permit any time soon, putting further design work was at risk. AE2S was told by DEQ that the way to initiate release of a draft permit would be to propose the discharge permit limits in a memorandum, and state that the design would proceed based on the proposed limits unless DEQ provided a new permit within 30 days. AE2S proposed discharge permit limits our team estimated based on DEQ and EPA standards in May.

DEQ responded with a draft permit that included extremely stringent future total nitrogen and total phosphorus limits that would have required a complete change in the design of the City's WRF Upgrade at an increased cost of several million dollars.

AE2S proceeded to negotiate with DEQ on the City's behalf, including: 1) preparation and submittal of a Water Quality Assessment (WQA) in Support of a Mixing Zone to DEQ on the City's behalf, 2) additional permit negotiation meetings and communication 3) preparation of a comment letter during the Public Comment period for the advertised draft permit, and 3) a three-month delay in our preliminary design process. AE2S had already dedicated staff full-time to the project, and we did our best to work only on design tasks that would be necessary regardless of final effluent limits, but inefficiencies over this three-month period were unavoidable. In addition, we had to extend our pre-procurement bidding period for the SBR equipment twice to accommodate the delay in receipt of the final permit.

AE2S' permitting work eventually resulted in a major improvement in the City's effluent discharge requirements, including relaxation of the ammonia limit, and complete removal of total nitrogen and phosphorus limits. We were able to procure a permit that enabled the City to continue to proceed with the already-selected SBR treatment, rather than having to provide nitrogen and phosphorus removal. We estimate that the permitting effort and project delay cost the budget approximately \$60,000. The additional permit negotiations saved the City from potentially millions of dollars in nutrient removal upgrades.



Design Contingencies

It is extremely difficult to develop an accurate scope for a project of this nature (wastewater treatment plant rehabilitation and expansion within existing plant footprint) before engaging in the work. The following design tasks had to be completed but could not have been foreseen prior to starting design.

- <u>SBR Effluent Equalization</u> effluent from SBRs is cyclical, or pulsed. Equalization (storage and pumping) was the original plan, to even out the flows through downstream UV Disinfection. Our work revealed that equalization would substantially increase the cost of the project and make operations more complex. Instead, our team worked to develop a UV design that would accommodate the pulsed flow pattern. This required an estimated \$30,000 of out-of-scope engineering, but resulted in a savings of an estimated \$400,000 of construction for the facilities that would have been required (storage and pumping).
- <u>Design of WAS Holding Basins</u> AE2S proposed thickening of Waste Activated Sludge (WAS) from the SBRs to enable reuse of the existing anaerobic digesters for aerobic digestion. This saved the City from having to have new aerobic digesters constructed. However, the cyclical timing of wasting solids from the SBRs required solids storage upstream of the thickening equipment. We were able to reuse the existing Primary Clarifiers to store solids, which saved approximately \$400,000 for new solids storage tanks. However, this design work cost us an estimated \$25,000 to complete.
- Reactor and Control Building design modifications The original design scope assumed that 1) the new Control Building would be co-located with the sequencing batch reactor basins to enable common wall construction, and 2) that the Control Building would include an Equipment Room, Control Room, Electrical Room and restrooms. These modifications cost the budget approximately \$20,000 to accommodate.
 - 1) As design progressed, it became apparent that siting the reactors and Control Building in the front lawn area would be problematic. Complex, expensive earthwork would be required to coordinate the structures with Bennett Street, and access to the site during construction would have been severely limited. We moved the basins and Control Building at approximately the 50% design stage to the northeast portion of the site, over the existing drying beds. This improved constructability, enabled full site access during construction, and resulted in significantly shorter yard piping lengths between facilities. This move will ultimately save the City construction and long-term O&M costs.
 - 2) After design was begun, the City decided to relocate the WRF laboratory to the new Control Building, put the new standby generator inside, and include a new Shop to replace the existing Shop that is being utilized for WAS Thickening Equipment. An enclosed stair tower also had to be added from the Control Building roof to the SBR deck, due to the height of the SBR basins (which was driven by the high and contaminated groundwater). The laboratory, Standby Generator Room, Shop and Stair Tower were not scoped to be included in the Control Building design, but were added to improve operations and functionality for the City.
- Reuse and renovation of the existing Anaerobic Digesters for Aerobic Digestion, and retrofit of the Control Building for use as a Solids Processing Building – Previous engineering work on the project indicated new Aerobic Digesters in the project, due to the existing digesters being undersized. AE2S proposed reuse of the existing Anaerobic Digesters by thickening sludge. This saved the City approximately \$1 million in construction costs, but required detailed engineering to depict the existing structures, piping and equipment accurately for demolition and location of new equipment. We also had



to retrofit a new electrical room in the current Superintendent's office, and add a small building on the side of Aerobic Digester for the new Jet Aeration Mixing Pump. This effort cost approximately \$30,000 more than was foreseeable prior to initiating design.

- The existing Influent Pump Station ventilation system This building was not compliant with current codes, and required a complete replacement to comply with National Fire Protection Agency (NFPA) standards. The building will now be safer and more comfortable for staff to work in, but the need for this work was not known during design contracting. This work cost approximately \$5,000 to complete.
- State Superfund Site Groundwater Contamination and WRF Upgrade Constructability –the full impact of the BNSF site contamination on the design scope was underestimated. The original agreement scoped just \$19,846, but this was to provide a Contaminated Soils Work Plan for use during the Geotechnical Investigation. This cost did not include any fees for design impacts or coordination with W&ET and DEQ-Remedial that occurred throughout the winter and spring of 2017, work that required approximately \$10,000 to complete.

Bidding Phase

Due to the additional design contingency items listed above, as well as unforeseen USDA-RD regulations and additional requirements for bidding, the bid phase services was under-scoped. Our contract was for \$45,244. Actual spend for our project team was \$80,357 for an overage of \$35,114.

Summary and Conclusion

This \$271,000 amendment requested herein for out-of-scope services would increase our total design and bid services fee from \$1.239 million to \$1.51 million. The lowest construction bid received was \$14.785MM. We previously provided the City with "% of construction cost" data on engineering fees (email dated April 4, 2017), despite our mutual acknowledgement of the limitations of using this as a metric. Without this amendment, our fee is just 8.4% of construction, very low for rehabilitation of a wastewater treatment facility. If this amendment is awarded, it would increase the fee to 10.2% of construction, still in the lower range for projects of this nature. We believe this amendment to be justifiable given the project complexity and the outcomes achieved with our additional services.

Viewed another way, the original scope included a \$50,000 design contingency, which represented just 4% of the total design fee estimate (4% contingency). In retrospect this was insufficient given the as-yet to be identified design requirements for a complete, successful project. The \$271,000 increase requested herein would put the design contingency at 21%, a more reasonable amount for a project of this nature and complexity.

This memo provides additional information on the Administrations recommendation of \$180,000 of additional design work for the WRF Project.

Funding Pursuit and Procurement:

The City Administration approves 100% or \$56,000 of this requested amount. AE2S was originally scoped for \$12,120 for "DEQ, Regulatory and Funding Agency Communications". The Uniform Application process (SRF and TSEP) required substantial assistance from AE2S to complete. Through this process it was discovered the City was eligible for USDA funding in April 2016. Given the technical complexity of the application and AE2S experience with USDA applications on other projects, the City requested that AE2S lead the USDA-RD funding procurement, which resulted in a major success for the City (\$1.715MM grant and \$5MM in a 40 year 1.375% loan).

Procurement of MPDES Permit

The City Administration approves 67%, or \$40,000 of this requested amount. This is simply a negotiation by the City, and represents our estimate of an approximate breakdown between the effort AE2S directly expended to procure a very favorable permit on behalf of the City, versus claims for "inefficiencies" due to slowdowns the permit uncertainties may have caused the design team.

Design Contingencies

The City Administration approves 41% or \$49,000 of this requested amount. This figure is another reflection of City staff's effort to negotiate with AE2S to a mutually agreeable amount, and was based on the following:

- We concur with AE2S that the following items were not foreseen or fore-seeable during fee negotiations in January of 2016:
 - Mid-design relocation of the Control Building across the site, and the addition of a lab, Shop Area, stair tower and Generator Room to the Control Building (\$20,000)
 - NFPA Code requirements for ventilation improvements in the Influent Pump Station (\$5,000)
 - The magnitude of the contaminated groundwater impacts on design and coordination with WET and DEQ-Remedial (\$10,000)

- We also agree that the effort AE2S spent to compare SBR effluent equalization and pumping to pulsed UV Disinfection operation was innovative, extensive, and resulted in a better overall facility for the City. We dipoint out that this analysis did also result in reduced design scope for equalization facilities, so we did not feel that the full amendment amount requested by AE2S (\$30,000) was justified. \$14,000 was our counter for this work.
- Conversely, it is our opinion that the need for, and complexity of, waste activated sludge storage ("WAS Holding"), reuse of the Anaerobic Digesters and conversion of the existing Control Building to a Solids Process Building were foreseeable in January of 2016 and were within the spirit of the scope that was negotiated at that time.

Bidding Requirements

The City Administration approves 100% or \$35,000 of this requested amount. Bid-phase services are truly a reaction to the size and complexity of a project. We observed AE2S expended extra effort during the bid phase than was estimated during fee negotiations in January of 2016, for the following reasons:

- 1. USDA-RD's onerous bidding regulations
- 2. An effort to reduce bidding Contractor's uncertainty surrounding groundwater levels and the DEQ requirement for a groundwater contamination work plan
- 3. The number of Bid Alternates that were developed (in an effort to give the City flexibility should bidding have exceeded the budget)
- 4. Extension of the bid period to accommodate bidder's and potential bidder's requests
- 5. A contractor's bidding market (AE2S accommodated dozens of contractor questions in an effort to maintain interest in the project).

Summary and Conclusion

In short, the \$180,000 recommended by City staff for this amendment represents a good-faith effort on City staff's behalf to negotiate with AE2S to arrive at an equitable amount of additional pay for service. This negotiation has taken place over several months with several discussions to arrive at this figure.

PROFESSIONAL SERVICES AGREEMENT

THIS PROFESSIONAL SERVICES AGREEMENT (this "Agreement") is made and entered into as of the _____ day of ______, 2017, by and between the CITY OF LIVINGSTON, MONTANA, a municipal corporation and political subdivision of the state of Montana with its principal business office located at 414 East Callender Street, Livingston, Montana 59047 (hereinafter referred to as the "City"), and THOMAS, DEAN & HOSKINS, INC., a Montana corporation with its principal office located at 1800 River Drive North, Great Falls, Montana 59401 (hereinafter referred to as the "Engineer"; and together with the City, the "Parties").

RECITALS:

- A. The City desires to complete the project commonly known as the Callender and Main Street Capital Improvement Project (the "Project"), which Project requires certain Construction Administration services to be performed in connection therewith.
- B. The City will selected a contractor to perform the construction work for the Project, and the City now desires to engage Engineer to perform professional engineering services in the form of Construction Administration.
- C. The Engineer is engaged in the business of professional engineering, independent of the City, and has the manpower, knowledge, expertise, skills, means, tools, licenses, if applicable, and equipment necessary to perform Construction Administration for the Project and is ready, willing and able to undertake and perform the same under the terms and conditions contained in this Agreement.

NOW, THEREFORE, in consideration of the foregoing recitals and the terms and conditions contained herein, the Parties agree as follows:

- 1. <u>INCORPORATION OF RECITALS</u>. The above Recitals are true and correct and are fully incorporated into this Agreement as if fully set forth in this Paragraph 1.
- 2. <u>PURPOSE AND SCOPE OF SERVICES.</u> City agrees to retain Engineer to perform all services and comply with all obligations specified or indicated in Exhibit A, which is attached hereto and incorporated herein as if fully set forth in this Paragraph 2, and as set forth and described in the Standard General Conditions of the General Services Agreement the City entered into, or will enter into, with the general contractor for the

Project (the services described in this Paragraph 2 shall be collectively referred to hereinafter as the "Services").

 <u>NON-DISCRIMINATION</u>. Pursuant to Mont. Code Ann. § 49-3-207, in the performance of this Agreement, the Engineer agrees that all hiring will be on the basis of merit and qualifications and that the Engineer will not be discriminate on the basis of race, color, religion, creed, political ideas, sex, age, marital status, physical or mental disability, or national origin.

4. NATURE OF RELATIONSHIP.

- a. The Engineer states that it is engaged in an established business or profession which is in no way affiliated with or connected to the City, except by this Agreement and that it uses independent judgment in the performance of services provided hereby free from control or direction of others. The Engineer shall perform the Services as an independent contractor. The Parties agree that the City is only interested in the end result of the Services, not in the method of performance, and as such, the Engineer has been and will continue to be free from the control or direction of the City in the performance of this Agreement.
- Engineer shall not be considered an employee of the City for purposes of tax, retirement system, or social security, FICA withholding, or for any other purpose. Engineers are not subject to the terms and provisions of the City's personnel policies and may not be considered a City employee for workers' compensation or any other purpose.
- c. The Engineer shall not be deemed by virtue of this Agreement nor the performance thereof to have entered into any partnership, joint venture, employer/employee or any other legal relationship with the City besides that of an independent contractor.
- d. The Engineer, its officers, agents and/or employees shall not have the authority to make representations on behalf of the City, and neither shall the aforementioned persons have the authority to legally bind or otherwise obligate the City to any third person or entity.
- e. Engineer shall furnish all labor, materials, supplies and incidentals necessary to conduct and complete the Services.

- 5. <u>ENGINEER'S REPRESENTATIONS AND WARRANTIES.</u> The Engineer represents and warrants as follows:
 - a. It and its employees are licensed by the State of Montana as engineers and agree to perform the Services in a professional manner according to the standards of care, skill, knowledge and diligence normally exercised by a professional engineer and in accordance with sound practices. In the event any service is found to be out of conformance with the foregoing standards, the Engineer, at its own expense, shall make such changes, modifications or additions as are necessary to remedy the situation.
 - b. It and its employees possess all of the necessary qualifications, experience, knowledge, tools and equipment to undertake the performance of the Services as set forth in this Agreement.
 - c. It will comply with all applicable laws, rules, ordinances and regulations adopted or promulgated by any governmental agency or regulatory body, whether State, federal or local, and furthermore agrees to assume full responsibility for the payment of all contributions of all federal and state income or other payroll tax or assessment, social security, worker's compensation insurance, unemployment insurance, self-employment tax or any other required deduction or contribution for himself or for any employees engaged by the Engineer in performance of this Agreement.
 - d. It will comply with the applicable requirements of the Workers' Compensation Act, Title 39, Chapter 71 of the Montana Code Annotated, and the Occupational Disease Act of Montana, Title 39, Chapter 71 of the Montana Code Annotated, and shall maintain workers' compensation coverage for all members and employees of the Engineer, except for those members who are exempted by law. Engineer shall furnish copies showing proof of workers' compensation coverage by an insurer licensed and authorized to provide workers' compensation insurance in the State of Montana or proof of exemption from workers' compensation granted by law for independent contractors. Proofs of coverage are collectively attached to this Agreement as Exhibit B.
 - e. It has reviewed the contract documents related to the Project and this Agreement and has entered into this Agreement based solely upon its own knowledge,

inspection and judgment, and not upon any representations or warranties made by the City or its officers, employees or agents.

6. <u>PAYMENT.</u>

- a. For the satisfactory completion of the Services, the City will pay the Engineer a sum not to exceed Two Hundred Forty Thousand Five Hundred Ninety Two and 64/100 Dollars (\$240,592.64); provided, however, the Parties may agree to additional compensation in an amount not to exceed Twenty Four Thousand Fifty Nine and 26/100 Dollars (\$24,059.26) in the event presently unforeseen circumstances require Engineer to provide additional services or spend additional time on items not contemplated by this Agreement. Each specific service the Engineer provides under this Agreement, and the maximum amount the City will pay the Engineer for each, is set forth in Exhibit A.
- b. The Engineer may submit monthly requests for payment based on actual work performed, which must be accompanied by an itemized invoice describing the services furnished, the number of hours worked to accomplish each item, the amount being billed for each item, a description of any other eligible expenses incurred during the billing period and the total amount being billed.
- c. In connection with obtaining payment under this Agreement, Engineer agrees to familiarize itself with, and agrees to be bound by, the City's claim procedure, including but not limited to deadlines for submitting claims for approval and payment. The Engineer assumes responsibility for the late filing of a claim.
- d. In the event the Engineer seeks payment or compensation for work, materials or services not included in this Agreement and the exhibits hereto, the Engineer must seek prior written authorization from the City before such expenditure is incurred. If the Engineer fails to obtain prior written authorization, the Engineer shall not be entitled to payment for the unauthorized work, materials or services.
- 7. <u>TERMINATION OF THIS AGREEMENT.</u> The City reserves the right to terminate this Agreement for any and all causes, or for its convenience, at any time upon fifteen (15) days written notice to the Engineer. If termination is effected by the City for default, an equitable adjustment in the fee shall be made, but no amount shall be allowed for anticipated profit or unperformed services. If termination is effected by the City for reasons of convenience, an equitable adjustment in the fee shall be made, including

reasonable profit. The equitable adjustment for any termination shall provide for payment to the Engineer for services rendered and expenses incurred prior to the termination. Upon termination, the Engineer will cease work and deliver to the City all data, design drawings, specifications, reports, estimates summaries and such other information and material accumulated by the Engineer in performing this Agreement whether completed or in progress.

- 8. <u>OWNERSHIP AND PUBLICATION OF MATERIALS</u>. All documents, design drawings, data, specifications, reports, estimates and such other information and material accumulated or prepared as a result of this Agreement are the property of the City, and the City shall have exclusive and unrestricted authority to release, publish or otherwise use, in whole or in part, information relating thereto. Any reuse without written verification or adaptation by the Engineer for the specific purpose intended will be at the City's sole risk and without liability or legal exposure to the Engineer.
- 9. <u>INDEMNIFICATION AND HOLD HARMLESS.</u> The Engineer waives any and all claims and recourse against the City, its officers, agents or employees, including the right of contribution for loss and damage to persons or property arising from, growing out of, or in any way connected with or incident to the Engineer's performance of this Agreement, except for liability arising out of concurrent or sole negligence of the City or its officers, agents or employees. Further, the Engineer will indemnify, hold harmless, and defend the City, its officers, employees and agents against any and all claims, demands, damages, costs, expenses or liability arising out of the Engineer's performance of this Agreement, except for liability arising out of the concurrent or sole negligence of the City or its officers, agents or employees or liability arising out of the Engineer's performance of this Agreement, except for liability arising out of the concurrent or sole negligence of the City or its officers, agents or employees.
- 10. <u>INSURANCE.</u> The Engineer will carry a general liability insurance and professional errors and omissions insurance during the term of this Agreement in an amount of not less than One Million Five Hundred Thousand and No/100 Dollars (\$1,500,000.00) per occurrence, and Seven Hundred Fifty Thousand and No/100 Dollars (\$750,000.00) per claim. Copies of certificates of insurance, suitable to the City, shall be filed with the City and are attached hereto and incorporated herein as Exhibit C. The Engineer shall also maintain workers' compensation and unemployment insurance, as well as other insurances as may be required by law for employers, or an exemption from the state of Montana.
- 11. <u>CONFLICT OF INTEREST</u>. The Engineer covenants that it presently has no interest and will not acquire any interest, direct or indirect, in the Project which would conflict in any

manner or degree with the performance of the Services. The Engineer further covenants that, in performing this Agreement, it will employ no person who has any such interest.

- 12. <u>NOTICES.</u> All notices or communications required to be given under this Agreement shall be in writing and shall be deemed to have been duly given by personal delivery or upon deposit into the United States Postal Service, postage prepaid, for mailing by certified mail, return receipt required and addressed, to the address set forth in this Agreement. Any change of address shall be made by giving written notice thereof to the other party, providing the new address.
- 13. <u>MODIFICATION AND WAIVER</u>. No amendment, modification or waiver of any condition, provision or term of this Agreement shall be valid or of any effect unless made in writing, signed by the party or parties to be bound and specifying with particularity the nature and extent of such amendment, modification or waiver. Any waiver by any party of any default of the other party shall not effect or impair any right arising from any subsequent default. Nothing herein shall limit the remedies or rights of the parties hereunder and pursuant to this Agreement.
- 14. <u>SEVERABILITY</u>. Each provision of this Agreement is intended to be severable. If any provision of this Agreement is illegal or invalid for any reason whatsoever, such illegality or invalidity of said provision shall not affect the validity of the remainder of this Agreement.
- 15. <u>ENTIRE AGREEMENT</u>. This Agreement contains the entire understanding of the Parties in respect to the Project and supersedes all prior agreements and understandings between the Parties with respect to the Project.
- 16. <u>INTERPRETATION.</u> All captions, headings, or titles in the paragraphs or sections of this Agreement are inserted for convenience or reference only and shall not constitute a part of this Agreement or act as a limitation of the scope of the particular paragraph or section to which they apply. As used herein, where appropriate, the singular shall include the plural and vice versa and the masculine, feminine or neuter expressions shall be interchangeable.
- 17. <u>TIME IS OF THE ESSENCE</u>. Time is of the essence in performance of this Agreement.
- 18. <u>COUNTERPARTS.</u> This Agreement may be executed in multiple counterparts, each of which shall be one and the same Agreement and shall become effective when one or

more counterparts have been signed by each of the parties and delivered to the other party.

- 19. <u>PARTIES IN INTEREST AND ASSIGNMENT</u>. This Agreement shall be binding upon, and the benefits and obligations provided for herein shall inure to and bind, the Parties and their respective successors and assigns, provided that this section shall not be deemed to permit any transfer or assignment otherwise prohibited by this Agreement. This Agreement is for the exclusive benefit of the Parties and it does not create a contractual relationship with or exist for the benefit of an third party. This Agreement shall not be assigned, or any right or obligation hereunder, in whole or in part, to another without first having prior written consent of the other party. No assignment or transfer of any interest under this Agreement shall be deemed to release the Engineer from any liability or obligation under this Agreement, or to cause any such liability or obligation to be reduced to a secondary liability or obligation.
- <u>APPLICABLE LAW AND VENUE.</u> This Agreement and the rights and obligations of the Parties shall be governed by and interpreted in accordance with the laws of the State of Montana. The parties stipulate and agree that the Montana Sixth Judicial District Court, Park County, has proper venue and jurisdiction to resolve all causes of action which may accrue in the performance of this Agreement.
- 21. <u>LIAISON</u>. The designated liaisons with the City are Shannon Holmes and Matt Whitman, both of whom can be reached at (406) 222-5667. The Engineer's liaison is Keith Waring, who can be reached at (406) 586-0277.
- 22. <u>ATTORNEY FEES</u>. In the event either party incurs legal expenses to enforce the terms and conditions of this Agreement, the prevailing party shall be entitled to recover its reasonable attorney fees and other costs and expenses, whether the same are incurred with or without suit.
- 23. <u>COMPUTING TIME.</u> For the purpose of calculating time under this Agreement, the following computation shall be used: If the period is stated in days or a longer unit of time, exclude the day of the event that triggers the period, count every day, including intermediate Saturdays, Sundays, and legal holidays, and include the last day of the period, but if the last day is a Saturday, Sunday, or legal holiday, the period continues to run until the end of the next day that is not a Saturday, Sunday, or legal holiday.

RE: Construction Management Role and Fees

This memo provides additional information on the requirements, responsibilities and fee structure associated with Construction Management for Municipal Infrastructure Projects.

Requirements:

For Utility Rehabilitation and Extensions:

The Administrative Rules of Montana (ARM 17.38.101) require water and sewer system improvements be designed by a professional engineer and certify the system was built in conformance with the approved plans and specifications. Montana DEQ requires a "Owner certification that a Professional Engineer will be retained for construction inspection and will certify completion in accordance with the approved plans and prepare as-builts for submittal to the department within 90 days of project completion."

Responsibilities:

- 1. Serve as an objective, experienced Owner's Representative to protect the Client's and project's best interests first and foremost.
- Reduce overall project costs, usually well in excess of their fees. Savings include enhanced competitive bidding, contract negotiation, value engineering, reduced change orders, reduction in time, and elimination of unnecessary scope and cost.
- 3. Centralize communication, acting as project liaison to fully and seamlessly integrate all participants.
- 4. Advise the Client on retention of the best qualified and appropriate project team.
- 5. Enhance quality control to reduce potential for defects and poor workmanship.
- 6. Provide realistic and reliable budgets.
- 7. Optimize and accelerate the design and construction schedule.

- 8. Provide cost effective document controls, including contract negotiation and issuance on standard AIA form 84 insurance review, and substantiation of invoices of all project participants to ensure correctness.
- 9. Protect the Owner from unnecessary liability.
- 10. Provide management expertise, applying resources wherever needed

Fees:

Based on the complexity of the project, the CM is typically 10-20% of construction costs.

THE COL has historically used a Time and Materials contract: CM bills for labor, equipment and travel based on the actual time worked. This is a direct correlation with the contractor's work schedule for the project.

- In 2015, MDT budgeted for CM as 10% of Construction costs for the 5th and E Street TA Project. Once the project was bid and constructed (\$166,511.32) the CM (\$61,050.77) ended up being 36.6% of construction costs.
- MDT is budgeting for 20% CM on the O Street Trail Project.
- Main Street CIP (Construction \$1,266,281) CM (\$106,128) or 8.4% of Construction cost.
- 2014 CIP (Construction \$803,758) CM (\$74,638) or 9.3% of Construction cost.
- 2015 CIP (Construction \$766,296) CM (\$73,000) or \$9.5% of construction cost.
- 2016 CIP * does not include 7th Street water* (Construction Estimate \$2,305,860) CM proposal (\$259,020) or 10.2% of construction cost. This CM will be slightly higher due to the complexity of the project plus the increase in meetings with the Downtown property owners and presentations to the City Commission.
- Lyndsey Volpe, Montana DNRC W2ASACT, stated that typical Construction Management contracts are between 10-12% of the construction costs depending on the complexity of the project. They have seen the CM costs approach 20% in some instances.
