#### CALL TO ORDER

Mayor French called the special meeting of June 5, 2025, to order at 6:00 p.m.

#### **ADOPTION OF THE AGENDA**

<u>Deputy Mayor Furutani moved</u> to adopt the agenda as presented. <u>Cmbr. Goode</u> <u>seconded</u>. The motion to adopt the agenda as presented carried unanimously.

Mayor French facilitated interviews of the City Council candidates. After brief introductory statements from the candidates, Councilmembers asked six predetermined questions of the candidates.

Mayor French invited the public to comment.

Don Fiene provided comments in support of Richard Saunders filling the council vacancy.

With no one else wishing to speak, Mayor French closed the public comment.

#### Executive Session – Review of City Council Candidate's Qualifications per RCW 42.30.110(1)(h)

The City Council went into Executive Session at 7:47 p.m. for approximately 40 minutes to review the City Council candidate's qualifications pursuant to RCW 42.30.110(1)(h).

Council returned from the Executive Session at 8:27 p.m.

#### Selection of Candidate to Temporarily Fill the Vacancy of City Council Position No. 2

Vice Chair Goldman proposed a similar nomination and voting system to the one used to select the Deputy Mayor and Vice Chair.

Cmbr. Goode nominated Ashton McCartney.

Cmbr. Riddle nominated Fiaz Mir.

Vice Chair Goldman nominated Sebastian Quesada.

Cmbr. Saunders nominated Richard Saunders.

Councilmembers spoke about their nominations. Mayor French called for a vote.

Two votes for Candidate McCartney: Cmbr. Goode and Deputy Mayor Furutani.

One vote for Candidate Mir: Cmbr. Riddle.

One vote for Candidate Quesada: Vice Chair Goldman.

Two votes for Candidate Saunders: Cmbrs. Saunders and Lebo.

Receiving only one vote, Candidates Fiaz and Quesada were eliminated.

Councilmembers spoke again about their nominations of Candidates McCartney and Saunders. Mayor French called for a vote.

Five votes for Candidate McCartney: Deputy Mayor Furutani; Vice Chair Goldman; Cmbrs. Goode, Riddle, and Saunders.

One vote for Candidate Saunders: Cmbr. Lebo.

With the majority vote, Candidate Ashton McCartney was appointed to fill the Position 2 Council vacancy temporarily.
