Staff recommends the following:

Motion to adopt Resolution No. 2024-48 certifying the election results of the City municipal election held in conjunction with the State General Election on November 5, 2024.

Overview / Background

The City of Long Lake held a municipal election in conjunction with the November 5, 2024 State General Election for the purpose of electing the office of Mayor for a two-year term, and two Council Member offices for four-year terms. Minnesota Statute 205.185, subd. 3, requires that the City Council serve as the Canvassing Board for City elections to canvass election results and declare prevailing candidates. The Canvassing Board is required to approve the City's municipal election results between the third and tenth day following the General Election; therefore, between November 8 and November 15, 2024.
