ORDINANCE NO. 2023-____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS AMENDING LOS ALTOS MUNICIPAL CODE CHAPTER 2.08 AND CHAPTER 2.12 PERTAINING TO CITY COMMISSIONS GENERALLY AND THE HISTORICAL COMMISSION

WHEREAS, the City of Los Altos has guidelines for the 11 Commissions regarding their scope of work, number of Commissioners, and frequency of Commission meetings within Los Altos Municipal Code Sections 2.08 and 2.12; and

WHEREAS, during the City Council retreat on February 21, 2023, the Council received a presentation from staff highlighting that Los Altos, when compared to other cities in the county, has more Commissions, with more members, that meet more frequently than is average; and

WHEREAS, the City Council discussed each of the commissions during the Study Session on March 28, 2023 and provided direction, feedback, or general thoughts; and

WHEREAS, during the regular City Council meeting on April 25, 2023, City Council provided direction to City staff on the proposed changes; and

WHEREAS, this ordinance will amend Los Altos Municipal Code Sections 2.08 and 2 regarding the guidelines for commissions; and

WHEREAS, this Ordinance is exempt from environmental review pursuant to Section 15061(b)(3) of the State Guidelines implementing the California Environmental Quality Act of 1970, as amended.

NOW THEREFORE, the City Council of the City of Los Altos does hereby ordain as follows:

SECTION 1. AMENDMENT OF CODE: Chapter 2.08 of the Los Altos Municipal Code is hereby amended to read as follows:

2.08.010 Creation of commissions.

There are hereby established the following commissions in the city, with the following regular voting members:

A. Complete streets commission: Seven (7) members

- AB. Environmental commission: Seven (7) members;
- BC. Financial commission: Seven (7) members;
- <u>CD</u>. Historical commission: <u>Seven Five (5)</u> members;
- DE. Library commission: Seven Five (5) members;

E<u>F</u>.Parks, arts, recreation and cultural-and recreation commission: Seven (7) members;

FG. Planning and transportation commission: Seven (7) members;

G. Design review commission: Five members;

- H. Youth commission: Eleven (11) members; from school grades seven <u>nine (9)</u> through twelve (12); <u>and</u>
- I. Senior Commission: Seven (7) members, age fifty-five (55) or older. Exceptions may be made for individuals with special skills which may benefit seniors;.
- J. Public arts commission: Seven members; and
- K. Bicycle and pedestrian advisory commission: Seven members.

2.08.020 Membership.

- A. All voting members shall be appointed by the council, with the following exceptions:
 - 1. Five Four (4) members of the library commission shall be appointed by the council and <u>one (1) member two members</u> of the library commission shall be appointed by the Town of Los Altos Hills city council; and
 - 2. Five (5) members of the senior commission shall be appointed by the council and two (2) members of the senior commission shall be appointed by the Town of Los Altos Hills City Council.
- B. All voting commissioners shall be residents of the city, except that:
 - 1. Three <u>One (1)</u> voting members of the library commission need not be <u>a</u> residents;
 - 2. <u>Two One (1)</u> voting members of the historical commission need not be <u>a</u> residents provided the criteria of Section 2.12.010 are met; and
 - 3. Two (2) voting members of the senior commission need not be residents.

2.08.030 Terms, appointments, and vacancies.

- A. Commissioners, with the exception of senior and youth commissioners, shall serve for a term of four (4) years and may be reappointed to one additional four-year term. Terms shall be staggered and expire on the last day of March or September. A commissioner shall be appointed by a majority vote of the Council and may be removed prior to the expiration of his or her term by a majority vote of the Council, and such removal may be with or without cause.
- B. Senior commissioners shall serve two-year terms with incumbents eligible to serve a total of four (4), two-year terms, in addition to an unexpired term. Terms shall be staggered and expire on the last day of MarchSeptember.
- C. Youth commissioners shall be appointed from school grades seven <u>nine (9)</u> through twelve (12) and shall serve two-year terms with incumbents eligible to reapply for appointment for terms through and including their senior year. Terms shall be staggered and expire on June 30th. The city council's youth commission interview committee shall interview commission applicants and recommend appointments.
- D. <u>Except for Senior and Youth Commissioners</u>, <u>a</u>A commissioner appointed to fill an unexpired term may be eligible for reappointment to an additional two (2) terms.
- E. The two-term limit shall apply to consecutive terms only. After a lapse of two (2) years, a former commissioner may reapply for an appointment to any commission desired as a new applicant. The two-year lapse between appointments shall apply

only to service on one commission. Upon leaving one commission, an individual may apply for an appointment to any other commission at any time.

- F. Appointments to each commission shall be made as terms expire or when unanticipated vacancies occur.
- G. Vacancies on any commission shall be filled by a majority vote of the council, except that the Town of Los Altos Hills City Council may fill two vacancies one vacancy on the library commission and two vacancies on the senior commission. An individual appointed to fill a vacancy prior to the expiration of the term for which his or her predecessor was appointed shall serve for such unexpired term.

2.08.040 Compensation

Commissioners shall serve without compensation. The council may approve payment reimbursement to commissioners of expenses incurred by them in their official capacity.

2.08.050 Organization

Annually, each commission shall elect one of its members as chair and one as vicechair, each to serve a one-year term. Each commission shall provide the time, place, and manner for holding regular and special meetings. A majority of the authorized membership of a commission shall constitute a quorum of that commission. All meetings of the commission as a whole, or any standing subcommittees, shall be open to the public and noticed in accordance with the California "Ralph M. Brown Act." <u>State law.</u>

2.08.060 Meetings

Each commission shall establish a regular meeting day and time and shall hold meetings as listed. All Commissions shall not hold regular meetings during the months of July and December.

- A. Complete Streets Commission: once monthly
- B. Environmental Commission: once monthly
- C. Financial Commission: twice quarterly
- D. Historical Commission: once quarterly
- E. Library Commission: every other month
- F. Parks, arts, recreation and cultural commission: once monthly
- G. <u>Planning Commission: twice monthly</u>
- H. Senior Commission: once monthly
- I. Youth Commission: once monthly

Any regular meeting may be cancelled in accordance with State Law.

2.08.0670 Powers and duties of the planning commission.

The planning commission shall have those powers and duties given it by the State Planning Act (Title 7 of Chapter 3 of the Government Code of the state, commencing with Section 65100), as amended from time to time, and such other powers as granted it by the other provisions of this Municipal Code, or as may be entrusted to it by the council from time to time, and shall submit an annual report to the council.

2.08.0870 Powers and duties of the library commission.

- A. The library commission shall: act in an advisory capacity to the council in all matters pertaining to the city library, shall cooperate with other governmental agencies and civic groups in the promotion of adequate and efficient library service to the citizens of the community, shall make budget recommendations to the council with regard to the library, and shall submit an annual report to the council.
- A. Serve as the principal liaison between the City Council of Los Altos and Los Altos Hills and the Santa Clara County Library District, and the various community entities that help to fund the library branches, including, but not limited to, the North County Library Authority, the Los Altos Library Endowment and the Friends of the Los Altos Library;
- B. Review the Los Altos Library programs, services and facilities, and make recommendations to the Council, the City Manager and/or County and Community Librarians as appropriate, for additions or modifications thereof;
- C. Conduct community outreach regarding the library facilities, programs and services, and report back to the Council and/or the County and Community Librarians as appropriate;
- D. Perform such other tasks as may be expressly requested of it by the City Council;
- E. Serve as a forum for community input and engagement;
- F. Submit an annual report to the Council; and
- G. Perform other tasks and duties as assigned by the Council.

2.08.0980 Powers and duties of the parks, art, and recreation and cultural commission.

The parks<u>, art</u>, and recreation <u>and cultural</u> commission shall: act in an advisory capacity to the council in all matters pertaining to parks and public recreation and shall cooperate with all other governmental agencies and civic groups in the advancement of sound parks and recreational planning and programming, shall make budget recommendations to the council with regard to parks and recreation, and shall submit an annual report to the council.

- A. Submit an annual report to the City Council providing an update on the direction and changes to parks and recreation facilities and infrastructure, and park, art, recreation and cultural programs and activities;
- B. Review and advise on programs, activities and resources designed to provide for, regulate and direct the future growth and development of parks facilities and recreation programming;

- <u>C. Manage the public outdoor sculpture loan program. The commission will conduct</u> <u>sculpture searches, evaluate and recommend sculptures, identify sculpture</u> <u>locations and work with staff on placement and maintenance of sculptures;</u>
- D. Annually review the inventory of art in public places and advise the city in matters pertaining to the maintenance, placement, alteration, sale, transfer, ownership and acceptance or refusal of donations of art in public places;
- E. Serve as a forum for community input and engagement; and
- F. Perform other tasks and duties as assigned by the Council.

2.08.090100 Powers and duties of the historical commission.

The historical commission shall have those powers and duties granted it by Section 2.12.030 of the Los Altos Municipal Code and/or as may be entrusted to it by the council from time to time and shall submit an annual report to the council.

2.08.1100 Powers and duties of the youth commission.

The youth commission shall act in an advisory capacity to the city council on matters relating to youth interests, youth concerns, and the need for outreach services. The city council's youth commission interview committee shall interview commission applicants and recommend appointments.

2.08.110 Powers and duties of the design review commission.

The design review commission shall have those powers and duties granted it by other provisions of this Municipal Code, or as may be entrusted to it by the council from time to time, and shall submit an annual report to the council.

2.08.120 Powers and duties of the environmental commission.

- A. The commission shall: have those powers and duties entrusted to it by the council from time to time, and shall submit an annual report to the council. The environmental commission studies and makes recommendations to council on issues that affect the natural and built environment in the city and the region. Additional duties include special projects as directed by the council.
- <u>A.</u> Submit an annual report to council providing an update on the implementation of the Climate Action and Adaptation Plan (CAAP) as well as updates on any relevant environmental policy or programs;
- B. Review and provide recommendations for the implementation of the CAAP, including prioritization of CAAP action items. Make annual recommendations for changes or updates to the Plan;
- <u>C. Annually provide recommendations to the council that affect the natural and built environment to inform policy, budget, and CIP prioritization;</u>
- D. Serve as a forum for community input and engagement; and
- E. Perform other tasks and duties as assigned by the Council.

2.08.130 Powers and duties of the financial commission.

The commission shall have those powers and duties entrusted to it by the council including:

- A. Annual review of the investment policy;
- B. Annual review of independent financial audit;
- C. Review of auditor selection process;
- D. Review of financial projections and assumptions. This especially relates to review of revenue projections provided in the annual mid-year report which are used biennially as the basis for the service and financial plan;
- E. Special projects as directed by the council, city manager or finance director; and
- F. Submission of an annual report to the council.

The financial commission provides resident input to the council and staff regarding financial policy issues, and promotes resident participation and understanding regarding the financial condition of the city.

2.08.140 Powers and duties of the senior commission.

The joint Los Altos/Los Altos Hills senior commission shall act in an advisory capacity to the council in all matters relating to senior interests and concerns, shall make recommendations aimed at improving the life of seniors, and shall submit an annual report to the council.

2.08.150 Powers and duties of the public arts commission.

- A. The public arts commission shall act in an advisory capacity to the council in all matters pertaining to public arts programs sponsored by the city. It shall take an active role in bringing about public awareness of the visual arts as well as in the definition, execution and promotion of those programs which include, but are not limited to, exhibition of sculpture, paintings, photography, video and other visual arts. The commission shall submit an annual report to the council.
- B. The primary focus of the commission is the public outdoor sculpture loan program. The commission will conduct sculpture searches, evaluate and recommend sculptures, identify sculpture locations and work with city staff on placement and maintenance of sculptures. The commission will also assist the city with ensuring that all conditions and agreements are being met. In addition, the commission will promote artists' works through media exposure of the sculpture program.

2.08.1560 Powers and duties of the complete streets commission.

The Complete Streets Commissions shall:

- A. Submit an annual report to council providing an update on the implementation of the Complete Streets Master Plan (CSMP) as well as an update on any relevant transportation policy or programs;
- B. Review and advise on the implementation of the projects outlined in the CSMP;
- <u>C.</u> Annually provide recommendations to the council on transportation-related priorities to inform policy, budget, and CIP prioritization;
- D. Serve as a forum for community input and engagement; and
- E. Perform other tasks and duties as assigned by the Council.
- Help to create multi-modal transportation solutions and policies that enable safe, attractive, comfortable and independent access and travel for pedestrians, bicyclists, transit users, and motorists of all ages and abilities, including connectivity across jurisdictional boundaries.
- Shall advise the council on existing and proposed city policies related to traffic calming and traffic enforcement.
- Shall advise the council on projects and budget priorities for transportation-related capital improvements.
- Provide for community engagement and serve as a conduit for community input.

2.08.1670 Role of staff liaison.

The city manager, or his/her designee, shall appoint an individual to serve as liaison to each commission. The role of the staff liaison is to assist the commission in carrying out its responsibilities. Duties of the staff liaison shall include attending all meetings of the commission, preparing agendas in collaboration with the chair, ensuring agendas and reports are posted in compliance with state law and city protocols, researching and preparing reports for the commission, as is consistent with the work plan and/or council direction, preparing action minutes for approval by the commission, preparing reports from the commission to the council, serving as the liaison between the commission and other city staff, communicating directions from the city council to the commission, and staying apprised of new laws and city protocols related to their assigned commission or commissions generally.

2.08.170 Contract authority.

<u>No commission shall have the power or authority to authorize</u> the expenditure of city funds or to bind the city to any written or implied contract.

2.08.180 Adherence to City policies

Unless otherwise provided herein, Commissioners shall be bound by all City policies, including the Commission Handbook.

SECTION 2. AMENDMENT OF CODE: Chapter 2.12 of the Los Altos Municipal Code is hereby amended to read as follows:

2.12.010 Creation – Qualification and residency of members.

A historical commission consisting of seven five (5) unpaid members, with the following qualifications, shall be appointed by the city council:

- A. Two One (1) members who, by reason of training and experience, are is (1) knowledgeable in the field of construction and structural rehabilitation, such as a licensed architect, engineer or contractor; or (2) social/architectural historian, archeologist and/or urban planner. Such members must either reside or have a place of business within the city; provided, however, with the approval of the city council, any such members who does not maintain an office within the city may reside within the geographic area covered by the 94022 and 94024 U.S. Postal Service zip codes.
- B. Five Four (4) members appointed at large having demonstrated interest in preservation of the historic resources within the city. Such members must be residents of the city.
- C. The original appointment of members of the commission shall be as provided in Section 2.08.030 of this title.

The term of office of members of the commission shall be as provided in Section 2.08.030 of this title.

2.12.020 Organization.

- A. The commission shall elect annually, on or before January 31st, one of its members to serve in the office of chairman, and may elect such other officers from among its members as designated in its charter. Should a mid-year vacancy in any office occur, the commission shall elect a replacement officer at the next regular or noticed special meeting to serve until the next annual election of officers.
- B. The city manager, or his/her designee, shall appoint an individual to serve as liaison to each commission. The role of the staff liaison is to assist the commission in carrying out its responsibilities. Duties of the staff liaison shall include attending all meetings of the commission, preparing agendas in collaboration with the chair, ensuring agendas and reports are posted in compliance with state law and city protocols, researching and preparing reports for the commission, as is consistent with the work plan and/or council direction, preparing action minutes for approval by the commission, preparing reports from the commission to the council, serving as the liaison between the commission and other city staff, communicating directions from the city council to the commission, and staying apprised of new laws and city protocols related to their assigned commission or commissions generally. The planning director or her/his authorized representative shall act as secretary for the historical commission, shall be the custodian of its records, shall conduct official correspondence, and shall generally supervise the elerical and technical work performed at the request or on behalf of the historical commission.
- C. The historical commission shall meet quarterlymonthly, or more frequently upon call of the chairman or commission staff <u>liaison</u>, as necessary. All meetings shall be

open to the public and a public record shall be kept of all commission proceedings and actions.

A majority of commissioners shall constitute a quorum, with the chairman having a vote. The city council shall prescribe rules and regulations for the conduct of its business, thereafter, giving the powers and authority to perform the duties hereinafter enumerated.

2.12.030 Powers and duties.

The historical commission shall be advisory only. It shall advise the city council, the planning commission and the agencies and departments of the city. The historical commission shall establish liaison and work in conjunction with such authorities to implement the purposes of this chapter. The historical commission shall have the following powers and duties:

- A. Work with staff to review and make recommendations on changes to Conduct, or cause to be conducted, a comprehensive survey of properties within the boundaries of the city for the purpose of establishing the historic resources inventory. To qualify for inclusion in the historic resources inventory, a property must satisfy the criteria listed in this chapter. The inventory shall be publicized and periodically updated, and a copy thereof shall be kept on file in the planning department;
- B. Recommend to the city council specific proposals for designation as an historic landmark or historic district;
- C. Recommend to the appropriate city agencies or departments, projects and action programs for the recognition, conservation, enhancement and use of the city's historic resources, including standards to be followed with respect to any applications for permits to construct, change, alter, remodel, remove or otherwise affect such resources;
- D. Review and comment upon existing or proposed ordinances, plans or policies of the city as they relate to historic resources;
- E. Review and comment upon all applications for building demolition or grading permits involving work to be performed upon or within a designated historic landmark or historic district, and all applications for tentative map approval, rezoning, building site approval, use permit, variance approval, design review or other approval pertaining to or significantly affecting any historic resource. The commission's comments shall be forwarded to the city agency or department processing the application within thirty (30) days after receiving the request for such comments;
- F. Investigate and report to the city council on the availability of federal, state, county, local or private funding sources or programs for the rehabilitation and preservation of historic resources;
- G. Cooperate with county, state and federal governments and with private organizations in the pursuit of the objectives of historical preservation, with the approval of and at the direction of the city council;

- HF. Provide resource information on the restoration, alteration, decoration, landscaping or maintenance of any cultural resource including the landmark, landmark site, historic district, or neighboring property within public view and promote and conduct public information and educational programs pertaining to those resources;
- IG. Submit an annual report to the City Council providing an update on the additions and deletions from the Historic Resources Inventory; Participate in, promote and conduct public information and educational programs pertaining to historic resources;
- JH. Perform such other functions as may be delegated to it by resolution or motion of the city council;
- KI. Cooperate with the association of the Los Altos historical museum;
- LJ. Submit an annual report work plan to the city council; and
- MK. Review and make its recommendation to the planning director on all permit applications pursuant to Article 3, Sections 12.44.100 through 12.44.170.

SECTION 3. CONSTITUTIONALITY. If any section, subsection, sentence, clause or phrase of this code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this code.

SECTION 4. PUBLICATION. This ordinance shall be published as provided in Government Code section 36933.

SECTION 5. EFFECTIVE DATE. This ordinance shall be effective upon the commencement of the thirty-first day following the adoption date.

SUBJECT: Discussions regarding expenditures for general and specific purposes under Measure L

Summary

The Futures Library Commission Subcommittee has submitted a correspondence to NCLA requesting clarification on certain questions relating to use of Measure L tax revenue towards "general purpose" items. This correspondence, included with this report as <u>Attachment 1</u>, asks several questions regarding whether the tax revenues collected may be used towards maintaining services, renovations, structural expansions, or new building construction. The Commission expressed desire for legal counsel to respond to these inquiries. This report provides an overview of the issue and responds to specific questions.

Background

In 2010, voters in the City of Los Altos and the Town of Los Altos Hills approved Measure L to levy a \$76 special parcel tax for 20 consecutive fiscal years. NCLA was formed through a joint powers agreement between the City of Los Altos and the Town of Los Altos Hills. As described in the joint power agreement, the purpose of the NCLA is to create an agency which will plan, support, acquire, maintain and operate programs and facilities for the extension of public library services for the benefit of the inhabitants within the collective boundaries of the City of Los Altos and Town of Los Altos Hills.

Under California law, the revenue collected from Measure L parcel tax is a "special tax" and thus may only be spent for specific purposes. Thus, NCLA's expenditure of Measure L funds is subject to the parameters set forth by the ballot measure. The Statement of Purposes under Measure L (included as <u>Attachment 2</u>) summarizes the services provided by the Los Altos and Woodland library branches (collectively referred to hereinafter as "library" for ease of reference). In addition, the document also outlines the specific purposes for which tax proceeds may be used, as follows:

- (1) **Maintain library hours.** Funds may be spent on maintaining specified number of hours at Los Altos and Woodland library locations.
- (2) **Purchase books and materials.** Funds may be used to supplement the Santa County Library system to purchase books and materials tailored to specific community needs and interests.

- (3) **Support library programs.** Funds may also be used to support and maintain the level of programs that is currently provided for all age groups.
- (4) **General purposes.** Funds may be used for any other expenditure necessary to uphold the level of service, including expenses related to a future election when the parcel tax expires.

Responses to Specific Questions Relating to "General Purposes" Expenditures

The Futures Library Commission Subcommittee requested NCLA to clarify the following questions. The questions are provided in summary here with further details shown in Attachment 1. Per the Commission's request, our review and responses are shown below.

1. Does the term "uphold the level of service" enable NCLA to spend funds to maintain or enhance services in 2023 to maintain services in place at the time the measure was passed? This question also asks how "level of service" is defined and whether that term includes meeting new governmental requirements that are mandatory to continue operations.

Measure L allows NCLA to spend tax revenue funds to maintain services that were in place in 2010. In reviewing the purposes of the measure, we think this expenditure does include responding to changes in 2023 and subsequent years in order to maintain service levels. Although the term "level of service" is not defined under the ballot measure, it is reasonable to interpret this term to encompass the types of services that were in place in 2010 which the tax measure sought to fund. To illustrate on the contrary, if funds were to be spent to expand the scope of activities and programs significantly, or beyond the library's existing purposes and functions, then such expenditure likely would not be "upholding level of services" and would not serve the general and specific purposes under Measure L.

Based on the description outlined in Measure L's Statement of Purpose, it is reasonable to conclude that service items to be maintained would include: operating hours, books and materials for circulation, library programs, and associated operational needs to maintain these library functions for the general public. In order to continue providing these services, therefore, it also reasonably follows that the library and NCLA will have to respond to certain changes in circumstances so that the level of service provided to the general public does not decline or disappear. This interpretation is further supported by the fact that the ballot measure contemplates the need to hold a future election when this parcel tax expires as the need for funding will likely increase or change. It is worth noting that, although not required by the ballot measure, as mentioned in a part of this question NCLA may consider evaluating service levels based on "per capita" assessment as one method to calculate the efforts needed to maintain service to the community.

In response to the specific questions raised here, we think that compliance with mandatory governmental regulations is an appropriate use of funds because it is responding to changes in circumstances that are necessary to operate the library and maintain services. Similarly, the change in population would also result in increased service needs, to which the NCLA may spend funds to meet in order to keep the same level of service it has been providing. Finally,



another example where NCLA may spend funds to maintain services is to respond to changes in technology and accessibility. In our view, these examples are appropriate responses to changes in circumstances and operational needs for the purposes of continuing to provide the level of services that the public has received.

2. May the NCLA spend funds on interior renovation aligned with the County's Strategic Initiatives? The question also specifically asks about Open+ Access, a comprehensive system designed to improve library services and efficiency, as well as alterations to the library building to provide visibility and access.

Probably yes. Based on the foregoing analysis, we think NCLA may also spend funds towards aligning with the County's strategic plan as long as the action being taken under the plan is consistent with preventing services from being reduced or eliminated, or responding to a change in circumstances and/or operational need that is necessary to continue the same level of services.

For instance, improving the library building in order to ensure ADA compliance is necessary to continue library operations. Implementing accessibility/technology systems to streamline library services also appears to be within the scope of maintaining the public's ability to receive the same level of services. As another example, providing additional space for library patrons based on the increase in service population likewise would make library services adequate and consistent for the public, and thus also appear to meet the purposes of the tax measure. On the other hand, if the proposed action under the strategic plan is to fundamentally alter or expand the types of services provided by the library system, then it is less likely that such action can be supported by spending Measure L funds.

3. May the NCLA spend funds on an expansion of the building to address additional space and service needs?

Likely yes but consistent with above, any proposed expansion must be for the purpose of restoring the reduction in space and services that were previously available to library patrons and staff. Otherwise, constructing new spaces unrelated to such purposes would probably be difficult to justify as "upholding" the level of services as their purpose is not to maintain the status quo as intended by the measure based on our reading of that language. If NCLA desires to proceed with the project through utilization of Measure L funds, such limitations should be clearly described in the project's scope of work.

4. May the NCLA spend funds to replace the current structure and build a new library?

Probably not, unless the current library building is determined to be non-compliant with state building code requirements as described in the question. As discussed above, expanding

library infrastructure, facilities and services likely would not be considered consistent with the stated purposes under Measure L as they do not "uphold services" and do not meet any of the specified purposes. However, meeting building code standards is most likely considered as meeting operational needs to continue library services at existing levels and would thus be appropriate. As noted above, such limitations should also be clearly described in the project's scope of work if NCLA desires to proceed with such construction through utilization of Measure L funds.

Recommendation

It is recommended the Commission review the information presented in this report and provide direction to staff regarding next steps.

Introduction

In 2010, voters in the City of Los Altos and the Town of Los Altos Hills approved Measure L to levy a \$76 special parcel tax for twenty (20) consecutive fiscal years ("Parcel Tax"). The Parcel Tax passed by the City of Los Altos and Town of Los Altos Hills voters in 2010 is a special tax because the ballot measure language sets forth specific purposes for which the funds are to be spent.

The North County Library Authority (NCLA) has the fiduciary responsibility for overseeing the Parcel Tax through 2030. The NCLA mission is "To plan, support, acquire, maintain and operate programs and facilities for the extension of public library services for the benefit of the inhabitants within the collective boundaries of the Member Entities (defined as City of Los Altos and City of Los Altos Hills)."

The NCLA has the authority to levy the Parcel Tax pursuant to Government Code Section 61121. Sections 50075 et seq. of the Government Code sets forth the requirements for how the Parcel Tax may be spent by NCLA.

The specific purposes for which the funds are to be spent are outlined in Measure L as follows:

- 1. **Maintain library hours**. Funds may be spent on maintaining specified number of hours at Los Altos and Woodland library locations.
- 2. **Purchase books and materials**. Funds may be used to supplement the Santa Clara County Library system to purchase books and materials tailored to specific community needs and interests.

- 3. **Support library programs.** Money may also be used to support and maintain the level of programs that is currently provided for all age groups.
- 4. **General purposes.** Funds may be used for any other expenditure necessary to uphold the level of service, including expenses related to a future election when the parcel tax expires.

Questions for Consideration on General Purposes

We ask that the NCLA request clarification of on the meaning of Item 4, the General purposes. What is the definition of "General Purposes" and the phrase "any other expenditure necessary to uphold the level of service." Specifically:

1. Does the term "uphold the level of service" enable NCLA to spend funds to maintain or enhance services in 2023 to maintain services in place at the time the measure was passed?

The ballot initiative for Measure L explained that in the twenty (20) years since the parcel tax of 1990, library circulation more than doubled, the library offered more than 500 programs for children, teens, and families, along with a significant collection, technology, books, computers, and Wi-Fi access. "The annual \$76 parcel tax - fixed for the next 20 years - will make certain that these services continue by covering current and future costs for library operating hours, staffing, programs, and book collections tailored to community needs." Today, the library population has ballooned to 54,000 (from 42,000 in 2010), hours have expanded ¹, the collection has grown by 15,000 volumes, and virtual access to online resources has scaled. How is level of service defined (e.g., per capita), and how does this term encompass new government requirements which must be met to continue operations?

2. May the NCLA spend funds on interior renovation aligned with the County's Strategic Initiatives?

In early 2023, the Santa Clara Library District rolled a five-year strategic plan. Our libraries have always supported these initiatives, especially in the area of Innovation. Woodland Library has successfully rolled out Open Access and we

need to continue to innovate, this time at the Main Library. We also owe our clients, especially families with a safe environment. Today, the doors to the children's section of the Los Altos Library are propped open to ensure ADA compliance. We need to revise our existing lobby and children's area to maximize visibility; minimize or eliminate spaces where children and youth cannot be seen; establish policies and procedures for access to and use of the space and make any required adjustments to the facility to provide for Open Access.

To improve services and ensure safety, the Community Librarian proposes to renovate the lobby area, install a family restroom adjacent to the children's area, enhance the community room to provide more program space, and introduce Open Access ². The population of Los Altos and Los Altos Hills has increased by over 2,600 people from 2010 to 2020 with a corresponding increase in the number of children. The growth in our teen population also provides us with the need to provide adequate space for studying and tutoring. The increase in population, especially that of children, means that we are no longer providing the same level of service to children that we did in 2010.

3. May the NCLA spend funds on an expansion of the building to address additional space and service needs?

COVID has changed how we view and use library space and services. The Community's needs are evolving. The demand for certain services, such as rooms for private and small-group meetings, and roomy program areas to ensure air circulation and attendee spacing, is growing to pre-pandemic levels. Suggested sizing for adult program space is 14-15 net square feet per occupant, exclusive of support spaces (such as A/V closets and kitchen facilities) and storage for all furniture³. The current meeting room nominally accommodates about 100

occupants sitting auditorium-style unless the programs involve special equipment (such as a piano) or movement (such as cultural performances). Staff areas also need upgrading. They lack the space to accommodate all the bins and carts needed for the volume of returns our library experiences.

4. May the NCLA spend funds to replace the current structure and build a new library?

Further study is required to determine if the current library building complies with the building code. Remodeling could trigger the need to upgrade the facility just to meet current codes. If rebuilding the library is deemed to be the only way to restore services to the level expected by the citizens of the Member Entities, may NCLA funds be used for these purposes? Funds are carved out for funding of a bond measure, but could NCLA funds be used replace either of our two libraries?

EXHIBIT A

BALLOT MEASURE

To maintain Los Altos and Woodland library hours, purchase books and materials, support library programs, and for general purposes, shall the North County Library Authority, a joint powers authority between Los Altos and Los Altos relies, continue a tax for 20 years, with annual oversight, at the fixed rate of \$76 per year on each developed parcel of land within Los Altos and Los Altos Hills and allowing an exemption for low-income senior households, and establish an appropriations limit?

PARCEL TAX AUTHORIZATION

By approval of this proposition by at least two-thirds of the registered voters voting on the proposition, the Authority will be authorized to levy a qualified special tax of \$76 per parcel per year, subject to all the accountability requirements specified below. If approved, the special tax will be levied for 20 consecutive fiscal years, starting in the fiscal year that begins on July 1, 2010, and ending in the fiscal year that begins on July 1, 2029.

EXEMPTIONS FROM PARCEL TAX

The Authority has provided an exemption from the special tax will be available to households made up of low-income persons who are 65 years or older and own and occupy a parcel as their principal residence, and who apply to the Authority for such exemption pursuant to guidelines established by the Authority.

ACCOUNTABILITY REQUIREMENTS .

The provisions in this section are specifically included in this proposition in order that the voters and (axpayers in the Authority may be assured that their money will be spent wisely. As required by the laws of the State of California, the proceeds of the qualified special tax will be deposited into a special account established by the Authority and will be applied only to the specific purposes identified below. The Authority has covenanted to have on file with its governing board no later than January 1 of each year a report stating the amount of the funds collected and expended and the status of any project authorized to be funded.

APPROPRIATIONS LIMIT

The California Constitution restricts governmental spending by setting an annual appropriations limit, which is the maximum amount a public entity may spend in a given fiscal year. The Constitution authorizes a public entity to establish or change its appropriations limit upon approval of a majority of voters voting on the measure. This ballot measure establishes

the appropriations limit for the Authority at \$2 million for the fiscal year that begins on July 1, 2010, as it may be adjusted annually thereafter in accordance with California law.

STATEMENT OF PURPOSES

The statement shown below is a part of the ballot proposition and must be reproduced in any official document required to contain the full statement of the proposition.

The current parcel tax of \$52 was established in 1990 to finance an expansion of the library and supplement the operating hours and book budget. In time, and with inflation taking its toll, the parcel tax has come to pay for a significant portion of the operating hours. Since the current parcel tax is scheduled to expire in tax year 2011-2012, a new parcel tax is necessary if the Los Altos Library is to continue the current level of service. Successful passage of the new parcel tax will require the Authority to terminate the current existing tax.

<u>Maintain Library hours</u>. The Main Library in Los Altos is currently open **7 days a week** for a total of 66 hours. Funding from the Santa Clara County Library system pays for 53 hours. The NCLA parcel tax pays for the additional 13 hours which currently cover all day Monday and Tuesday morning.

The Woodland Branch is currently open 6 days a week. Funding from the Santa Clara Library system pays for 20 hours of the 39 hours that the Branch is open. Absent the renewal of this parcel tax, Woodland Branch hours will be reduced by approximately 49%.

Purchase Books and Materials. The proceeds of the parcel tax will also be used to supplement the ability of the Santa Clara County Library system to purchase books and materials tailored to our Community's specific interests, such as its Science and Technology Collection.

Support Library Programs. Last fiscal year, our Library presented a total of 501 programs for all age groups: Toddler and Pre-School, Elementary and Middle School. Teens, Adults and Family. Programs were well attended and the number of participants increased by 9% over the prior fiscal year. While NCLA does not currently pay for programs directly, a reduction of service hours would negatively impact the Library's capability to deliver the current level of programs.

General Purposes. Any other expenditure necessary to uphold the level of service, including expenses related to a future election when the new parcel tax expires.

Subject: Los Altos Library Patio Project

Summary:

- The Patio Project is fully funded by the Los Altos Library Endowment and supported by the Santa Clara County Library District who will take the lead on the public project management.
- The proposed library patio will provide the community with 7,700 square feet of safely enclosed outdoor space that can be used by residents of all ages to read, study, learn, and explore. Working in partnership with the History Museum, this project creates educational experiences both within the Historic Orchard and attached to the main library.
- Based on the needs assessment for the library, additional public space is a priority to allow the library to offer free educational events and flexible spaces for patrons to read and study. The current library community room space is limited in both size and accessibility, and this new extension creates an interactive outdoor space that will encourage discovery for all ages, as well as expand seating and event spaces.
- The History Museum and library are natural partners that can work collaboratively to highlight the Historic Orchard through innovative programming with a new outdoor patio space. The library and Orchard Commons joint programming ideas include diverse creativity, healing in nature, adopt-a-tree, oral history with apricots and orchards, and nature journaling and sketching.
- The patio project provides many opportunities for public programming with local organizations including schools, Master Gardeners, and GreenTown. Other potential community partners include LASD Living Classrooms, LASD Art Docents, The Garden Club of Los Altos, ArtVentures, Santa Clara Watercolor Society, and Ikebana.
- The project is supported by the Los Altos Library Endowment, the Chou Family, the History Museum, the Library Commission, and the Friends of the Los Altos Libraries.

Recommendation:

Staff recommends, if the City Council approves the proposal, sending the item to the Development Services Director for review and necessary approvals of this project.

Purpose

To create an outdoor space that provides residents with a place to read, relax, study, work, and learn. The patio will be used to provide free library programs for all ages, as well as open seating to use during leisurely time. Backed with research from professional library journals, outdoor

spaces in libraries enhance the lives of residents. Due to limited space inside the library, library staff feel strongly that the outdoor space will expand options to best meet the needs of residents with 7,000 square feet of enclosed space.

Due to the Covid-19 pandemic, outdoor spaces are now more in-demand to provide patrons with opportunities to protect their health in a public environment. And the moderate climate allows for year-round use. According to the National Oceanic and Atmospheric Administration, the average temperature over the course of a year (San Jose and surrounding cities) is 71.5 degrees--making this outdoor space accessible year-round for residents of Los Altos and Los Altos Hills.

Background

The vision of an outdoor patio space at the library to meet a community need was inspired by a private donation. Taking into consideration the need for more public space, the success of outdoor programming and the design trends of innovative library spaces, the library began working closely with the Orchard Commons Committee and the city to explore a way to highlight the Historic Orchard and create a unique outdoor space at the library.

With City Council approval to repurpose 7,700 sf of city space, the library will work with a professional architecture firm on the design that meets the needs of the community.

Recommendation

Staff recommends, if the City Council approves the proposal, sending the item to the Development Services Director for review and necessary approvals of this project.

Dear Honorable Mayor Meadows and City Council Members:

The Los Altos Library Endowment is excited to share its support with you for the Santa Clara County Library District's (SCCLD) vision for an exterior expansion project to benefit the patrons of our local library. We enthusiastically support funding an outdoor patio that will complement the existing building design while increasing green space and improving natural light. The proposed outdoor patio will also prove to be a very user-friendly space to meet the needs of our community members now, and for the next generation. We seek your support, so that SCCLD may move forward with the proposed project.

The Los Altos Library Endowment (LALE) was established with the desire to support our community to maintain a library that meets the needs of everyone. Since inception in 2001, LALE has funded unique and innovative projects and programs such as the GoGo Biblio mini bookmobile, 3D printers, and the pilot Open Plus access at the Woodland Branch library.

It is well known that the library serves as a constant in the lives of our citizens, with patronage crossing every demographic and age group in the community. We are gratified that SCCLD has received a five-star rating from the Library Journal, and designation as a Star Library for the 15th straight year. SCCLD has recently been recognized as ranking second in the U.S. among comparably sized library districts.

Despite advances in technology, rather than merely stream or download from the comfort of their home, the numbers of individuals and families using the library space has continued to grow to such an extent that our library's walls are bursting....which led SCCLD and LALE to investigate how best to further invest to benefit our populace. Through its recently-completed Strategic Plan 2023-2028, SCCLD has received overwhelming support for the need to maximize accessibility for all community members, be environmentally responsible, reflect the cultures of the population, and provide new spaces for families and teens to learn and create, and for individuals to gather, meet, and work or study independently. The patio project is in complete alignment with the Strategic Plan.

We recognize the importance of respecting the historical landmarks within the boundary of the Civic Center Heritage Orchard. Based upon community input, and working in collaboration with the Los Altos History Museum and its Orchard Commons Committee, SCCLD and LALE have developed a plan that we believe is both feasible and cost-effective while respecting those landmarks as well as creating a new safe, inviting and desirable destination.

1. <u>The Specifics of the Proposed Plan</u>

A review of the architectural renderings demonstrate why we are proud of this proposed enhancement to our library. Having the ability to create a safely enclosed outdoor space with amenities will prove to be a positive physical addition to the library campus. The plan is to create a beautiful area, with two access points: a sliding glass door from the Orchard Room utilizing a new folding NanaWall system and glass doors that open from the Children's Room.

The area once constructed will include shade structures, and provide needed space for programs and seating. Apricot trees will be incorporated into the design elements, and there will be views to the surrounding orchard. The public will have access to the patio at all hours in which the Library is open to the public, which currently is 10:00 a.m. to 9:00 p.m. weekdays, and 10:00 a.m. to 7:00 p.m. on Fridays and weekends.

2. Community Outreach

Thanks to the funding that LALE provided, a feasibility study was conducted by SSA Architects. We are grateful that SCCLD will be partnering with the Los Altos History Museum in a collaborative effort to pool resources and talents. As you are aware, the History Museum has extensive experience with their own beautiful, and widely used, outdoor patio in the Civic Center area. At all times SCCLD has stressed LALE's

objective: a quality project that the community will be proud of. The positive feedback has been gratifying.

3. The Financing and the Timing

LALE's Board of Directors has approved a financial commitment to cover the entire estimated construction cost of the Patio Project of Two Million Dollars (\$2,000,000.00). That commitment includes a generous Five Hundred Thousand Dollar (\$500,000.00) donation from the Chou family, through a directed grant specified to be provided through LALE. At a time when there is widespread reporting of the difficulty of financing new construction projects given the turmoil in the financial markets, our commitment to provide this financing demonstrates our interest in moving forward as soon as possible, before construction costs increase and additional funding would be required. In short, we believe that the time to act is now.

On a personal note, the Chou family would like the patio project completed during the lifetime of the patriarch and matriarch of the family. Having the ability to see the results of their generous donation will provide great pride to the entire Chou family.

4. The Approval and Implementation

Upon approval by the City Council, SCCLD will be responsible for the final design and building plans. As the public will be the beneficiary of the completed construction, we strongly encourage a rapid approval so as to enable the final building plans to be submitted for approval. The positives of expanded use of the library facilites by patrons far outweigh the negatives of delay (increased costs of construction).

5. <u>The Future Use</u>

The journey to get to this point has already proven to be a positive experience. After all, we have been working together to accomplish something that we could not do alone. The end result will prove to be beneficial for the whole of our community.

Naturally, so that the community learns about the expansion to the facility, we intend to promote the patio project. Information and depictions will be included in all of our marketing materials and the various forms in which we engage the public.

6. Conclusion

The Library Commission as well as Friends of the Los Altos Library have each passed unanimous motions in support of the patio project, establishing that the project is a strong priority that should move forward. In anticipation of approval, SCCLD has secured a memorandum of understanding with the History Museum.

Both the SCCLD and the Los Altos Library Endowment wish to acknowledge your dedication of time and attention to the library's future. We look forward to working toward collectively implementing approval of the patio project in order to improve and enhance the library as part of a continued commitment to meet our community's long-term needs. We believe that the time is now!

RE: Library Patio Project

This memorandum documents the intent of Los Altos History Museum, through its Orchard Commons Committee, to collaborate with the Los Altos Library on the design of an outdoor reading room. We understand and appreciate the desire to provide access into the Children's Reading Room through a corridor that would be constructed within the boundary of the Historical Landmark of the Civic Center Heritage Orchard, as designated in Resolution 91-31 (see attachment).

The City of Los Altos is responsible for maintaining the quality of City Historical Landmarks, as an irreplaceable historical asset of benefit to all members of the community. This responsibility includes timely exchange of information about all activities that might affect expansion of the footprint of existing buildings or landscaping features that might extend into the landmark boundaries.

Maintaining the quality of this City Historical Landmark entails collaboration to ensure that any alterations are constructed with a soft footprint that will enhance outreach programs without reducing the capacity of the orchard to sustain the original number of trees. If construction operations alter the quality or quantity of tree sites in the orchard, it is our understanding that the damage will be offset by appropriate mitigation actions agreed upon through open communication.

The goal of the <u>Orchard Commons Committee</u> of the Los Altos History Museum is to maintain, restore and renovate the Civic Center Heritage Orchard in a manner that provides an appealing working landscape and to facilitate outreach programs that enhance a sense of place and civic pride. This goal is in alignment with the vision of the Museum to provide inclusive multi-generational and multi-cultural programming and with the City's <u>Climate Action and Adaptation Plan</u>.







CONCEPTUAL DESIGN OF LIBRARY PATIO PARAMETER



Be sure you take part in our Summer Reading challenge. All you need to do is register on <u>Beanstack</u>. Those who read 5 books (Audiobooks count!) and complete one activity by July 31 will earn badges for logging in their progress. Finishers will be able to pick up a reward at their local library during the month of August, while supplies last.

Lunch at the Library

Morgan Hill and Gilroy Libraries are providing free lunches this summer to youth under 18 and their caregivers. These hot, nutritious meals, which are available while supplies last, are to be enjoyed at the library. No registration is necessary.

Parks and Recreation Month

Summertime is here and with it a desire to get out and enjoy the warmer, longer days. July is <u>Parks and</u> <u>Recreation Month</u>, when many Americans choose to visit local, <u>state</u> and <u>federal</u> parks. The Library offers many resource guides for <u>parks</u> and <u>hiking</u>. You can check out a <u>California State Park Pass</u> from the library that grants free parking access to over 200 participating state parks.



The Gilroy Library and Morgan Hill Library circulation desks also carry <u>Nature Daypacks</u>, which come equipped with a compass, nature guides, binoculars, and a parking voucher that can be used at <u>County</u> <u>parks</u> for families to enjoy their outdoor adventures. The Milpitas Library and Campbell Express also lend out county park passes.

Libraries to Stock Life-Saving Drug Narcan

The Library District, in response to the request by the County Board of Supervisors to expand availability of Naloxone throughout the County, has limited onsite supply of the drug (better known by its brand name <u>Narcan</u>) at every library location for emergency use. Library staff members who volunteered have been trained on how to administer the Narcan nasal spray. Many facilities including schools and recreation centers are also stocking supplies of Narcan as a preventative step.



Narcan is an <u>FDA approved</u> over the counter anti-opioid medication, which if used immediately can saves lives in the case of an overdose, including from the drug fentanyl. The County Behavioral Health Department recently launched a <u>public information campaign</u> to help increase awareness about the dangers of fentanyl, particularly when combined with other drugs, such as methamphetamines.

July through September, the Library District, in partnership with the County Behavioral Health Services Department will be holding a series of public education events around the danger of drugs and fentanyl, information about Narcan and the proper use of the Narcan nasal spray. Attendees who complete the one-hour program will receive a one box supply of Narcan.





Requirements for Reimbursement

To be eligible for ON THE MOVE ride reimbursement, you must meet ALL of the following criteria.

- 1. Ride services must take place between July 1, 2023 and June 30, 2024
- 2. You must create an account on CIVIC Rec.
- 3. This program is for ages 50 years and older.
- 4. Must be residents of Los Altos or Los Altos Hills.
- 5. Ride must begin and end within the city of Los Altos, Town of Los Altos Hills, El Camino Hospital Complex including North Dr., South Dr., Hospital Dr., and Solace Pl., Kaiser Mountain View (555 Castro St., Mountain View), Satellite Healthcare (247 El Camino Real, Mountain View), Kaiser Santa Clara (facilities on Lawrence Expressway & Facilities on Homestead), Palo Alto Medical Foundation in Palo Alto and Mountain View, Palo Alto VA Hospital and all VA associated facilities located on Miranda Ave. and Loop Road, Stanford Hospital and associated facilities on Jordan, Pasteur and Blake Wilber with no stops outside those areas. Reimbursements are for basic rides, no upgrades.
- 6. Now accepting COVID-19 related trips and other trips that meet guidelines listed in #4.
- 7. You must use an on-demand ride company that can provide official verification of ride cost and transportation start and finish points.
- 8. Full cost of ride and up to \$3 driver gratuity will be reimbursed, any additional gratuity given will not be reimbursed.

Process for reimbursement is as follows:

- 1. Complete reimbursement form.
- 2. Print a copy of ride receipt from your rider history.
- Submit completed reimbursement form and ride receipt to the Parks & Recreation front office, 97 Hillview Avenue, Los Altos, CA 94022 (within 90 days). Make sure the ride receipt includes beginning and end points.
- 4. Consolidate reimbursements to one or two months at a time.
- 5. Wait for Approval by Recreation and Finance Departments.
- 6. Look for reimbursement in your mail (2-3 weeks)
