Los Altos Mayor Dailey and Distinguished Council Members

Subject: Council 4-22-2025 Study Session Downtown Park with Parking Presentation

Presentation Report shows a "pretty picture" park painted on a "blank palette". Unfortunately, Plaza 1 and 2 have "dirty palettes" that need cleaning up designs before starting public outreach. It is important that public outreach comments are based on "blank palette" surface and have some data about actual size, parking loss, undergrounding utilities before surface of park can start construction. Also, a total cost estimate to achieve a "blank palette" surface in Plaza 1 and 2 surfaces.

#### As always, "devil is in the details".

Following are items that will need to be done before start of surface park construction:

- Plaza 1 is the "heart" of PG&E electrical power distribution for almost all downtown triangle. Master very high voltage step down distribution underground transformer location is near Plaza 1 middle of west end and requires a surface access safety zone around it. Overhead PG&E lines / step-down transformers from very high transformer run east through Plaza 1 and 2. Branch lines in middle of Plaza 1 and 2 run south to Lyell / San Antonio. These overhead lines also have both AT&T and Comcast lines. All will require utilities / services undergrounding and re-routing to 16 the Main Street stores. My experience with recent Los Altos PG&E undergrounding is 3 to 5 years lead time for high voltage.
- Los Altos sewer line runs underground next to first row of trees, near backside of Main stores along Plaza 1 and 2. It will have to be moved closer to Main Street stores to make room for underground parking foundation.
- Both natural gas and water lines dissect both Plaza I and 2 and will need relocation.
- Both Plaza 1 and 2 have downhill slope of 5 feet that could cause loss of underground parking spaces due to extended underground parking ramps.
- In my opinion, Los Altos parking Plaza's agreement 68 years ago with downtown property owners gave alley access to rear of their stores. County Fire Department has declared all downtown Plaza alleys emergency accessible routes. This means that alleys on north and south sides of Plaza 1 and 2 must remain. Plaza 1 is APN 167 40 039 and Plaza 2 is APN 167 40 072 for official site dimensions.

P.S. It appears that potential developers interested in Plaza 7 and 8 are having trouble "penciling out" housing projects because of undergrounding and narrow lot width.

#### **DISCUSSION/ANALYSIS**

Please find attached the City's Treasurer's Report for the quarter ending March 31, 2025. This report includes the quarter-end balances for all City treasury accounts and the check registers for the period January 1 through March 31, 2025, which document the City's disbursements during the quarter.

As of March 31, 2025, the City of Los Altos holds 4 treasury accounts as follows:

- 1. US Bank General Checking: This account is used to meet the City's daily cash needs, for regular deposit of City receipts, and disbursement of funds for the City's regular obligations.
- 2. LAIF: the Local Gency Investment Fund (LAIF) is Managed by the California State Treasurer; this investment pool holds funds in excess of the City's daily cash flow needs. This investment is fully liquid and serves as the City's primary repository of

cash to cover the City's expenses when they exceed the balance held in the City's general checking account.

- 3. CAMP: the California Asset Management Program (CAMP) is a Joint Powers Authority (JPA) established to provide California public agencies with professional investment services. The fund is fully liquid and serves as a repository of cash to cover the City's short-term expenses when they exceed the balance held in the City's general checking account.
- 4. Public Trust Advisors: Public Trust Advisors in an investment firm specializing in local government investments. The City utilizes their investment account to hold funds not needed to meet current obligations, which are available for longer term investment.

#### PREVIOUS COUNCIL CONSIDERATION

August 26, 2003, January 27, 2004, and March 1, 2005.

#### BACKGROUND

The City of Los Altos established the Raymundo Avenue Curb and Gutter Assessment District in 2003 under the Municipal Improvement Act of 1913 (Division 12 of the California Streets and Highways Code, the "Act"). Bonds were issued pursuant to the Improvement Bond Act of 1915 (Division 10 of the California Streets and Highways Code, the "Code"). The project aimed to improve infrastructure by installing curbs, gutters, and storm drains, as well as conducting necessary street surface repairs along Raymundo Avenue from Springer Road to Mountain View Avenue.

A total of twenty-eight residences benefited from the project, contributing financially through the assessment district process. This funding mechanism ensured that property owners who directly benefited from the improvements shared the cost.

On August 26, 2003, the City Council authorized staff to proceed with the formal bidding process for the Raymundo Avenue Curb and Gutter Assessment District Project. Following a competitive bidding process, the contract was awarded to O'Grady Paving, Inc. on January 27, 2004. The project was successfully completed and formally accepted by the City Council on March 1, 2005.

#### ANALYSIS

To finance the construction and installation of curbs and gutters along Raymundo Avenue, the City issued Limited Obligation Improvement Bonds totaling \$274,391 in July 2005. These bonds were secured through special assessments levied on the benefiting properties, ensuring an equitable funding structure while allowing for upfront capital to complete the necessary improvements.

Over the years, the property owners met their financial obligations, leading to the full repayment of the bonds. On September 2, 2020, the City confirmed that all outstanding debt associated with the bonds had been retired, marking the successful financial closure of the project.

#### DISCUSSION

To formally close out the assessment district, the City engaged NBS, a consulting firm specializing in public finance, to conduct a thorough review and prepare a District Closeout Analysis Report. This report details the required administrative steps for dissolving the district and provides final documentation related to the bonds and special assessments levied on the affected properties.

According to the analysis, all special assessments levied as security for the bonds have been fully satisfied by the property owners. With no outstanding debt or further obligations, the City can now proceed with the formal dissolution of the Raymundo Avenue Curb and Gutter Assessment District.

Adopt an ordinance of the Los Altos City Council adding Chapter 14.91 for Lighting Performance Standards and find that this ordinance is exempt from environmental review pursuant to Section 15061(b)(3) of the State Guidelines implementing the California Environmental Quality Act of 1970.

#### **ENVIRONMENTAL REVIEW**

The proposed amendments are exempt from environmental review pursuant to Section 15061(b)(3) of the California Environmental Quality Act (CEQA) Guidelines.

#### PREVIOUS COUNCIL CONSIDERATION

April 8, 2025.

#### BACKGROUND

In late 2023, the Los Altos City Council directed staff to develop an ordinance in coordination with the Environmental Commission regarding Bird Safe Design and Dark Skies. The Los Altos Municipal Code does not presently regulate either of these two provisions.

In late spring the Environmental Commission voted on the general requirements of what should be included within a Bird Safe Design and Dark Skies ordinance. Following the discussion regarding the general requirements for the ordinance an Environmental Commission Subcommittee worked directly with the Development Services Department, Management Analyst II and Assistant City Manager on the draft ordinances under consideration. Additionally, the draft ordinances were reviewed by the Environmental Commission on October 9, 2024; the Environmental Commission made a unanimous decision for the Draft Ordinance to advance to the following stages for adoption.

Since the draft regulations will largely affect housing developments within the City of Los Altos it is essential for these provisions to be included within the Zoning Code which will allow for universal application of standards. All Zoning Code amendments require review by the Los Altos Planning Commission. Following the decision of the Environmental Commission the draft ordinance was scheduled for consideration of the Planning Commission on November 21, 2024.

On November 21, 2024, the Planning Commission was presented the draft ordinances as approved by the Environmental Commission. The Planning Commission made the following recommendation to the Los Altos City Council:

Motion by Beninato and Second by Steinle to recommend the Los Altos City Council adopt Chapter 14.91 for Lighting Performance Standards with a modification to Section 14.91.070 changing provisions for existing nonconforming lighting to be modified upon a 50% threshold of a remodel instead of a five and ten year compliance period and look at providing an incentive program for existing structures; and not adopt Chapter 14.90 for Bird Safe Design Standards; and find the proposed amendments are exempt from environmental review pursuant to Section 15061(b)(3) of the California Environmental Quality Act (CEQA) Guidelines. Motion carried unanimously by roll call vote.

On April 8, 2025, the City Council considered both recommendations by the Environmental and Planning Commissions. The City Council Introduced the Lighting Standards Performance Ordinance with a minor modification to the Kelvin rating from 2,700 to 3,000. The Bird Safe Design Ordinance failed for a lack of motion by the City Council.

#### DISCUSSION

The proposed Lighting Performance Standards Ordinance is to protect and enhance the city's natural environment and public health by reducing light pollution at night through reasonable restrictions on outdoor lighting.

The Lighting Performance Standards as modified are largely consistent with the recommendation of the Environmental Commission except for Section 14.91.070 Application of Chapter to Existing Nonconforming Lighting as modified by the Planning Commission. The original recommendation of the Environmental Commission included enforcement of nonconforming lighting on a 5- or 10-year compliance schedule post adoption, which the Planning Commission was concerned about the impact on existing developments and the future financial costs associated with those upgrades. The Planning Commission recommended the compliance mechanism for existing nonconforming lighting to be modified upon a 50% threshold of a remodel. The City Council agreed with the recommendation of the Planning Commission.

The City Council Introduced the Lighting Standards Performance Ordinance with a minor modification to the Kelvin rating from 2,700 to 3,000. The modification in Kelvin rating is more consistent with industry standards, and available fixtures.

#### AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS ADDING CHAPTER 14.91 OF THE LOS ALTOS MUNICIPAL CODE

**WHEREAS**, the City Council is empowered pursuant to Article XI, Section 7 of the California Constitution to make and enforce within the City all local, police, sanitary, and other ordinances, and regulations not in conflict with general laws; and

**WHEREAS,** the City Council held a duly noticed public hearing on April 8, 2025, and April 22, 2025; and

**WHEREAS,** the amendments were processed in accordance with the applicable provisions of the California Government Code and the Los Altos Municipal Code; and

**WHEREAS**, this Ordinance is exempt from environmental review pursuant to Section 15061(b)(3) of the State Guidelines implementing the California Environmental Quality Act of 1970, as amended; and

NOW, THEREFORE, the City Council of the City of Los Altos does hereby ordain as follows:

**SECTION 1. AMENDMENT OF CHAPTER 14.91 OF THE MUNICIPAL CODE**. Chapter 14.91 of the Los Altos Municipal Code is hereby added as set forth in Appendix A to this Ordinance, underline indicating addition, strikethrough indicating deletion.

**SECTION 2. CONSTITUTIONALITY; AMBIGUITIES.** If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions hereof. Any ambiguities in the Los Altos Municipal Code created by this Ordinance shall be resolved by the Development Services Director, in their reasonable discretion, after consulting the City Attorney.

**SECTION 3. PUBLICATION**. This Ordinance shall be published as provided in Government Code Section 36933.

**SECTION 4. EFFECTIVE DATE.** This Ordinance shall be effective upon the commencement of the thirty-first day following the adoption hereof.

# **APPENDIX A**

# CHAPTER 14.91 LIGHTING PERFORMANCE STANDARDS

#### 14.91.010 PURPOSE.

The purpose of this chapter is to establish regulations and a process to review outdoor lighting to accomplish the following:

- A. <u>Minimize direct glare and prevent excessive lighting, thereby minimizing light</u> pollution caused by inappropriate or misaligned light fixtures, and promoting common courtesy among neighbors; and
- B. Provide sufficient lighting where it is needed to promote safety and security; and
- C. Provide standards for efficient and moderate use of lighting; and
- **D.** Encourage human health benefits and local wildlife safety.

### 14.91.020 DEFINITIONS.

"Correlated color temperature" or color temperature is a specification of the color appearance of the light emitted by a light source, measured in Kelvin (K). Warmer color temperatures are a lower number, and cooler color temperatures are a higher number.

"Curfew" means the time of day when lighting restrictions are in effect.

"Directional lighting" means methods of directing light downward, rather than upward or outward, with the intention of directing light where it is needed.

"Fully shielded" means a light fixture constructed and installed in such a manner that all light emitted, either directly from the lamp or a diffusing element, or indirectly by reflection or refraction from any part of the fixture, is projected below the horizontal plane (from the bottom of the lamp).

"Glare" means light entering the eye directly from a light fixture or indirectly from reflective surfaces that causes visual discomfort or reduced visibility to a reasonable person.

"Government facilities" means a building or structure, parcel or property, owned, leased, operated, or occupied by the City of Los Altos. Government facilities include any public infrastructure maintained within the City of Los Altos.

"Light pollution" means the material adverse effect of artificial light, including, but not limited to, glare, light trespass, sky glow, energy waste, compromised safety and security, and impacts on the nocturnal environment, including light sources that are left on when they no longer serve a useful function.

"Light trespass" means a condition in which artificial light emitted from a luminaire on one property, not inclusive of light incidentally scattered or reflected from adjacent surfaces, is directed in such a manner that the light source is visible from any other property. "Lumen" means the common unit of measure used to quantify the amount of visible light produced by a lamp or emitted from a light fixture (as distinct from "Watt," a measure of power consumption).

"Outdoor light fixtures" means outdoor illuminating devices, lamps and similar devices, including solar powered lights, and all parts used to distribute the light and/or protect the lamp, permanently installed or portable; synonymous with "luminaires" affixed to the exterior of a building.

"Seasonal lighting" means lighting installed and operated in connection with holidays or traditions.

"Security lighting" means lighting intended to detect intrusions or other criminal activity occurring on a property or site.

"Skyglow" means the brightening of the nighttime sky that results from scattering and reflection of artificial light by air molecules, moisture, and dust particles in the atmosphere, caused by light directed or reflected upwards or sideways and reduces one's ability to view the night sky.

"String lights" means light sources connected by free-strung wires or inside of tubing resulting in several or many points of light.

# 14.91.030 APPLICABILITY.

- A. <u>All existing outdoor light fixtures installed prior to the effective date of the</u> ordinance from which this chapter is derived shall conform to the provisions of this chapter according to the compliance schedule set forth in Section 14.91.070.
- **B.** <u>All outdoor light fixtures installed or replaced after the effective date of the</u> <u>ordinance from which this chapter is derived shall comply with this chapter.</u>
- **C.** For any property subject to this chapter and regulated by permit conditions pertaining to outdoor lighting, the more restrictive provisions in terms of minimizing light pollution shall apply.
- D. Nothing in this chapter shall prohibit a declaration of covenants, conditions, and restrictions for private enforcement from further restricting lighting so long as it meets the minimum standards detailed in this chapter.
- E. The following lighting and activities are not regulated by this chapter:
  - 1. Indoor lighting.
  - 2. <u>Construction or emergency lighting provided such lighting is temporary,</u> <u>necessary, and is discontinued immediately upon completion of the</u> <u>construction work or termination of the emergency; provided, however,</u> <u>construction or emergency lighting shall be deployed to comply with the</u> <u>ordinance to the greatest practical extent.</u>
  - 3. <u>Building or premises address identification lighting that complies with the</u> <u>minimum applicable building or health and safety requirements, provided</u> <u>however, such lighting shall be deployed to comply with this chapter to the</u> <u>greatest practical extent, with the exception of curfew requirements.</u>

- **4.** <u>Low-intensity landscape lighting which is directed downward and no greater</u> <u>than one hundred and fifty (150) lumens per fixture.</u>
- 5. <u>Short-term lighting associated with activities that are otherwise exempt from</u> <u>discretionary or ministerial permitting by the city; provided, however, such</u> <u>lighting shall be deployed to comply with this chapter to the greatest extent</u> <u>practical.</u>
- 6. Public Schools Facilities which include athletic fields and parking lot lights.
- 7. <u>Government Facilities provided however, such lighting shall be deployed to</u> <u>comply with this chapter to the greatest practical extent, except for curfew</u> <u>requirements.</u>
- 8. <u>Lighting at building entrances is subject to all requirements of this chapter</u> except for the curfew requirements in subsection 14.91.040(E) of this chapter.

# 14.91.040 GENERAL STANDARDS.

- A. Shielding.
  - 1. <u>All outdoor light fixtures shall be fully shielded.</u>
    - **a.** EXECEPTIONS to the full shielding requirement include:
      - i. <u>String lights when used in occupied residential and</u> <u>commercial decks or patios. String lighting is limited to a</u> <u>maximum of 50% of usable outdoor area, and must be</u> <u>extinguished by 11:00pm, with a maximum of 42 lumens.</u>
- **B.** <u>Light Trespass. Light trespass is prohibited, except for fixtures exempted from</u> <u>this chapter.</u>
- **C.** <u>Location. Location of Outdoor Lighting, the following limitations are imposed on the location of outdoor lighting:</u>
  - 1. Lighting within five (5) feet of the perimeter of a site is prohibited, except where it is controlled by motion sensor which extinguishes the light no later than ten (10) minutes after activation unless otherwise exempted within this chapter.
- D. Lighting Color (Color Temperature). The correlated color temperature of all outdoor lighting shall be three thousand (3,000) Kelvin or less except for seasonal lighting.
- E. Curfew.
  - Residential Uses: All lighting subject to this chapter shall be extinguished no later than 11:00 p.m., except lighting at building entrances, parking areas and driveways, and lighting activated by motion sensor which extinguishes ten (10) minutes after activation.
  - 2. <u>Commercial Uses:</u>
    - a. <u>All lighting shall be extinguished no later than 12:00 a.m. or close of business, whichever occurs first, except lighting at the building entrances and driveway egress points, and lighting activated by motion sensor which extinguishes ten (10) minutes after activation.</u>

- b. Automated control systems, such as motion sensors and timers, shall be used to meet the curfew requirements for commercial uses. Photocells or photocontrols shall be used to extinguish all outdoor lighting automatically when sufficient daylight is available. Automated controls shall be fully programmable and supported by battery or similar backup.
- F. <u>All outdoor lighting shall comply with applicable regulations in the California</u> <u>Building Standards Code, as may be amended from time to time.</u>

# 14.91.050 SPECIALIZE STANDARDS.

- A. Fuel Station Canopies.
  - 1. <u>Canopies shall not be transparent or translucent.</u>
  - 2. <u>Lighting fixtures in the ceiling of canopies shall be fully recessed into the underside of the canopy. All lighting fixtures shall be located to shield direct rays from adjoining properties or public rights-of-way.</u>
  - 3. Lighting shall not be mounted to the top of facia of canopies.
  - 4. <u>The maximum light intensity under the canopy shall not exceed an</u> average maintained foot-candle (horizontal) of 12.5, when measured at finished grade. Luminaires shall be of a low level, indirect diffused type.
  - 5. <u>No luminaire shall be higher than fifteen (15) feet above the finished grade.</u>
  - 6. <u>The fascia of such canopies shall not be illuminated, except for approved signage.</u>
- B. Outdoor Security Lighting.
  - 1. <u>All security lighting shall be controlled by a programmable motion</u> <u>detecting device and shall be extinguished within ten (10) minutes.</u>
  - 2. <u>Security lighting shall be downward directed, fully shielded, and not be</u> mounted at a height that exceeds twelve (12) feet.
  - 3. Floodlights are not permitted.
  - 4. Lights intended to illuminate a perimeter are permitted only if such lights do not result in light trespass.
  - 5. <u>Motion-activated security lights shall not use luminaires that exceed a</u> <u>maximum of 1,600 lumens.</u>

# 14.91.060 MODIFICATION OF STANDARDS.

- A. <u>Modification of Standards from the lighting standards provided in this chapter</u> <u>may be approved for private properties if approved by the Development Services</u> <u>Director or their designee.</u>
- **B.** <u>Applications to deviate from the lighting standards shall include the following information:</u>
  - 1. <u>A site plan depicting the location of proposed lighting on the site; and</u>
  - 2. <u>A lighting inventory that provides, at minimum:</u>

- **a.** <u>The brightness (in lumens) and correlated color temperature (in Kelvin) of each luminaire; and</u>
- b. The height of each fixture; and
- c. The directional angle of each fixture; and
- d. The character of shielding for each luminaire, if any; and
- e. <u>Identification of luminaires that diverge from the standards of this</u> <u>chapter and are subject to the deviation request; and</u>
- f. <u>Detailed description of the circumstances which necessitate the deviation; and</u>
- **3.** <u>Other data and information may be required by the Development Services</u> <u>Director.</u>
- **C.** <u>The deviation may be granted if the following findings are made:</u>
  - 1. <u>There are unique circumstances affecting the subject</u> property or unique design and land use characteristics that make it infeasible or impractical to comply with strict application of the lighting standards detailed in this chapter.
  - 2. <u>The proposed deviation will achieve the intent of this</u> <u>chapter to the maximum extent feasible.</u>
  - 3. <u>The proposed deviation is to provide necessary</u> <u>security and/or safety lighting of the subject property.</u>
- D. Notice of the Development Service Director's decision to approve the requested deviation shall be posted by city staff or, to their discretion, the applicant, and it shall be legible and visible from the public right-of-way. Such notice shall state the decision on the application and shall provide information on the appeal process pursuant to this chapter.
- E. Appeal Procedures.
  - An appeal of the Development Service Director's decision shall be in writing and filed with the city clerk within fourteen (14) days after the date of the notice of the decision. The appeal shall be accompanied by a fee, as set by the city council, and shall clearly state the reason for the appeal.
  - Upon receipt of such an appeal, the city clerk shall notify the Development Service Director and the applicant and shall set a time for an administrative appeal hearing with the city manager as soon as practical but within thirty (30) days after the receipt of such an appeal.
  - 3. <u>Notice of the appeal hearing shall be published in a newspaper of general circulation, and state the decision being appealed, date, time, and location of the appeal hearing.</u>
  - 4. <u>The city manager shall conduct a de novo hearing of the application. At the close of the hearing, the city manager may affirm, reverse or modify the decision of the director, or refer the matter to the director for further consideration as may be directed by the city manager. The city manager's decision following the appeal hearing will be final.</u>

# 14.91.070 APPLICATION OF CHAPTER TO EXISTING NONCONFORMING LIGHTING.

- A. Effective Date. The effective date of this chapter shall be May 1, 2025.
- **B.** <u>The following requirements shall apply to existing outdoor light fixtures within one</u> (1) year of the effective date of the ordinance from which this chapter is derived:
  - 1. Existing outdoor light fixtures with the ability to be redirected shall be directed downward to minimize sky glow, glare and in a manner to minimize light trespass onto adjacent properties.
  - 2. Existing outdoor light fixtures that have adjustable dimmers shall be dimmed to minimize glare and light trespass onto adjacent properties.
  - **3.** Existing outdoor light fixtures that are motion sensor equipped shall be programmed to extinguish not more than ten (10) minutes after activation.
- **C.** <u>Compliance Period. Notwithstanding the provisions in section B of this section, a property owner shall comply with the remaining requirements of this chapter in association with any site improvements set forth below:</u>
  - 1. Construction of a new single-family dwelling.
  - 2. Construction of a new residential development with two or more dwelling <u>units</u>.
  - 3. <u>An addition to an existing residential development that within a five (5)</u> year period adds and/or replaces fifty (50%) percent or more to the <u>developments existing habitable square footage that is known and</u> provided on the latest County of Santa Clara Assessors Office Tax Roll.
  - 4. Construction of a new non-residential development.

# 14.91.080 AUTHORITY AND ENFORCEMENT.

- A. <u>Authority and enforcement of this chapter shall be enforced as prescribed in Title</u> <u>1 of the Los Altos Municipal Code.</u>
- **B.** Each violation of this chapter shall be considered a separate offense.
  - 1. First Violation shall result in a written warning.
  - 2. <u>Second Violation shall result in an infraction of one hundred dollars</u> (\$100.00).
  - **3.** <u>Third Violation shall result in an infraction of two hundred dollars</u> (\$200.00).
  - **4.** Fourth Violation and subsequent shall result in an infraction of five hundred dollars (\$500.00).

# 14.91.090 NO CONFLICT WITH FEDERAL OR STATE LAW.

Nothing in this chapter is intended to or shall be interpreted as conflicting with any federal or state law or regulations.

# 14.91.100 SEVERABILITY.

If any section, subsection, subdivision, paragraph, sentence, clause, phrase, or portion of this chapter is, for any reason, held to be invalid or unconstitutional by any court of

competent jurisdiction, such a decision shall not affect the validity or effectiveness of the remaining portions of this chapter. The city council hereby declares that it would have adopted this chapter and each section, subsection, subdivision, paragraph, sentence, clause, phrase, and portion of this chapter irrespective of the fact that one or more, sections, subsections, subdivisions, paragraphs, sentences, clauses, phrases, or portions thereof may be declared invalid or unconstitutional to this end, the provisions of this chapter are declared severable.

#### PREVIOUS COUNCIL CONSIDERATION

November 9, 2021, November 30, 2021, May 9, 2023, June 13, 2023, November 12, 2024, & April 8, 2025

#### BACKGROUND

The Los Altos Stage Company has operated in the Bus Barn Theater at the Los Altos Civic Center site for 29 years.

In August 2018, a community theater was identified as part of the Los Altos Downtown Vision Plan that would relocate the Los Altos Stage Company to a new theater in the downtown triangle.

During the November 9, 2021 meeting, the Los Altos Stage Company presented to the City Council and requested a Memorandum of Understanding (MOU) with the City of Los Altos in order to pursue building a downtown theater. At that meeting, the City Council directed staff to prepare a MOU under which the City would reserve a specified City-owned parking plaza through November 9, 2024 as a potential site for a community theater, in order to give the Los Altos Stage Company an opportunity to raise funds towards building a community theater

During the November 30, 2021 meeting, the City Council approved the MOU for a three year agreement through November 30, 2024.

During this time, the Los Altos Stage Company hired AMS Research to do a Feasibility Study built around project objectives, program possibilities, and costs. The results of this study were presented to the City Council in May 2023. This analysis presented an estimated cost of \$24 million with \$1 million escalation for a 23,400 square foot building with a 160-seat theater and other performing arts spaces.

During the May 9, 2023 study session with the Los Altos Stage Company, City Council directed staff to bring a one year extension of this MOU in order to support their next step in completing a capital campaign analysis.

During the June 13, 2023 meeting, the City Council voted to extend the existing MOU through November 9, 2025 with the updated language.

The Los Altos Stage Company hired BuildingBlox Consulting who completed their findings in June 2024. BuildingBlox created a prospective donor list with over 200 names, conducted indepth interviews with 20 prospective donors, and drafted an analysis on the potential for a fundraising campaign.

Per the analysis, they were likely to raise roughly \$9 - \$12 million without a lead gift. In order to reach a \$25 million goal, it was recommended that Los Altos Stage Company should hire a capital campaign manager to cultivate the largest gifts between \$2.5 and \$5 million.

At the November 12, 2024 City Council meeting, the Los Altos Stage Company requested the City to fund two \$2.5 million requests, with one as the lead gift for the project and another at the \$10 million goal mark, and to hire a Capital Campaign Consultant, which is estimated at roughly \$300,000 over a few years. The final request was to extend the MOU with the City to continue their work.

At the November 12, 2024 meeting, the majority of the City Council directed City staff to explore the best feasible next steps to support the request for "a capital campaign consultant or firm that will provide a progress update in the first year to know about the standing and the contract could extend out two to years as necessary."

City staff first evaluated the previous reports provided to City Council by AMS Research and BuildingBlox. City staff believe a project that is 25,000 square feet with the full amenities listed in the project will cost more than the \$25 million mentioned in the report. However, City staff believes a scaled down building with more flexible, less technical spaces and one larger performing arts room in a smaller square footage may be possible for the price of \$25 million. It is the intention to continue pursuing the fundraising goal of \$25 million as outlined in the two reports.

City staff has met with close to ten individuals and firms that focus on major performing arts fundraising in different capacities. After meeting with them, City staff has distilled the following notes and recommendations regarding the project.

There should be a Steering Committee consisting of one individual from the City, the Los Altos Stage Company, and Los Altos Mountain View Community Foundation that will focus only on ensuring the ongoing operations of the fundraising activities, but will not be directly involved in the fundraising. The Steering Committee will also be tasked with hiring the capital campaign firm or individual.

As mentioned in previous reports, Los Altos Stage Company does not have the current staffing to support this capital campaign development. The capital campaign firm or individual will focus on fundraising for this project alone. City staff believes it makes the most sense to have this capital campaign firm or individual work directly out of a third-party beyond the City or Stage Company, which is the Los Altos Mountain View Community Foundation.

Once the capital campaign firm or individual is hired, the Steering Committee will meet with them to identify the best selection process and criteria for a Capital Campaign Cabinet. The Capital Campaign Cabinet will be comprised of individuals from the community, Los Altos Stage Company, and philanthropic community who are donors themselves that will work to support the initiatives and concepts presented with the goal to solicit donations directly from other prospective donors.

The Capital Campaign Cabinet will be the sole group working to fundraise for the downtown theater project through the Los Altos Mountain View Community Foundation and would collaborate with the Los Altos Stage Company as necessary, but the Los Altos Stage Company will not be directly involved in fundraising for the project as it will all be completed by the Capital Campaign Cabinet. The Capital Campaign Cabinet should be comprised of individuals not currently on the boards of any of the three groups.

This type of project will require a quiet phase where the capital campaign firm or individual will be meeting directly with potential Capital Campaign Cabinet members and developing relationships with prospective donors over a period of time.

If City Council desires to allocate funding for this project, City staff recommends that the City provide \$300,000 to the Los Altos Mountain View Community Foundation to retain the services of a capital campaign firm or individual with requirements:

• Must create a Steering Committee consisting of one individual from the City, the Los Altos Stage Company, and Los Altos Mountain View Community Foundation

- Must create a Capital Campaign Cabinet that will oversee the capital campaign firm or individual's work and ensure they are moving forward through this quiet phase
- Must provide a report back to the City around one year from their initial start date with a status update on their current capital campaign efforts and a realistic timeline at the end of one year for the project to reach its goal
- Must provide an analysis to the City of how a City contribution towards the project, requested \$5 million, would be best received in this process

#### DISCUSSION

At the April 8, 2025 meeting, City Council unanimously approved allocating \$300,000 to the Los Altos Mountain View Community Foundation to retain the services of a capital campaign firm or individual for fundraising activities for a downtown performing arts center.

#### BACKGROUND

On April 26, 2022, the Council approved the multi-family design review application and the associated Tentative Map for the new development at 705 Vista Grande Avenue. The recommended action will finalize the tentative map for the project.

A Tentative Map is a map showing the layout of a proposed Subdivision, including the general description of the associated infrastructure. The approved Tentative Map also sets conditions such as access, frontage, grading improvements, stormwater protection, and so forth which must be met before the final Parcel Map or Tract Map can be filed. An approved Tentative Map does not divide the property, rather it sets the conditions under which the division can occur. To divide the property, one must file a final Parcel Map or Tract Map or Tract Map (i.e., Final Map).

The attached Final Map is the instrument that divides the property. It must conform to and incorporate all the Tentative Map conditions and must also comply with the standards for Tract Maps or Parcel Maps as set forth in the State Subdivision Map Act. It must also include plans describing the various improvements to the project site and to all other affected properties, including public roadways and public and private utilities.

#### ANALYSIS

Parcel Map for the development at 705 Vista Grande Avenue conforms to the Tentative Map approved on April 26, 2022. The map and survey have been checked and found satisfactory. All conditions of approval have been complied with and appropriate controls to ensure compliance have been established. All required fees and deposits have been received. This Improvement Agreement (this "Agreement") is made and entered into by and between the CITY OF Los Altos, a municipal corporation (hereinafter "City"), Sandesh & Shikha Tawari (hereinafter "Homeowner"). City and Homeowner may be collectively referred to herein as the "parties."

#### RECITALS

- A. In accordance with the Subdivision Map Act (California Government Code Sections 66410, *et seq.*), and the Subdivision Ordinance (Los Altos Municipal Code, Title 13), and the Street Ordinance (Los Altos Municipal Code, Title 9), the Homeowner has submitted to the City a Parcel Map (hereinafter "Parcel Map") for the project known as 705 Vista Grande Ave (hereinafter "Project").
- **B.** The Project is geographically located within the boundaries of the Tentative Subdivision Map known as 705 Vista Grande Ave Tentative Map (hereinafter "Tentative Map"). The Tentative Map is on file with the City Engineer and is incorporated herein by reference. The area within the boundaries of the Tentative Map is described in **Exhibit A** hereto (the "Property").
- **C.** The City's approval of the Tentative Map was subject to specified conditions of approval (hereinafter "Conditions"). The Conditions are attached hereto as **Exhibit B** and incorporated herein by reference.
- **D.** As required by the Conditions, the Tentative and Parcel Maps, and the other Project entitlements, Homeowner shall construct public improvements in connection with the Project along Vista Grande Ave, including but not limited to the following: installation of approximately 15 linear feet of concrete rolled curb and installation of all appurtenances associated with above listed improvements (collectively, the "Work").

# NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND CONDITIONS IDENTIFIED HEREIN, THE PARTIES HEREBY AGREE AS FOLLOWS:

- 1. <u>SCOPE OF WORK</u>. The Homeowner shall perform, or cause to be performed, the Work described in the Plans and Specifications and the Conditions (hereinafter "Work"), to the satisfaction of the City Engineer. The Work shall be performed, and all materials and labor shall be provided, at the Homeowner's sole cost and expense. No change shall be made to the Scope of Work unless authorized in writing by the City Engineer.
- 2. <u>PERMITS, LICENSES, AND COMPLIANCE WITH LAW</u>. The Homeowner shall, at the Homeowner's expense, obtain and maintain all necessary permits and licenses for the performance of the Work. The Homeowner shall comply with all local, state, and federal laws, whether or not said laws are expressly stated in this Agreement.
- 3. <u>HOMEOWNER'S AUTHORIZED REPRESENTATIVE</u>. At all times during the progress of the Work, Homeowner shall have a competent foreperson or superintendent (hereinafter "Authorized Representative") on site with authority to act on behalf of the Homeowner. The Homeowner shall, at all times, keep the City Engineer informed in writing of the name and telephone number of the Authorized Representative. The Homeowner shall, at all times, keep the City Engineer informed in writing of the name and telephone number of the Authorized Representative. The Homeowner shall, at all times, keep the City Engineer informed in writing of the names and telephone numbers of all contractors and subcontractors performing the Work.

- 4. <u>IMPROVEMENT SECURITY</u>. The Homeowner shall furnish faithful performance and labor and material security concurrently with the execution of this Agreement by the Homeowner, and prior to the commencement of any Work. The Homeowner shall furnish warranty security prior to the City's acceptance of the Work. The form of the security shall be as authorized by the Subdivision Map Act (including Government Code Sections 66499, *et seq.*) and Section 13.20.210 the Los Altos Municipal Code, and as set forth below:
  - **4(a).** <u>Faithful Performance</u> security in the amount of \$4,500.00 (which amount is equal to the estimated cost to construct the Work in accordance with the Plans and Specifications) to secure faithful performance of this Agreement (until the date on which the City Council accepts the Work as complete) pursuant to Government Code Sections 66499.1, 66499.4, and 66499.9.
  - **4(b).** <u>Labor and Material</u> security in the amount of \$2,250.00 (which amount is equal to fifty (50) percent of the estimated cost to construct the Work in accordance with the Plans and Specifications) to secure payment by the Homeowner to laborers and materialmen pursuant to Government Code Sections 66499.2, 66499.3, and 66499.4.
  - **4(c).** <u>Warranty</u> security in the amount of \$450.00 (which amount is equal to ten (10) percent of the estimated cost to construct the Work in accordance with the Plans and Specifications) to secure faithful performance of this Agreement (from the date on which the City accepts the Work as complete until one year thereafter) pursuant to Government Code Sections 66499.1, 66499.4, and 66499.9.
- 5. <u>BUSINESS TAX</u>. The Homeowner shall apply for and pay the business license tax for a business license, in accordance with Los Altos Municipal Code Chapter 4.04.
- 6. **INSURANCE.** Homeowner shall, throughout the duration of this Agreement, maintain insurance to cover Homeowner (including its agents, representatives, contractors, subcontractors, and employees) in connection with the performance of services under this Agreement. **Exhibit C** of this Agreement identifies the minimum insurance levels with which Homeowner shall comply; however, the minimum insurance levels shall not relieve Homeowner of any other performance responsibilities under this Agreement (including the indemnity requirements), and Homeowner may carry, at its own expense, any additional insurance it deems necessary or prudent. The general liability and automobile policies required under **Exhibit C** shall contain, or be endorsed to contain, provision for the City, its officers, officials, employees, agents and volunteers, to be covered as additional insureds as respects alleged liability arising out of activities performed by or on behalf of the Homeowner under this Agreement. Concurrently with the execution of this Agreement by the Homeowner, and prior to the commencement of any services, the Homeowner shall furnish written proof of insurance (certificates and endorsements), in a form acceptable to the City. Homeowner shall provide substitute written proof of insurance no later than 30 days prior to the expiration date of any insurance policy required by this Agreement.
- 7. <u>**REPORTING DAMAGES.</u>** If any damage (including death, personal injury or property damage) occurs in connection with the performance of this Agreement, Homeowner shall immediately notify the City Risk Manager's office by telephone at, and Homeowner shall promptly submit to the City's Risk Manager and the City Manager or desingee, a written report (in a form acceptable to the City) with the following information: (a) a detailed description of the damage (including the name and address of the injured or deceased person(s), and a description of the damaged property), (b) name and address of witnesses, and (c) name and address of any potential insurance companies.</u>

- 8. <u>INDEMNIFICATION</u>. Homeowner shall indemnify, hold harmless, and defend (with counsel reasonably acceptable to the City) the City and its elected officials, officers, agents and employees from and against any and all claims (including all litigation, demands, damages, liabilities, costs, and expenses, and including court costs and attorneys' fees) resulting or arising from performance, or failure to perform, under this Agreement (with the exception of the gross negligence or willful misconduct of the City).
- **9. <u>TIME OF PERFORMANCE</u>**. Time is of the essence in the performance of the Work, and the timing requirements set forth herein shall be strictly adhered to unless otherwise modified in writing in accordance with this Agreement. The Homeowner shall submit all requests for extensions of time to the City, in writing, no later than ten (10) days after the start of the condition which purportedly caused the delay, and not later than the date on which performance is due.

**9(a).** <u>Commencement of Work</u>. No later than fifteen (15) days prior to the commencement of Work, the Homeowner shall provide written notice to the City Engineer of the date on which the Homeowner shall commence Work. The Homeowner shall not commence Work until after the notice required by this section is properly provided, and the Homeowner shall not commence Work prior to the date specified in the written notice.

**9(b).** <u>Schedule of Work</u>. Concurrently with the written notice of commencement of Work, the Homeowner shall provide the City with a written schedule of Work, which shall be updated in writing as necessary to accurately reflect the Homeowner's prosecution of the Work.

**9(c).** <u>Completion of Work</u>. The Homeowner shall complete all Work by no later than three hundred sixty-five (365) days after the City's execution of this Agreement.

- 10. <u>INSPECTION BY THE CITY</u>. In order to permit the City to inspect the Work, the Homeowner shall, at all times, provide to the City proper and safe access to the Project site, and all portions of the Work, and to all shops wherein portions of the Work are in preparation. Homeowner shall reimburse the City for the costs of the City Engineer's inspections of the Work, as required by Los Altos Municipal Code Section 13.20.190.
- 11. **DEFAULT.** If either party ("demanding party") has a good faith belief that the other party ("defaulting party") is not complying with the terms of this Agreement, the demanding party shall give written notice of the default (with reasonable specificity) to the defaulting party, and demand the default to be cured within ten days of the notice. If: (a) the defaulting party fails to cure the default within ten (10) days of the notice, or, (b) if more than ten (10) days are reasonably required to cure the default and the defaulting party fails to give adequate written assurance of due performance within ten (10) days of the notice, then (c) the demanding party may terminate this Agreement upon written notice to the defaulting party.

**11(a).** The Homeowner shall be in default of this Agreement if the City Engineer determines that any one of the following conditions exist:

**11(a)(1).** The Homeowner is insolvent, bankrupt, or makes a general assignment for the benefit of its creditors.

11(a)(2). The Homeowner abandons the Project site.

11(a)(3). The Homeowner fails to perform one or more requirements of this Agreement.

11(a)(4). The Homeowner fails to replace or repair any damage caused by Homeowner or its agents, representatives, contractors, subcontractors, or employees in connection with performance of the Work.

- 11(a)(5). The Homeowner violates any legal requirement related to the Work.
- **11(b).** In the event that the Homeowner fails to cure the default, the City may, in the discretion of the City Engineer, take any or all of the following actions:

11(b)(1). Cure the default and charge the Homeowner for the costs therefore, including administrative costs and interest in an amount equal to seven percent (7%) per annum from the date of default.

**11(b)(2).** Demand the Homeowner to complete performance of the Work.

11(b)(3). Demand the Homeowner's surety (if any) to complete performance of the Work.

- 12. <u>ACCEPTANCE OF WORK</u>. Prior to acceptance of the Work by the City Engineer, the Homeowner shall be solely responsible for maintaining the quality of the Work, and maintaining safety at the Project site. Neither the final certificate of payment, nor any provision in this Agreement, nor partial or entire use or occupancy of the improvements by the City shall constitute an acceptance of the Work not done in accordance with this Agreement or relieve Homeowner of liability pursuant to Section 13, below. The Homeowner's obligation to perform the Work shall not be satisfied until after the City Engineer has made a written determination that all obligations of the Agreement have been satisfied and all outstanding fees and charges have been paid, the City Engineer has accepted the Work as complete, and the City Council has authorized the release of the security for faithful performance as described in Government Code Section 66499.7.
- 13. <u>WARRANTY PERIOD</u>. The Homeowner shall warrant the quality of the Work, in accordance with the terms of the Plans and Specifications, for a period of one year after acceptance of the Work by the City. In the event that (during the one year warranty period) any portion of the Work is determined by the City Engineer to be defective as a result of an obligation of the Homeowner under this Agreement, the Homeowner shall be in default.
- 14. **RELATIONSHIP BETWEEN THE PARTIES.** Homeowner is, and at all times shall remain, an independent contractor solely responsible for all acts of its employees, agents, contractors, or subcontractors, including any negligent acts or omissions. Homeowner is not City's agent, and shall have no authority to act on behalf of the City, or to bind the City to any obligation whatsoever, unless the City provides prior written authorization to Homeowner.
- **15.** <u>**CONFLICTS OF INTEREST PROHIBITED.</u>** Homeowner (including its employees, agents, contractors, and subcontractors) shall not maintain or acquire any direct or indirect interest that conflicts with the performance of this Agreement. If Homeowner maintains or acquires a conflicting interest, any contract with the City (including this Agreement) involving Homeowner's conflicting interest may be terminated by the City.</u>
- 16. <u>NONDISCRIMINATION</u>. Homeowner shall comply with all applicable federal, state, and local laws regarding nondiscriminatory employment practices, whether or not said laws are expressly stated in this Agreement. Homeowner shall not discriminate against any employee or applicant because of race, color, ancestry, ethnicity, religious creed, national origin, physical disability, mental disability, medical condition, marital or family status, sexual orientation, gender or gender identification, age (over 40), veteran status, or sex.
- 17. <u>NOTICES</u>. All notices required or contemplated by this Agreement shall be in writing and shall be delivered to the respective party as set forth in this section. Communications shall be deemed to be effective upon the first to occur of: (a) actual receipt (or refusal) by a party, or (b) actual receipt (or

refusal) at the address designated below, or (c) three (3) working days following deposit in the United States Mail of registered or certified mail sent to the address designated below. Either party may modify their respective contact information identified in this section by providing notice to the other party.

- **18.** <u>**HEADINGS.**</u> The heading titles for each paragraph of this Agreement are included only as a guide to the contents and are not to be considered as controlling, enlarging, or restricting the interpretation of the Agreement.
- **19. SEVERABILITY.** If any term of this Agreement (including any phrase, provision, covenant, or condition) is held by a court of competent jurisdiction to be invalid or unenforceable, the Agreement shall be construed as not containing that term, and the remainder of this Agreement shall remain in full force and effect; provided, however, this paragraph shall not be applied to the extent that it would result in a frustration of the parties' intent under this Agreement.
- **20.** <u>**GOVERNING LAW, JURISDICTION, AND VENUE.**</u> The interpretation, validity, and enforcement of this Agreement shall be governed by and interpreted in accordance with the laws of the State of California. Any suit, claim, or legal proceeding of any kind related to this Agreement shall be filed and heard in a court of competent jurisdiction in the County of Santa Clara.
- 21. <u>ATTORNEYS' FEES</u>. In the event any legal action is commenced to enforce this Agreement, the prevailing party is entitled to reasonable attorney's fees, costs, and expenses incurred.
- 22. <u>ASSIGNMENT AND DELEGATION</u>. This Agreement, and any portion thereof, shall not be assigned or transferred, nor shall any of the Homeowner's duties be delegated, without the written consent of the City. Any attempt to assign or delegate this Agreement without the written consent of the City shall be void and of no force or effect. A consent by the City to one assignment shall not be deemed to be a consent to any subsequent assignment.
- 23. <u>MODIFICATIONS</u>. This Agreement may not be modified orally or in any manner other than by an agreement in writing signed by both parties.
- 24. <u>WAIVERS</u>. Waiver of a breach or default under this Agreement shall not constitute a continuing waiver or a waiver of a subsequent breach of the same or any other provision of this Agreement.

- 25. <u>CONFLICTS</u>. If any conflicts arise between the terms and conditions of this Agreement and the terms and conditions of the attached exhibits or any documents expressly incorporated, the terms and conditions of this Agreement shall control.
- 26. <u>ENTIRE AGREEMENT</u>. This Agreement, including all documents incorporated herein by reference, comprises the entire integrated understanding between the parties concerning the Work described herein. This Agreement supersedes all prior negotiations, agreements, and understandings regarding this matter, whether written or oral. The documents incorporated by reference into this Agreement are complementary; what is called for in one is binding as if called for in all.
- 27. <u>COVENANT RUNNING WITH THE LAND</u>. This Agreement is entered into as a condition of the Tentative Map, is an instrument affecting the title or possession of the real property, and is intended to run with the land. All the terms, covenants and conditions herein imposed shall be binding upon and inure to the benefit of City, Homeowner, the successors in interest of Homeowner, their respective successors and permitted assigns, and all subsequent owners of a fee interest in the Property or of a beneficial interest substantially equivalent to a fee interest. The obligations of the Homeowner under this Agreement shall be the joint and several obligations of each and all of the parties comprising Homeowner, if Homeowner consists of more than one individual and/or entity. Upon the sale or division of the Property, the terms of this Agreement shall apply separately to each parcel and the fee owners of each parcel shall succeed to the obligations imposed on Homeowner by this Agreement.
- **28.** <u>**MISCELLANEOUS.</u>** This Agreement may be executed in counterparts, each of which shall be deemed an original. There are no third-party intended beneficiaries of this Agreement. This Agreement represents the contributions of both parties, each of whom has had the opportunity to be represented by competent counsel, and the rule stated in Civil Code Section 1654 that ambiguities in a contract be construed against the drafter shall have no application hereto.</u>
- **29.** <u>SIGNATURES</u>. The individuals executing this Agreement represent and warrant that they have the right, power, legal capacity, and authority to enter into and to execute this Agreement on behalf of the respective legal entities of the Homeowner and the City. This Agreement shall inure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.

#### EXHIBIT B

#### **CONDITIONS OF APPORVAL**

#### GENERAL

#### 1. Approved Plans

Project approval is based upon the tentative map submitted on December 22, 2022, except as may be modified by these conditions.

#### 2. Public Utilities

The property owner shall be responsible for contacting all public utilities including but not limited to electric, gas, communication and water utilities regarding the installation of new utility services to the site and ensuring all required utility connections are provided.

#### 3. Protected Trees

All existing trees on the site subject to Tree Protection Regulations (Chapter 11.08) of the Municipal Code shall not be removed unless approved by the City during any subsequent development review or tree removal permit application.

#### 4. Encroachment Permit

An encroachment permit, and/or an excavation permit shall be obtained prior to any work done within the public right-of-way and it shall be in accordance with plans to be approved by the City Engineer.

#### 5. Stormwater Management Plan

The project shall comply with the City of Los Altos Municipal Regional Stormwater (MRP) NPDES Permit No. CA S612008, Order No. R2-2015-0049 dated November 19, 2015.

#### 6. Americans with Disabilities Act

All improvements shall comply with Americans with Disabilities Act (ADA) and all regulations and design guidelines adopted pursuant to the ADA or any other state or federal disability access law. The latest edition of Caltrans ADA requirements shall apply to all improvements in the public right-of-way.

#### 7. Sewer Lateral

Any proposed sewer lateral connection shall be approved by the City Engineer. Only one sewer lateral per lot shall be installed. All existing unused sewer laterals shall be abandoned according to the City Standards, cut and cap 12" away from the main.

#### 8. Transportation Permit

A Transportation Permit, per the requirements specified in California Vehicle Code Division 15, is required before any large equipment, materials or soil is transported or hauled to or from the construction site. Applicant shall pay the applicable fees before the transportation permit can be issued by the Traffic Engineer.

#### 9. Pollution Prevention

The improvement plans shall include the "Blueprint for a Clean Bay" plan sheet in all plan submittals.

#### 10. Civil Engineering Drawings

The property owner shall submit civil engineering drawings that show property lines with bearing and easements.

#### 11. Indemnity and Hold Harmless

The applicant/owner agrees to indemnify, defend, protect, and hold the City harmless from all costs and expenses, including attorney's fees, incurred by the City or held to be the liability of the City in connection with the City's defense of its actions in any judicial or administrative proceedings, challenging any of the City's action with respect to the applicant's project. The City may withhold final maps and/or permits, including temporary or final occupancy permits, for failure to pay all costs and expenses, including attorney's fees, incurred by the City in connection with the City's defense of its actions.

#### PRIOR TO MAP RECORDATION

#### Demolition

The property owner shall obtain and final a demolition permit from the Building Division to remove all existing structures on the property or relocate the structures to meet all required R1-10 zoning district development standards including but not limited to setbacks, lot coverage, and floor area.

#### 13. Payment of Fees

The property owner shall pay all applicable fees, including but not limited to sanitary sewer impact fees, parkland dedication in-lieu fees, traffic impact fees and map check fee plus deposit as required by the City of Los Altos Municipal Code.

#### 14. Easement Dedication

The property owner shall dedicate public utility casements as required by the utility companies to serve both parcels.

#### 15. Right-of-Way Dedication

The property owner or applicant shall dedicate a 25-foot public right-of-way along Springer Road to the City of Los Altos for use as public right-of-way. In addition, a 25-foot radius of the intersection of Springer Road and Vista Grande Avenue shall be provided.

#### 16. Subdivision Agreement

The property owner shall sign and return Subdivision Improvement Agreement to the city for recordation. The Subdivision Improvement Agreement sets forth the property owner's obligation to construct public improvements required as part of the project.

#### 17. Storm Water Filtration Systems

The Applicant shall insure the design of all storm water treatment systems and devices are without standing water to avoid mosquito/insect infestation.

#### 18. Utility Plan

The applicant shall submit a utility plan which includes the location of the sanitary sewer laterals for each lot.

#### 19. Rolled Curb

The applicant shall extend City Standard rolled curb at Vista Grande frontage to the intersection of Springer Road and Vista Grande Ave.

#### 20. Public Infrastructure Repairs

The Applicant shall repair any damaged rolled curb and replaced as directed by the City Engineer or his designee.

### 21. Maintenance Bond

A one-year, ten-percent maintenance bond shall be submitted upon acceptance of improvements in the public right-of-way.

### 22. Cost Estimate and Performance Bonds

The applicant shall submit a cost estimate for the improvements in the public right-of-way and shall submit a 100 percent performance bond or cash deposit (to be held until acceptance of improvements) and a 50 percent labor and material bond (to be held 6 months after acceptance of improvements) for the work in the public right-of-way.

### PRIOR TO ISSUANCE OF A BUILDING PERMIT

### 23. Map Recordation

The applicant shall record the final map. Plats and legal descriptions of the final map shall be submitted for review by the City Land Surveyor. Applicant shall provide a sufficient fee retainer to cover the cost of the map review by the City.

### 24. Construction Management Plan

The Applicant shall submit a construction management plan for review and approval by the Community Development Director and the City Engineer. The construction management plan shall address any construction activities affecting the public right-of-way, including but not limited to excavation, traffic control, truck routing, pedestrian protection, material storage, earth retention and construction vehicle parking. The plan shall provide specific details with regards to how construction vehicle parking will be managed to minimize impacts on nearby single-family neighborhoods.

### 25. Storm Water Filtration Systems

The Applicant shall insure the design of all storm water treatment systems and devices are without standing water to avoid mosquito/insect infestation.

### 26. Grading and Drainage Plan

The Applicant shall submit on-site grading and drainage plans that include (i.e. drain swale, drain inlets, rough pad elevations, building envelopes, drip lines of major trees, elevations at property lines, all trees and screening to be saved) for approval by City Engineer. No grading or building pads are allowed within two-thirds of the drip line of trees unless authorized by a certified arborist and the Planning Department.

### 27. Stormwater Pollution Prevention

The project shall comply with the Stormwater Pollution Prevention Measures per Chapter 10.16 of the Los Altos Municipal Code.

### EXHIBIT C

### **INSURANCE REQUIREMENTS**

Homeowner's performance of Work under this agreement shall not commence until Homeowner shall have obtained all insurance required under this Exhibit and such insurance shall have been reviewed and approved by the Risk Manager. All requirements herein provided shall appear either in the body of the insurance policies or as endorsements and shall specifically bind the insurance carrier.

Homeowner shall procure and maintain for the duration of the contract all necessary insurance against claims now and in the future for alleged injuries to persons or damages to property which may arise from or in connection with the performance of the Work by the Homeowner, the Contractor it's agents, representatives, employees and contractors.

### INSURANCE COVERAGE AND LIMITS RESTRICTIONS

- 1. It shall be a requirement under this agreement that any available insurance proceeds broader than or in excess of the specified minimum insurance coverage requirements and/or limits shall be available to the additional insured. Furthermore, the requirements for coverage and limits shall be (1) the minimum coverage and limits specified in this agreement; or (2) the broader coverage and maximum limits of coverage of any insurance policy or proceeds available to the named insured; whichever is greater.
- 2. The limits of insurance required in this agreement may be satisfied by a combination of primary and umbrella or excess insurance. Any umbrella or excess insurance shall contain or be endorsed to contain a provision that such coverage shall also apply on a primary and non-contributory basis for the benefit of the City before the City's own insurance or self-insurance shall be called upon to protect it as a named insured.

### A. MINIMUM SCOPE OF INSURANCE

Coverage shall be at least as broad as:

- 1. Insurance Services Office Commercial General Liability coverage:
  - a. Blanket contractual liability
    - b. Broad form property coverage
    - c. Personal injury
- 2. Insurance Services Office form covering Automobile Liability, code 1 (any auto).
- **3.** Workers' Compensation insurance as required by the State of California and Employer's Liability insurance.
- 4. Such other insurance coverages and limits as may be required by the City.

### **B. MINIMUM LIMITS OF INSURANCE**

Homeowner shall maintain limits no less than:

- 1. General Liability: \$1,000,000 per occurrence for bodily injury, personal injury and property damage and a \$2,000,000 aggregate. If Commercial General Liability insurance or other form with a general aggregate liability is used, either the general aggregate limit shall apply separately to this agreement or the general aggregate limit shall be twice the required occurrence limit.
- 2. Automobile Liability: \$1,000,000 per accident for bodily injury and property damage.
- **3.** Employer's Liability:

Bodily Injury by Accident - \$1,000,000 each accident. Bodily Injury by Disease - \$1,000,000 policy limit. Bodily Injury by Disease - \$1,000,000 each employee.

4. Such other insurance coverages and limits as may be required by the City of.

### C. DEDUCTIBLES AND SELF-INSURED RETENTIONS

- 1. Any deductibles or self-insured retentions must be declared to and approved by the City of. At the option of the City, either: the insurer shall reduce or eliminate such deductibles or self-insured retentions as respects the City of \*\*CITY\*\*, its officers, officials, employees, and volunteers; or the Homeowner shall procure a bond guaranteeing payment of losses and related investigations, claims administration and defense expenses.
- 2. Policies containing any self-insured retention (SIR) provision shall provide or be endorsed to provide that the SIR may be satisfied by either the named insured or the City.
- **3.** The City reserves the right to obtain a full certified copy of any insurance policy and endorsement. Failure to exercise this right shall not constitute a waiver of the right to exercise later.

### **D. ADDITIONAL INSURED REQUIREMENTS:**

The required general liability and automobile policies are to contain, or be endorsed to contain the following provisions:

- a. The City, its officers, officials, employees, agents, and volunteers are to be covered as additional insureds as respects alleged: liability arising out of activities performed by or on behalf of the Homeowner; products and completed operations of the Homeowner; premises owned, occupied or used by the Homeowner; or automobiles owned, leased, hired or borrowed by the Homeowner. The coverage shall contain no special limitations on the scope of protection afforded to the City, its officers, officials, employees, agents or volunteers.
- b. Any failure to comply with reporting or other provisions of the policies including breaches of warranties shall not affect coverage provided to the City, its officers, officials, employees, agents or volunteers.
- c. The Homeowner's insurance shall apply separately to each insured against whom a claim is made or suit is brought except, with respect to the limits of the insurer's liability.
- d. Homeowner shall furnish properly executed Certificates of Insurance from insurance companies acceptable to the City and signed copies of the specified endorsements for each policy prior to commencement of work under this agreement. Such documentation shall clearly evidence all coverages required above including specific evidence of separate endorsements naming the City and shall provide that such insurance shall not be materially changed, terminated or allowed to expire except after 30 days prior written notice by certified mail, return receipt requested, has been filed with the City Clerk.

Such insurance shall be maintained from the time work first commences until completion of the work under this agreement. Homeowner shall replace such certificates for policies expiring prior to completion of work under this agreement.

### **E. ACCEPTABILITY OF INSURERS**

Insurance is to be placed with insurers with a current A.M. Best's rating of no less than A: VII.

### F. COMPLETED OPERATIONS

Homeowner shall maintain insurance as required by this contract to the fullest amount allowed by law and shall maintain insurance for a minimum of five years following the completion of this project. In the event the Homeowner fails to obtain or maintain completed operations coverage as required by

this agreement, the City at its sole discretion may purchase the coverage required and the cost will be paid by the Homeowner.

### G. CROSS-LIABILITY

The Liability policy shall include a cross-liability or severability of interest endorsement.

### H. FAILURE TO MAINTAIN INSURANCE COVERAGE

If Homeowner, for any reason, fails to maintain insurance coverage, which is required pursuant to this Agreement, the same shall be deemed a material breach of contract. The City, at its sole option, may terminate this agreement and obtain damages from the Homeowner resulting from said breach. Alternatively, the City may purchase such required insurance coverage, and Homeowner shall reimburse the City for any premium costs advanced by the City for such insurance.

### I. PRIMARY AND NON-CONTRIBUTORY

For any claims related to this project, the Homeowner's insurance coverage shall be primary insurance as respects the City, its officers, officials, employees, agents and volunteers. Any insurance or selfinsurance maintained by the City, its officers, officials, employees, agents or volunteers shall be in excess of the Homeowner's insurance and shall not contribute with it.

The additional insured coverage under the Homeowner's policy shall be primary and noncontributory" and will not seek contribution from the City's insurance or self-insurance and shall be at least as broad as CG 20 01 04 13.

### J. SUBCONTRACTORS

Homeowner shall require its contractors to maintain the same levels of insurance and provide the same indemnity that the Homeowner is required to provide under this Agreement. A contractor is anyone who is under contract with the Homeowner or any of its contractors to perform work contemplated by this Agreement. The Homeowner shall require all contractors to provide evidence of valid insurance and the required endorsements prior to the commencement of any work.

#### **K. SUBROGATION WAIVER**

Homeowner agrees to waive subrogation rights against City regardless of the applicability of any insurance proceeds, and to require all Contractors, subcontractors or others involved in any way with the services to do likewise.

### L. VERIFICATION OF COVERAGE

Homeowner shall furnish the City with original endorsements effecting coverage required by this clause. The endorsements are to be signed by a person authorized by that insurer to bind coverage on its behalf. All endorsements are to be received and approved by the City before the services commence.

### SUMMARY

- The City sponsors certain special events as outlined in 2015-23.
- The City Council has directed staff to bring special event sponsorship for discussion

### BACKGROUND

The City Council adopted Los Altos Municipal Code 9.25 "Special Events" in March 2007 that governs special events. In October 2023, the City Council adopted changes to this code section that simplified a confusing code section, retained control over more events on public property, and simplified the special event and block party process.

In 2024, the City received, reviewed, and approved various special event applications. These special event applications vary from one-time events to the weekend-long Art and Wine Festival to the weekly Farmers Market in downtown. They also vary in attendance from large events such as the weekend-long Fine Art in the Park to the multi-minute (depending upon the speed of Los Altos children in any given year) Spring Egg Hunt.

### **DISCUSSION/ANALYSIS**

The U.S. Supreme Court recently decided that the city of Boston's flag raising policy was in violation of an applicant's First Amendment right to free speech due to insufficient guidance in the policy regarding selection of flags that the city would allow to be flown from city-owned flagpoles. The flying of flags on City-own flagpoles is analogous to the City allowing certain special events to be held on City-owned property. There are two options under consideration for the City.

The first option is to review and revise the City's Special Event Resolution No. 2015-23 to expressly adopt certain special events as government speech (City speech). Typically, when a government entity opens its property for expressive activities by members of the public, it creates a public forum. In other words, if one person can use the property to exercise his or her right to free speech, then everyone else must be accorded the same right. Content based restrictions on speech are impermissible unless policies are first established that are reasonable considering the purpose served by the forum. However, in *Pleasant Grove City v. Summum* (2008) 555 U.S. 460, the United States Supreme Court held that this rule does not apply to expressive activity that a government agency adopts as its own speech. Just like private parties, a government agency has a right to use its own property to convey its values, and in doing so the agency does not open its property as a public forum. Thus, the City Council should not authorize certain special events unless the Council is prepared to adopt the event's message as government speech (City speech).

All recommendations provided by the City Council will be returned at another meeting with a resolution determining that those City-sponsored events qualify as government speech and provide the sponsorship level prescribed by the City Council.

The second option is to prohibit the use of City-owned property and/or any sponsored special events.

The list of continuing special events that occurred in 2024, and scheduled to continue in 2025, are:

Prior to a special event, City staff gathers a cost estimate for the cost of City services provided for the event, which is discussed during a pre-event meeting and provided to the event organizer in advance of the event. After the event concludes, City staff will put together the cost recap that will calculate the final cost of City services provided for the event and is sent to the event organizer for payment.

The chart above illustrates the relative City cost for special events with one dollar sign being on the lower end for most events that only require an application fee and five dollar signs being the more expensive special events that require larger street closures to operate from the City perspective. The biggest cost is shutting down the street for a special event as that has historically been completed by our Police Department on a minimum overtime or call-out basis. Moving forward, that may be adjusted as we have a third-party operator who can shut down the street at a lower cost than our sworn Police officers, but it will still be an expense for the special event organizer.

The City Council determines what special events qualify as full-sponsored or half-sponsored events that will not be required to pay a portion or all of their cost for City services. There are two tiers for sponsorship. Full-sponsorship means the City bears the full cost of City services. Half-sponsorship means that the City bears half the cost of City services and invoices the organization afterward for their half the cost of City services.

Historically, these events have been identified by a resolution of the City Council and was last updated on June 9, 2015 to adjust per Council direction.

### **DISCUSSION/ANALYSIS**

The City Council can alter this list of City-sponsored special events listed in the City's Special Event Resolution No. 2015-23 by adding or removing any special events they would like to sponsor as City-sponsored events. All recommendations provided by the City Council will be returned at another meeting with a resolution determining that those City-sponsored events qualify as government speech and provide the sponsorship level prescribed by the City Council. The amount of sponsorship does not affect whether the event is government speech.

The City Council should adopt a policy to provide clear guidance for additional and/or future special events on City-owned property. This policy, like the flag flying policy and its application process, allows City Council to review special event requests and approve them on a case-by-case basis. When a special event is approved, the City Council would be required to adopt the particular event as government speech. Public agencies have the right to free speech on their own property, which means the City Council can convey any event, message, or symbol as their own speech on their own property without opening it into a public forum.

Attached to this agenda report is a draft special event policy that outlines this process moving forward.

### EXHIBIT 1 LOS ALTOS SPECIAL EVENT SPONSORSHIP POLICY

City Council has the authority to review special event sponsorship requests and approve them on a case-by-case basis. When a special event sponsorship request is approved, the City Council would be required to adopt the particular event as government speech. Public agencies have the right to free speech on their own property, which means the City Council can convey any event, message, or symbol as their own speech on their own property without opening it into a public forum. Such authorization by the City Council shall take the form of a resolution, which shall include the following information:

- (1) The date or dates on which the event will take place;
- (2) A finding that the special event constitutes government speech in that the particular message conveyed by the special event is a message that the City Council wishes to express on behalf of the residents of the City;
- (3) A statement describing the particular message conveyed by the special event and expressing the reason or reasons the City Council wishes to express that message on behalf of the residents of the City; and
- (4) A statement that the resolution is adopted pursuant to this policy and a statement of reasons why the adoption of the resolution is consistent with this policy.

Under no circumstances shall the City Council authorize the sponsorship of a special event that:

- (1) Represents a group, organization, or movement that advocates the unlawful overthrow of the state or federal government;
- (2) Commemorates a rebellion against the federal government by the government of any state;
- (3) Advocates discrimination or intolerance against individuals on the basis of any classification specified in Civil Code Section 51;
- (4) Endorses or expresses a preference for any religious sect;
- (5) Advocates for or against a candidate for public office, a political party, or a ballot measure or proposition;
- (6) Is considered highly offensive to persons of average sensitivity within the community; or
- (7) Poses a real and substantial threat to public safety based on objective circumstances or criteria.

The City Council may consider authorizing the sponsorship of a special event pursuant to this policy referral of the entire Council on motion of any Councilmember made during the time reserved at regular City Council meetings for discussion of future agenda items, or at the recommendation of a commission of the City. The City Council may also consider authorizing the sponsorship of a special event on application of a resident or community group, as long as they shall complete a Special Event Sponsorship Application Packet, on a form to be created by the City Manager or designee. City staff shall provide a recommendation to City Council for every application on whether the proposed special event meets the above criteria listed 1 through 7 for a special event sponsorship, which will allow City Council to make the final determination on the application.

This policy is intended for the City's sole benefit, and nothing herein is intended to confer any legal right or privilege on any member of the public.

City of Los Altos requires all non-profit organizations or Los Altos residents interested in having the City of Los Altos sponsor a special event to meet all the below guidelines and submit a completed application packet.

- 1. Applicant Guidelines
  - a. Only special events that are consistent with the City's vision, mission, and ongoing strategic priorities, incorporating themes of diversity, equity, social justice and inclusion.
  - b. At no time will the City of Los Altos sponsor special events that pose a danger to public health or public safety, are deemed to be inappropriate or offensive in nature, support discrimination, prejudice or religious or political movements
  - c. All special events will be sponsored in accordance with all applicable laws.
- 2. Application Procedure
  - a. Applicant will complete the Special Event Sponsorship Application Form and required documentation.
- 3. Review and Approval Process
  - a. Applications will be reviewed by City staff for completeness.
  - b. Approval of the special event sponsorship is at the discretion of the City Council.
- 4. Fee Guidelines
  - a. Applicants may be required to pay any additional costs that were incurred beyond the authorized special event costs by City Council.

### BACKGROUND

Stormwater Assessment Districts allow communities to focus on the specific improvements that directly benefit the properties within a local watershed. This targeted approach ensures that resources are allocated efficiently, fairly and exactly where needed. An assessment district is a funding mechanism available to property owners who request stormwater improvements.

NBS Government Finance Group (NBS) prepared educational materials regarding the benefits of an assessment district, the process to establish a stormwater assessment district, and the forms associated with this process. Please refer to Attachment 1, 2, and 3, which have been posted to the City's website.

### ANALYSIS

The process to form a Stormwater Assessment District is a collaborative effort between the City and the property owners. It is a resident-initiated process, with the City providing support. Property owners are responsible for communicating with neighbors and generating support for the proposed assessment within the affected area.

The process consists of the following steps:

- 1. Determine the community team spokesperson. The project will require leadership among the residents to provide effective communication and coordination. A community team spokesperson needs to be established in order to provide the City with a primary point of contact. The spokesperson will initially be responsible for defining the problem, evaluating the affected properties, and testing local support of the directly affected properties.
- 2. Submitting the application to the City. The spokesperson will prepare a Stormwater Assessment District formation application with the information from Step 1 and submit to the City.
- 3. Confirm community support. The spokesperson will distribute a second survey reflecting any changes and the additional information produced in the City review.
- 4. Formal petition. The City will mail a formal petition to all property owners within the district boundary to confirm support of the preliminary project, cost estimate and proposed assessments. The petition will include the options and/or estimated costs for long-term financing of the proposed assessments.
- 5. Formation proceedings. The City Council will approve the Engineer's Report in a public hearing, initiate the formation by mailing a notice of the public hearing and a ballot to each property owner within the district conduct the public hearing and tabulate the ballots.
- 6. Forms and establish district. If the property owners and the City Council approve the assessment, the City Council will by resolution order the formation and establishment of the assessment district. The assessment will become payable via a short-term cash collection period or may quality for long-term financing.
- 7. Assessment financing. The assessments may be appropriate for long-term financing. This may take the form of public debt (municipal bonds) or some other form of loan.

### DISCUSSION

Following the unsuccessful stormwater funding ballot measures in 2019, the City has received numerous drainage complaints, particularly after major storm events. Staff inspections have determined that many of these issues would require infrastructure or Low Impact Development (LID) projects, which often benefit only a small number of residents. As a result, funding such projects through the City's general stormwater budget would not be an equitable use of resources.

A Stormwater Assessment District provides a fair solution by allocating costs directly to the properties that benefit from improvements. This approach ensures that resources are used efficiently and prevents individual property owners from bearing the full financial burden of necessary drainage projects.





project will require leadership among the residents to provide effective communication and coordination. A community team spokesperson needs to be established in order to provide the City with a primary point of contact. This person will help to:

Define the problem

Confirm community support. The spokesperson will



distribute a second Survey (Survey2) reflecting any changes/ additional information produced in the City review. The changes may include the addition or deletion of property to the boundary, the proposed construction project, and the associated estimated project and

If < 70% of the properties support the proposed assessment, the spokesperson will provide the completed surveys to the City. The City will then mail a formal formation petition (Step 4) to the property owners to validate continuing the expenditure of funds and to pursue formation.

If > 70% of the property owners support the assessment, local community meetings may be required.



Formation Proceedings. The City Council will conduct the following proceedings.

Approve Engineer's Report: In a public meeting the City Council will receive and approve the Assessment Engineer's Report by resolution. This report contains the final project cost estimate together with the proposed assessment on each parcel. Property owners will have the opportunity to comment on the agenda item approving the report.

Initiate Formation: If the Assessment Engineer's Report is approved by the City Council, the City Council may then order by resolution a public hearing and prescribe the balloting process according to Prop. 218 and other applicable law.

Mailing of Notice of Public Hearing and Ballot: As required by Proposition 218, City Council will direct that all property owners who are subject to proposed assessments will be mailed a Notice of Public Hearing with an assessment ballot.

Public Hearing: A public hearing will be held at least 45 days after the mailing of the Notice of Public Hearing and Ballot.

The public hearing will give property owners the opportunity to publicly support or oppose the assessment. All ballots must be submitted by the conclusion of the public hearing in order to be counted.

Ballot Tabulation: The mailed ballots allow all affected property owners to express their support for, or opposition to, the proposed assessment. The ballots will be weighted based on the assessment amount proposed to be paid by each property. If a weighted majority of the assessment ballots cast are in favor of the assessment, the City Council may proceed with formation of the assessment district. If a weighted majority of the ballots cast are in opposition to the assessment, then the assessment district must be abandoned.

Submit the Application to the City. The spokesperson

will prepare a Stormwater Assessment District formation application with the information from Step 1 and submit it to the Public Works Department.

The City will review the application and meet with the spokesperson to:

- Confirm that the project is appropriate for Stormwater Assessment District funding.
- Confirm that the included properties establish an appropriate preliminary boundary of all parcels affected by the problem.
- Discuss potential solutions to the problem, including conceptual project designs and preliminary project cost estimates.
- Discuss potential/preliminary individual property owner costs.

Formal Petition. The City will mail a formal petition to all property owners within the district boundary to confirm support of the preliminary project, cost estimate and proposed assessments. The petition will include the options and/or estimated costs for long-term

financing of the proposed assessments. If the formal petition receives 70% support of all the affected parcels, City Staff

will prepare a formation proposal to be submitted to the City Council. City Council may authorize the expenditure of funds to:

- . Prepare formal project construction engineering design documents suitable for construction bidding.
- Retain legal counsel for the assessment district establishment.
- Retain bond counsel if debt is proposed to be issued to finance the project.
- Prepare project environmental reviews as required.
- Retain an assessment engineer to confirm the district boundary and to prepare the comprehensive Engineer's Report calculating the actual proposed assessments for each parcel based on the latest cost estimates and the estimated special benefit to each parcel.

If less than 70% of the property owners support the assessment, additional local community meetings may be required. The City may provide staff support to answer community questions as appropriate. Project redesign to reduce improvements and associated costs may be pursued.



Formation. If the property owners and the City Council approve the assessment, the City Council will by resolution order the formation and establishment of the assessment district. The assessment will become payable via a short-term cash collection

period or may qualify for long term financing.

#### Long Term Assessment Financing. The assessments may be appropriate for long-term financing. This may take the form

of public debt (municipal bonds) or some other form of loan. The long-term funding options and preliminary disclosures will be addressed at the formal petition stage and throughout the proceedings. The financing options vary greatly from project to project and it is impractical to attempt to address which option will be preferred for any particular project.
