Virtual Homework Help Available

Students are invited to join SCCLD's online tutoring pods. Free online homework help will be offered for students in grades 1-12 through May 26th via Zoom. This service aligns to Common Core math and ELA and provides personalized social emotional growth activities and learning support.

Sessions for students in grades 1-6 will be available Mondays and Wednesdays from 3:30pm-5pm. Sessions for students in grades 7-12 are available Tuesdays and Thursdays from 3:30pm-5pm. Tutors are provided by the Bay Area Tutoring Association and the coach to student ratio is a maximum of 1:8. Students will be organized by grade level within each session. Up to 50 students can attend each session and waitlists will be available. This service is offered to residents of Campbell, Cupertino, Gilroy, Los Altos, Los Altos Hills, Milpitas, Monte Sereno, Morgan Hill, Saratoga, and the unincorporated areas of Santa Clara County.

Why are the Friends of the Library moving?

The City of Los Altos is looking to update the civic center

FOL are already working in the Library; consolidating from the portables to one location will streamline workflow

It will free up premium space in the library for community use by relocating their current workspace by the City Hall entrance to the new location

Why was this location selected?

Moves the current setup from premium space close to exit/entrance to another part of the library

Out of the way, mainly used for collection storage

Next to an emergency exit point, minimize disruption to library users for FOL to use for their operations



What's changing?

Opening space by the city hall entrance for high demand collections and more seating

Update our current collection and space to reflect usage trends

Room structure will be built to house the FOL operations, with shelving along the outside walls

Installing quiet study/work pods of various sizes for group work, meetings and tutoring

3-3-2022 Report of the Infrastructure Subcommittee

1. Nelvin to report on progress with foldable door panel vendors for dividing Orchard Room. REPORT: Nelvin has met with the exclusive distributors of the three top manufacturers of foldable partitions.

The partition manufacturers are Modern Fold, Modernco, and HufCor.

Two of the distributors (Modern Fold and Modernco) provided a great deal of detail regarding what would be required to prepare the Orchard Room for the installation of foldable partitions.

Nelvin, Freddie, and Bryant met with Ken Dellinger, the distributor for Modern Fold at the Orchard Room on Feb 18. Mr. Dellinger installed foldable partitions at the Morgan Hill Library so the SCCLD has experience working with him and he understands working with the District. Mr. Dellinger offered to provide us with drawings which will help progress the project and assist in our meeting with the Fire Marshall.

2. Carolle to report on her son's other ways of dividing the Orchard Room. Please see attached pdf from Craig showing other ways.

REPORT: Drawing provided by Carolle's son which shows how the Orchard Room could be divided if something other than a 50:50 divide was selected.

- 3. Freddie has reached out to Fire Marshall to arrange meeting at Orchard Room.

 REPORT: The Fire Department contact for Library issues provided by Rose is no longer with the SCCFD. Freddie has left messages with new Deputy Fire Marshall in charge of Los Altos, Jose Garcia.
- 4. Any news regarding fix for Patio Door at Woodland Branch?
 REPORT: Bryant will investigate. At present the door still won't close due to air pressure from the HVAC. Bryant will also investigate with the Maintenance Director whether there is any way the noise from activating the push bar can be dampened.

The next meeting of the Infrastructure Subcommittee is scheduled for March 31 at 4:00pm.

3-3-2022 Report of the Awareness Subcommittee

1. LALE ads for March, April, May - Cindy Hill, President of LALE, suggested that since April is Library Staff Appreciation month, the LALE ad should focus on Appreciation of our Library Staff. The following topics were scheduled:

March - Free Weston Wood Children's Videos

April – LinkedIn Learning

May – E-Library Card – Instant Access to Online Library Resources

REPORT: Library Staff Appreciation Month will be the topic of the LALE ad for April. LinkedIn Learning will move to May or June. E-Library Card will be moved to another time slot. Sharvari offered to find free clipart depicting library staff.

Bryant suggested that the Los Altos community should be aware that the Main Library and the Woodland Branch both offer Medication Disposal Bags and Sharps Disposal Containers. Both the Rx disposal bags, and sharps containers are mailed back directly to companies that properly process the contents. This is a great free service that is very much underutilized.

We will ask LALE if they will use their ad in the 4th week of April to publicize this service of the library because April 30th is National Prescription Drug Takeback Day. The timing of the ad and the National Day of Recognition would coincide perfectly. If LALE is unable to use this the topic for that ad, we will feature this service in the May Awareness Subcommittee LALE ad.

Bryant also suggested other underutilized services provided by the library such as being an eyeglasses donation site and a battery disposal site. He also suggested that we might come up with an ad featuring all the random items available to take home from the library such as Driver's Handbooks for the exam and other items. We will work with Bryant to explore such an ad in the future.

- 2. Freddie reported back to the Subcommittee that the LALE Board approved our request for funding for these ads for calendar year 2022.
- 3. Carolle reported on PSA possibilities with Gunn High School, Homestead High School and Mt View High School.

REPORT: Carolle reported that both none of the three high schools offered PSAs, but Gunn and Homestead offered opportunities for the library staff to speak to a student who might feature the PSA information in an article. Mt. View High did not respond further.
