Dear City Council,

Two comments on the "Community Engagement Plan for Downtown Park with Parking":

The Community Engagement should explicitly ask whether a park and/or an underground parking are desirable, and not just whether the entrance to the parking should be on the left or the right.

The Scope of Work (Design) should include some quantification of the environmental costs. It should also discuss the evolution of the underground parking should the needs/desires of the community evolve over the lifetime of the structure.
