### BACKGROUND

The Los Altos Historic Preservation Award was adopted by City Council Resolution on March 13, 2012. The intent of the award is to recognize exemplary rehabilitation and preservation of historic properties, and individuals, groups or organizations in the community that exemplify the spirit of historic preservation in Los Altos. Nominees should demonstrate a dedication to historic preservation within at least one of the following criteria:

1. Demonstration of pioneering or innovative efforts in historic preservation or education;
2. Conformance with the Secretary of the Interior's Standards for Historic Rehabilitation;
3. Public benefit received (educational, beautification, advocacy, etc.); and/or
4. Impact to the City of Los Altos.

The purpose of the award is to encourage public knowledge, understanding and appreciation of the City's past, and foster civic and neighborhood pride and sense of identity based upon the recognition and use of the City's historic resources. If the Historical Commission finds that none of the nominees meet the above criteria, the Commission is not obligated to grant the Preservation award.

### DISCUSSION

Staff received two nominations for the Historic Preservation Award. A nomination was received for the Los Altos Chapter of the National Society of the Daughters of the American Revolution, nominated by Ann Hepenstal (Attachment A) and a nomination for Anne Roberts and Dick Liewer, nominated by Gary Hedden (Attachment B).

The Commission should consider the written evidence and oral testimony from members of the public before voting on the award recipient. The award recipient or their designee will be recognized with a Mayor's Proclamation at a future City Council Meeting.

**2022 HISTORIC PRESERVATION AWARD NOMINATION**

I am nominating Los Altos Chapter, Daughters of the American Revolution for the 2022 Historic Preservation Award.

Describe the reasons why the nominee should receive the Historic Preservation Award and how the nominee meets the following criteria:

1. Demonstration of pioneering or innovative efforts in historic preservation or education.
2. Conformance with the Secretary of the Interior’s Standards for Historic Rehabilitation.
3. Public Benefit received (educational, beautification, advocacy, etc.).
4. Impact to the City of Los Altos.

Members of the Los Altos Chapter, National Society of the Daughters of the American Revolution (DAR) researched the lives and history of early settlers in the Los Altos, Los Altos Hills, and Mountain View area. While history books usually focus on "famous people," this project documented the lives of people who were in this area before 1900. Some of the researchers chose to investigate the person who had owned the property where they now live, or a street or school named for an early resident. Others chose someone identified on maps or in other records, as long as the person was in the area and active before 1900.

As a "pandemic project," the researchers relied on materials accessible at home and online: maps, genealogy resources, internet articles, newspapers, books, and more. The project gave insight into the pioneering and entrepreneurial spirit that contributed to the commercial and civic evolution of the early San Francisco Bay Area. Thirty-five early settlers were profiled in one-page biographies written by 16 DAR member-authors. These settlers include such "Los Altos names" as Cyrus Philbrick Berry (965 Berry Ave), Silas Blake Emerson, David L. Farnsworth (439 Rinconada Ct), and Elias Fulton Springer (Springer School and Springer Rd). Copies of the book have been donated to Los Altos Library and the Family History Center.

To increase the impact on the Los Altos community and public access to this information, the Chapter has donated printed copies (plus an electronic version on thumbdrive) to the Los Altos History Museum, the Family History Library at Los Altos Stake of the Church of Jesus Christ of the Latter-day Saints, Mountain View Historical Association (at the Mountain View Library), Santa Clara County Historical and Genealogical Society, and the Santa Clara County Library District - Los Altos Branch. An electronic version has also been donated to the Family Search Library to be added to their online catalog (familysearch.org) and to the Daughters of the American Revolution library. The *Los Altos Town Crier* ran photos on its front page covering the event where the chapter presented the books to the recipients.

The California State Society of the Daughters of the American Revolution (CSSDAR) awarded the Settlers Project a Certificate of Historic Achievement at the 2022 State Conference. In addition, the State Historian featured the project in her committee poster display, and in her report to the conference.

Project manager Martha Wallace received the "Special Project Award, Volunteer Information Specialist" at the CSSDAR 2022 State Conference, recognizing her innovative approach to using technology to run this project during the Covid-19 pandemic. She used Zoom coaching sessions, deployed electronic templates to the authors for their profile write-ups, taught about databases and resources available online and more.

## 2022 Historic Preservation Award Nomination

20 April 2022

Honored Historical Commissioners,

I look forward to the nominations that are presented to the Commission each Spring. It is when we hear about the people who have helped preserve and protect the story of Los Altos. This connection to the past is an important part of the charm of our city.

Some of the people you have recognized have played a critical role in saving our history. People like Don McDonald, Margaret Thompson, Marion and Bob Grimm, Nan Geschke, Jane Reed and others have been recognized for truly significant work. This year, I encourage you to recognize two of the longest-serving and most dedicated members of the History Museum's Education Committee, Anne Roberts and Dick Liewer. Teaching history is an important component of the Museum's mission and Anne and Dick have reached countless thousands of elementary age students with their very personal and engaging history lessons.

Anne Roberts retired from Almond Elementary School in 2007 and immediately joined the Education Committee, becoming Chair in 2009, a position she continues to hold. As Chair, Anne has been managing the Margaret Thompson essay contest in a joint effort with the Historical Commission. Working with the Education Committee, her work has involved picking a subject based on the current exhibit in the changing exhibits gallery at the Museum, writing the "prompt" describing the topic for the essay, reading and scoring the entries, and with the Historical Commission picking the winners and recognizing them at an Ice Cream Social in May.

Anne has dedicated herself to this for over 12 years and the genuine pleasure the winning students show is one of Anne's most satisfying rewards.

Dick Liewer has been leading school tours for longer than he can remember. The third-grade tours were already an established annual tradition when he joined the effort in the 90s. The tours then involved three stations, a visit with Annie Knapp Fitz and a look at her art, a walk downtown to look at historic buildings, and of course a visit to the Smith House. In 2001, after the History Museum's new home had been built, Bob Grimm told Dick, "There is more potential here." As a former teacher and administrator, Dick could easily reach out to the schools to find out what they needed, and the answer was fourth-grade tours. Dick asked Don McDonald, our esteemed town historian, for help, and they came up with a plan. The tours would have four stations, Early City Hall, Take Me to the Movies, People Movers and Cal Aggies.

Early City Hall is always fun for the kids. They play the role of city council members, city staff and the public to debate a dog license ordinance! In 1953, the city was only one year old and didn't have a lot of rules. There was a real debate between folks who wanted some rules and those who didn't. A dog named Beans was the cause of it all,

and the kids get to argue and debate and come up with a rule.

This year, with the help of the new Museum Educator, Georgianna Shea, the tours have been upgraded with some tweaks to the script and best of all, now the docents wear costumes. Dick Liewer wears a San Francisco Seals uniform when he talks about the early history of local baseball.

For Anne Roberts and Dick Liewer, teaching history to the students is more fun than work. Nevertheless, their dedication is worthy of your selection of them for the 2022 Historic Preservation Award.

## 2022 Historic Preservation Award Nomination

I support the nomination of Anne Roberts and Dick Liewer for the 2022 Historic Preservation Award.

Anne Roberts has been the chair of the LAHM Education Committee for over 12 years. As the chair, Anne has coordinated the Margaret Thompson essay contest each year. This is the 38th year of the contest which is named for Margaret Thompson who started it when she was on the Historical Commission. Anne has been in charge of the judging of the essays and coordinating with the City of Los Altos and the Historical Commissioners to recognize the essay contest winners. Anne also has been in charge of the 3rd grade field trip tours of the Museum and the Smith House during her time as chair. This year, Anne has spearheaded the revising of our scripts for each of the 3rd grade stations that are presented during our tours. These stations help preserve our Los Altos history and present it in an engaging manner to 3rd graders. The historic Smith House, Annie Knapp Fitz and her paintings, and the history of baseball in the Bay Area are being presented this year.

Dick Liewer has been a member of the Education Committee for well over 12 years. Dick is in charge of the 4th grade field trip tours. Dick has written the scripts for each of the four stations that are presented to the 4th graders. This year, Dick has spearheaded the revising of the 4th grade scripts. Training was presented for each of these stations so that docents could be familiar with the new engaging approaches to use with the students. Dick was involved with each of these training sessions. The 4th grade stations include: a City Council simulation of a meeting that took place about dog ordinances in Los Altos in 1953, a hands-on presentation about the importance of apricots and walnuts to Los Altos, a station called "Take Me to the Movies" and the history of baseball. Dick has been instrumental in preserving the history of Los Altos and presenting it in an engaging manner to 4th graders in Los Altos.

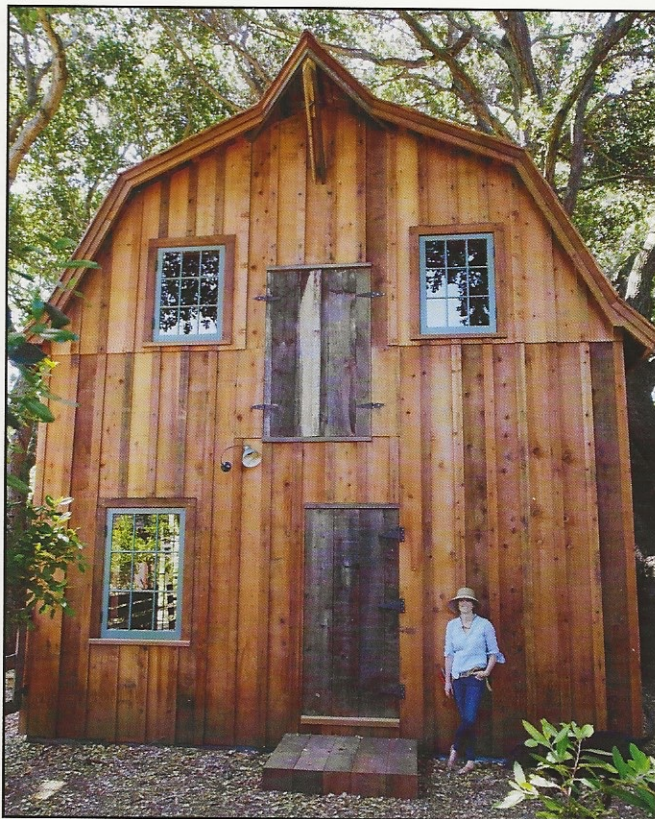

## History in the News

Two steps forward and two steps back. The historic 1930s Ames/Landels Barn at 210 Alta Vista was completely renovated, a 3+ year project that wrapped up in April. Led by local architect Greg Evard, the renovation included careful preservation of much of the original wood. Another 3+ year project is nearing completion, the historic Oliver Holt House at 1365 Grant Road. The owner says they hope to finish in June. These two projects took determination and patience, and needless to say, came at considerable expense. We are grateful to the people who love historic properties and are willing take on the challenge of saving them.

Sadly, the charming 1920s Bungalow at 67 Lyell was recently removed from the Historic Resource Inventory at the owners request. The owner claimed "loss of historical integrity" and the Historical Commission consented. The home went on the market the very next week. In another setback, the request for Historic Landmark designation for the 1905 Emerson House at 980 Covington was denied by the City Council, against staff recommendation, due to some recent exterior changes. This will block Mills Act protection for the property, an important consideration for homeowners seeking relief from the expense of renovation and maintenance of historic properties. This relief encourages homeowners and developers to preserve our very limited stock of historic properties. These properties are the visual representation of our history and important to the charm of Los Altos. We must fiercely guard and protect each and every one.

## Remembering Margaret Thompson

The Museum's Education Committee is really going to miss our dear friend Margaret Thompson who passed away February 24 at the age of 98. We worked closely with Margaret for many years on the essay contest that bears her name.

Margaret initiated the contest while on the Los Altos Historical Commission. Her granddaughter, Mariko, recalled "Grandmother decided to start the essay contest after I won several writing awards in high school. She thought a writing contest with cash prizes was a great way to encourage kids to write. She enjoyed writing and in another era might have pursued a writing career. In the early 1940's she turned down a newspaper job writing the society page. I got the sense she always wondered what might have happened if she'd said yes."

Margaret's daughter, Susan, recalled, "I left for college early in the contest history, and all I really remember is having to hop over all the stacks of essays in the living room once a year!"

For the 25<sup>th</sup> anniversary of the contest, Margaret introduced a trophy to be engraved and given to the school with the most winning essays. Each year, a school "wins" the trophy and keeps it at their school for a year. The trophy is awarded in May at an ice cream social which recognizes the winners. She often commented that attending the social and meeting the winning students was a special highlight in her life. She truly loved children and enjoyed meeting them and their families.

As Chair of the Education Committee, it was my privilege to develop a wonderful friendship with Margaret. We would often meet for lunch, talk about the books she was reading, the news, and what was being taught in the elementary schools. She was very sharp and interested in so many things that I often forgot I was visiting a woman in her 90's. It was a privilege to count Margaret as a dear friend!



They teach young students about Los Altos' past and shape future generations by instilling in them an appreciation for the history of Los Altos.

As a former educator, I recognize the impact an individual can have on a student. Anne and Dick continue to educate and inspire students as they share their knowledge and passion for the rich and important history in Los Altos. Through their perseverance, they have made sure that Los Altos local history is an important area of study for every student in the Los Altos School District.

I am a member of the Los Altos DAR and I jumped at the invitation to participate in the “at home” project to compile a one page biography of a settler who lived here in the late 19th century. Sixteen of us participated! We began by selecting names from 1876 and 1889 maps of this area then known as the Fremont Township. My eye fell on a tract of land known as the Madigan Subdivision because my own home is recorded in county maps as on a portion of lot 11 of the estate of G. Madigan. This is the area known today as the South Clark neighborhood between El Monte and Springer Roads. History became personal. I was fortunate to find the probate records of Garrett Madigan on line. His story led me to research the merchants he dealt with in old Mountain View and the buyer of the majority of his estate, David Farnsworth, whose home on Rinconada Ct. is one of our Historic Landmarks.

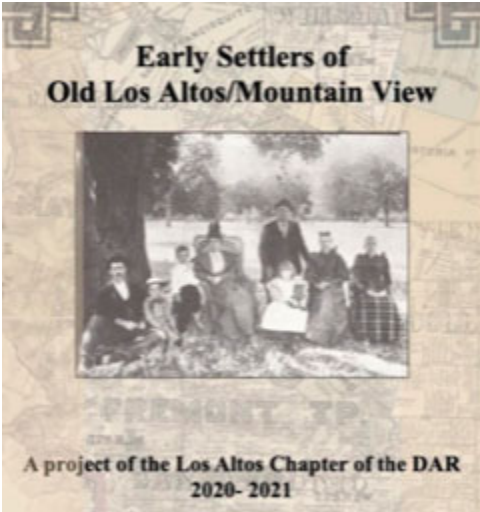

One of the strongest “take aways” was learning about the individuals who worked together build the community such as the neighbors who joined together to create a local bank which in turn provide the capital for further growth and development.

**BACKGROUND**

The City adopted a Historic Plaque Program in 2013 to recognize properties and structures listed on the Historical Resource Inventory (HRI) to further the City’s goals of community outreach and education about Los Altos History. Since 2015, staff from the Planning Division has sent letters each year to homeowners if interested in participating in the program. Upon the homeowners’ requests, more than 50 properties on the HRI list have received the historical plaques that were purchased by the City.
