Title of Art Piece Vortex

Brief Description

Vortex is my homage to one of my favorite shapes in nature, the spiral. Although I use spirals in lots of my sculptures, this one is probably my purest version. I wanted it to look very plant like, as if it were growing out of the ground. My goal is to fool the viewer into thinking that they are looking at some strange plant or animal and not at a steel sculpture, at least for a moment. I like to use corten steel because the patina seems almost like an organic material.

Sorry but I didn't have a better shot of the right side. Also the photo from the back is from when I first installed it at it's current location and the patina hadn't formed yet. You can't really see the base of the sculpture all the way either but if you need me to I can send you some shots from when I was building it. Thank you.

On June 23, 2022, the Public Arts Commission (PAC) approved a call for art for entries to the City's Art Without Walls program. On December 8, 2022, the PAC reviewed potential locations for sculptures.

Selected entries will receive a stipend of \$1,500 to be paid using allocated Public Art Funds.

Discussion/Analysis

Entries were due to the City on October 13, 2022. At the October 27, 2022 PAC meeting, the Commission reviewed entries and selected a certain number to move forward in consideration. The subcommittee for this call for art recommended potential locations for the entries at the December 8, 2022 meeting. As of the February 23, 2023 meeting, locations had been identified for all pieces selected except for one. The subcommittee was directed to review potential locations for the remaining piece.
