## D. ACTION ITEMS

1. Recognition of Council Member Juan Munoz & Council Member Terry Vinson for their years of service to the community.

Mayor Flores and the City Council shared words of appreciation for outgoing council members Mr. Vinson and Mr. Muñoz. Mr. Terry was in attendance and received a plaque and a gift basket from City Manager Mr. Milum in recognition of his years of dedicated service. Mr. Vinson expressed his gratitude to everyone present.

2. Canvass of November 4, 2025 General Election Returns.

Mayor Flores presented the canvassing report for the City of Los Fresnos. For Council Place 2, Juan Munoz received 358 votes, representing 47.61% of the total, while Andrew Gonzales received 394 votes, or 52.39%. There was one overvote and 49 undervotes, for a contest total of 802 votes. For Council Place 5, Leonel Casanova Jr. secured 460 votes, accounting for 60.53%, and Rosa Munoz Vallejo received 300 votes, or 39.47%. This contest included two overvotes and 40 undervotes, with a total of 802 votes cast.

3. Consideration and ACTION to approve a Resolution Declaring Results of the November 4, 2025 City General Election.

Motion was made and seconded to approve the Resolution declaring the results of the November 4, 2025 City General Election.
