Mr. Milum reported the check registered listed normal monthly checks, 75% through the fiscal year as of June 30th, 73.1% in sales tax revenue, total revenue at \$500,941, and \$448,789 in expenditures. He continued with the sales tax report, 3.53% increase year to date compared to last year.

3. Consideration and ACTION to approve funding for wastewater upgrades in the commercial area of the City.

Mr. Milum explained the project included upgrades to existing manholes that have broued or collapsed. The city was awarded a \$4,082,618 grant and \$1,705,000 loan for the project. About 30% of the lines and manholes directly affect business in the community, 30% of the loan would be \$33,000 per year beginning late 2025 through 2045. The total amount being \$660,000.

Mr. Milum answered questions from the board.

Motion was made and seconded to approve the funding for wastewater upgrades in the commercial area of the City, a total of \$33,000 for 2025-2026 fiscal year budget up until 2045.

SERVICE AGREEMENT

This is an agreement between the Narcisco Martinez Cultural Arts Center (Festival) and the Los Fresnos Community Development Corporation (CDC) and the City of Los Fresnos (City). The event will be held in October 2024 at the Memorial Park.

The Festival agrees to provide the following for their annual Narcisco Martinez Conjunto Festival:

- · Contracting the bands and sound engineer;
- · Promoting the festival via print and social media;
- Acquisition of event insurance to cover liability issues, holding the City of Los Fresnos, Los Fresnos Community Development Corporation and Los Fresnos CISD harmless;
- · Alcohol Beverage License;
- Renting of portable restrooms to add to the existing restrooms in the city park;
- Provide personnel at the entrance to enter the festival;
- Provide extra fencing as necessary;
- Festival t-shirt will include the City of Los Fresnos as a sponsor;
- Develop a color program guide that includes band bios, advertising, human interest stories, as well as information provided by the city.

The CDC will provide \$5,000 for promoting and bringing business to the community. Payment to the Festival will be paid in full in the month of August 2024.

The City will provide the following: Half page ad in the magazine for \$350, Security on the grounds from Friday afternoon through Sunday at the conclusion of the event, Security for safe passage for the street crossings between High School parking areas and the Park, light plants and generators as needed, Public Works personnel for trash and restroom cleanup and assistance as needed, promotion of the event through Facebook, web site and welcome sign.

The Festival must submit Audited Financials from a Certified Public Accountant. A Form 990 to the IRS is sufficient to meet this requirement.

Item Title: Consideration and ACTION to approve funding for the Los Fresnos

Little League 2026 season.

Recommendation:

Members of the Los Fresnos Little League will be present to review last season, discuss the upcoming season and discuss funding.

The are requesting \$15,000 for the general agreement. CDC provided \$10,000 for the 2025 season. The League is doing a really good job, being consistent, providing a lot for the youth and operating at a high level with many volunteers. Practices and games bring a lot of economic benefit to area businesses with teams providing snacks and meals and families getting supper to save time due to all the activities.

Additionally, the League would like to replace the 2 scoreboards. The current ones are very old and do not work well. The cost is \$11,000 plus labor for installation.

They would also like to include \$40,000 plus labor for shades for the bleachers. One of the biggest complaints we receive is it is too hot out in the sun. This would be a tremendous benefit and a "home run" in the eyes of the community.



Item Title:Consideration and ACTION to approve the purchase of promotional items.

Recommendation:

Promotion and advertising is allowed to be 10% of the budget. These items regularly include the events the CDC sponsors, Halloween Festival, Christmas Festival, Easter Celebration, Independence Day Celebration, Fireworks, Earth Day, LF Rodeo, Cameron County Fair & Livestock Show, Conjunto Festival, LF Little League, and the Cowboy Cookoff. Another part of promoting Los Fresnos is to have "goodies" to give to folks as we have events and hold meetings with prospective businesses. This includes caps, pens, pins, tote bags, note pads, journals, calendars and other similar type items. We currently have \$7,500 available in the current budget to get supplied and set up an inventory of these. We would like approval to do this now and then include an amount in the annual budget to keep those types of items available as needed.



Item Title: Consideration and ACTION to approve fiscal year 2025-2026 budget.

Recommendation:

Sales Tax: For the last year this has been flat or just a small increase so we will be conservative and keep in the same as we project it this year. The last few years are as follows:

2019-2020	\$445,965
2020-2021	\$518,583
2021-2022	\$542,108
2022-2023	\$612,815
2023-2024	\$622,259
2024-2025	\$650,000

Interest is still greater than a few years ago but has decreased a little.

Salaries and Benefits: This amount reflects the Economic Development Coordinator Position.

Auditing Services will be \$6,000.

Professional Services: Zero since we have a full time employee.

Business Recruit & Development: Depends on what is decided during the presentation. It was increased \$3,000 to \$18,000 after being at \$15,000 for 2 years. I believe it should stay at \$18,000.

City Promotion & Advertising: This is based on 10% of sales tax revenue according to state law. With a sales tax revenue estimate of \$650,000 it computes to \$65,000. The specific amounts are listed on the handout.

Travel/Seminars: An increase to allow travel for EDC to train.

Park Improvements: We would like to install some commercial fans at the Pavilion at Memorial Park for \$10,000 and to upgrade the lighting to LED at the Little League fields for \$50,000.

Special Projects - That leaves a healthy amount of \$202,700 for projects that come up during the year. Additionally, LL has asked for \$11,000 plus labor and installation costs for new scoreboards and \$40,000 plus labor and installation costs for shade covers for all bleachers; Patriotic lighting for \$35,000.
