1) PURPOSE This State Plan of Operation (SPO) is entered into between the State/United States (U.S.) Territory and Law Enforcement Agency (as identified above), to set forth the terms and conditions which will be binding on the parties with respect to Department of Defense (DoD) excess personal property conditionally transferred pursuant to 10 USC § 2576a, in order to promote the efficient, expeditious transfer of property and to ensure accountability of the same.

2) AUTHORITY The Secretary of Defense (SECDEF) is authorized by 10 USC § 2576a to transfer to Federal and State Law Enforcement Agencies (LEAs), personal property that is excess to the needs of the DoD, including small arms and ammunition, that the Secretary determines is suitable to be used by such agencies in law enforcement activities, with preferences for counter-drug/counter-terrorism, disaster-related emergency preparedness or border security activities, under such terms prescribed by the Secretary. The SECDEF has delegated program management authority to the DLA. The DLA Disp Svcs LESO administers the program in accordance with (IAW) 10 USC § 2576a, 10 USC § 280, DoDM 4160.21 and DLAI 4140.11. The DLA defines "law enforcement activities" as activities performed by governmental agencies whose primary function is the enforcement of applicable federal, State, and local laws and whose compensated law enforcement officers have powers of arrest and apprehension.

3) GENERAL TERMS AND CONDITIONS "DoD excess personal property" also known as "items", "equipment", "program property", or "property". "DLA Disposition Services Law Enforcement Support Office" also known as "1033 Program", "LESO Program", "the program", or "LESO". "State or U.S. Territory" also known as "the State", "State Coordinator (SC)", "State Point of Contact (SPOC)", or "SC/SPOC". "Law Enforcement Activities" also known as "agencies in law enforcement activities", "Law Enforcement Agency (LEA)", "program participant", or "State/LEA".

a) Property made available under this agreement is not for personal use and is for the use of authorized program participants only. All requests for property shall be based on bona fide law enforcement requirements. Authorized participants who receive property from the program will not loan, donate, or otherwise provide property to other groups or entities (i.e., public works, county garage, schools, etc.) that are not otherwise authorized to participate in the program. Property will not be obtained by program participants for the purpose of sale, lease, loan, personal use, rent, exchange, barter, transfer, or to secure a loan. To receive such property, on an annual basis the LEA shall certify that they have:

i) Obtained authorization of the relevant local governing body authority (i.e., city council, mayor, etc.).

ii) Adopted publicly available protocols for the appropriate use of controlled property, the supervision, and the evaluation of the effectiveness of such use, including auditing and accountability policies.

iii)Annual training in place and provides it to relevant personnel on the maintenance, sustainment, and appropriate use of controlled property, including respect for the rights of citizens under the Constitution of the U.S. and de-escalation of force.

b) All costs associated with the transportation, turn-in, transfer, repair, maintenance, insurance, disposal, repossession or other expenses related to property are the sole responsibility of the State/LEA. The State/LEA shall also be responsible to reimburse the U.S Government (USG) for costs incurred in retrieving and/or repossessing property impermissibly transferred by the State/LEA to unauthorized participants.

c) The State/LEA will maintain and enforce regulations designed to impose adequate security and accountability measures for controlled property to mitigate the risk of loss or theft of property. Program participants shall implement controls to ensure property made available under this agreement is used for official law enforcement use only. The State/LEA shall take appropriate administrative and/or disciplinary action against individuals that violate provisions of the Memorandum of Agreement (MOA) between the Federal Government and the State/U.S. Territory and/or this SPO, including unauthorized use of property.

- d) All property transferred to the State/LEA via the program is on an as-is, where-is basis.
- e) LESO reserves the right to recall property issued to a State/LEA at any time.
- f) General use of definitions/terms:

i) Demilitarization (DEMIL code)-a code assigned to DoD property that indicates the degree of required physical destruction, identifies items requiring specialized capabilities or procedures, and identifies items which do not require DEMIL but may require Trade Security Controls (TSC). Program participants are not authorized to conduct physical demilitarization of property.

ii) "Controlled property"-items with a DEMIL code of B, C, D, E, F, G, and Q (with an Integrity Code of "3". Title and ownership of controlled property remains with the DoD in perpetuity and will not be relinquished to the State/LEA. When a State/LEA no longer has a legitimate law enforcement use for controlled property, they shall notify the LESO, and the property will be transferred to another program participating State/LEA (via standard transfer process) or returned to DLA Disp Svcs for disposition.

iii) "Non-controlled" property"-items with a DEMIL code of A or Q (with an Integrity Code of "6"). These items are conditionally transferred to the State/LEA and will remain on State/LEA accountable inventory for one year from the ship date. However, after one year from the ship date, DLA will relinquish ownership and title for the property to the State/LEA without issuance of further documentation. During this one year period, the State/LEA remains responsible for the accountability and physical control of the property and the LESO retains the right to recall the property. Participants should return any property in this one year period that becomes excess to their needs or they otherwise determine is not serviceable.

(1) The LEA receives title and ownership of DEMIL "A" and "Q6" property as governmental entities. Title and ownership of this property does not pass from DoD to any private individual or State/LEA official in their private capacity. Such property shall be maintained and ultimately disposed of IAW provisions in State and local laws that govern public property.

(2) Sales/gifting of DEMIL"A" and "Q6" property after one year from the ship date inconsistent with State/local law may constitute grounds to deny future participation in the program.

(3) After one year from ship date, DEMIL "A" and "Q6" property may be transferred, cannibalized for usable parts, sold, donated, or scrapped.

(4) Once the property is no longer on the LEA accountable inventory, the property is no longer subject to the annual physical inventory requirements and will not be inventoried during a LESO Program Compliance Review (PCR).

g) All physical transfers of property require LESO approval. Program participants will not physically transfer property until the LESO approval process is complete. Program participants may request their SC/SPOC approval to temporarily conditionally loan property to another program participant (if mission requires). If the SC/SPOC approves the temporary conditional loan, it shall be done using an acceptable Equipment Custody Receipt (ECR). At the end of the temporary conditional loan, the item (s) shall be returned to the original LEA for accountability. All requests for conditional loans will be based on bona fide law enforcement requirements. h) The program may authorize digital signatures on required program documentation.

i) The State/LEA is not required to maintain insurance on controlled property, aircraft or other property with special handling requirements that remain titled to DoD. However, the State/LEA will be advised that if they elect to carry insurance and the insured property is on the program inventory at the time of loss or damage, the recipient will submit a check made payable to DLA for insurance proceeds received in excess of their actual costs of acquiring and rehabilitating the property prior to its loss, damage, or destruction.

#### 4) STATE PLAN OF OPERATION The State shall:

a) Assist in training LEAs with enrollment, property requests, transfers, turn-ins, and disposal procedures.

b) Adhere to the requirements outlined in the MOA between the Federal Government and the State/U.S. Territory and ensure MOA amendments or modifications are incorporated into this SPO and program participants are notified and acknowledge responsibility to comply with changes.

c) Submit a SPO to LESO that shall address procedures for determining LEA eligibility, allocation, equitable distribution of property, accountability, inventory, training, and education, State-level internal PCRs, export control requirements, procedures for turn-in, transfer, and disposal and other responsibilities concerning property.

d) Enter into written agreement with each LEA, via the LESO-approved SPO, to ensure program participants acknowledge the terms, conditions, and limitations applicable to property. This SPO must be signed by the current Chief Law Enforcement Official (CLEO) (or designee) and the current SC/SPOC.

e) Provide program participants the following information:

- iii) Funding to administer the LESO Program at the State-level is provided via:
- iv) The Governor of the State of Texas has appointed the Texas Department of Public of Public Safety to conduct management. and oversight of this program. All funding and staffing will be provided by the Texas Department. of Public Safety

5) PROPERTY ACCOUNTING SYSTEM The State will maintain access to Federal Excess Property Management Information System (FEPMIS) (or current property accounting system), to ensure LEAs maintain property books, to include, but not limited to, transfers, turn-ins, and disposal requests from an LEA or to generate these requests at the State-level and forward all approvals to the LESO for action. The State will:

a) Conduct quarterly reconciliations of State property records.

b) Ensure at least one person per LEA maintains access to the property accounting system. Users may be "active" or "inactive" in the system, so long as they are registered. Ensure registered users are employees of the State/LEA.

c) Ensure LEAs receive and account for property in the property accounting system within 30 days.

6) LESO WEBSITE The State shall access the LESO website for timely and accurate guidance, information, and links concerning the program and ensure that all relevant information is passed to the program participants.

7) ANNUAL TRAINING 10 USC § 280 provides that the SECDEF, in cooperation with the U.S. Attorney General, shall conduct an annual briefing of law enforcement personnel of each State (including law enforcement personnel of the political subdivisions of each State). Individuals who wish to attend are responsible for funding their own travel expenses. The briefing will include information on training, technical support, equipment, and facilities that are available to civilian law enforcement personnel from the DoD. The state shall provide program participants training material as discussed during the annual LESO training which includes information on property management best practices to include (but not limited to) searching for property, accounting for property on inventory, transfer and turn-in of property when it is no longer needed or serviceable.

8) ENROLLMENT The LESO shall establish and implement program eligibility criteria IAW 10 USC § 2576a, DLA Instructions and Manuals and this SPO and retains final approval/disapproval authority for application packages forwarded by the State. Non-governmental law enforcement entities such as private railroad police, private security, private academies, correctional departments, prisons, or security police at private schools/colleges are not eligible to participate. Fire departments (by definition) are not eligible to participate and should be referred to the DLA Fire Fighter program administered by USDA. Law enforcement agencies requesting program participation shall have at least one full-time law enforcement officer. Program property may only be issued to full-time/part-time law enforcement officers. Non-compensated reserve officers are not authorized to receive property. State law enforcement training facilities/ academies may be authorized to participate in the program given their primary function is the training of bona fide State/local law enforcement officers. Law enforcement training facilities/academies will be reviewed on a case-by-case basis. The State shall:

a) Validate the authenticity of state/LEAs that are applying for program participation. Only submit to the LESO those application packages that the SC/SPOC recommends/certifies are government agencies whose primary function is the enforcement of applicable federal, State, and local laws and whose compensated officers have the powers of arrest and apprehension. If the State forwards an unauthorized participant application package, this may result in a formal suspension of the State.

b) Have sole discretion to disapprove state/LEA application packages in their State. The SC/SPOC should provide notification to the LESO when application packages are disapproved at the State-level.

c) Ensure that screeners listed in the application package are employees of the LEA. A screener may only screen property for two LEAs. Contractors may not conduct screening on behalf of a LEA.

d) Make recommendation on what constitutes a "full-time" or "part-time" law enforcement officer.

e) Ensure LEAs update their account information annually, or as needed. This may require the LEA to submit an updated application package. An updated application package shall be submitted for (but is not limited to) the following: a change in CLEO, the addition or removal of a screener, a change in the LEA physical address or contact information, etc.

f) Provide the LEA a comprehensive program overview once approved by the LESO for enrollment. The overview will be done within 90-days of a LEA being approved to participate.

#### 9) PROPERTY ALLOCATION

a) The LESO shall:

i) Upon receipt of a SC/SPOC validated request for property through the RTD website, will review and give preference to requisitions indicating that the requested property will be used in the counter-drug, counter-terrorism, disaster-related emergency preparedness, or border security activities of the requesting LEA. Program participants that request vehicles used for disaster-related emergency preparedness, such as high-water rescue vehicles, should receive the highest preference.

ii) Require additional justification for small arms, aircraft, ammunition, and vehicles and to the greatest extent possible, ensure fair and equitable distribution of property based on current LEA inventory and justification for property.

iii) Reserve the right to determine and/or adjust allocation limits, to include the type, quantity and location of property allocated to the State/LEA. Generally, no more than one item (per part-time/full-time officer) will be allocated. Quantity exceptions may be granted by the LESO on a case-by-case basis based on the justification provided by the LEA. Currently, the following allocation limits apply:

- (1) Robots: one (of each type) for every ten officers (full-time/part-time).
- (2) High Mobility Multipurpose Wheeled Vehicle (HMMWV)/Up-Armored HMMWV (UAH): one vehicle for every three officers (full-time/part-time).
- (3) Mine Resistant Ambush Protected (MRAP) / Armored Vehicles: two vehicles per LEA.
- (4) Small arms: one (of each type) per officer (full-time/part-time).

(a) LESO may authorize over allocations of small arms in preparation for inevitable scenarios, i.e., training, equipment downtime (damage, routine maintenance, inspections) or other law enforcement needs. The chart below is the standard for small arms acceptable over-allocations:

Small Arms Over-Alle	-
# of Officers	# by type
1-10	2 or less
11-25	3 or less
26-100	5 or less
101-299	8 or less
300 or more	10 or less

(b) In instances where small arm allocation amounts exceed the "acceptable over-allocation" levels, the LESO will coordinate with States to verify accuracy of the officer count. If small arm allocation is still beyond acceptable levels, LESO may authorize one of the following: 1) an exception to policy, 2) a transfer, or 3) a turn-in.

#### b) The State shall:

i) Assist the LEA in the use of electronic screening of property via the RTD website and shall access the RTD website a minimum of once daily (Monday-Friday) to review and process LEA requests for property. Property justifications shall be validated to ensure they meet the intent of 10 USC § 2576a as suitable for use by agencies in law enforcement activities. Prior to approving a request or transfer, review the LEAs property allocation report to prevent over allocation.

ii) Upon receipt of a valid LEA request for property, provide a recommendation to the LESO on the preference to be given to those requisitions for property that will be used in counter-drug, counter-terrorism, disaster-related emergency preparedness or border security activities of the recipient agency. Requests for vehicles used for disaster-related emergency preparedness, such as high-water rescue vehicles, should receive the highest preference. The State shall consider the fair and equitable distribution of property based on current LEA inventory and LEA justifications for property. The State shall ensure the type and quantity of property being requested by LEAs is reasonable and justifiable given the number of officers (full-time/part-time) and prior requisitions for similar items they have received (both controlled and non-controlled property). Generally, no more than one of any item per officer (full- time/part-time) will be allocated.

**10) PROPERTY MANAGEMENT** Certain controlled equipment shall have a documented chain of custody (i.e., an acceptable ECR), including a signature of the recipient. Controlled property requiring an ECR: small arms (including parts and accessories), aircraft, vehicles, optics, and robots. It is encouraged to utilize ECRs for all controlled property. LEAs may request cannibalization on aircraft or vehicles. Cannibalization requests shall be submitted to the State for review. Cannibalization must be approved by the LESO prior to any cannibalization actions. The cannibalized end item shall be returned to DLA Disp Svcs within the timeframes determined by the LESO.

a) Aircraft-Aircraft will not be obtained by LEAs for the purpose of sale, lease, loan, personal use, rent, exchange, barter, transfer, or to secure a loan and shall be reported to the LESO at the end of their useful life. All aircraft are considered controlled property, regardless of DEMIL code. Aircraft that are no longer needed or serviceable shall be reported to the General Services Administration (GSA) for final disposition by the LESO Program Aircraft Specialist.

b) Vehicles-Program participants that request vehicles used for disaster-related emergency preparedness, such as highwater rescue vehicles, should receive the highest preference. Vehicles will not be obtained by LEAs for the purpose of sale, lease, loan, personal use, rent, exchange, barter, transfer, or to secure a loan and vehicles that are considered controlled property will be returned to DLA Disp Svcs at the end of their useful life. DLA Disp Svcs Field Activity/Site will identify qualifying DEMIL A or Q6 vehicles and may issue (upon LEA request) a Standard Form (SF) SF-97 to the LEA upon physical transfer of the vehicle. The LEA may modify the vehicle during the one year conditional transfer period.

c) Ammunition-LESO will support the U.S. Army (USA), in allocating ammunition to program participants. Ammunition obtained via the program will be for training use only. At the time of request, the LEA will certify in writing that the ammunition will be used for training use/purposes only. The USA will issue approved transfers directly to the State/LEA. The State/LEA is responsible for funding all packing, crating, handling, and shipping costs for ammunition. The LEA will make reimbursements directly to the USA. Ammunition will not be obtained by LEAs for the purpose of sale, lease, loan, personal use, rent, exchange, barter, transfer, or to secure a loan. Ammunition obtained via the program shall not be sold. Ammunition will be treated as a consumable item and not tracked in any DLA inventory system or inspected during PCRs. LESO shall track and maintain necessary records of ammunition that has been transferred to LEAs and will post all requests, approvals, and denials on the LESO public website.

#### d) Small arms:

i) Small arms will not be obtained by LEAs for the purpose of sale, lease, loan, personal use, rent, exchange, barter, transfer, or to secure a loan and shall be returned to DLA Disp Svcs at the end of their useful life. Cannibalization of small arms is not authorized.

ii) Temporary modifications to small arms are authorized; permanent modifications to small arms are not authorized (i.e., drilling holes in the lower receiver of a small arm). In cases of temporary modifications, all parts are to be retained and accounted for in a secured location under the original serial number for the small arm until final disposition is determined. If the modified small arm is transferred to another LEA, all parts will accompany the small arm to the receiving LEA.

iii) Small arms will be issued utilizing an acceptable ECR which obtains certain information about the property being issued to include (but is not limited to) the signature of the law enforcement officer who is accepting responsibility for the small arm(s), the serial number of the small arm, the date in which the law enforcement officer took possession of the small arm, etc.

iv) Small arms that are not carried on an officer's person or in the officer's immediate physical vicinity will be secured using "two levels of physical security". Two levels of physical security meaning two distinct lockable barriers, each specifically designed to render a small arm inaccessible and unusable to unauthorized persons. Lockable barriers meeting this description may be either manual or electronic.

v) Program participants no longer requiring program small arm(s) shall request authorization to transfer the small arm to another participating LEA or request authorization to turn-in/return the small arm. Transfers and turn-in requests shall receive final approval from the LESO; small arms will not physically move until the LESO provides official notification that the approval process is complete. When turning-in small arms to Anniston Army Depot, the LEA shall follow LESO turn-in guidance.

vi) Local destruction (DEMIL) of small arms is not authorized.

vii) Lost, Stolen or Destroyed (LSD) small arms:

(1) Program participants with multiple instances of LSD small arms in a five-year window will be assessed by DLA Disp Svcs to determine if a systemic problem exists IAW DLAI 4140.11.

(2) DLA OIG investigations may be initiated if small arms are improperly disposed of or become LSD while in program inventory. The State/LEA may be required to reimburse DLA the fair market value of the small arms when negligence, willful misconduct, or a violation of the MOA between the Federal Government and the State/U.S. Territory and/or this SPO is confirmed at the conclusion of the Financial Liability Investigation of Property Loss (FLIPL).

(a) Reimbursement will be within 60-days of the completion of the FLIPL.

(b) Title will never transfer to the recipient regardless of the status of the small arm.

(c) Payments due to DLA Disp Svcs, based upon the findings of the FLIPL, may be paid by one of three methods: 1) credit card via pay.gov, 2) cashier/ business check, or 3) wire transfer.

(3) In instances of LSD small arm recovery, DoD retains title in perpetuity and the small arm shall be immediately relinquished/surrendered back to the program.

#### 11) PROGRAM COMPLIANCE REVIEWS (PCR)

#### a) The LESO shall:

i) Conduct PCRs to ensure that the SC/SPOC, and all LEAs within a State are compliant with the terms and conditions of the program as required by 10 USC § 2576a, the MOA between the Federal Government and the State/U.S. Territory and/or this SPO and any DLA Instructions and manuals regarding the program. PCRs are conducted to ensure property accountability, program compliance, and program eligibility.

ii) Conduct PCRs for participating States every 2 years, providing training to the State/LEA as needed.

iii) Reserve the right to conduct no notice PCRs, or require an annual review, or similar inspection, on a more frequent basis for any State/LEA.

iv) Intend to physically inventory 100% of property selected for review at each LEA during a PCR. The use of ECRs in lieu of physical inspection is discouraged during PCRs. Extensive use of the ECR (without prior coordination with LESO) may result in a non-compliance finding during the PCR.

v) Intend to review as much property as possible during a PCR.

(1) The goal is to review 20% of a State's overall small arms inventory.

(2) The goal for inventory selections (at LEAs selected for review) is 15% of an LEAs general property to include non-controlled property (DEMIL code A and Q6).

vi) Select LEAs not visited during the last three regularly scheduled PCR cycles (as applicable).

vii) Recommend corrective actions (which may include suspending a State/LEA from program participation) for findings of non-compliance identified during a PCR.

(1) The LESO shall issue corrective actions (with suspense dates) to the State, which will identify what is needed to rectify the identified deficiencies within the State/LEA.

(2) If the State/LEA fails to correct identified deficiencies within the LESO suspense dates, the LESO may move to restrict, suspend, or terminate the State/LEA from program participation.

(3) States found non-compliant for a PCR will be suspended for a minimum of 60-days and will not be reinstated until the State successfully passes a LESO-conducted PCR.

viii) Ensure the State/LEA understand that property shall be transferred to a participating agency with SC/SPOC and LESO approval or returned to DLA Disp Svcs when no longer needed or serviceable.

b) The State shall:

i) Assist the LESO as required, prior to, during and upon completion of the PCR.

ii) Assist in the coordination of the PCR daily schedule of events and forward the schedule to LEAs that have been selected for review.

iii) Contact LEAs that have been selected for the PCR via phone, email or in person to ensure they are aware of the schedule and are prepared for the PCR.

iv) Receive inventory selections from the LESO and forward them to the selected LEAs. The State shall ensure the LEA physically gathers the selected property in a central location (to the greatest extent possible) which will allow the LESO to physically inventory the property efficiently during the PCR.

v) Coordinate the use of any ECR with the LESO prior to the PCR.

vi) Ensure LEAs understand property shall be transferred to a participating agency with SC and LESO approval or returned to DLA Disp Svcs when deemed no longer needed or serviceable.

vii) Conduct State-level (internal) PCRs of participating LEAs to ensure property accountability, program compliance and program eligibility utilizing a PCR checklist provided by the LESO, or equivalent (for uniformity purposes).

(1) Ensure a State-level (internal) PCR of at least 8% of LEAs with program inventory is completed annually (3% of which will be focused on program participants with no controlled property). Results of the State-level (internal) PCR will be kept on-file with the State. Documentation shall be provided to the LESO for each LEA that received a State-level PCR.

(2) The State-level (internal) PCR will include, at minimum:

(a) A review of the dually-signed SPO, ensuring it is uploaded to the property accounting system.

(b) A review of the LEA application package to confirm authenticity and eligibility of the LEA.

(c) An inventory of property selected for review at each LEA.

(d) A review of each selected LEA files for any of the following which may include turn- in/transfer DD Form 1348-1A, ECR, small arm documentation, FLIPL documents, exception to policy letters, approved cannibalization requests, or other pertinent documentation as required.

(3) Request that the LESO restrict, suspend, or terminate an LEA based on findings during State- level internal PCR or due to non-compliance with terms of the MOA between the Federal Government and the State/U.S. Territory and/or this SPO, DLA Instruction/Manual or any statute or regulation regarding the program.

(4) Notify the LESO and initiate an investigation into any questionable activity or action involving property issued to a LEA that comes to the attention of the State and is otherwise within the authority of the Governor/State to investigate. Upon conclusion of any such investigation, take appropriate action and/or make appropriate recommendations on restriction, suspension, or termination of the State/LEA to the LESO. The SC may suspend or terminate a State/LEA participation in the program at any time for non-compliance.

12) ANNUAL PHYSICAL INVENTORY Each State/LEA is required to conduct an annual physical inventory of all property on the active property book and provide certification in the property accounting system. DEMIL "A" and "Q6" property records will not be closed during the annual physical inventory period. In the State of \_\_\_\_\_\_\_\_, the annual physical inventory and certification in the property accounting system process starts on July 1<sup>st</sup> and must be completed by August 31\_\_\_\_\_. The State shall:

a) Provide training to LEAs to properly conduct the annual physical inventory and complete the certification of property in the property accounting system.

b) Ensure an approved and current SPO is uploaded in the property accounting system for each LEA.

c) Validate the annual physical inventory certifications submitted by LEAs.

d) Adhere to annual physical inventory certification requirements as identified by the LESO. Physical inventories and certification statements will be maintained on file IAW the DLA records schedule.

e) Annually certify property is utilized and is within allocation limits IAW the MOA between the Federal Government and the State/U.S. Territory and this SPO.

f) Recommend suspension of program participants who fail to complete or submit the certified annual physical inventory.

#### 13) REPORTING LOST, STOLEN, OR DESTROYED (LSD) PROPERTY Any property identified as LSD

on a LEA current inventory, shall be reported to the State/LESO. A FLIPL (aka the DD Form 200) shall be submitted to the State/LESO for LSD property. Program participants agree to cooperate with investigations into LSD property by any federal, state, or local investigative body and, when requested, assist with recovery of LSD property.

a) LSD controlled property shall be reported to the State/LESO within 24-hours. Program participants may be required to provide their SC/SPOC additional documentation which may include (but is not limited to):

1) Comprehensive police report, 2) NCIC report/entry, and 3) Contact information for the Civilian Governing Body (CGB) over the LEA involved, to include: Title, Name, Email, and mailing address.

b) LSD property with a DEMIL code of "A" and "Q6" shall be reported to the State/LESO within 7-days.

14) RESTRICTION, SUSPENSION OR TERMINATION Program participants are required to abide by the terms and conditions of the MOA between the Federal Government and the State/U.S. Territory and this SPO in order to maintain active program participation status. If a State/LEA fails to comply with any term or condition of the MOA, SPO, DLA Instruction or Manual, federal statute or regulation, the State/LEA may be suspended, terminated, or placed on restricted status. Restriction, suspension, or termination notifications will be in writing and will identify remedial measures required for reinstatement (if applicable). *Suspension*-A specified period in which an entire State/LEA is prohibited from requesting or receiving additional property through the program. Additional requirements may be implemented, to include the State/LEA requirement to return specifically identified controlled property. Suspensions will be for a minimum of 60-days. *Termination*-The removal of a State/LEA from program participation. The terminated State/LEA shall transfer or turn-in all controlled property previously received through the program at the expense of the State/LEA involved. *Restricted Status*-A specified period in which a State/LEA isolated issues with the identified item or commodity. Restricted status may also include restricting a State/LEA from all controlled property.

a) State termination-The SC/SPOC will coordinate with LESO to identify a realistic timeframe to complete the transfer or turn-in of all property. The LESO retains final authority to determine timeframe requirements.

b) LEA termination-The SC/SPOC will coordinate with LESO to identify a realistic timeframe to complete the transfer or turn-in of all property. The LESO retains final authority to determine timeframe requirements.

c) In the event of a termination, the State/LEA will make every attempt to transfer the property of the terminated State/LEA to an authorized State/LEA, as applicable, prior to requesting a turn-in of the property to DLA Disp Svcs. In cases that require a repossession or turn-in of property, the State/LEA will bear all expenses related to the repossession, turn-in or transfer of property to DLA Disp Svcs.

d) The State shall:

i) Suspend LEAs for a minimum of 60-days in all situations relating to the suspected or actual abuse of property or requirements and/or repeated non-compliance related to the terms and conditions of this SPO. Suspension may lead to termination. The State shall also issue corrective action guidance to the LEA with

suspense dates to rectify issues and/or discrepancies that caused the restriction, suspension, or termination. The State shall require the LEA to submit results on completed police investigations and/or reports on LSD property to include the LEA CAP. The LESO retains final discretion on reinstatement requests. Reinstatement to full participation from a restriction, suspension or termination is not automatic.

ii) Initiate corrective action to rectify suspensions or terminations of the LEA for non-compliance to the terms and conditions of the program. The State shall also make contact (until resolved) with suspended LEAs to ensure corrective actions are rectified within required timeframes provided by the LESO.

iii)Require the LEA to complete and submit results on completed police investigations or reports regarding LSD property. The State will submit all documentation to LESO upon receipt.

iv) Provide documentation to LESO when actionable items are rectified for the State/LEA.

v) Request that the LESO suspend or terminate an LEA based upon their findings during State-level internal PCR or due to non-compliance with any term of this SPO, DLA Instruction/Manual or any statute or regulation regarding the program.

vi) Notify the LESO and initiate an investigation into any questionable activity or action involving property issued to an LEA that comes to the attention of the State and is otherwise within the authority of the Governor/State to investigate. Upon conclusion of any such investigation, take appropriate action and/or make appropriate recommendations on restriction, suspension, or termination of the LEA to the LESO. The SC may revoke or terminate concurrence for LEA participation in the program at any time.

vii) Provide written request to the LESO for reinstatement of an LEA for full participation status at the conclusion of a restriction or suspension period. Written verification shall be provided that the SC/SPOC has validated the LEA CAP.

**15) RECORDS MANAGEMENT** The LESO, SC/SPOC, and LEAs participating in the program will maintain program records IAW the DLA records schedule. Records for property acquired through the program have retention controls based on the DEMIL code. Property records will be filed, retained, and destroyed IAW DLA records schedule. Records may include but are not limited to: DD Form 1348-1A for transfers, turn-ins, requisitions, Bureau of Alcohol, Tobacco, Firearms and Explosives (BATFE) Forms 5 and 10.

#### 16) TRADE SECURITY CONTROL (TSC) and COMPLIANCE WITH EXPORT CONTROL

**REGULATIONS** Items transferred to program participants, including DEMIL A and Q (with an Integrity Code of 6) property, may be subject to export control restrictions. Program participants shall comply with U.S. export control laws and regulations if they contemplate further transfers of any property. Once title transfers, LEAs should consult with the Department of State (DoS) and Department of Commerce (DoC) export control regulators about the type of export controls that may apply to items, regardless of DEMIL code. Program participants may request a formal Commodity Classification from the DoC, Bureau of Industry and Security (BIS), or submit a general correspondence request to the DoS, Directorate of Defense Trade Controls. Information on managing exports of CCL items can be found at the U.S. DoC Bureau of Industry and Security website. Program participants shall notify all subsequent purchasers or transferees, in writing, of their responsibility to comply with U.S. export control laws and regulations.

17) NOTICES Any notices, communications, or correspondence related to this SPO shall be provided by email, the U.S. Postal Service (USPS), express service, or facsimile to the appropriate DLA office. The LESO may (from time to time) make unilateral modifications or amendments to the provisions of the MOA between the Federal Government and the State/U.S. Territory and/or this SPO. Notice of these changes will be provided to the State in writing. Unless the State takes immediate action to terminate the MOA between the Federal Government and the State/U.S. Territory and/or this SPO, such modifications or amendments will become binding. In such cases, reasonable opportunity will (insofar as practicable) be afforded the State/LEA to conform to changes affecting their operations.

**18)** ANTI-DISCRIMINATION By signing or accepting property, the State/LEA pledges agreement to comply with provisions of the national policies prohibiting discrimination: 1) On the basis of race, color, or national origin, in Title VI of the Civil Rights Act of 1964 (42 USC 2000d et seq.) as implemented by DoD regulations 32 CR Part 195, 2)On the basis of age, in the Age Discrimination Act of 1975 (42 USC 6101, et seq) as implemented by Department of Health and Human Services regulations in 45 CFR Part 90 and 3) On the basis of handicap, in Section 504 of the Rehabilitation Act of 1973, P.L. 93-112, as amended by the Rehabilitation Act Amendments of 1974, P.L. 93-516 (29 USC 794), as implemented by Department of Justice (DoJ) regulations in 28 CFR Part

41 and DoD regulations at 32 CFR Part 56. These elements are the minimum essential ingredients for establishment of a satisfactory business agreement between the State and the DoD.

**19) INDEMNIFICATION CLAUSE** The State/LEA is required to maintain adequate liability insurance to cover damages or injuries to persons or property relating to the use of property issued under the program. Self-insurance by the State/LEA is considered acceptable. The USG assumes no liability for damages or injuries to any person(s) or property arising from the use of property issued under the program. It is recognized that State and local law generally limit or preclude the State/LEA from agreeing to open ended indemnity provisions. However, to the extent permitted by State and local laws, the State/LEA shall indemnify and hold the USG harmless from any and all actions, claims, debts, demands, judgments, liabilities, cost, and attorney's fees arising out of, claimed on account of, or in any manner predicated upon loss of, or damage to property and injuries, illness or disabilities to, or death of any and all persons whatsoever, including members of the general public, or to the property of any legal or political entity including States, local and interstate bodies, in any manner caused by or contributed to by the State/LEA, its agents, servants, employees after the property has been removed from USG control.

**20) TERMINATION** This SPO may be terminated by either party, provided the other party receives a thirty (30) day notice (in writing) or as otherwise stipulated by Public Law. The undersigned SC hereby agrees to comply with all provisions set forth herein and acknowledges that any violation of the terms and conditions of this SPO may be grounds for immediate termination and possible legal consequences, to include pursuit of criminal prosecution if so warranted.

Technology advances allow us to do things in a much better way. Manhole covers were always made with cast iron. They were extremely heavy making it difficult to handle. These covers are seldom able to be removed by hand. They require machinery to lift them. Additionally, they are brittle and most of the time break when we try to remove them and then we have to replace the cover. Composite ones are now available that are lighter but still strong to hold the weight of vehicles. We utilize SuperCover Composite Manhole Covers and Rings and want this to be the standard required so they are all uniform.

Additionally, the language on encasing water lines was vague and not complete so we are updating it to be clear so there is no misunderstanding.

I recommend approval.

Sec. 38-79 Sewers, (j) *Manholes.* Manholes shall be fiberglass with a cast iron ring and cover **SuperCover Composite Manhole Cover and Ring or comparable as approved by the City**. There shall be a manhole approximately every 400 feet or less, and at strategic locations and when the sewer line changes direction more than 20 degrees.

Sec. 38-80 Utility lines, All utility lines that are underground and run under a street or alley shall be installed by the developer and approved by the city before the street or alley is paved. When it is necessary that utility lines pass under the street or alley pavement crossing the centerline, they shall be installed to a point of at least three feet beyond the edge of the pavement. Water lines, main or lateral may not be encased unless meeting TCEQ separation requirements. Main or lateral water lines are not required to be encased unless specifically required by the City, TCEQ, TXDOT or other relevant entity. All underground utilities installed in a utility easement at the rear of the lot shall be offset from the property line.

SECTION 2. That all ordinances that are in conflict with the provisions of this ordinance are hereby repealed.

SECTION 3. Should any paragraph, sentence, subdivision, clause, phrase, or section of this ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this ordinance as a whole or any part of provision thereof, other than the part so declared to be invalid, illegal or unconstitutional.

SECTION 4. This Ordinance shall take effect after the final reading and when caption of Ordinance has been published in the official newspaper of the City.

# LOS FRESNOS

Item Title:

Consideration and ACTION to approve the first reading of an ordinance providing an amendment to the Los Fresnos Code of Ordinance Chapter 44-Utlities, Article I. General, Sec. 44-13. Services Rates and Other Charges; Billing and Collection; providing repealer, severability, and effective date.

#### **Recommendation:**

This was approved last meeting. This is what was discussed.

The City continues to have numerous problems with wastewater service outside of the city limits.

As I have reported to the Council before, each time we receive a large rain that causes any flooding at all in primarily the Laureles area, the wastewater system becomes inundated with rain water that leaks or drains into our sewer system. In a few cases our manhole lids leak for one reason or the other but almost every time, someone has removed their cap to their cleanout thus allowing the flood water to drain into our system. Our sewer system is not designed to handle flows from rain water or flooding. Drainage in this area is the responsibility of Cameron County Drainage District # 4 and Cameron County. We have no control over drainage and no authority to fix it but yet we get blamed for the problems with the resident's sewer not working, backing up and smelling.

Additionally, there has been tremendous growth in the Laureles area. The existing lift stations and lines area nearing capacity. Subdivisions have already been approved and the developer has paid for future connections in these subdivisions. Not all homes have been built yet so we have to leave some room for those as they get built. Once all this is completely built out we will be very close to capacity.

Taking this action would mean the people would utilize septic tank systems like are utilized in any area where city sewer is not available.

Due to these 2 reasons, I recommend the City not approve any more wastewater connections in areas outside the city limits of Los Fresnos with city staff following this decision but allowing individual appeals to be made to the Planning & Zoning and then the City Council.

This just places the action taken properly into the ordinance so it can be enacted and followed.

I recommend approval.

**SECTION 1.** Chapter 44-Utilities, Article I. General, Sec. 44-13. Service rates and other charges; billing and collection, in the Code of Ordinances of the City of Los Fresnos, Texas is hereby amended to reflect as follows:

#### ADD in red

#### Sec. 44-13. Service rates and other charges; billing and collection.

- a) *Generally; exceptions.* The rates for furnishing water and sewer service inside and outside the city limits shall be calculated, charged, billed and collected as provided in the city fee schedule.
- b) Free service prohibited. No free service shall be allowed, and to the extent that the city or any of its agencies or instrumentalities shall avail themselves of the services and facilities afforded by the systems, they shall pay therefor the same rates and charges prescribed in the city fee schedule.
- c) Service outside city limits. Water and sewer service may be furnished outside the corporate limits of the city only in the event the city is able to do so without detriment to consumers within the city limits, upon terms and conditions as may be determined by the city council in the best interests of the city.
  - i. *Wastewater connections outside city limits*. Additional wastewater connections by individuals outside the city limits of Los Fresnos shall no longer be allowed. However, individuals may appeal to the Planning and Zoning Commission and subsequently to the City Council in writing if they can provide sufficient evidence demonstrating that the proposed connection will not negatively impact the existing wastewater system or service to current users within the city limits. The final decision shall rest with the City Council, based on the merits of the information presented and in consideration of the best interests of the City.

**SECTION 2. REPEALER** All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

**SECTION 3. SEVERABILITY.** In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction. It shall not effect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Los Fresnos, Texas, declares that it would have passed.

**SECTION 4**. **EFFECTIVE DATE.** This Ordinance shall take effect after the final reading and when caption of Ordinance has been published in the official newspaper of the City.

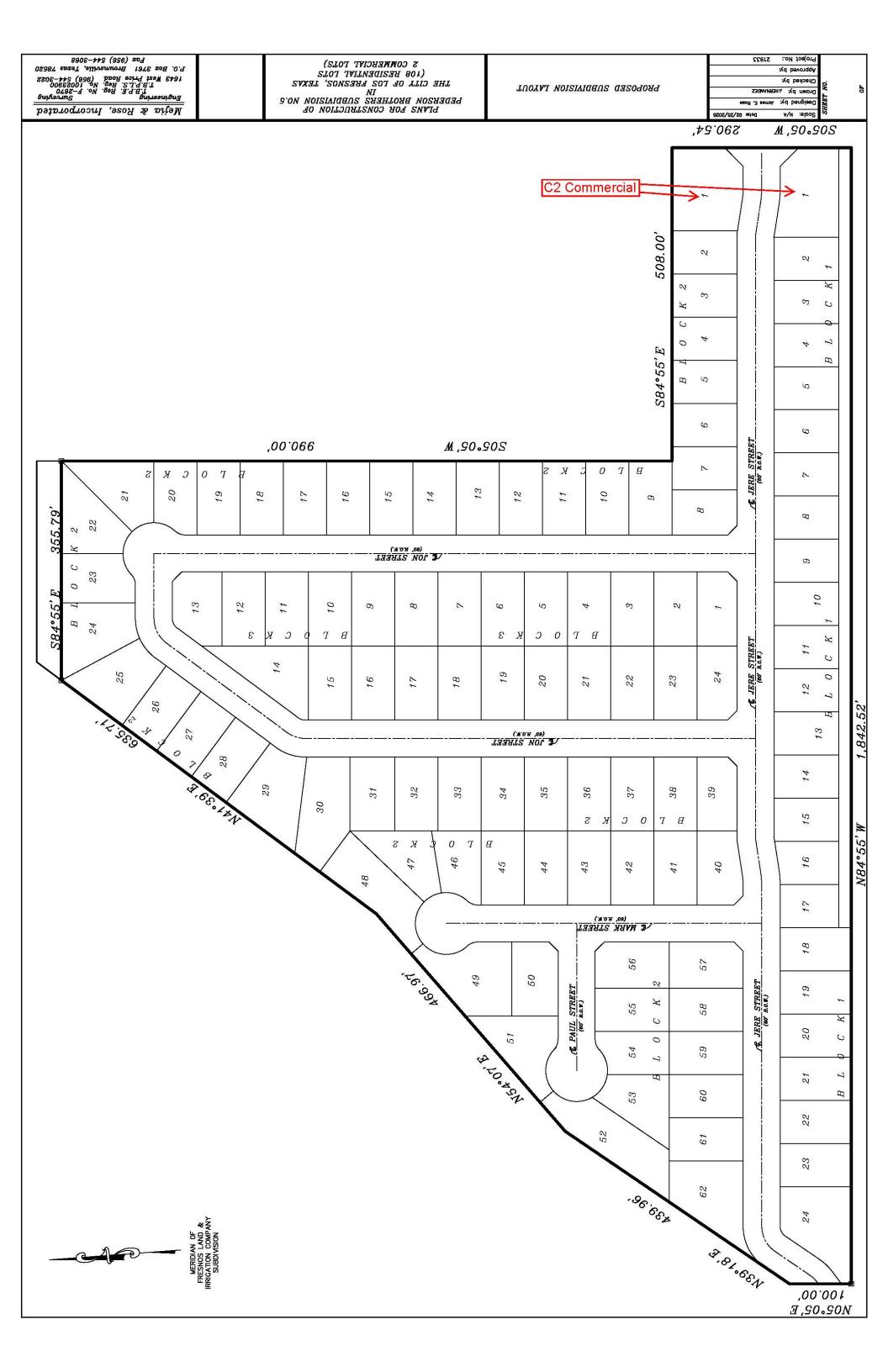

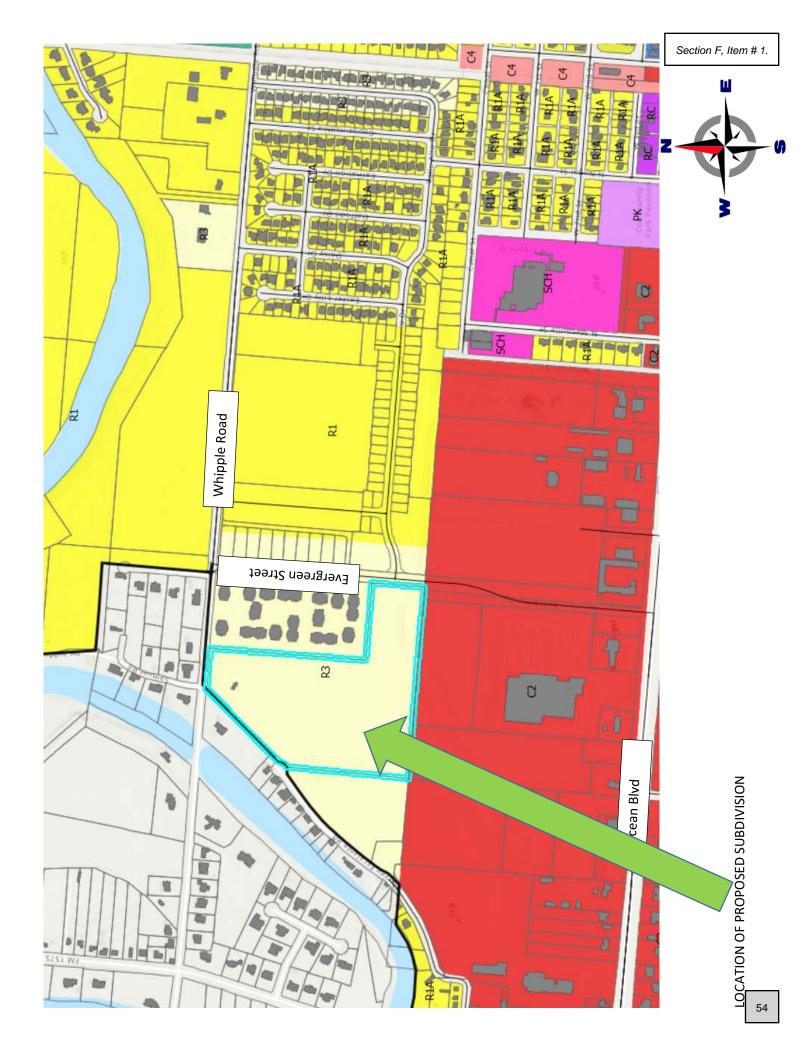

Consideration and ACTION to approve a service agreement with Greer and Associates, Inc., A Spire Risk Management Co.

#### **Recommendation:**

Greer & Associates has been handling our insurance for many years, prior to when I was hired. They have been instrumental in keeping our insurance rates more in check than most businesses have experienced. They continually look out for the best interest of the City, combining the need for the City to keep expenses low to help better manage our expenses along with the City's desire to provide great benefit for our employees. They provide superior support to our staff in managing the insurance for the city as well as supporting each employee as the need arises with specific issues that arise in their individual situations. Each year as we approve insurance for employees, we automatically designate Greer & Associates as our agent of record. The city does not pay them directly for their services. They get funding through the particular insurance company. While we have followed this in principle, it was not written down.

This provides a document to protect the City and them by having a written document.

I recommend approval.

# City of Los Fresnos Service Agreement

The City of Los Fresnos, Cameron County, Texas, a municipal corporation ("City"), and Greer and Associates, Inc., A Spire Risk Management Co. ("Agents of Record"), are the Parties to this Agreement with an effective date of October 1, 2024.

#### RECITALS

WHEREAS, City wishes to obtain the assistance of Agents of Record to include agent services with strategic benefit planning, design, administration, and communication with respect to its employee ancillary programs; insurance benefits.

WHEREAS, Agents of Record have superior knowledge and expertise in assisting employers with designing and servicing employee insurance plans; and

WHEREAS, the Parties wish to set forth their respective expectations;

**NOW**, **THEREFORE**, for and in consideration of the mutual covenants and promises in this Agreement and of the faithful performance of such covenants and conditions, the City and Agents of Record agree as follows:

#### SECTION I

#### Scope of Services to be Provided by Agents of Record

- 1. Agents of Record, subject to the terms of this Agreement, shall provide the below services. Agents of Record shall render the Services in a diligent, careful, thorough, and professional manner consistent with good business practice and shall at all times provide the City with the soundest and reasonable recommendations and advice. Time shall be of the essence with respect to all matters set forth in this Agreement.
  - a. Serve the City as an agent regarding the supplemental insurance to include Group Health, Vision, Dental, and Permanent Universal Life.
  - b. Review, on an ongoing basis, the existing employee insurance programs for competitiveness, appropriateness, and overall acceptance by plan participants.
  - c. Prepare a working summary for the City of each policy including key terms, conditions, and endorsements, and maintain summary up to date (outline will be approved by the City's Manager).
  - d. Assist the City in preparing and presenting periodic reports to the City Council, City Manager on the progress, applicability, and overall benefit of a specific plan.
  - e. Review new methods to determine the most effective and efficient service delivery strategies.
  - f. Assist the City with Premium renewals during its annual budget process.
  - g. Provide the City with Customer service, renewal negotiations, billings administration, transition, and implementation of voluntary plans employee benefits platform.
  - h. Collect information and making periodic presentations to staff, employees, and City Council, as requested, of insurance companies.

- i. Provide periodic comparisons of plans of benefits and employer/employee contributions to area cities and comparable businesses.
- j. Provide periodic reports using carrier data on claims and fixed expenses, and relate those to total premium and expectations for renewal.
- k. Add historical perspective to premium and claims data for all coverage and provide reports as needed by the City.
- I. Meet periodically with the City's staff relating to levels of customer service received from various carriers, and where required intercede with both parties to assist in problem resolution.

# SECTION II

# Information, Disclosure, and Record Keeping

- City has the right to approve the hiring or utilization of any third-party entities or other intermediaries in connection with, arising out of, or in any way related to City's insurance and employee benefits management program. Agents of Records must seek written approval from the City prior to the use of any of the above in connection with the City's employee benefits management program. City shall promptly notify Agents of Record whether to approve or not approve such third-party entity or other intermediary, recognizing that time is of the essence.
- Agents of Record will maintain accurate and current files, including but not limited to insurance policies and correspondence with insurers or Agents of Record, related to the services performed under this Agreement for a minimum of five (5) years. In connection with the performance of the services by Agents of Record, Agents of Record agree to promptly and fully disclose to City any information regarding the services as City may request.
- 3. All work product, including but not limited to reports, plans, drawings, tracings, sketches, photographs, videos, illustrations, presentations, PowerPoint, specifications, maps, computer files, electronic data, and other documents (electronic or paper) prepared or created in the course of the performance of the services or obtained in the performance of this Agreement, as well as all data collected, together with summaries and chars derived therefrom, will be considered works made for hire and shall be the exclusive property of the City upon their creation without restriction or limitation on their use and will be made available, upon request, to the City at any time during the performance of such services.
- 4. When requested by Agents of Record, City agrees to provide information reasonable available to the City and pertinent to the services provided by Agents of Record to the City.

# SECTION III

# Confidentiality of Information and Security

 Agents of Record shall take reasonable efforts to keep all City and related employee information confidential in accordance with normal operating procedures and industry standards. Agents of Record do not guarantee the security of any third party entities or intermediaries, and City agrees that Agents of Record shall not be liable for any breach of confidentiality, loss, or theft of any records, data, files, or other information held by third party entities or intermediaries. Agents of Record shall follow written instructions from City as to policy and procedure.

#### SECTION IV

#### Terms and Termination

- 1. This Agreement shall commence as of the Effective Date for an Initial Term of one year. The term of this Agreement shall automatically renew on each successive anniversary of the Effective Date (the "Anniversary Date") for an additional term of one year, unless otherwise terminated as allowed in this Agreement.
- 2. City or Agents of Record may terminate this Agreement upon giving 30 days' prior written notice to all parties. IN addition, City shall have the right, upon written notice, to cancel this Agreement immediately if, in the City's sole judgment, the Services rendered by Contractor breach or violate any of the provisions of this Agreement.
- 3. After such termination, this Agreement will continue to govern the parties' rights and obligations regarding the services and work performed before the termination. The terms and conditions in this Agreement that by their sense and context are intended to survive the performance hereof by either or both parties hereunder shall so survive the termination, cancellation, or completion of performance of this Agreement.
- 4. Upon termination of this Agreement or at such other time as may be requested by City, Agents of Record shall return to City within ten (10) days of termination or request all documents, records, notebooks, including copies thereof, whether prepared by Agents of Record or others, in Agents' of Record possession and related to the services.
- 5. Upon termination of this Agreement, the City may take over the work and may obtain the services of another entity.
- 6. City acknowledges that products and services provided through third party entities and intermediaries may be terminated by those entities or intermediaries at any time without notice and that Agents of Record are not responsible for any termination of services by third party entities or intermediaries.

# SECTION V

# Cost of Services

1. Agents of Record will receive compensation or commission from insurance carriers and insurance vendors for the services rendered under this contract. Agents of Record agree that, in no event, shall the City be responsible for any compensation or commission for which Agents or Record are unable to collect from or are in dispute with insurance carriers and insurance vendors.

 Agents of Record consent to the City requesting from the insurance carriers and insurance vendors' confirmation of all fees paid to Agents of Record arising out or related to the City's insurance coverages during the term of this Agreement. Agents of Record agree to execute any required documents or otherwise perform as needed to facilitate City's request.

#### SECTION VI

#### Personnel

1. Agents of Record will assign their personnel according to the needs of City and according to the disciplines required to complete the appointed task (s) in a professional manner. Agents of Record retain the right to substitute personnel with reasonable cause.

#### SECTION VII

#### Independent Contractor

1. Agents of Record acknowledge and agree that they are independent contractors of the City and are not employees of the City. Agents of Record more specifically acknowledge that it's employees will not be covered by the City's workers' compensation insurance; and Agents of Record will be solely and exclusively responsive for payment of all federal and state income taxes due in respect of all compensation and/or other consideration paid by the city of Agents of Record under this Agreement. Agents of Record shall be responsible for social security, unemployment and disability taxes and all other payroll taxes due with respect to Agents' of Record employees who provide services under this Agreement. Agents of Record acknowledge that they shall have no authority to bind City to any contractual or other obligation whatsoever. Agents of Record shall be entitled to seek and accept other engagements and/or employment during the term of this Agreement so long as such other employment or engagements do not interfere with the performance of Agents' of Record duties under this Agreement. Agents of Record shall be responsible to the City for all work or services performed by Agents of Record or any person or firm engaged as a subconsultant or subcontractor to perform work in fulfillment of this Agreement.

#### SECTION VIII

#### **Limitations**

- 1. City acknowledges that:
  - a. Agents of Record have no authority or control over management of any of the employee benefit plans;
  - b. Agents of Record have no authority or control with respect to management or disposition of the assets of City's employee benefit plans;
  - c. Agents of Record shall perform services pursuant to this Agreement in a non-fiduciary capacity;

- d. Agents of Record are not in the business of providing legal services and cannot represent City in a legal dispute or propose or amend employee benefit plans; and
- e. Agents of Record are not in the business of providing tax advice or services, and cannot represent City in a tax related dispute.
- 2. City agrees to notify Agents of Record as soon as possible of any proposed amendments to the plans' legal documents to the extent that City reasonably believes the amendments would affect Agents of Record in the performance of their obligations under this agreement.

#### SECTION IX

#### <u>Notices</u>

 Any notices to be given under this Agreement shall be in writing, (i) sent by registered or certified mail, postage prepaid, return receipt requested or (ii) sent by nationally recognized overnight courier (e.g. Federal Express) with electronic tracking, and addressed to such party as follows:

# SECTION X Indemnification and Limitation of Liability

- The City agrees to indemnify, defend and hold harmless Agents of Record against and from any liability, expense (including reasonable attorney fees), and claims for damages or relief, of any nature whatsoever, which may be asserted against Agents of Record as a result of or arising out of (a) any acts, errors, or omissions of the City, or its employees and (b) any breach of this Agreement by the City. The City's duties to defend, indemnify and hold harmless Agents of Record shall extend beyond the termination of this Agreement.
- 2. To the maximum extent allowed by law, Agents of Record agree to and shall indemnify, hold harmless, and defend City, its officers, agents, and employees from any and all claims, losses, causes of action and damages, suits and liability of every kind, including all expenses of litigation, court costs, and attorney's fees arising out of or directly connected with the negligent or willful conduct of Agents of Record, its agents, officers, and employees in connection with the services under this agreement.
- 3. The Parties agree that none shall be liable to any other for any indirect, incidental, special, or consequential punitive or multiple damages, including without limitation any damages resulting from loss of use, loss of business, loss of revenue, loss of profits, or loss of data, arising in connection with the Agreement, performance of services, or of any other obligations relating to this Agreement, even if any of the Parties have been advised of the possibility of such damages. The foregoing limitation of liability shall apply to the

maximum extent allowed by law for limitation of each of the Parties' liability, regardless of the cause of action under which such damages are sought.

#### SECTION XI

#### Alternate Dispute Resolution

- If any dispute, controversy, or claim between or among the Parties arises under this Agreement or is related in any way to this Agreement or the relationship of the Parties hereunder (a "Dispute"), the Parties shall first attempt in good faith to settle and resolve such Dispute by meeting at a mutually agreeable time and place to discuss the Dispute within seven (7) days following the original written notice of any Dispute by the party making such a claim. The Parties shall seek to resolve the Dispute in writing within fourteen (14) days following the original written notice of any Dispute by the party making such a claim.
- 2. If a mutual resolution and settlement are not obtained at the meeting, the Parties shall participate in good faith in formal mediation, within thirty (30) days following the original written notice of any Dispute, with a mutually agreeable mediator at a mutually agreeable time and place. No settlement reached under this provision shall be binding on the Parties until reduced to a writing signed by a representative of Contractor and the City Manager. Unless the parties expressly agree otherwise, each party shall bear its own costs and legal and expert fees incurred in the mediation, and evenly share the costs of the mediator. If after proceeding in good faith the parties, with the assistance of a neutral mediator, do not resolve the dispute within forty-five (45) days following the original written notice of any Dispute, the parties may proceed in accordance with Section IX below.

#### SECTION XII

#### Controlling Law, Mandatory Venue, and Fees and Expenses

- After exhausting the procedures set forth above, either party may initiate litigation to resolve the dispute. The Law of the State of Texas shall control the Dispute. Venue is mandatory in State courts located in Cameron County, Texas.
- 2. In the event of any litigation between the parties, the parties shall bear their own costs including attorney's fees, costs, and expenses.

#### SECTION XIII

#### Agreement Construction

1. The headings of the Sections contained in this Agreement are for reference purposes only, and shall not affect the meaning or interpretation of this Agreement. The parties have been advised by counsel in connection with this Agreement. This Agreement shall be construed and interpreted in accordance with the plain meaning of its language, and not for or against either party, and as a whole, giving effect to all of the

terms, conditions, and provisions of this Agreement. Nothing contained in this Agreement shall be deemed to confer any right or benefit on any person who is not a party to this Agreement.

#### SECTION XIV

#### No Pending Litigation

1. Contractor represents that there is no action, proceeding, inquiry, or investigation, at law or in equity, before any court, arbitrator, governmental or other board or official, pending to the best knowledge of Contractor threated against or affecting the Contractor or any subsidiaries of the Contractor, questioning the validity or any action taken or to be taken by the Contractor in connection with the execution, delivery and performance by the Contractor of this Agreement to which the Contractor may be a party or seeking to prohibit, restrain, or enjoin the execution, delivery or performance by the Contractor hereof or thereof, where in an unfavorable decision, ruling, or finding (i) would adversely affect the validity or enforceability of, or the authority of ability of the Contractor to perform, its obligations under this Agreement to which the contractor may be party or (ii) would have an adverse effect on the consolidated financial condition or results of operations of the Contractor or on the ability of the Contractor to conduct its business as presently conducted or as proposed or contemplated to be conducted.

# SECTION XV

#### **Severability**

1. If any term or provision of this Agreement is held by a court of competent jurisdiction to be invalid, void, or unenforceable, the remainder of the provisions of this Agreement shall remain in full force and effect and shall in no way be affected, impaired or invalidated.

# SECTION XVI

#### Successors and Assigns

1. City and Contractor each bind themselves, their partners, successors, executors, administrators, and assigns to the other party of the Agreement in respect to all covenants of this Agreement. Neither City nor Contractor shall assign, sublet, or transfer interest in this Agreement without written consent of the other.

# SECTION XVII

# **Conflict of Terms**

1. If any of the terms of this Agreement conflict in any respect with any of the terms of the attached Exhibits or any current or future Task Orders (including exhibits), the terms of this Agreement shall be controlling.

#### SECTION XVIII

#### No Waivers or Accord and Satisfaction

- 1. This Agreement may be amended only by written instrument signed by all parties.
- 2. No failure or delay of the City, in any one or more instances (i) in exercising any power, right, or remedy under this Agreement or (ii) in insisting upon the strict performance by Contractor of its covenants, obligations, or agreements under this Agreement, shall operate as a waiver, discharge, or invalidation thereof, nor shall any single or partial exercise of any such right, power or remedy or insistence on strict performance, or any abandonment or discontinuance of steps to enforce such as right, power, or remedy or to enforce strict performance, preclude any other or future exercise thereof or insistence thereupon or the exercise of any other right, power, or remedy. The covenants, obligations, and agreements of Contractor and the rights and remedies of the City upon a default shall continue and remain in full force and effect with respect to any subsequent breach, act or omission.
- 3. Without limiting the generality of the above, the receipt by City of any Services with knowledge of a breach by Contractor of any covenant, obligation, or agreement under this Agreement shall not be deemed or construed to be a waiver of such breach. No acceptance of Services or payment to Contractor shall be deemed to be other than on account of the earliest installment of the amounts due under this Agreement, nor shall any endorsement or statement on any check, or any letter accompanying any check, wire transfer or other payment, be deemed an accord and satisfaction. City may accept services or make payment without prejudice to its rights under this Agreement or pursue any remedy provided in this Agreement or provided otherwise by law or equity.

#### SECTION IXX

#### Minimum Insurance Requirements

Contractor shall be adequately insured and carry liability, workers' compensation, automobile insurance and professional liability for injury to its employees and others incurring loss or injury as a result of the acts of contractor or its employees. In accordance with City ordinances, Contractor shall be required to hold the following minimum insurance coverage throughout the duration of this agreement:

- A. Workers Compensation In accordance with State statute.
- B. Comprehensive General Liability
  - 1. Bodily Injury

- 2. Property Damage
- C. Comprehensive Auto Liability
  - 1. Bodily Injury
  - 2. Property Damage
- Or
  - D. Professional Liability
    - 1. Professional
  - E. Evidence of the above insurance coverage is attached as Exhibit "A" and the City of Los Fresnos shall be listed as an additional insured.
  - F. If at any time and for any reason Contractor fails to provide, maintain, keep in force and effect, or deliver to the City proof of, any of the insurance required and such failure continues for then (10) days after Notice thereof from City to Contractor, City may, but shall have no obligation to , procure single interest insurance for such risks covering City (or, if no more expensive, the insurance required by this Agreement), and Contractor shall, within ten (10) days following City's demand and Notice, pay and reimburse City therefor with interest at Prime Rate plus 2%, the Prime Rate being that in place on the date of Notice, from the date of payment by the City until repayment of City in full by Contractor.
  - G. With respect to each and every one of the insurance policies required to be obtained, kept, or maintained under the terms of this Agreement, on or before the date on which each such policy is required to be first obtained and at least fifteen (15) days before the expiration of any policy required hereunder previously obtained, Contractor shall deliver evidence reasonably acceptable to City showing that such insurance is in full force and effect.
  - H. Contractor hereby agrees as follows:
    - To punctually pay or cause to be paid all premiums and other sums payable under each insurance policy required to be obtained, kept, and maintained pursuant to this Lease;
    - 2. To maintain in full force and effect the policies required to be carried to the extent so required to be carried pursuant to the terms hereof;
    - To endure that all Casualty Proceeds are paid to the Party entitled to receive same;

4. Not, at any time, to take any action (or omit to take action) which action (or omission) would cause any insurance policies required to be obtained, kept, and maintained under this Lease to become void, voidable, unenforceable, suspended, or impaired in whole or in part of which would otherwise cause any sum paid out under any such insurance policy to become repayable in whole or in part; and

Promptly deliver Notice to City of any facts or circumstances of which it is aware which, if not disclosed to its insurers or re-insurers, is likely to affect adversely the nature or extent of the coverage to be provided under any insurance policy required hereunder.

# SECTION XX

#### Representations and Warranties

- 1. Agents of Record represent that they are duly licensed to perform the services under this Agreement and that they will continue to maintain all licensed and approvals required to conduct business.
- 2. Agents of Record warrants that they have not employed or retained any company or person, other than a bona fide employee working solely for Agents of Record, to solicit or secure this Agreement and that they have not paid or agreed to pay any person, company, corporation, individual, or firm, other than a bona fide employee working solely for Agents of Record, any fee, commission, percentage, gift, or any other consideration contingent upon or resulting from the award or making of this Agreement. In the event of a breach or violation of this provision by Agents of Record, the City shall have the right to terminate the Agreement and to recover, the full amount of such fee, commission, percentage, gift, or consideration.
- 3. In the conduct of the services under this Agreement, Agents of Record shall comply in all material respects with all applicable federal and state laws and regulations and all applicable county and City ordinances and regulations.

# SECTION XXI

# Ethics and Conflicts of Interest

- 1. Agents of Record represent that they have not given or accepted a kickback in relation to this Agreement and have not solicited this Agreement by payment or acceptance of a gratuity or offer of employment.
- 2. Agents of Record represents that they have not solicited this contract by payment of a gift or gratuity of offer of employment to any official, employee of the City or any City agency or selection committee.

- 3. Agents of Record represents that they did not employ, directly or indirectly, the mayor, members of the city council or any official, department director, head of any City agency, or member of any board, committee or agency of the City.
- 4. Agents of Record represent that they have not knowingly given, directly or indirectly, any gift with a value greater than \$100 in the aggregate in any calendar year to the mayor, members of the city council, any department director or head of any city agency, any employee of the city or any city agency, or any member of a board that provides regulation, oversight, management or policy-setting recommendations regarding Agents of Record or its business.
- Agents of Record represent that they presently have no interest and shall acquire no interest, either direct or indirect, which would conflict in any manner with its performance under this Agreement. Agents of Record further represents that no person having any interest shall be employed or engaged by it for said services.
- 6. Agents of Record, its officers, personnel, subsidiaries and subcontractors shall not have or hold any continuing or frequently recurring employment, contractual relationship, business association or other circumstance which may influence or appear to influence Agents of Record's exercise of judgment or quality of the Services being provided under this Agreement. Agents of Record, their officers, personnel, subsidiaries and subcontractors shall not perform consulting work for any third party that would in any way be in conflict with the services to be provided to the City under this Agreement.

#### Item Title:

Consideration and ACTION to approve the first reading of an ordinance providing an amendment to the Los Fresnos Code of Ordinance Chapter 10-Buisinesses, Article V. Sexual Oriented Businesses, Sec. 10-123. Definitions; providing repealer, severability and effective date.

#### **Recommendation:**

The ordinance regulating sexually oriented businesses needed some clarification of definitions including more details and specifics. We have utilized other cities as a guide for these updates.

I recommend approval.

#### **ORDINANCE 569**

# NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESNOS, TEXAS:

**SECTION 1.** Chapter 10-Businesses, Article V. Sexual Oriented Businesses, Sec. 10-123. Definitions, in the Code of Ordinances of the City of Los Fresnos, Texas is hereby amended to reflect as follows:

#### REMOVE

Sexually oriented business means an adult arcade, adult bookstore, adult video store, adult cabaret, adult motel, adult motion picture theater, adult theater, escort agency, nude model studio or sexual encounter center.

#### ADD

Sexually-oriented business means either:

- (1) An adult arcade, adult bookstore, adult cabaret, adult encounter center, adult motel, adult motion picture theater, adult theater, adult video store, nude model studio, sexual encounter center, sexually-oriented merchandise store; or any commercial enterprise for which a primary business focus is the offering of a service or the selling, renting or exhibiting of devices or any other items intended to provide sexual stimulation or sexual gratification to the customer; or
- (2) Any business which either:
  - a. Holds itself out to the public as a sexually-oriented business;
  - b. Receives a substantial portion of its gross monthly revenue from the offering of a service or the selling, renting or exhibiting of devices, such as sexually-oriented merchandise as described by this chapter, or any other items intended to provide sexual stimulation or sexual gratification to the customer; or

c. Utilizes a substantial portion of its building floor space for the offering of a service or the selling, renting or exhibiting of devices or any other items intended to provide sexual stimulation or sexual gratification to the customer.

<u>Sexually-oriented merchandise</u> means instruments or paraphernalia such as, but not limited to lap dance bags, benwa balls, dildos, genital pumps, sexually oriented vibrators, inflatable orifices, anatomical balloons with orifices, simulated and battery operated vaginas, and similar sexually-oriented devices that are designed or marketed primarily for the stimulation of or use with the stimulation of human genital organs or breasts, or for sadomasochistic activity.

<u>Sexually-oriented merchandise store</u> means a commercial establishment which has significant or substantial stock-in-trade in, derives a significant or substantial portion of its business or advertising, or maintains a substantial section of its sales or display space for the sale or rental, for any form of consideration, sexually oriented merchandise.

<u>Significant or substantial portion</u> means ten percent or greater of the total amount, measure, or duration of a referenced quantity, portion, size, or time period.

**SECTION 2. REPEALER** All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

**SECTION 3. SEVERABILITY.** In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction. It shall not effect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Los Fresnos, Texas, declares that it would have passed.

**SECTION 4**. **EFFECTIVE DATE.** This Ordinance shall take effect after the final reading and when caption of Ordinance has been published in the official newspaper of the City.

WHEREAS, the City of Los Fresnos desires to implement regulations for the sale of E-cigarettes, Hemp products and locations of Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops, defined herein, for the health, safety and general welfare of the City; and

**WHEREAS**, the City of Los Fresnos finds that adopting this ordinance promotes the health safety and wellbeing of Los Fresnos and is in the best interest of the citizens of Los Fresnos.

#### NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESNOS, TEXAS:

**SECTION 1:** Amendment of Chapter 10. Chapter 10 of the Los Fresnos Code of Ordinances is hereby amended to add the following Article IX Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops:

#### Sec. 10-250 PURPOSE

It is the purpose of this article to regulate the sale of E-Cigarettes and location of smoke lounges, Smoke/Vape shops and tobacco stores businesses to promote the health, safety and general welfare of the city residents; to protect and preserve the quality, property values, and character of the city; to prevent the concentration of smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores businesses within the city; and to minimize the potential negative impacts of smoke lounges, Smoke/Vape shops and tobacco stores businesses on residential areas, churches, schools, public areas or similar locations in which children may regularly gather.

#### Sec. 10-251 DEFINITIONS:

1. Cigarette means a roll for smoking: that is made of tobacco or tobacco mixed with another ingredient and wrapped or covered with a material other than tobacco; and that is not a cigar.

- E-cigarette an electronic cigarette or any other device that simulates smoking by using a mechanical heating element, battery, or electronic circuit to deliver nicotine or other substances to the individual inhaling from the device; or A consumable liquid solution or other material aerosolized or vaporized during the use of an electronic cigarette or other device described by this subdivision.
  - a. The term "e-cigarette" does not include a prescription medical device unrelated to the cessation of smoking.
  - b. The term "e-cigarette" includes: A device described by this subdivision regardless of whether the device is manufactured, distributed, or sold as an e-cigarette, e-cigar, or e-pipe or under another product name or description; and A component, part, or accessory for the device, regardless of whether the component, part, or accessory is sold separately from the device.
- 3. Hemp means the plant Cannabis sativa L. and any part of that plant, including the seeds of the plant and all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3 percent on a dry weight basis.
- 4. CBD/HEMP/Cannabis Store means a store that sells products containing cannabidiol otherwise known as CBD, contacting a tetrahydrocannabinol (THC) concentration of less than 0.3%; any product processed or manufactured for human consumption containing hemp; and/or any product containing cannabis.
- 5. Church means a facility that is owned by a religious organization and that is used primarily for religious services.
- 6. School means a private or public elementary or secondary school.
- 7. Family day care home child care setting provided in a private residence, typically by one caregiver, offering care for a small group of children, often six or fewer.
- 8. Child care facility as any place that provides care and supervision for children, often in a group setting, for periods less than 24 hours a day.
- 9. Youth center A youth center is a facility designed for young people (typically ages 6-17) to gather for various activities and programs, offering a safe and supervised environment for recreation, socialization, and skill development.
- 10. Public library means a non-profit institution that provides free access to books, materials, and services to the general public, often supported by local taxes
- 11. Recreational facility is a place or space dedicated to recreation, designed for activities like sports, games, or leisure. It can be an indoor or outdoor area, building, or site, administered by a public or private entity to serve the recreational needs of the community.
- 12. Smoke lounge a dedicated space, whether a room, building, or designated area, where smoking is permitted, often within a larger establishment or building where smoking might otherwise be restricted
- 13. Smoke/Vape shops A retail establishment engaged in the sale of smoking and vaping products and/or paraphernalia for the consumption of smoking related products.

# Sec. 10-252 DISTANCE REGULATIONS:

Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores shall not be located within one thousand (1,000) feet, measured from closest point property line to property line, from school (public or private), family day care home, child care facility, youth center, community center, dance studio, public library, recreational facility, park, church or religious institution, hospital, medical clinics, or similar locations in which children may regularly gather.

# Sec. 10-253 ADVERTISEMENT & SIGNAGE REGULATIONS

All Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores establishments must comply with most current adverting and signage regulations as set forth by applicable local, state and federal laws. Any changes to state and federal adverting and signage requirements must be adhered to immediately upon their effective date and continued operation shall be contingent upon ongoing compliance.

#### Sec. 10-254 PERMITS

All Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores establishments must apply for a Certificate of Occupancy with the City of Los Fresnos Building Department. Proof they have complied with the most current state and federal laws and have been permitted by the following but not limited to:

- a) E-Cigarette Sales any person or business engaged in the retail sale of E-cigarettes must obtain the appropriate permit from the Texas Comptroller of Public Accounts.
- b) Hemp and CBD Product Sales any person or business engaged in the sale of consumable hemp products, including those contacting cannabidiol (CBD), must obtain the appropriate license or registration from Texas Department of Agriculture (TDA).

Compliance with regulations of this Article shall be a condition of approval at the time an application for a Certificate of Occupancy is submitted.

**SECTION 2. REPEALER** All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

**SECTION 3. SEVERABILITY.** In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction. Item Title:

Consideration and ACTION to approve creating the position of a Part-Time Human Resources Clerk and set the wages.

## **Recommendation:**

With the city continuing to grow and demands on each of us increasing, we are in need of a part time Human Resources employee. This person will be responsible for handling retirement, insurance, worker's comp, vacation, sick, new hires, job separations, FMLA, policies, evaluation processes and all things related to employees benefits and retention. The position will be part time up to 25 hours per week with the pay up to \$15.00 per hour depending on experience, background and availability.

Money for this position can come from Municipal Court revenue which is trending well over \$50,000 higher than projected in the budget. The estimated cost for an employee from June through October is about 450 hours or about \$6,750 not counting employment taxes and fees that would bring the total to no more than \$10,000.

# **Recommendation:**

A. Wastewater Collection System & Upgrade - We have about \$700,000 in grant funds to complete additional projects at the Wastewater Plant. We received approval from TWDB to allow us to utilize the funds for areas that need improvement at the plant. Hanson Professional Services is working with TWDB to get the approval so we can get bids. Still no additional progress.

B. Water Treatment Plant Expansion – There are only little items left to be completed. It is taking a long time due to certain products not being available. The plant is not operational at this time waiting for some tanks for chemicals to arrive and be installed, some vales and more of the electronic functions to be operational. We started producing water on May 1.

TCEQ conducted an inspection of our reservoirs. We don't have a plan of action yet as the cost is very high.

C. We have received a grant award for \$500,000 for the CDBG funding for the next cycle to repair 7th from Palma to Fresno; 9th from Mesquite to Olmo; 5th from Mesquite to Palma. Accepting the bid is on the agenda for this meeting.

Other streets in need of repair but not funded include (We have applied for a \$750,000 grant and should know it February if we received the grant): Canal from 1847 to Mesquite; Mesquite from 100 to Canal; 1st from Nogal to the cul-de-sac; 2nd from 1847 to Alamo; Ebano from 100 to 3rd; Nogal from 10th to the shooting range as well as a few others. We are working on a financing plan to address these issues as well as targeting East 1st Street and East 5th Street since both have never been developed. We discussed this several months ago regarding borrowing the funds to complete these. However, we want



to wait to determine the financial impact the water and sewer work that must be done will have on the budget and our citizens on their water, sewer and trash bill.

D. Drainage - Hanson Professional Services has made good progress on these drainage projects. The loan and grant were funded. It is \$843,704 in loan forgiveness which means a grant, free money. It also includes a zero percent interest loan for \$860,000 for the rest of the project. This will be for drainage of Resaca Escondida (south of Nature Park), drainage improvements along Whipple Road and Valle Alto Subdivision and ditches to Highway 100 and a city wide drainage study and plan. Hanson is working on the environmental clearance on the projects. This final approval of the environmental could take from 6 months to a year.

The backup of water along Highway 100 near the Motel seems to have improved due to development that we required to divert drainage to the north instead of the south to Highway 100. It seems to have helped. We will have to go through another rain event to be sure. This is actually a problem that TxDot created but they have not been willing to fix it so we did.

There is also a backup of water along Highway 100 just past the school to the west of FM 1575 around the Longhorn Lane area. This is the responsibility of TxDot. They don't see it as a major issue so are not interested in doing anything. I will be working with TxDot, the School, the County and Drainage District # 1 to try to improve the drainage there.

We sent a letter to Cameron County Drainage District # 1 on 2 areas where we feel like they as the drainage district collecting taxes in this area, should take over some drainage ditches that area currently not owned and maintained by anyone (well property is owned by the local property owner). Easements need to be acquired and then the ditches need to be cleaned and maintained. Another area of concern is south on California Road where the drainage ditches are not maintained by anyone. We are working with CCID#6, CCDD#4, the County and a developer to redirect the water. This was discussed at length with the CCDD#1 Board. It was agreed to look at one area at a time to see how this can be dealt with. The concern is if CCDD#1 agrees to take over this area or these areas, it will open the door for many others. I have suggested the CCDD#1 staff to look at all areas that need to be taken over, calculate initial costs and then ongoing costs on an ongoing basis to determine how this can be done. As of now they say it is not in their budget to do these types of things. I will be revisiting this with CCID#1 to see what they will do.

E. Whipple Road – Engineering is in progress. They are currently identifying all the utilities that are near the roadway and may need to be moved. If you have driven the road you will see all kinds of small flogs indicating locations of the utilities. Construction is scheduled in 2026.

F. COVID-19 - The total amount of funds that we received is \$1,941,898.48. There are still some amounts that I am waiting to come in before I can provide you with an accurate accounting of all the projects that have been approved by the Council but we estimated that all the funds will be utilized once all the projects are done.

G. Veteran's Memorial – Landscaping is done except for the additional area of grass needed that is over the approved amount. The architect and engineer are discussing to see who will need to pay. Some items of concern have been identified for them to correct. Once it is complete we will decide on a date to hold an event.

H. Water Funding - We have continued to seek funding in any means possible for upgrades that are needed as part of a system wide study we conducted about 8 years ago. We were notified last week we were approved for funding in the amount of \$13,252,290. TWDB let us know the offering of funding; Loan Forgiveness (grant) for \$9,063,103 or 68.4%, Zero Percent Loan for \$2,190,000 or 16.5%, Equivalency Loan at an interest rate of about 3% for \$1,999,187 or 15.1%. This will require an increase

in water rates but we will have to run all the numbers and see how the wastewater is funded as wenbefore we put it all together. It was scheduled to get final approval from TWDB in March but have delayed that due to the need to update the CCN with us and Olmito Water Supply.

I. Wastewater Funding - We have continued to seek funding in any means possible for upgrades that are needed as part of a system wide study we conducted about 8 years ago. We were notified last week we were approved for funding in the amount of \$5,867,618. TWDB let us know the offering of funding: Loan Forgiveness (grant) for \$4,082,618 or 69.6% and an Equivalency Loan at an interest rate of about 3% for \$\$1,785,000 or 30,4%. This will require an increase in water rates but we will have to run all the numbers and see how the wastewater is funded as well before we put it all together. This was scheduled to get final approval from TWDB in March but is delayed waiting to see what happens on the water side.

J. Senior Citizen's Program - See the attached calendar of events for March. As you can see there is a full schedule of events. Also attached is the numbers of folks we have at each event. As previously mentioned, bingo is popular and other events have little to no interest. All seems to be moving along smoothly.
