#### LFCDC R&D and business outreach:

The following have been visited or contacted with the objective of advocating Los Fresnos affordable housing;

- Community Development Corporation of Brownsville (CDCB), a non-profit org is an affordable housing provider for low and moderate income (LMI) families in the Coastal Counties of Cameron, Willacy and Nueces County. The CDCB Barn Modular Home Factory and land is located in the Los Fresnos ETJ,
- Cameron County Housing Finance Corporation (CCHFC) has public bond financing capability for affordable housing projects. Consultant has outreached to CDCB to start a project on their existing ETJ property or buy land inside the city. A model CDCB project could include CCHFC bond financing of an affordable single family housing subdivision or planned development with a request for matching state and federal grants for infrastructures; water, sewer, streets, drainage, and homes to be built and sold by CDCB to eligible Los Fresnos area customers.
- Los Fresnos CDC would support a CDCB project with information, public and grants search, outreach and promotion of a project to eligible customers qualifying for USDA 502 Single Family Housing Loan Program presently at a 4.37% interest rate for 33-year term (changes monthly).
- Texas State Representative Janie Lopez, San Benito, and Texas Senator-Elect, Corpus Christi, for 2025 Legislative Session state matching funding for a CDCB for a model affordable single family housing subdivision or planned development and grants for water, sewer, utility taps, streets and drainage,
- The U.S. Department of Commerce, EDA, and HUD are also being contacted on grants search options.)

## **Community Development:**

- \* Developing a flyer for the Los Fresnos Boys and Girls Clubs
- \* Designing flyers for commercial vacant sites available in Los Fresnos.
