



WHEREAS, the City of Los Fresnos desires to implement regulations for the sale of E-cigarettes, Hemp products and locations of Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops, defined herein, for the health, safety and general welfare of the City; and

WHEREAS, the City of Los Fresnos finds that adopting this ordinance promotes the health safety and wellbeing of Los Fresnos and is in the best interest of the citizens of Los Fresnos.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESNOS, TEXAS:

SECTION 1: Amendment of Chapter 10. Chapter 10 of the Los Fresnos Code of Ordinances is hereby amended to add the following Article IX Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops:

Sec. 10-250 PURPOSE

It is the purpose of this article to regulate the sale of E-Cigarettes and location of smoke lounges, Smoke/Vape shops and tobacco stores businesses to promote the health, safety and general welfare of the city residents; to protect and preserve the quality, property values, and character of the city; to prevent the concentration of smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores businesses within the city; and to minimize the potential negative impacts of smoke lounges, Smoke/Vape shops and tobacco stores businesses on residential areas, churches, schools, public areas or similar locations in which children may regularly gather.

Sec. 10-251 DEFINITIONS:

1. Cigarette means a roll for smoking: that is made of tobacco or tobacco mixed with another ingredient and wrapped or covered with a material other than tobacco; and that is not a cigar.

- 2. *E-cigarette* an electronic cigarette or any other device that simulates smoking by using a mechanical heating element, battery, or electronic circuit to deliver nicotine or other substances to the individual inhaling from the device; or A consumable liquid solution or other material aerosolized or vaporized during the use of an electronic cigarette or other device described by this subdivision.
 - a. The term "e-cigarette" does not include a prescription medical device unrelated to the cessation of smoking.
 - b. The term "e-cigarette" includes: A device described by this subdivision regardless of whether the device is manufactured, distributed, or sold as an e-cigarette, e-cigar, or e-pipe or under another product name or description; and A component, part, or accessory for the device, regardless of whether the component, part, or accessory is sold separately from the device.
- 3. Hemp means the plant Cannabis sativa L. and any part of that plant, including the seeds of the plant and all derivatives, extracts, cannabinoids, isomers, acids, salts, and salts of isomers, whether growing or not, with a delta-9 tetrahydrocannabinol concentration of not more than 0.3 percent on a dry weight basis.
- 4. CBD/HEMP/Cannabis Store means a store that sells products containing cannabidiol otherwise known as CBD, contacting a tetrahydrocannabinol (THC) concentration of less than 0.3%; any product processed or manufactured for human consumption containing hemp; and/or any product containing cannabis.
- 5. Church means a facility that is owned by a religious organization and that is used primarily for religious services.
- 6. School means a private or public elementary or secondary school.
- 7. Family day care home child care setting provided in a private residence, typically by one caregiver, offering care for a small group of children, often six or fewer.
- 8. Child care facility as any place that provides care and supervision for children, often in a group setting, for periods less than 24 hours a day.
- 9. Youth center A youth center is a facility designed for young people (typically ages 6-17) to gather for various activities and programs, offering a safe and supervised environment for recreation, socialization, and skill development.
- 10. Public library means a non-profit institution that provides free access to books, materials, and services to the general public, often supported by local taxes
- 11. Recreational facility is a place or space dedicated to recreation, designed for activities like sports, games, or leisure. It can be an indoor or outdoor area, building, or site, administered by a public or private entity to serve the recreational needs of the community.
- 12. Smoke lounge a dedicated space, whether a room, building, or designated area, where smoking is permitted, often within a larger establishment or building where smoking might otherwise be restricted
- 13. Smoke/Vape shops A retail establishment engaged in the sale of smoking and vaping products and/or paraphernalia for the consumption of smoking related products.

Sec. 10-252 DISTANCE REGULATIONS:

Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores shall not be located within one thousand (1,000) feet, measured from closest point property line to property line, from school (public or private), family day care home, child care facility, youth center, community center, dance studio, public library, recreational facility, park, church or religious institution, hospital, medical clinics, or similar locations in which children may regularly gather.

Sec. 10-253 ADVERTISEMENT & SIGNAGE REGULATIONS

All Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores establishments must comply with most current adverting and signage regulations as set forth by applicable local, state and federal laws. Any changes to state and federal adverting and signage requirements must be adhered to immediately upon their effective date and continued operation shall be contingent upon ongoing compliance.

Sec. 10-254 PERMITS

All Smoke lounges, Smoke/Vape shops, CBD/HEMP/Cannabis shops and tobacco stores establishments must apply for a Certificate of Occupancy with the City of Los Fresnos Building Department. Proof they have complied with the most current state and federal laws and have been permitted by the following but not limited to:

- a) E-Cigarette Sales any person or business engaged in the retail sale of E-cigarettes must obtain the appropriate permit from the Texas Comptroller of Public Accounts.
- b) Hemp and CBD Product Sales any person or business engaged in the sale of consumable hemp products, including those contacting cannabidiol (CBD), must obtain the appropriate license or registration from Texas Department of Agriculture (TDA).

Compliance with regulations of this Article shall be a condition of approval at the time an application for a Certificate of Occupancy is submitted.

SECTION 2. REPEALER All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

SECTION 3. SEVERABILITY. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction. It shall not effect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Los Fresnos, Texas, declares that it would have passed.

SECTION 1. Chapter 10-Businesses, Article V. Sexual Oriented Businesses, Sec. 10-123. Definitions, in the Code of Ordinances of the City of Los Fresnos, Texas is hereby amended to reflect as follows:

REMOVE

Sexually oriented business means an adult arcade, adult bookstore, adult video store, adult cabaret, adult motel, adult motion picture theater, adult theater, escort agency, nude model studio or sexual encounter center.

ADD

Sexually-oriented business means either:

- (1) An adult arcade, adult bookstore, adult cabaret, adult encounter center, adult motel, adult motion picture theater, adult theater, adult video store, nude model studio, sexual encounter center, sexually-oriented merchandise store; or any commercial enterprise for which a primary business focus is the offering of a service or the selling, renting or exhibiting of devices or any other items intended to provide sexual stimulation or sexual gratification to the customer; or
- (2) Any business which either:
 - a. Holds itself out to the public as a sexually-oriented business;
 - b. Receives a substantial portion of its gross monthly revenue from the offering of a service or the selling, renting or exhibiting of devices, such as sexually-oriented merchandise as described by this chapter, or any other items intended to provide sexual stimulation or sexual gratification to the customer; or

c. Utilizes a substantial portion of its building floor space for the offering of a service or the selling, renting or exhibiting of devices or any other items intended to provide sexual stimulation or sexual gratification to the customer.

<u>Sexually-oriented merchandise</u> means instruments or paraphernalia such as, but not limited to lap dance bags, benwa balls, dildos, genital pumps, sexually oriented vibrators, inflatable orifices, anatomical balloons with orifices, simulated and battery operated vaginas, and similar sexually-oriented devices that are designed or marketed primarily for the stimulation of or use with the stimulation of human genital organs or breasts, or for sadomasochistic activity.

<u>Sexually-oriented merchandise store</u> means a commercial establishment which has significant or substantial stock-in-trade in, derives a significant or substantial portion of its business or advertising, or maintains a substantial section of its sales or display space for the sale or rental, for any form of consideration, sexually oriented merchandise.

<u>Significant or substantial portion</u> means ten percent or greater of the total amount, measure, or duration of a referenced quantity, portion, size, or time period.

SECTION 2. REPEALER All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

SECTION 3. SEVERABILITY. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction. 



Item Title:

Consideration and ACTION to approve the second reading of an ordinance providing an amendment to the Los Fresnos Code of Ordinance Chapter 44-Utlities, Article I. General, Sec. 44-13. Services Rates and Other Charges; Billing and Collection; providing repealer, severability, and effective date.

Recommendation:

This was approved in concept at the April meeting.

This was approved by the Council on the first reading on May 13.

The City continues to have numerous problems with wastewater service outside of the city limits.

As I have reported to the Council before, each time we receive a large rain that causes any flooding at all in primarily the Laureles area, the wastewater system becomes inundated with rain water that leaks or drains into our sewer system. In a few cases our manhole lids leak for one reason or the other but almost every time, someone has removed their cap to their cleanout thus allowing the flood water to drain into our system. Our sewer system is not designed to handle flows from rain water or flooding. Drainage in this area is the responsibility of Cameron County Drainage District # 4 and Cameron County. We have no control over drainage and no authority to fix it but yet we get blamed for the problems with the resident's sewer not working, backing up and smelling.

Additionally, there has been tremendous growth in the Laureles area. The existing lift stations and lines area nearing capacity. Subdivisions have already been approved and the developer has paid for future connections in these subdivisions. Not all homes have been built yet so we have to leave some room for those as they get built. Once all this is completely built out we will be very close to capacity.

Taking this action would mean the people would utilize septic tank systems like are utilized in any area where city sewer is not available.

Due to these 2 reasons, I recommend the City not approve any more wastewater connections in areas outside the city limits of Los Fresnos with city staff following this decision but allowing individual appeals to be made to the Planning & Zoning and then the City Council.

This just places the action taken properly into the ordinance so it can be enacted and followed.

I recommend approval.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LOS FRESNOS, TEXAS:

SECTION 1. Chapter 44-Utilities, Article I. General, Sec. 44-13. Service rates and other charges; billing and collection, in the Code of Ordinances of the City of Los Fresnos, Texas is hereby amended to reflect as follows:

ADD in red

Sec. 44-13. Service rates and other charges; billing and collection.

- a) Generally; exceptions. The rates for furnishing water and sewer service inside and outside the city limits shall be calculated, charged, billed and collected as provided in the city fee schedule.
- b) Free service prohibited. No free service shall be allowed, and to the extent that the city or any of its agencies or instrumentalities shall avail themselves of the services and facilities afforded by the systems, they shall pay therefor the same rates and charges prescribed in the city fee schedule.
- c) Service outside city limits. Water and sewer service may be furnished outside the corporate limits of the city only in the event the city is able to do so without detriment to consumers within the city limits, upon terms and conditions as may be determined by the city council in the best interests of the city.
 - i. Wastewater connections outside city limits. Additional wastewater connections by individuals outside the city limits of Los Fresnos shall no longer be allowed. However, individuals may appeal to the Planning and Zoning Commission and subsequently to the City Council in writing if they can provide sufficient evidence demonstrating that the proposed connection will not negatively impact the existing wastewater system or service to current users within the city limits. The final decision shall rest with the City Council, based on the merits of the information presented and in consideration of the best interests of the City.

SECTION 2. REPEALER All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

SECTION 3. SEVERABILITY. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstance shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction. It shall not effect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Los Fresnos, Texas, declares that it would have passed.

SECTION 4. **EFFECTIVE DATE.** This Ordinance shall take effect after the final reading and when caption of Ordinance has been published in the official newspaper of the City.

MEMORANDUM OF UNDERSTANDING BETWEEN TROPICAL TEXAS BEHAVIORAL HEALTH AND

This Memorandum of Understanding (the Agreement) establishes the mutual agreement of **Tropical Texas Behavioral Health (TTBH)**, a Certified Community Behavioral Health Center (CCBHC), and _____, ____, Texas ______, a referral PARTNER (PARTNER) to coordinate referrals and services for those individuals who receive community-based mental health and/or substance use disorder services from TTBH. The purpose of this Agreement is to establish the roles of both parties in the collaborative treatment planning and care coordination activities.

I. Referral Activities

- 1. TTBH will, within its scope and capacity:
 - a) Provide integrated and coordinated care across a spectrum of services in a manner that is both person-centered, family-centered and consistent with Section 2402(a) of the Patient Protection and Affordable Care Act (ACA).
 - b) Adhere to the requirements of the TTBH CCBHC demonstration, as implemented by the Texas Health and Human Services Commission (HHSC).
 - c) Inform PARTNER if TTBH becomes unable to accept new referrals.
- 2. PARTNER will, within its scope and capacity:
 - a) Make and/or accept referrals to/from TTBH in order to assist individuals in need of services and resources.
 - b) If accepting referral, PARTNER agrees to notify TTBH if at any time it becomes unable to accept new referrals.
 - c) Inform TTBH if PARTNER becomes unable to accept new referrals.

II. Care Coordination Processes

BOTH parties confirm their understanding that, within their scope, capacity, and role:

- 1. **TTBH will** to provide initial screening, intake, and, as capacity permits, appropriate treatment to clients referred to TTBH for the provision of community-based mental health and substance use disorder services, and to establish and maintain records of such individuals' healthcare.
- 2. **TTBH will** If such screening and/or treatment indicate the need for referral to PARTNER for services, TTBH will assist clients and/or their families to obtain an appointment with PARTNER TTBH will also confirm with PARTNER that the appointment was kept, consistent with the Referral and Communication Protocol described below in Section II.6.
- 3. TTBH will ensure that clients' preferences and those of their families, as applicable, for shared information will be adequately documented in the applicable clinical records, consistent with the philosophy of person and family-centered care. TTBH will make reasonable efforts to obtain necessary consent for release of information from clients of TTBH.
- 4. TTBH will make and document reasonable attempts to screen all clients who are referred for outpatient services within 24 hours and to schedule intake for individuals in need within 10 business

days. TTBH will make all reasonable efforts respond to requests for mental health crisis within 1 hour of request. For all TTBH clients who present as a potential suicide risk, TTBH will provide crisis intervention services, emphasizing smooth transitions to and from emergency department care or psychiatric hospitalization, as indicated. TTBH will coordinate consent and follow-up services with the consumer within twenty-four (24) hours of discharge, which shall continue until the individual is linked to services or assessed to be no longer at risk.

- 5. **TTBH and PARTNER will** collaborate in treatment planning and care coordination activities in a manner that is person and family-centered.
- 6. TTBH and PARTNER will coordinate care for individuals served, making/accepting timely referrals, incorporating consumer preferences and needs for care, allowing TTBH and PARTNER to track clients and the services they receive, coordinating the transfer of medical records for services, coordinating TTBH's active follow-up and other activities necessary for effective management of care transitions.
- 7. TTBH and PARTNER agree that the individuals served by either party are considered clients of the Party furnishing the services. Accordingly, each Party agrees to be solely responsible for billing and collecting all payments for such services from appropriate third-party payors, funding sources, and, as applicable, clients, observing the Party's customary billing, collection, and discount/charity care policies.
- 8. **TTBH and PARTNER agree** that each Party shall be responsible for training and competencies of staff employed by the Party and meet all requirements of their respective state laws, statutes, and other standards including but not limited to licensing.

III. Insurance and Liability

1. TTBH and PARTNER represent and warrant that each Party and its clinicians, if applicable, providing services hereunder are covered by a professional liability insurance policy (malpractice, errors, and omissions) that provides sufficient coverage against professional liabilities that may arise from acts or omissions in connection with or related to the Services that the Party furnishes under this Agreement.

IV. Assurance of Patient and Clinician Choice, if Applicable

- TTBH and PARTNER acknowledge and agree that all health and health-related professionals
 employed by or under contract with either TTBH or PARTNER retains ole and complete discretion,
 subject to any valid restriction(s) imposed by participation in a managed care plan and consistent
 with Section II above, to refer clients to any and all providers who best meet the medical needs of
 such clients.
- 2. TTBH and PARTNER acknowledge that all clients have the freedom to choose (and/or request referral to) any provider of services, and the parties will advise clients of such right, subject to any valid restriction(s) imposed by participation in a managed care plan.
- 3. TTBH and PARTNER acknowledge and agree that they have freely negotiated the terms of this Agreement and that neither Party has offered or received any inducement or other consideration in exchange for entering into this Agreement. Nothing in this Agreement requires, is in tended to require, or provides payment or benefit of any kind (directly or indirectly) for the referral of individuals or business to either Party by the other Party, subject to Section II above.
- 4. TTBH and PARTNER remain separate and independent entities. No provision of this Agreement is intended to create, nor shall any provision be deemed or construed to create, a relationship

between the parties other than that of independent contractors. TTBH and PARTNER retain the authority to contract or affiliate with, or otherwise obtain services from, other parties, on either a limited or a general basis.

V. Term and Termination

- 1. This Agreement will be effective on March 1, 2025, and will expire on August 31, 2026, and will thereafter automatically renew for an additional one (1) year term (August 31, 2027) unless written notice of intent not to renew is provided by one Party to the other Party no less than thirty (30) days prior to the expiration of the then-current Agreement in accordance with Section V.
- 2. Either TTBH or PARTNER may terminate this Agreement without cause upon ninety (90) days prior written notice to the other Party.
- 3. This Agreement may be terminated for cause upon written notice by either TTBH or PARTNER. "Cause" shall include, but is not limited to when the life, health, welfare, or safety of individuals served or its employees is endangered or could be endangered either directly or through the Parties willful or negligent discharge of its duties under this Agreement.

VI. Privacy and Confidentiality of Consumer Information

- 1. TTBH and PARTNER will coordinate care in compliance with privacy and confidentiality requirements, including but not limited to those of the Health Insurance Portability and Accountability Act of 1996 (HIPAA) (Pub. L. No. 104191, 110 Stat. 1936 (1996)), 42 CFR Part 2, and other federal and state laws, including privacy requirements specific to the care of minors.
- 2. Each Party shall seek clients' consent for disclosure of their health information when required in accordance with state and federal law and regulations. Each Party shall follow clients' preferences for shared protected health information, consistent with the philosophy of person and family-related consent.
- 3. This Section VI shall survive termination of this Agreement.
- 4. See attached Business Associate Agreement for further information on HIPAA.

ACTION ITEM REPORT



Item Title: Consideration and ACTION to update the Senior Citizen Program and

take appropriate action.

Recommendation:

In December it was approved to continue operation of the Senior Citizen's program as is until June and see what the situation looks like at that time. The question then was what to do with the program since funding was cut and we still were not having in house programming. All meals were being delivered 2 times per week to homes and no other programming was occurring so there was no need for a full time employee. The original discussion is at the bottom underlined and in italics.

In January, we were notified by the funding agency that home deliveries would cease except for those that are not able to attend in person and that congregate meals would need to begin February 3. This forced us to offer full time programming and forced participants to come to the center once again like was done prior to COVID. It changed the prior options that were recommended.

In February we had 28-32 participants for congregate meals and 30 home delivered meals to begin with. In May we had 42 participants for congregate meals and 33 home delivered meals. There has been a good steady increase.

We also began offering coffee and bingo (most bring items for breakfast that everyone shares in) from 8 am to 11 am. We began with 16 – 29 participants in February. In May we had a low of 24 participants to a high of 46 participants. LF folks love bingo/chalupa.

We also provide different activities in the afternoon (a few are offered in the morning between 11 to 11:30) beginning at 1 pm such as walking, dancing, going to other places such as Walmart, 510 Church Pantry, Ice Cream, walking, movie day, birthday & holiday celebrations, sit & Fit Exercises, English Classes, Nutrition Education, Chalupa and Cards. Many of these offerings have no participants but we offer a variety as you never know when something catches on and we want to at least offer variety to participants. Cards has been something that 3-4 folks have started regularly doing.

The largest extra time that is required is to deliver the home bound meals. With 33 home delivered meals, there are about 24 stops, so it takes quite a bit of time. We have moved custodian services around a bit and have the custodian delivering the meals. The custodian also takes a few of the participants home.

As can be seen on the attached budget 2024-2025 for this current year, the city is providing \$48,657 to the program. It is projected the city will support approximately the same, \$48,835 for next year provided the funding from the grant remains at \$40,000. There is about \$2,500 to \$5,000 in other

expenses per year that is paid through the General Fund since we also utilize the facility as a Community Center in the evenings and weekends.

The program is operating and providing services to citizens of Los Fresnos and the Los Fresnos area as it should. The requirement in February to return to normal congregate meals and normal programing as it was prior to COVID changed the part time duties back to needing full time duties.

I recommend to continue the Senior Citizens Program as it currently is operating through the end of the year. We will include in the budget to continue operating the same in the new 2025-2026 budget year that will be presented and approved by the Council in September.

The Senior Citizens program as it exists today and how it has operated since Covid, will not be affected at all. The current programing for the Seniors will continue as is. Current programing will not change.

I recommend to not reconsider the action taken and stay with the original decision with Option 2.

Information provided last month.

All through the summer and budget discussions, The LRGVDC Area Agency on Aging told us that we would be receiving the same funding as before. We asked if we could add a part time activities coordinator to help with activities for the seniors. They told us to include it in our request as they would most likely fund it. We did and then it was approved by the Council with the budget. On October 29, a month after the start of our fiscal year, Area Agency on Aging notified us that they cut the funding to \$40,000 from \$\$102,000 which was our current budget and last year of \$79,494.

Since we just added the activities coordinator in the budget but have not hired anyone yet, that position goes away and the \$16,222 that it associated with it. That leaves \$85,778. We are required to match the grant with \$7,059 of in kind services and since we are only getting \$40,000, we need to decide how to handle the balance of \$38,719.

Option 1: Fund the \$38,719 through the General Fund. Since our budget year is just starting, I don't have a place to cut expenses at this time and we don't have any excess funds from other revenue sources. We can hope that during the year we can come up with that amount either by cutting expenses or getting additional revenue so we don't go over budget.

Option 2: Cut the Senior Citizen Coordinator position from full time to part time, saving approximately \$23,485 and cut the supply budget to \$1,683 instead of \$3,976 saving \$2,293. This would leave only \$12,941 to fund through the General Fund and much easier to cover and sustain. Since we have to pay electricity, utilities, building maintenance and insurance all totaling \$11,224 regardless if we have the Senior Citizens Program or not, this is the most fiscally sound approach. This would be a huge impact on the Senior Citizen Coordinator and it makes it hard when dealing with an employee. However, due to the change in the funding and the program overall the way it is not operated, it is the most responsible thing to do. If this option is taken, I suggest it be effective January 1.

There could be other options you come up with.

I recommend Option 2.

Item Title:

Consideration and ACTION to approve participation in funding of a grant administrator in participation with Bayview Irrigation District # 11 and Cameron County Irrigation District # 10 for the application of a grant for Phase 2 of the underground irrigation canal.

Recommendation:

We have discussed this project several times and were given approval to proceed. It is to continue placing the open irrigation canal underground from Nogal Street to the east city limit line. This will help in it being an eye sore, having dead fish, people throwing unwanted items in the canal and general maintenance that is not done regularly by either water district. One day we can place a Hike & Bike trail where the canal now is. This is the first step. Patty Alexander has been hired by Bayview Irrigation District to handle the grant. She is the one that did Phase 1. We have used her before as well to do other projects. The grant has to go through Bayview Irrigation District so they officially hire her. Her fee is \$10,000 to be paid equally by all 3 entities. Our share is \$3,333.33.

Recommendation:

- A. Wastewater Collection System & Upgrade We have about \$700,000 in grant funds to complete additional projects at the Wastewater Plant. We received approval from TWDB to allow us to utilize the funds for areas that need improvement at the plant. Hanson Professional Services is working with TWDB to get the approval so we can get bids. Still no additional progress.
- B. Water Treatment Plant Expansion There are only little items left to be completed. It is taking a long time due to certain products not being available. The plant is operational at this time with final items nearer to completion.

TCEQ conducted an inspection of our reservoirs. We don't have a plan of action yet as the cost is very high.

C. We have received a grant award for \$500,000 for the CDBG funding for the next cycle to repair 7th from Palma to Fresno; 9th from Mesquite to Olmo; 5th from Mesquite to Palma. Council accepted the bid and we added work on First Street from Nogal Street to the cul-de-sac. We had the pre-construction meeting. Work will begin in the next month or so.

Other streets in need of repair but not funded include (We have applied for a \$750,000 grant and should know it February if we received the grant): Canal from 1847 to Mesquite; Mesquite from 100 to Canal; 1st from Nogal to the cul-de-sac; 2nd from 1847 to Alamo; Ebano from 100 to 3rd; Nogal from 10th to the shooting range as well as a few others. We are working on a financing plan to address these issues as well as targeting East 1st Street and East 5th Street since both have never been developed. We discussed this several months ago regarding borrowing the funds to complete these. However, we want

to wait to determine the financial impact the water and sewer work that must be done will have on the budget and our citizens on their water, sewer and trash bill.

D. Drainage - Hanson Professional Services has made good progress on these drainage projects. The loan and grant were funded. It is \$843,704 in loan forgiveness which means a grant, free money. It also includes a zero percent interest loan for \$860,000 for the rest of the project. This will be for drainage of Resaca Escondida (south of Nature Park), drainage improvements along Whipple Road and Valle Alto Subdivision and ditches to Highway 100 and a city wide drainage study and plan. Hanson is working on the environmental clearance on the projects. This final approval of the environmental could take from 6 months to a year.

The backup of water along Highway 100 near the Motel seems to have improved due to development that we required to divert drainage to the north instead of the south to Highway 100. It seems to have helped. We will have to go through another rain event to be sure. This is actually a problem that TxDot created but they have not been willing to fix it so we did.

There is also a backup of water along Highway 100 just past the school to the west of FM 1575 around the Longhorn Lane area. This is the responsibility of TxDot. They don't see it as a major issue so are not interested in doing anything. I will be working with TxDot, the School, the County and Drainage District # 1 to try to improve the drainage there.

We sent a letter to Cameron County Drainage District # 1 on 2 areas where we feel like they as the drainage district collecting taxes in this area, should take over some drainage ditches that area currently not owned and maintained by anyone (well property is owned by the local property owner). Easements need to be acquired and then the ditches need to be cleaned and maintained. Another area of concern is south on California Road where the drainage ditches are not maintained by anyone. We are working with CCID#6, CCDD#1, the County and a developer to redirect the water. This was discussed again at length with the CCDD#1 Board. They continue to not want to take over that drainage problem. The concern is if CCDD#1 agrees to take over this area or these areas, it will open the door for many others. I have suggested the CCDD#1 staff to look at all areas that need to be taken over, calculate initial costs and then ongoing costs on an ongoing basis to determine how this can be done. As of now they say it is not in their budget to do these types of things.

- E. Whipple Road Engineering is in progress. They are currently identifying all the utilities that are near the roadway and may need to be moved. I am including the latest progress report for your review.
- F. COVID-19 The total amount of funds that we received is \$1,941,898.48. There are still some amounts that I am waiting to come in before I can provide you with an accurate accounting of all the projects that have been approved by the Council but we estimated that all the funds will be utilized once all the projects are done.
- G. Veteran's Memorial We should get final clearance in the next couple of weeks. I am meeting with engineer and contractor on Thursday. The area that was not placed in grass is due to the expanding of drainage due to TxDot installing the sidewalk while the project was ongoing. This means it is our responsibility. I am getting a quote on the grass needed. Depending on the cost, we may just allow the grass to spread over time. Once it is complete we will decide on a date to hold an event.
- H. Water Funding We have continued to seek funding in any means possible for upgrades that are needed as part of a system wide study we conducted about 8 years ago. We were notified last week we were approved for funding in the amount of \$13,252,290. TWDB let us know the offering of funding; Loan Forgiveness (grant) for \$9,063,103 or 68.4%, Zero Percent Loan for\$2,190,000 or 16.5%, Equivalency Loan at an interest rate of about 3% for \$1,999,187 or 15.1%. This will require an increase in water rates but we will have to run all the numbers and see how the wastewater is funded as well

before we put it all together. It was scheduled to get final approval from TWDB in March but nave delayed that due to the need to update the CCN with us and Olmito Water Supply.

- I. Wastewater Funding We have continued to seek funding in any means possible for upgrades that are needed as part of a system wide study we conducted about 8 years ago. We were notified last week we were approved for funding in the amount of \$5,867,618. TWDB let us know the offering of funding: Loan Forgiveness (grant) for \$4,082,618 or 69.6% and an Equivalency Loan at an interest rate of about 3% for \$\$1,785,000 or 30,4%. This will require an increase in water rates but we will have to run all the numbers to see the impact. I hope to have that ready for the next Council meeting.
- J. Senior Citizen's Program See the attached calendar of events for March. As you can see there is a full schedule of events. Also attached is the numbers of folks we have at each event. As previously mentioned, bingo is popular and other events have little to no interest. An item it included with this agenda for further discussion.


