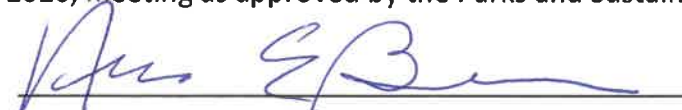
Commissioner Vrijen reported on a Xerces Society grant for the Blossom Hill Park garden and that Blossom Hill Elementary School is interested in assisting.
