Robert Lipp, commented in favor of Pickleball. Will the cameras be live with motion detection, so the police came come right away? Are there any long-term plans for a permanent home for Pickleball. What can we do to help to get things going?

Nicolle Burnham, PPW Director, and Tyler Thomas, PPW Superintendent, responded to the questions.

Rachel Larrenaga, resident. Understands the importance of exercise. Neighbors are not causing vandalism. A threating letter was received by one of the neighbors and experienced a verbal threat.

Sussie O'Neill, commented in favor of Pickleball. Joined the Pickleball community and have experienced closeness and kindness.

Philip de Lovroille, commented in favor of Pickleball. El Quito court sound mitigation nets failing apart. At El Quito early and locking mechanism was not engaged. A lot of power to engage the locking mechanism.

SUBJECT: Receive a Report on the Town's Open Space Wildfire Mitigation Work for

2025

#### **RECOMMENDATION:**

Receive a Report on wildfire mitigation work completed in Town Parks and Open Spaces in 2025.

#### **BACKGROUND:**

The Town of Los Gatos has been working on a vegetation management program since 2020. To support this work, the Town was awarded funding through the Federal Emergency Management Agency's (FEMA) Hazard Mitigation Grant Program for vegetation management in the Town-owned open spaces of La Rinconada Park, Worcester Park, Novitiate Park, Heintz Open Space, and Santa Rosa Open Space.

The open space vegetation management project implements the Vegetation Management Plan<sup>1</sup> that the Town Council adopted in 2021. In October 2024, Town Council authorized an agreement with Anvil Builders, Inc. to perform this work. This project thinned underbrush and small trees and removed dead and dying trees to improve open space health and wildfire resilience.

#### **DISCUSSION:**

Work was started on March 17, 2025 in La Rinconada Park and concluded in mid-June at Heintz/Santa Rosa Open Space Area.

The work completed will:

 Establish healthy, resilient fire adapted ecosystems to protect and conserve the Town's natural resources;

SUBJECT: Receive a Report on 2025 Open Space Vegetation Management Work



• Reduce wildfire risk at residential properties adjacent to Town open spaces; and

• Reduce the severity of catastrophic wildfire by removing and thinning overgrown fuels in the open spaces.

Treatment activities consisted of mechanized work in areas with less than 35% slope. Work included using skid steers and tracked chippers to remove dense stands of understory vegetation and using chainsaws to thin live trees less than eight-inches in diameter and dead trees up to 12-inches in diameter. Understory will be retained for wildlife habitat and soil erosion control in accordance with all required CEQA (California Environmental Quality Act) requirements.

The agreement with Anvil includes two years of maintenance vegetation management in these spaces, and maintenance is planned for Spring of 2025 ahead of next fire season.

SUBJECT: Urban Forest Management Plan Work Plan

#### **RECOMMENDATION:**

Receive a report on the proposed work plan for the development of an Urban Forest Management Plan for the Town of Los Gatos

#### **REMARKS:**

On July 1, 2025, Public Works staff issued a Request for Qualifications (RFQ) to solicit qualified consultants to prepare an Urban Forest Management Plan (UFMP) for the Town of Los Gatos. The goal of establishing a UFMP is to implement a set of policies, procedures, and standards to guide the Town as it pertains to the urban forest.

Once a qualified Consultant has been selected, the process of creating an UFMP will begin. Public Works staff will work closely with the Consultant to assess the current state of the urban forest along with the Town's current approach to managing the urban forest. This will be an indepth review of current town policies, procedures and ordinances that affect management of private and street trees followed by the creation of a comprehensive UFMP. The Consultant will assess many factors such as the unique landscape and ecosystem of Los Gatos, the existing urban forest, and input from residents through public outreach. Staff estimates that this process will take 12 to 18 months after a consultant has been chosen.

Implementing a UFMP will allow the Town of Los Gatos to manage the urban forest with consistency and a clear path forward. An urban forest is a long-term commitment and by referring to a UFMP, staff will be empowered to maintain the urban forest for years to come.

Staff recognizes the role of the Parks and Sustainability Commission with regard to tree management and the trust the Commission holds with the residents regarding this important community value. Staff intends for the Consultant to perform community outreach. During the community outreach phase of the UFMP process, staff wishes to include the Commission and utilize the knowledge of the Commission as well as the commission's relationship with the



SUBJECT: Oak Meadow Playground Improvements

#### **RECOMMENDATION:**

Receive a report on the condition of Oak Meadow playground equipment and provide feedback to staff on potential replacement assets.

#### **REMARKS**:

On February 21, 2025, the Town of Los Gatos conducted a playground inspection of all playgrounds within the Town. Public Works staff contracted with Certified Playground Safety Inspector (CPSI) Sedgwick to perform these inspections. At the conclusion of the inspection, the Town was provided with a detailed safety report. Within the safety report, three items located within Oak Meadow Park were identified as being of concern.

- 1) The historic Air Force airplane
- 2) The historic fire truck
- 3) The wooden train

Items one and two were identified as not being traditional equipment designed for playground use. Item three is an aging structure that has fallen into disrepair.

To address the safety concerns with these three items, Public Works staff propose the following:

- 1) Complete the fence surrounding the historic Air Force airplane to deter children from playing in and around the plane. The plane holds significant historical value, and staff intends to add a sign detailing the history of the plane for park goers.
- 2) Remove the historic fire truck and the wooden train. Replace these items with a single new piece of playground equipment, further discussed below.

SUBJECT: Oak Meadow Playground Improvements

DATE: July 31, 2025

With the historic fire truck and wooden train retiring from service, a new piece of playground equipment will be selected to take their spot in Oak Meadow Park. Staff have identified four potential replacement items (Attachment 1) that would fit well in this location and that retain a transportation focused playground theme. Some of the determining factors that went into these selections were, the size of the fall zone required for each piece, availability of replacement parts and cost of purchasing and installing the equipment. Staff intends to seek public input on the four potential replacements, both through the Commission meeting and through interaction with park users in order to select a playground structure that our residents will enjoy for many years to come.

Staff will be seeking input from the Commission through discussing the following:

- 1. Which of these do you like?
- 2. Which of these do you not like?
- 3. Is there something else staff should potentially consider?
