RECOMMENDATION:

BACKGROUND:

The Town's Boards, Committees, and Commissions (hereafter "Commissions") advise Los Gatos elected officials on a variety of policy and community interest matters. The Town of Los Gatos had an open recruitment for all Boards, Commissions, and Committees that had either existing vacancies or expiring terms, including the Finance Commission. Only Commissions with qualified applicants are included in the recommended action. Commission members are appointed by the Town Council with the exception of the Finance Commission. Per Los Gatos Municipal Code Section 2.50.205(c)(4), each member of the Town Council shall appoint one Citizen Appointee to the Finance Commission.

This recruitment period opened on November 5, 2024, and closed on December 9, 2024. Current Commissioners were notified of their term expiration and asked to submit an application if they wished to be reappointed. Individuals interested in serving on a Town Board, Committee, or Commission were asked to complete the appropriate application and submit it using the Boards, Commissions, and Committees application portal during the designated recruitment period. However, the Clerk's office received one application, which was completed using an active application link that remained accessible after the official deadline and submitted via email. The link was on a webpage that did not provide clear deadline information, and the link itself suggested the recruitment period was still active. Given these circumstances, we have included this application for your review and consideration.

SUBJECT: Boards and Commissions Interviews and Appointments

DATE: December 11, 2024

Notices for the recruitment were published in the local newspaper, shared on various social media platforms, and included in the Town's newsletter. The notice was posted in the Clerk's Office, the Community Development posting board, within the Library, advertised on KCAT Channel 15, and displayed on the Town's official website. Emails and text notifications were sent on November 5, 2024, and again on December 5, 2024, to approximately 46 subscribers who had requested updates on Boards, Commissions, and Committee recruitments.

DISCUSSION:

On December 16, 2024, Council will interview applicants for the vacant and expiring Commission positions. Following the interviews, each Council Member will complete a written ballot with their respective selections. The Town Clerk will tally the votes and issue runoff ballots if needed. Applicants are appointed with a majority vote. Upon completion of the appointment process, the Town Clerk will announce the votes.

All applicants will receive a notification regarding the appointments. The Town Clerk will advertise any unfilled positions and welcomes any additional direction from the Town Council. The next recruitment process is scheduled to open in March, with interviews to be conducted in May or June of 2025, or as directed by the Town Council at this meeting.

Call it giving back. I grew up in San Francisco and remember well my mom taking me to the North Beach Public Library to get our library cards. My folks both worked so I spent many days afterschool at my local library hanging out with friends and reading. Having free access to so many books was and is a game changer for many who don't have the means.





What are your unique perspectives and experiences that you would bring to this role?

I am Asian-American and in these polarizing times, I see myself as not just an advocate for the public library but as a protector of the institution for all. My input and suggestions are through the lens of an Asian American who grew up in the multicultural, socially, and economically diverse city of San Francisco. My immigrant parents prioritized education of which the public library system and schools were an essential component. I currently sit on Stanford's Investigational Review Board which approves which studies are accepted by the university. I gained experience evaluating drug and behavioral science studies and discussing them with the medical board at large. This experience of working in a collaborative setting and evaluating studies critically should be helpful.

By keeping an open mind, being empathetic, listening to the input of other board members, and most importantly listening to the library staff and patrons. I am keenly aware that we serve in an advisory role with the primary objective being supporting our library and its staff.

What do you see as the role of this Board?



I graduated from Santa Clara University in 1995 and worked in Advertising Sales in NYC and SF before resigning to raise our four children.

We lived overseas and then in Southern California, moving to Los Gatos in 2017 with two children in middle school and two children in elementary school. Currently, my two youngest children attend RJ Fisher Middle School and Los Gatos High School and my two older children are in college.

I served as a VP on the Fisher Home & School Board and a board member for LGHS Wildcat Foundation (formerly known as New Millennium Foundation). One of the highlights of my time on the LGHS Foundation was writing and then being awarded a \$5k grant for the LGHS library from the town of Los Gatos.



What is your initial reaction to the above referenced project?

Response

My initial reaction is that the proposed project meets the Town's Commercial Design Guidelines in square footage, height, and FAR. An initial thought is that this project should be approved and allowed to move forward.

What issues do you feel will need to be investigated further?

Response

Clearly the residents of the area feel there is an existing traffic issue that will be enhanced with the proposed project. While the traffic engineer had said there will be no impact, I would want to listen to the residents and understand what they are currently experiencing and I would want to understand how many additional car trips the proposed project may bring to the area. It could be that a traffic study would need to be done to verify the potential impact of the project.

How would you weigh your personal observations or experience regarding traffic and the professional input and recommendations of Town staff and Town consultants?

Response

Decisions by the Planning Commission should be based on objective standards, therefore any opinion I may have should not weigh in on my decision.





Case Study #2 - Fictitious Location

What is your initial reaction to the above referenced project?

Response

My initial response is that the proposed project meets the Town's Residential Design Guidelines in relation to square footage of both the house and garage, FAR, and building height. While that can be cause to approve the project, there are other issues that need to be investigated before a final decision could be made.

What issues do you feel will need to be investigated further?

Response

The residents of the neighborhood have brought up two significant potential issues, privacy and neighborhood compatibility. I would want to understand the makeup of the homes within the immediate neighborhood (2-2-5) to see if those homes are predominately single stories. How I would react to the overall building massing would depend heavily on this information. I would also want to discuss other ways to hide massing with the applicant's architect to see if we could soften the vertical plane facing the street. For the privacy issue, I would want to hear from the neighbors adjacent to the property and see if there are, in fact, privacy issues and see if any privacy issues could be addressed by window placement and height, removal or changes to any proposed balconies. If we are able to mitigate these issues in design changes, the project can be approved. If we can't mitigate the issues, I would continue the application to a date certain to allow the applicants to see if they can address the issues with the neighbors before the next meeting. If they can't, I don't believe I would approve the application.

How would you weigh your personal observations or experience regarding neighborhood compatibility and privacy and the professional input and recommendations of Town staff and the Town consultant?

Response

Again, our decisions need to be based on objective standards, such as line of sight to windows, massing and building size, and other standards. My personal experiences should not influence my decisions.



What is your initial reaction to the above referenced project?

Response

My initial reaction is that this project is within the Town zoning, restrictions and doesn't have traffic impact based on the study. Note also that they are proposing 10,000 sq. ft, and they are allowed to build 15,000 sq. ft., so it is only 2/3rd the size. Also note that Smith Blvd has other commercial buildings. The owner has a right to build on that property, and since they are within the zoning standards, and there is no adverse traffic impact, I would be initially in favor of this application. I would like to learn more from the neighbors if there are other impacts, and will look at ways if those impacts can be mitigated before making the final decision.

What issues do you feel will need to be investigated further?

Response

The traffic impact since this is a concern from some residents.

How would you weigh your personal observations or experience regarding traffic and the professional input and recommendations of Town staff and Town consultants?

Response

For issues to be investigated further, I am not sure if the traffic impact is on certain days, or certain times, and I want to make sure that traffic study has studied the specific concerns highlighted by the majority of neighbors.

I would say that I am not an expert in zoning or traffic, so I would weigh the analysis and testimony of the experts much higher. I will however, critically analyze the traffic study to make sure that the right elements were studied, and whether the outcomes are supported by evidence.

Response

My reaction is that this project is within the Town zoning, and restrictions. Yes, that is correct - it meets the objective criteria. Exactly on the 2 story - we cannot deny this owner the right to construct a two story home especially since there are other 2 story homes.

What issues do you feel will need to be investigated further?

Response

I think we need to look at 2 things, mass of the house and privacy as these are the critical areas that need investigation to make the best decision for the owner and the neighborhood.

Mass = bulkiness - how bulky does it look as compared to other 2 story or even one story

On the privacy, I would look to see what is the impact - for example, can second floor windows look straight into the other house. and whether there are ways to mitigate the privacy by planting hedges or trees to obscure the view into neighbors homes and backyards. If not, I would consider asking the homeowner to increase the sill height of the windows to help mitigate the privacy.

How would you weigh your personal observations or experience regarding neighborhood compatibility and privacy and the professional input and recommendations of Town staff and the Town consultant?

Response

I would need to look at the plans and also possibly do a site visit to make a determination on the privacy impact, and whether there are mitigations available to address the concerns.

This will help me to assess the mass of the house compared to the area. I strongly believe that this will help make an informed decision that works well for all involved.

- Learning: Serving on the Planning Commission will further my education into planning, zoning, and municipal governance.
- Relationships: I look forward to working closely with Town, staff, the Council and other community leaders.

How would you define the role of a Planning Commissioner in relation to the Town Council in planning matters?

A Planning Commissioner plays an important role, along with the full Commission, in shaping the Town's development and land use policies. Here are several important roles. A Commissioner

- Acts as an advisor to the Town Council (once again, along with the full Commission).
 Key roles include review and recommendations on various planning matters such as zoning, design guidelines, considered exceptions based on site and location of specific development projects.
- Objectively receives input from residents and stakeholders on proposed projects and policy changes. This ensures the planning process is as open and fair as possible for the benefit of the community.
- Must be open-minded and objective while considering applications that come before the Commission. This approach is important since not all applications are black and white.
- Needs to work closely in a collaborative manner with fellow Commissioners, the Town staff and other committees to address complex planning issues and ensure that recommendations are well-informed and balanced.

Finally, a Commissioner must remember that she/he serves as a bridge between the Community and the Town Council, ensuring that planning decisions reflect the needs and desires of Los Gatos residents while adhering to legal and policy guidelines.





Have you ever attended or viewed a Planning Commission meeting? If yes, please note which meeting you viewed or attended and provide a summary of your observation. If not, why not?

Yes, I attended the November 13, 2024, Planning Commission meeting to present verbal comments on the 110 Wood Road project. I was called upon by the Applicant to review their proposed development from a wildfire safety standpoint. I attended the meeting from 7:00-9:00 PM.

I also attended virtual Planning Commission meetings during my 2022 Town Council (August/September 2022) campaign to get an understanding of the workings of the Commission.

I will focus my observations on the November 13 meeting. First, I was impressed by the preparation of the Planning Staff. In preparation for the meeting, I studied the Staff Reports for the 15411 National Avenue and 110 Wood Road applications. I found the Staff reports to be professional, well written, easy to understand and contained solid conclusions.

From a Planning Commission standpoint, I was impressed with their demeanor, decorum and the questions asked by Commissioners. Even though there was not complete agreement, it was evident the Commissioners had done their homework.

How will you demonstrate impartiality in your role as a Commissioner with your personal beliefs with regards to land use and planning policies?

Demonstrating my impartiality as a commissioner involves several key things:

- Adherence to Guidelines: I will follow the town's General Plan, zoning ordinances, and other regulatory requirements. My decisions will be based on established policies rather than my personal beliefs.
- Fact-Based Decisions: Like I always say, "In God we trust, all others bring data!" Relying on data, expert opinions, and comprehensive staff reports will help me ensure that my decisions are grounded in objective information rather than subjective views.
- Public Input: I will actively seek and consider input from the community during public hearings by asking good questions. This will ensure a fair hearing of facts and perspectives. My goal is to balance my personal beliefs with the community's needs.
- Collaborative Approach: I will be committed to working closely with other commissioners, Town staff, and stakeholders to reduce the influence of my own biases. It's

not about me!





The Commission is expected to demonstrate knowledge of the Town Code and its land use and planning policies. What experience do you have that would be useful on the Commission?

Town Code: While I am just familiarizing myself with Chapters 20 & 29, Planning and Zoning Regulations (only 240 pages!), I have referred to the Town Code in my work on wildfire, specifically Chapter 9 – Fire Prevention and Protection and Chapter 26 – Trees and Shrubs. I know how to access and read the Town Code. I will be spending more time in the Town Code.

 Community Involvement: My participation in Wildfire leadership activities, including leadership of the Ad Hoc Wildfire Committee, and my run for Town Council in 2022 have provided me with valuable experience on the inner workings of the Town. It has also facilitated development of professional relationships with Council members and Town staff.

 Homework: over the past several years, I have studied Town code, Staff reports and other public Town reference documents to prepare for verbal communications, meetings with Council members or to perform Ad Hoc committee work. I do possess the ability to analyze complex reports, plans, and data.

 Communication: I have demonstrated strong verbal and written communication skills in my work with the Town and during my campaign for Council. I am comfortable making public presentations and have engaged with residents and stakeholders to address difficult issues e.g., tree removal, enforcement actions, etc.

The exposure, both education and relationships, that I have experienced over the past 5+ years with the Town will help me, as a Planning Commissioner, make balanced, informed, and fair decisions that align with the Town's goals and policies.

How would you describe your approach to planning and how it would relate to making a land use or policy determination?

My approach to planning involves principles and values that guide my decisions.

Community-Centric: I will place a high priority on community needs and input. Engaging
with residents (within limits of the Brown Act) and the give and take during
Applicant/Community comments help ensure that policies reflect the community's

desires and address their concerns.

• Data-Driven: I rely on data, reports and other reference material to inform my decisions. This will assist me in making informed policy decisions.

• Flexibility and Adaptability: I am open to new ideas and adapt well to changing circumstances. This allows for better solutions and adjustments to policies as new information emerges.

Case Study #1 - Fictitious Location

What is your initial reaction to the above referenced project?

Response

Based on the analysis and review performed by Planning for this proposed project in a C-1 (Neighborhood Commercial) zone, the proposed project could be approved as presented. It meets the criteria outlined in Chapter 29, Article VI, Division 3 - C-1 or Neighborhood Commercial Zone.

- 1. Height: The proposed building height is 32 feet, which is within the maximum allowed height of 35 feet.
- 2. Lot Coverage: The proposed building's footprint is 10,000 square feet, well within the maximum allowable lot coverage of 15,000 square feet.
- 3. Use: Office buildings are a permitted use in the C-1 zone. Additional reference: Sec. 29.20.185. Table of conditional uses.
- 4. Surrounding Area: The surrounding area on Smith Boulevard includes other commercial buildings, which aligns with the intended use of the C-1 zone.

What issues do you feel will need to be investigated further?

Response

The main area of concern for the residents is traffic impact and the discussion should remain focused on this concern. One item this case does not address. Has the applicant met with the residents to discuss how their concerns can be addressed to some degree? If not, the applicant should be encouraged to meet with the neighbors to share full details of the proposed project including the number of expected vehicle trips/day, parking plans including entrance location for above (if any) and below ground. If this project is adding to existing neighborhood concerns about traffic and traffic safety in general, perhaps traffic calming measures need to be considered. This neighborhood may be a candidate for the "Neighborhood Traffic Calming Program" adopted in March 2002.

How would you weigh your personal observations or experience regarding traffic and the professional input and recommendations of Town staff and Town consultants?

Response

Traffic congestion is a major issue for Los Gatos residents – over 60% of residents surveyed a couple of years ago selected traffic as a major issue with only ~30% satisfied with the Town's response. All to say, when traffic concerns are raised, special attention needs to be paid to those raising the concerns. That said, once good faith efforts are made by the applicant and residents to address traffic concerns and backed by the professional input and recommendations of Town staff and Town consultants, the project should be approved. Hopefully all concerned will be able to say, regardless of putcome, there was a fair hearing.

Case Study #2 - Fictitious Location

What is your initial reaction to the above referenced project?

Response

The project meets all the requirements set forth in the Town's R-1 (Single Family Residential) Zoning District, specifically Zone R-1:8. Seems like there is a 50/50 split in neighborhood support for this project. The major concerns are focused on "bulk and mass" and privacy, specifically the one-story homes on either side of the project. Based on the concerns being raised, it makes me wonder what degree the applicant has engaged the residents particularly those with one-story houses on either side of the project. I would want to hear from the applicant and the residents to get an better understanding about possible solutions discussed related to privacy e.g., line of sight from the second story to the one-story houses. Have windows, location or privacy glass been considered? Can the height of the structure be lowered without impacting living space? Answers to these two topics: "bulk and mass" and privacy would guide my decision.

What issues do you feel will need to be investigated further?


As I have already stated in the prior response: bulk and mass, and privacy.

How would you weigh your personal observations or experience regarding neighborhood compatibility and privacy and the professional input and recommendations of Town staff and the Town consultant?

Response

Ah neighbors! I think everyone wants to live in a nice neighborhood and have good relationships with their neighbors, at least your next-door neighbors. Being a good neighbor means at least listening to the concerns of your neighbors and ideally coming to some agreement on a solution. Assuming I had done a field visit to the project site, and further assuming or determining the main concerns are coming from the residents in one-story houses either side of the project related to privacy, I would look to the applicant and those residents to address that issue. I would further expect the applicant and residents to present what solution/s each has presented to resolve the concerns to the Planning Commission.

The Town staff and consultant have done their job. This project meets the requirements for this R-1 zoning district. What they cannot be called upon to do at this point is mediate a solution between the applicant and the neighbors. It is up to the Planning Commission to listen to both sides and ultimately make a final decision.

My educational background includes a BA in Education from the University of Arizona, a MAT from the University of Washington, and a JD from Hastings College of the Law. I taught school for USDESEA in Ethiopia and Spain and then In school districts in Mukilteo, Washington, and Watsonville, California. After graduating from law school I was an aide to a county supervisor in Santa Cruz County until I became an attorney for the Santa Clara County Counsel's Office, where I worked for 17 years. I have served on the board of the Los Gatos Elementary Education Foundation and the Personnel Board for the Santa Clara County Office of Education.

Why are you interested in serving on the Historic Preservation Committee?

After having the opportunity to travel while my family lived in Europe and I worked overseas, I gained an appreciation of the history and culture represented in part by the buildings and monuments of those communities. That general interest became a bit more focused when my husband and I purchased a house originally built in 1887 that had been damaged in the Loma Prieta earthquake. I value the character that historical buildings bring to our community.

Yes, it was in approximately 2004 and I don't have a specific recollection of the meeting. I was seeking to learn about the process in relation to a proposed remodeling of my house.


How will you balance your personal interests with the broader role of the Committee which requires impartiality in the decision making process?


Why are you interested in serving on the Historic Preservation Committee?

I've been a "history buff" for as long as I can remember!

In 2016, I created and launched a free mobile app called "Discover LOST Gatos". The app offers a series of three self-guided walking tours of our historic downtown. My collaborators were Sandy Decker and Peggy Conaway Bergtold. Our mission was to generate enthusiasm among Los Gatos residents for preserving our town's unique character and historic treasures before they are "lost" forever. This entirely self-funded project was a year-long labor of love and a gift to the community.

In the years since, I've given multiple presentations about Los Gatos history to our service clubs, and have led several historical walking tours for small groups. I've been interviewed for a Community Storytelling episode on KCAT. For the past three years, I've written a monthly "Discover LOST Gatos" history column for the Los Gatan.

I intend to bring this same passion for Los Gatos history to the Historic Preservation Committee.





Have you ever attended a Historic Preservation Committee meeting? If yes, please provide a summary of your observation. If not, why not?

I've attended multiple HPC meetings as an observer beginning in 2022 and I appreciated the opportunity to learn about the review process firsthand. It struck me as objective and impartial, with only the most specific and relevant questions addressed to applicants.

The voting and approval process seemed to be fairly quick and efficient for a variety of commercial and residential applications. I was also impressed by how well organized and efficiently all three meetings were run.

The information packets provided by staff were complete and comprehensive and easy even for a lay person like me to understand. Communication among and between commissioners, staff, and applicants was straightforward and professional. Zoom seemed to be an efficient way to conduct some of these meetings during COVID.

How will you balance your personal interests with the broader role of the Committee which requires impartiality in the decision making process?

I'm not involved in commercial or residential development and have no outside interests, either personal or professional, in any projects related to historic preservation in Los Gatos or elsewhere.

Although many proposals delivered to the HPC will likely come from the historic homes in my Glenridge neighborhood, I'm aware that I will need to recuse myself from decisions involving properties within 1,000 feet of my home.

Finally, I'm retired so there won't be any work-related scheduling conflicts.

What do you see as the role of this Committee?

I understand that the HPC is an advisory committee whose role is to objectively review proposals for development or alteration of historic properties that are either within a historic district or with a landmark designation. The committee may directly approve applications for minor development. Projects of greater scope are also reviewed, and the committee's recommendation is subsequently forwarded to the Planning Commission for further review and approval. The entire process is outlined in great detail on the Town's website.





Describe your background in architecture, history, architectural history, city planning, archeology, or other historic preservation related disciplines.

Navigating through five years of engineering school requires a high level of attention to detail as well as a significant process orientation. Ditto for two years of graduate business school. These skills, combined with a passion for Los Gatos history enable me to bring a unique perspective to the HPC. I'm sure I'll be surrounded by other committee members and planning commissioners with experience and/or training in architecture, city planning, or related disciplines and I'm confident that I'll be able to contribute to the HPC even though I don't have the same background as my colleagues.

Describe your knowledge of the Town's residential and commercial design guidelines, and/or historic preservation regulations.

When I started attending HPC meetings as an observer, I began educating myself by reviewing the most relevant material on the town website, including the Draft 2040 General Plan and the Housing Element. I've also read the Historic Preservation Town Code, researched the minutes of previous HPC meetings, and familiarized myself with the approval process. There's a tremendous amount of information to absorb, so I expect to be in constant learning mode.





How would you describe your philosophy on planning?

My philosophy on planning is straightforward. I believe it's important to have objective, published guidelines and even more important to apply them consistently to all projects across the board. While there's always room for interpretation, I believe that granting exemptions should be kept to a minimum. The same holds true for any type of plan developed by the town. I also believe that projects should be considered in context and that compatibility with neighboring properties is an important issue when considering any changes to one specific property. Neighbor outreach and pubic input to solicit feedback are vital. Finally, I dislike excessive bureaucracy so I expect that the HPC will be seen as an asset and not an obstacle to development.

Have you discussed the role of a Committee member with any current or former Historic Preservation Committee member or with anyone on the Planning staff? If yes, who and what did you learn?

I've had multiple discussions with current HPC committee members Susan Burnett, and Lee Quintana, former committee member and current vice mayor Matthew Hudes, and former mayor Sandy Decker.

These were excellent opportunities to get answers to a dozen or more specific questions that I had about the HPC organization, the roles of committee members, and the challenges and limitations they face. Some of these were procedural and administrative questions including why there's an opening for a new committee member, when my term might begin, when I would be required to recuse myself from voting, and how the appeal process works. I also wanted to get their views on the impact of SB9 and how the committee's role might evolve.



What, from your perspective, are the major priorities in the areas of parks with respect to policies, capital investment, and/or maintenance?



The committee is also the Sustainability Commission. I hope that Los Gatos is proactively working on projects to improve sustainability throughout the area and expect the Commission to discuss these projects at every meeting.

What do you see as the role of this Commission?

I believe the Commission should be a proactive and community-focused entity which evaluates the community's park usage to understand any improvements or modifications that town members would like to see.

I would look at the town's tree policies and determine how to improve our tree cover. The US Forest Service estimated that Los Gatos had lost 2.7 percent of its tree cover between 2012 and 2018. Since then, we had fierce winter storms that toppled trees, our spruce trees are reaching the end of their natural life, PG&E has cleared or cut back trees from the power lines, and the insurance companies have demanded homeowners trim or remove trees. All of which would lead to an even greater reduction in tree cover. I think the town should also look at how to increase the amount of native, low-water plants used in landscaping. Blossom Hill Park is the park I visit the most, and the edges of the park are a great example of a place that could be enhanced with more native plants. I believe in maintaining the large lawn area for children and families to enjoy. However, the lawn near Blossom Hill Road could be low-water plants instead, reducing water usage. I recently attended a native plant symposium, and two groups presented on town/resident partnerships. In Palo Alto, the town has allowed a group of residents to plant and maintain 7 gardens on public streets

(http://www.primrosewaypollinatorgarden.com/index.html). In San Carlos, the town and a master gardener group jointly sustain a sizeable native garden behind the city hall (https://www.cityofsancarlos.org/city_hall/departments_and_divisions/parks_and_recreat ion/parks_and_facilities/native_habitat_garden.php). I would love to see Los Gatos look into possibilities such as these.

I would also like to expand the Growing Greener newsletter once the department identifies a new Environmental Programs Specialist or other owner.

How will you balance your personal interests with the broader role of the Commission?

Having always worked in group situations. I understand that no individual makes the decisions of a Commission. I am upfront and will always present my viewpoint, but I also realize that the group will not always agree with me. I would work hard to build and maintain positive relationships with all Park and Sustainability Commissioners.





What, from your perspective, are the major priorities in the areas of parks with respect to policies, capital investment, and/or maintenance?

The first priority has to be safety. With all the ground squirrels in Oak Meadow Park and the large trees in all the parks, we need to ensure that the trees are properly maintained to provide a safe environment for all park users.

I think it is time to analyze the parks and see if we can make areas more water-efficient with native and other drought-tolerant plants. There have been discussions in commission meetings about painting courts for use by pickleball and tennis players. It is important to continue to evaluate the recreation options in town and make sure they align with the residents' current needs.

Have you visited any of the Town parks? If yes, which ones? What did you like most and least about them?

I have spent many hours in the town's playgrounds with my three daughters when they were younger (though even as young adults, they often visit the park when they are home.) We spent most of our time at Blossom Hill Park because it is closest to our house. I also walk my dogs through the park on a weekly basis. I love how vibrant the park is. There are also people using the facilities, and I love to see the little ones learning soccer. Both edges of the park have a dirt path that appears to have been made by people walking versus planned infrastructure. I would love to see these spaces be more organized so they can include an educational component such as informative boards or a permanent scavenger hunt, as well as less ivy and other high-maintenance plants.

I walk or run on the creek trail regularly. My favorite section is from Oak Meadow Park to Campbell Park, so this is the section I do the most. My daughters used to love to go to Oak Meadow Park to ride their bikes or the train. Although I understand the necessity of creating a fire break, it is unfortunate that there are so many fewer bushes and trees, creating a sound barrier between Highway 17 and the creek trail. Frankly, I no longer use that part of the trail because the highway is so present.

I have supported the high school's freshman fun run at Novitiate Park, which is also where we start our hikes to St Joseph's. The park could be more exciting, but it is a convenient entrance point from town.

I took pickleball lessons at La Rinconada Park. I hiked at Belgatos Park. My daughter's friend lived across the street from Bachman Park. One of our dog walks goes through Worchester Park. And, of course, I have been to the Town Plaza for the farmer's market, Jazz on the Plazz, and just daily life! Our parks are one of the jewels of Los Gatos, and I would love to be on the Commission to enhance our parks to keep them unique, while expanding the Commissions focus to promote sustainability and improve our town.


What, from your perspective, are emerging needs/trends in our older adult community that you would like the Commission to address?



I have served as president 5 terms and am currently the Director of Voter Services focused on voter registration, candidate forums and development of pros and cons on ballot measures. As part of my League work, I also chaired the 3 year LWVC State Study of Public Higher Education and participated in two local studies. I am also a member of the Initiative and PR sub committee of the Los Gatos Thrives Foundation.

I have enjoyed serving on the Community Health and Senior Services Commission these past 3 years. I agree/support the mission of the Commission and feel that it does work that is important, worthwhile, informative, and acknowledged by the Town Council. I like and support the Commission's areas of focus: Senior Services and Community Health.

Have you ever attended a Community Health and Senior Services Commission meeting? If yes, please provide a summary of your observation. If not, do you follow any other senior oriented programming in the area (e.g. LGS Rec 55+, Saratoga Area Senior Coordinating Council, Sourcewise, etc.)?

As a member of and current chair of the Community Health and Senior Services Commission, I have attended all meeting the past 3 years. My observation is that the LG Town Council has demonstrated its belief in the work of the Commission by assigning it specific duties (i.e. provide oversight on the implementation of the Senior Services Roadmap goals) and then allowing significant time at a Board meeting to review our Annual Report and acknowledge our recommendations. I have also observed that all CHSSC members are very focused on the implementation of the Senior Services Roadmap goals as well as providing our growing senior population with information and access to the many services available in our local and surrounding community. I was very involved, along with LGS Rec.55+ staff, in the development of the HUB - which is an online access tool for seniors. One of the Goal Area Task Forces has just recently reviewed all aspects of the HUB and will provide that info to LGSRec 55+ program staff for updates. Lastly, when able, I also attend the West Valley Service Providers' Meetings.





How do your personal interests align with the broader role of the Commission?

My personal interests closely align with the broader role of the Commission in that I am a representative of and a voice for the "senior age group" the Commission and the Senior Services Roadmap is focused on. As I myself have aged, I find my interests in learning about senior services and their availability in our community have increased. Serving on the Commission has allowed me to gain much information and promote access to that information and services to the broader community and to my personal community of friends and acquaintances.

What do you see as the role of this Commission?

The role of the Commission is an advisory one - to provide information, oversight and possible recommendations to the LG Town Council regarding Seniors Services and Community Health.

What, from your perspective, are emerging needs/trends in our older adult community that you would like the Commission to address?

The survey conducted a few years ago confirmed that Los Gatos' older adult population will continue to increase dramatically. It is estimated to reach 30% of our population by 2030 - a mere five years away from 2025. This significant demographic group has and will have on-going economic and social implications for the Town. Spending habits and property tax revenue will impact the Town's economic base. The need for in-home care and/or leveled senior housing, social activities, and outreach will increase. Personally, I would like the CHSSC to put even more focus on addressing senior loneliness and social isolation, along with housing and transportation opportunities, and caregivers' support programs. One commissioner and another volunteer are currently involved in reviewing, editing, and updating the LG Housing report, completed by Town staff, that is available on the town's website.

What has been your experience or involvement with grant programs?

During my public school tenure as an administrator (elementary school principal, associate superintendent for curriculum and instructions, and superintendent) I was involved with many successful grant writing experiences. While often extremely time intensive to successfully complete, grants require critical reading to address requirements, clear identification of goals and expected outcomes, and identification of specific assessment tools to evaluate successful use of the funds. The most successful grant writing experience I was involved in secured a three year, \$300K grant to fund literacy coaches at 3 elementary schools.







PURPOSE

To establish a policy to encourage participation by the Town's residents on Town Boards, Commissions and Committees (hereinafter referred to as "Commissions"). The Town of Los Gatos is committed to inclusivity. We value all our community members, regardless of religion, immigration status, ethnicity, race, disability, gender, sexual orientation, or gender identity. The Town will encourage residents to participate on Commissions by advertising vacancies on Commissions for at least 30 days, preparing easily understood applications, maintaining clear descriptions of the role of each Board, Commission, and Committee and its respective members, providing current meeting schedules, and conducting public interviews of all Commission applicants, except as provided by this Policy.

SCOPE

This Policy applies to all applicants to Town Boards, Commissions and Committees.

POLICY

The Town Council encourages public participation in all decision-making and to be successful residents must be assured both that the participation is meaningful and that their input will be valued. The widest representation from the community can only be achieved if vacancies are well advertised so that anyone interested will have the opportunity to apply. Interviews of the applicants conducted in public by the Town Council demonstrates that it values these appointments and that all have an equal opportunity to be appointed. Applicants may apply to more than one Commission, and shall rank their choices in their preferred order, during each recruitment cycle.

To ensure the greatest possible participation by the public, it is the Town's policy that no person shall be appointed to more than one Commission except in those cases where they are ex-officio members of other Boards, Commissions and Committees. This Policy does not apply to Commission members serving as representatives of their Commission who have been appointed by the Town Council.

RESIDENCY REQUIREMENTS

Residency within the incorporated municipal limits of the Town of Los Gatos, California is required for appointment and continued membership on all Town of Los Gatos Boards, Commissions, and Committees, with the exception of the Youth Commission and the Diversity, Equity, and Inclusion Commission.

Youth Commission:

The members shall be students who are entering grades 8 through 12 in the fall. Membership for the students requires either residency in the incorporated limits of the Town of Los Gatos or residency in the unincorporated areas of the County of Santa Clara, which have a Los Gatos mailing address.

Diversity, Equity, and Inclusion Commission:

Membership composition shall be as outlined in the Commission's enabling resolution and includes a Los Gatos business owner/employee, faith leader who leads a congregation in Los Gatos, and Los Gatos non-profit employee who may or may not reside in Los Gatos.

ATTENDANCE REQUIREMENTS

- 1. All members of all appointive Town Advisory Bodies should attend all regular and special meetings of said Advisory Bodies.
- 2. Any member not in attendance at a regular meeting of said Advisory Body for at least 70% of the meeting shall be considered absent.
- 3. Any member of an appointive Town Advisory Body who is absent from the number of regular meetings listed below appropriate to his or her Advisory Body shall, as a result, surrender his or her office on the Advisory Body and the office shall be considered vacant.
 - a. For an Advisory Body which holds six (6) or more regular meetings per a consecutive twelve (12) month period: three (3) regular meetings.
 - b. For an Advisory Body which holds five (5) or fewer regular meetings per a consecutive twelve (12) month period: two (2) regular meetings.
 - c. For an Advisory Body which holds sixteen (16) or more regular meetings per a consecutive twelve (12) month period: eight (8) regular meetings.
- Consistent with the Family Medical Leave Act and the California Family Rights Act, absences of up to 12 weeks due to parental leave constitute excused absences.
- 5. The vacant position shall be filled by appointment by a majority vote of the Town Council, for a term equal to the unexpired portion of the office vacated. Any member

removed from office due to non-attendance may re-apply to serve on a Town Advisory Body but will not be treated as an incumbent in any subsequent application to the same Advisory Body.

6. If a Youth Commissioner liaison misses three meetings of a liaison Commission during a consecutive twelve (12) month period*, the Youth Commission shall appoint a different Youth Commissioner as liaison.

*Consecutive twelve (12) month period is defined as any consecutive twelve-month period beginning with the first absence. A regular meeting shall not be cancelled and replaced with a special meeting in order to alleviate an absence by an advisory body member.

QUORUM REQUIREMENTS

The number of members needed to constitute a quorum on any Town Advisory Body shall be a majority of the total number of filled seats.

PROCEDURES

The following procedures will be followed by the applicant, the Town Clerk, and the Town Council for the appointment of applicants to Town Commissions:

Responsibility and Actions: Town Clerk

A. Annual Recruitments

Adult Commission members' terms begin on January 1st and end December 31st, Youth Commissioners' terms follow the academic year and begin on August 1st and end on June 30th. The Town Clerk shall perform the following duties in conducting an annual recruitment for Commission members:

- Notify Town Council of vacancies on Commissions by indicating the names of the Commissions, the number of terms expiring or being vacated, names of individual(s) with expiring terms or vacating seats, advertising periods (at least 30 days) and the date of interview.
- 2. Advertise the vacancies, including the application deadline and the interview date. Interviews and appointments for Adult Commissioners shall occur after annual Mayor and Vice Mayor selection, and in the case of election years, after new Council Members have been seated. Interviews and appointments for Youth Commissioners shall occur by the fourth Wednesday in May, no earlier than 4:00 p.m.
- 3. Prepare and maintain easily understood applications for appointment to Commissions. Applications shall include the following policy information:
 - a. Prior to initial appointment to any Commission, non-incumbent applicants must be interviewed by the Town Council. The applications of those not appearing will be held for the next recruitment.

- b. If an incumbent Commissioner is requesting reappointment to the same Commission, the incumbent may submit a request to be interviewed by telephone, with their application, instead of attending the interview or must submit a letter prior to the interviews, describing the reason why the applicant cannot be present telephonically or in person for the interview, and why the applicant should be reappointed to the Commission.
- c. Submissions deadlines are mandatory; no exceptions are permitted.

4. Applications:

- a. For adult applicants Accept applications, verify eligibility, and distribute copies of the applications of eligible applicants to the Town Council prior to the interviews for appointment.
- b. For student applicants Accept applications, verify eligibility, and distribute copies of the applications of eligible applicants to the Town Council Selection Committee, consisting of the Mayor, Vice Mayor, Police Chief, and Youth Commission Chair (if not reapplying), prior to the interviews for appointment.
- 5. Notify the applicant by letter or email as to the date and time of the interview and provide the option for an in person or teleconference interview.
- 6. Facilitate the Council voting process set forth below by informing Council as to how many votes are possible on each Commission, calling out applicants' names, and identifying the applicants receiving sufficient votes for appointment. This process does not apply to student applicants.

7. Applicants:

- a. For adult applicants After the interviews and Council vote are completed, notify all applicants of the Council's action, and explain Town policy of keeping application active for one year with notification of subsequent openings on that Commission to the interested applicants.
- b. For student applicants After the interviews are completed, notify all applicants of the Council Committee's action, and prepare a staff report for the Town Council to ratify the Committee's appointment at the first Town Council meeting in June.

Interview Process

To ensure the interview process is consistent, fair, and equitable, each applicant shall be asked the same standard questions, as provided below. Notwithstanding, no Council Member shall be prevented from asking appropriate questions of applicants.

- 1. If appointed, what ideas would you like to see the Commission explore?
- 2. Please expand beyond the written response on your application: your experience, interest, and/or expertise that you feel would be most useful to the Commission.
- 3. Please elaborate on any written response provided in the application to assist the Council learn more about you.
- 4. If you did not answer any of the questions on the application, please explain why.

The standard questions are limited in number to allow an applicant sufficient time to respond. While the intent is for each Council Member to be able to ask one question of each applicant, the Council may decide not to ask all of the provided questions, change the order of the questions, or rotate which Council member asks a specific question. Applicants will be given a two-minute time limit to answer each question.

Balloting Process

Unless determined otherwise, the Council shall conduct a ballot vote for the appointment of individuals to fill the vacancies for each Commission. Such ballot vote may be conducted at either a regular, adjourned, or special meeting of the Town Council. The ballot vote process shall be conducted as follows:

- The Town Clerk shall provide a ballot to each Town Council member listing the names of all applicants and "None of the above" for each respective Commission. Prior to the vote, the Town Clerk shall publicly announce the position vacancy and all applicant names that are listed on the ballot.
- 2. Each Council member may vote for the same number of applicants as there are current vacancies on the respective Commission. In no case, can a Council Member cast more votes than there are vacancies; or vote for the same candidate more than once on each ballot (i.e. cumulative voting -- e.g. where there are three vacancies, a Council member may not give all three votes to the same candidate). A Council Member is not required to vote for any of the candidates or for the total number of vacancies available.
- 3. The Town Clerk shall collect all ballots and shall publicly announce the name of each Town Council member and how that Council member cast his or her vote. In the case of a tie vote, the Town Clerk will announce that there is a tie and that a run-off vote shall be conducted but will not announce the names of the applicants in the run-off. Once all voting is concluded and a decision made, the votes will be made public. The run-off ballot will also include a "None of the above" option.
- 4. Applicants receiving a majority number of votes shall be deemed appointed to the Commission. In the event of a tie, a run-off vote shall be conducted among the applicants receiving the highest number of votes from the previous round. This shall continue until a majority consensus on an applicant(s) is reached for the number of vacancies to be filled. In the event of an unbreakable tie, the Council may determine an alternative method for selecting the appointee(s) or direct the Town Clerk to re-advertise the vacancy.
- If an applicant(s) is appointed to an Advisory Body which has vacancies for both full and partial, unexpired terms, the length of the appointee's term will be determined by the Mayor.

B. Mid-Term Recruitments

During the year, Commissions may experience vacancies that drop the number of filled seats to a number of members that is not sufficient to conduct Commission business. The Commission may request the Council to conduct a mid-term recruitment to fill seats. To the

extent possible, the Town Clerk will consolidate mid-term recruitments to minimize the number of recruitments occurring throughout the year. In the event of a vacancy on the Planning Commission, the Town will automatically conduct a mid-term recruitment. Mid-term recruitments will not be conducted for Youth Commissioners. The Town Clerk shall advertise mid-term vacancies on Commissions for at least 15 days.

Responsibility and Action: Applicant

- Read the Commission Appointments, Residency and Attendance Requirements, and Establishing a Quorum Policy, complete and submit to the Town Clerk the application for appointment to a Town Commission by the advertised deadline date and time.
- 2. For adult applicants: Attend the Council meeting to be interviewed for Commission appointment. The applicant is required to notify the Town Clerk no later than 4:00 p.m. the Friday before the scheduled interview date whether they will attend in person or via teleconference.
- 3. For student applicants: Attend the Council Selection Committee interview session. The applicant is required to notify the Town Clerk no later than 4:00 p.m. the Friday before the scheduled interview date whether they will attend in person or via teleconference.
- 4. If an incumbent Commission member is requesting reappointment to the same Commission and is not available on the date of the interview, the incumbent must submit a letter by 4:00 p.m. the Friday prior to the interviews, describing the reason why the applicant cannot be present telephonically or in person for the interview, and why the applicant should be reappointed to the Commission.
- 5. If appointed, prior to starting the Commission term, appointees are required to attend a Commissioner Orientation and take the "Oath of Office."
- 6. Attend Advisory Body meetings once term begins.
- 7. Read the Commissioners' Handbook. Hard copies of the Handbook are to be returned to the Town Clerk when the term is complete.

Responsibility and Action: Town Council

- Review applications.
- 2. For adult applicants Interview applicants individually by Commission at a public meeting with all applicants present.
 - For student applicants Town Council Selection Committee interviews applicants.
- 3. Determine if the incumbents not in attendance and having submitted a letter pursuant to this Policy should be considered for reappointment.
- 4. If there are limited applications for any vacancy to a Commission, the Mayor, on behalf of the Council, may request that the Town Clerk re-advertise the vacancy, reschedule the interviews, and notify all applicants of the new interview date.

COMPLIANCE - GROUNDS FOR DISMISSAL

A member may be removed from the Advisory Body prior to the end of his or her term by a three-fifths (3/5) vote of the Town Council and may not be reappointed for the following reasons:

- 1. Failure to attend Advisory Body meetings.
- 2. Failure to file the following documents required by the Fair Political Practices Commission (Adult Commissioners):
 - a. Form 700 Assuming Office, Annual, and Leaving Office when term is complete.
 - b. Planning Commissioners are also required to complete AB 1234 Ethics Training and file the original certificate with the Town Clerk every two years.
- 3. Failure to comply with all Town Policies, Guidelines, and Handbooks.

CONFLICT OF INTEREST

Under the Fair Political Practice Act, an advisory board member has a disqualifying conflict of interest in a governmental decision if it is foreseeable that the decision will have a financial impact on his or her personal finances or other financial interests. In such cases, there is a risk of biased decision-making that could sacrifice the public's interest in favor of the official's private financial interests. To avoid actual bias or the appearance of possible improprieties, the public official is prohibited from participating in the decision.

The Fair Political Practice Act does not prohibit an advisory board member from participating in a decision simply by virtue of holding a position as a board member, director, officer, or employment with a nonprofit corporation. However, the Town strongly encourages that in the event that a decision concerns a nonprofit corporation for which an advisory board member is a board member, director, officer, or employed with that nonprofit corporation, the person should recuse him or herself and at a minimum shall disclose the potential conflict of interest before any discussion and decision.

Thank you for opportunity to be interviewed for the position on the Arts & Culture Commission. I am an incumbent, my name is Thomas C. Spilsbury, and I have been a very active Commissioner and a member of the Arts Commission for over 12 years. Unfortunately, due to the late notice of this very important interview, and the unique holiday schedule this year I am unable to attend the interview. I will be out of town and unable due to time change issues participate in the teleconference interview process as well. I am required to be in Nampa, Idaho in business meetings I cannot postpone or reschedule.

I take my involvement with the Arts Commission very seriously and have volunteered hundreds of hours for the work and involvement that the Arts Commission has been associated with over the past many years. I am very proud of the accomplishments that we have been apart of to promote Public Art in our Community and the public art projects that I have worked tirelessly to make come to fruition. Some of the projects I have been involved with are as follows:

- The Children's Art Bridge: I was instrumental in securing an application process of the Children Art that would be compatible with the bridge materials, work with the Los Gatos Rec. Department to hire an art teacher and set the curriculum for the program, and then work with the Town's Public Works Department to get them installed and maintained. This project is now and ongoing program that almost pays 100% for itself and has been wildly successful. (this project took almost 3 years to get up and operating)
- 2) Outside The Box Program: I worked hand in hand with Marina Chislett, Parks & Public Works on all phases of this very successful project that converted old unattractive utility boxes into small "Works Of Art" in all the different neighborhoods of Los Gatos. This project is still on going and was started in 2015 or so.
- 3) The Public Art Assessment Fund: This program took almost nine years to conceptualize, get approved legally and politically and involved the public for their support and approval. This program was the most important project I was totally involved with in that it creates funds for Public Art for now and in the future. This fund provides for Public Art that is funded without the burden on the Town of Los Gatos budget.
- 4) The Gateway "Cat" Project: This project originated in 2014. I worked with Public Works and researched 14 different locations as to their viability for "Gateway" status. These locations were then further defined down to 5 locations. We then went out to secure artists, which Ryan Baker was instrumental and got 17 artists which thru the public being involved got it to 3 artists then to 1. This project has been extremely successful as we have installed 3 of the sculptures and as of now, we have defined the last 2 locations for the last two "Cats" which will be installed early 2025 and 2026.
- 5) Member of the committee for The Town Of Los Gatos Art Grant Program.

II believe that I have

been a creative force on this Commission and I have used my knowledge and background to work to achieve more awareness of Public Art. I have been able to as use my skills to promote the implementation of these concepts. I have lived all my adult life in Los Gatos having moved here in the beginning of 1962 (63years). I am very proud of what we have been able to accomplish and believe that the Town is also proud of the work we have done. I also have the time to commit to the schedule and time required of the Commission. I would very much enjoy moving forward with the Commission as we are looking at the "Beautification of The Bas Relief Concrete Panels "under the Town's Roberts Road Bridge on the Los Gatos Creek Trail.
