RECOMMENDATION:

Receive a report and provide direction on the Pinehurst Community Garden (CIP No. 831-4610) and Lynn Avenue Pedestrian Pathway (CIP No. 832-4510).

BACKGROUND:

The Town's Adopted Capital Budget includes funding for the Pinehurst Community Garden and the Lynn Avenue Pedestrian Pathway. Given their close proximity to each other in east Los Gatos, staff proceeded with concept development for both projects concurrently.

On June 20, 2023, Town Council authorized the execution of an agreement with Dillingham Associates to provide preliminary design services for both projects. The scope of work includes development of multiple concept plans for each location, community outreach, and the preparation of one concept for each location that reflects the community feedback. The final concept plan will be brought to Town Council for review before proceeding with development of design drawings.

At present, the consultant has developed multiple concept plans for each location and community outreach is in process. At this study session, staff will present the base mapping of the properties in questions, show the concept plans to Town Council, summarize the feedback received to date, and receive Council comments and direction.

DATE: December 11, 2023

DISCUSSION:

The proposed projects span three separate properties, two owned by the Town of Los Gatos and one owned by Pacific Gas and Electric. All three parcels are encumbered with a PG&E easement for overhead electric transmission lines and a Valley Water easement for a potable water transmission line. Other reported encumbrances in favor of private property owners are still being verified.

Three community garden concepts were developed that include up to 30 raised garden beds plus up to nine beds that meet requirements of the Americans with Disabilities Act. Small areas for seating are shown for consideration. One alternative proposes off-street parking in response to community concerns regarding lack of parking in this area. Staff also contracted a consultant to complete parking counts in the area to assess the existing use of on-street parking spaces.

Three concepts have been developed for the Lynn Avenue Pedestrian Pathway. Each concept proposes both bicycle and pedestrian pathways to allow for connection to the planned Blossom Crest Trail. Community Feedback

Staff and the consultant team presented preliminary project information at a joint meeting of the Arts and Culture and the Parks Commissions on October 18, 2023 (this was prior to the name change to Parks and Sustainability Commission). Notices for this meeting were mailed to residents within a 500-foot radius of the project sites and posted on social media. Members of the public were invited to attend and provide comment. Approximately 20 residents attended the meeting and eight comment cards were received. Two spoke in favor of the project and six against.

On December 4, 2023, the Parks and Sustainability Commission received a presentation about the two projects and provided feedback. The Commission's feedback regarding the garden included support for the idea of off-street parking to alleviate potential impacts to the neighborhood, a desire to provide tribal land acknowledgement, and interest in providing seating and picnic space. With regard to the walkway, the Commission expressed concern about bicycle and pedestrian conflicts, interest in nature-based amenities, and the desirability of including art and play features such as slides or swings.

DISCUSSION (continued):

On December 7, 2023 the project team hosted a community meeting. Notices for this meeting were mailed to the residents in the same 500-foot radius, emailed to residents that had expressed interest in wanting to be notified about the project, and posted on various social media platforms, the Town website, and in the Town's weekly newsletter. Approximately 25 residents attended the meeting with most of them being against the project.

A copy of written comments received through this process (as of December 14, 2023 at 11 a.m.) are presented in Attachment 1.

Residents adjacent to the project sites have expressed concern regarding parking and traffic, loss of privacy, loss of access to areas of their property, and noise from the proposed uses. Some of the feedback received included scaling the project down (i.e., not providing 30 beds to start), not including the seating area, and requests to demonstrate the need for a community garden.

CONCLUSION:

Staff will provide Town Council with generally the same presentation as the community saw on December 7, 2023, summarize the feedback received at that meeting and other engagement touchpoints, and seek direction from the Town Council. Following this Town Council Study Session, the project team will compile the feedback received and use that information to refine the concept for each project. One final concept plan for each project will be presented to the community and to Town Council in Spring 2024.

COORDINATION:

This report has been coordinated with the Town Attorney and the Town Manager's Office.

FISCAL IMPACT:

This item is for feedback only and no new expenditures are proposed.

ENVIRONMENTAL ASSESSMENT:

The Pinehurst Community Garden is defined as a project under CEQA. The necessary environmental review will be completed following development of a final concept plan.

The Lynn Avenue Pedestrian Pathway is a project as defined under CEQA. The necessary environmental review will be completed following development of a final concept plan.



RE: LYNN AVENUE PEDESTRIAN PATH AND COMMUNITY GARDEN

We and the neighborhood are opposed to both of these projects.

The man who broached the subject of the Lynn Avenue Pathway and Community Garden to the Town Council <u>did not and does not live in the Lynn Avenue neighborhood</u>. He polled the neighbors more than once and got no support for either of these projects from our neighborhood. His family will not have to suffer the consequences, if either or both of these projects goes forward, but those who live here will.

We bought our piece of property more than 60 years ago specifically because the easement was behind us and was a buffer from noise and someone across our back fence. We sit in our back yard every day and enjoy the peace and tranquility it affords from the busy world. It is our oasis. The pathway will not only destroy this but bring loss of privacy, noise, and trash. Before P.G.&E. put up the cyclone fences and gates, we had a serious problem with motorcycles and cars racing through the easement, vandalism and even a fire. We are also concerned about the pathway making our property more vulnerable to break-ins and damage. So, it is also a <u>safety</u> issue for us. In addition to the above concerns, we feel there is a real possibility of it becoming a haven for the homeless. A few years ago a homeless person living in the easement had to be removed by a Los Gatos police officer. The stench from his using the area as a toilet was horrible! The pathway could also encourage illegal drug activity in proximity to Union School.

We have a rose garden in the easement, which we have a paid permit from P. G. & E. to use. We feel the pedestrian walkway would affect our enjoyment of this quiet spot and potentially subject it to vandalism.

The traffic on our street from the two schools in the area is already terrible. Cars park in front of houses during the week and on the week-ends. We can't even park in front of our own homes much of the time. The Community garden would add even more cars and noise to our neighborhood. Approximately 15-20 years ago a community garden was proposed in the same spot. The idea was abandoned because of neighborhood opposition. The neighborhood opposition still exists and is an important issue to consider.

Dear friends,

I am writing with regard to the proposals for a Pinehurst Community Garden and Lynn Avenue Pedestrian Path, which are up for public discussion in the LG Council on Oct. 18, 2023. Unfortunately, my work schedule prevents me from attending the meeting, but I am a Los Gatos homeowner, living on the same block of Pinehurst that the garden will be located. I hope that you will give my viewpoint the same weight as if I were able to be there because we are very worried that these projects will negatively impact the quality of life in our area.

Our house is on the corner of Blossom Valley Drive and Pinehurst, on the same block as the proposed garden, across the street but with a backyard fence adjacent to the same PG and E easement that is under discussion. So we are basically "kitty corner" to the proposed garden, which would approximately 30 yards away from our back fence.

When a young man named Kevin first came to the area to discuss the project with local homeowners, I spoke with him about it, so he has heard my concerns before. At the time we talked, I appreciated his community-spirit and his willingness to hear the opinions of the people in the area. I don't much like being in the position of arguing against something that is intended to improve and beautify our community. These are surely worthy goals.

However, my wife and I both are very concerned that the garden in particular will increase the noise and congestion on our street. As you might expect, we love the quiet of our neighborhood. What community resident doesn't treasure the limited amount of "peace and quiet" that they have? We already tolerate a certain amount of traffic and school noise on weekday afternoons because of Union Middle School, which has an exit on to Lynn Avenue. Putting another neighborhood gathering place in the area, it seems to us, would threaten the quiet of the "off-hours," the summer evenings, and the weekends, as well.

When Kevin and I talked, he was sympathetic to my concerns and assured me that the garden would operate with strict rules for conduct and that an online signup list would keep congestion to a minimum. I imagine, nevertheless, that even with the best of intentions, a new public area will bring additional noise in the form of cars coming and going and people talking, and beyond that, it is easy to imagine things getting of Page 15. The garden would easily come to seem to people like a park or a playground, with adults

picnicking and drinking, children playing in the easement, music coming from cellphones and boom-boxes, barking dogs,...even after hour teenage activities like parties and fireworks?

From our point of view, all of these would be very unwelcome developments over our backyard fence. In a big city, a "community garden" may well offer a break from urban congestion, but in a quiet suburb, surely it would have the opposite effect and increase the concentration of people and noisy activity in the area.

We hope that the Los Gatos City Council will take the interests of the local residents like us very seriously when weighing whether or not such projects as the ones being proposed are realistic. Thank you very much for taking public comment on this issue. I would be happy to discuss any of the above concerns further, personally or via email or by phone, as above.

Dear Director Burnham,
Greetings. I hope this letter finds you well.

I believe we spoke at the meeting on Dec. 7, so what I say in the following letter will not be new to you. Nevertheless, I think it's only fair that you should be cognizant of what I'm arguing in the letter that I'm sending to other Los Gatos officials. So, I'm reproducing it with few changes here.

As a Los Gatos homeowner (for 20 years), I am writing to ask for concrete answers about the status of a proposal before the LG town council to construct a "Pedestrian Pathway" running through a current PG&E easement that extends from Union Avenue to Pinehurst St., north of Blossom Valley Drive, and a "Community Garden" in the same easement on opposite side of Pinehurst.

My wife and attended the community meeting regarding these projects at the Los Gatos Adult Education Center on Dec. 7, and we left greatly upset by the scale of the projects and the sudden, arbitrary way that they are being imposed on the local residents. These projects will affect us very directly. Our home is located on the corner of Pinehurst and Blossom Valley Drive, and our back fence borders the easement marked out for the "Pathway," while the area for the "Community Garden" is directly across the street.

I will try to be brief, but I would like to explain our concerns if I you will allow me.

The first notice we received about the plans was in the notice of a town meeting about them on Oct. 18, but work obligations kept us from attending. Fortunately, last Thursday, Dec. 7, there was a second meeting, and my wife and I were able to be there.

What we heard and saw there shocked us. Naturally, we thought that the city of Los Gatos would start a project of this scope by soliciting opinions from the residents

directly impacted – but that was not at all what we encountered. The project was presented to us as already in motion, with extensive plans drawn up, including a range of options for the layout of the sites, photographs of various examples of parkland development to compare, and professionally-done landscape drawings.

You may well have seen these same plans.

I can tell you that a number of neighbors attended the meeting (whom we did not know), and almost all of us were utterly dismayed by what we saw and heard. The facilitators at the meeting did their best to respect our feelings and even to console us, but they made clear that their job was to register our input with regard to the various options on the table – but not to evaluate the reasonableness of the project overall.

To put it bluntly once more, we are furious that such extensive plans, which will completely transform the area in which we live, have been drawn up – apparently without any input from the residents who live here.

As for the merits of the ideas being proposed, many questions need asking, perhaps first of all: who exactly are the Los Gatos residents in need of additional gardening space? In a big city, a "community garden" may provide very welcome open space and reduce congestion – but here the opposite is sure to be the result: more people, more traffic, more human and animal noise – not to speak of various kinds of possible bad behavior, from drinking to lighting fireworks – located directly behind our back fences. Of course we are anxious to preserve the modicum of quiet that these easements provide. Who wouldn't be?

As you may be aware, the vicinity of Pinehurst, Lynn Avenue, and Blossom Valley Drive is already the focus of a lot of traffic and noise related to activities at Union Middle School. Has the city actually studied how much congestion <u>currently</u> exists on Lynn Avenue (on the opposite side of the easement from us), not just from the daily school activities but also from privately-run sports which make use of the field? I suggest you listen to the residents directly affected, some of whom were at the meeting on Thursday. Living near the school, we bear our fair share of city congestion and are naturally upset at the prospect of being sandwiched between school activities on one side and these new parks on the other.

I can only tell you that it was hard to avoid the impression that the planners of this initiative were well aware that the residents of the area wouldn't be happy about it, and this was precisely why no one consulted with us regarding the initial decision. Could the intention to bypass us entirely also be why the third meeting on the subject is scheduled for Dec. 19, during the run-up to the holidays? Our suspicion is that the answer to this last question is yes – which adds to our sense of betrayal and our anger.

Without making this personal, I first met the individual whom we all believe to be the original proponent of the idea a couple years ago when he was checking out the area. At the time, I thought he might have in mind a row of 5 or 6 planters behind a

chain-link fence, but he and the city-planner people have clearly run with the idea and gone way beyond that.

The plans we saw for both the "Community Garden" and "Pedestrian Pathway" far exceeded anything tailored to fit a residential area. What they were talking about, without naming it as such, was a large public park, with 15 – 20 raised planters and a possible orchard as well, benches, a seating area that could be used for events, classes, and meetings, as well as "native plants" educational tours and art exhibits.

I expect you have seen the site for yourself, but perhaps you should come out and look at it and imagine all that over the back fences of people on both sides – and then imagine it was your back fence! Every person talking on a cell-phone, every pod of teenagers, and every barking dog would be the soundtrack filling your backyard and coming through the windows while you make dinner, rest after work, or sleep late in the morning!

You get the idea so I'll stop here.

Director Burnham, residents of this area deserve answers on the status of these projects. I expect you'll attend the next meeting on this subject, which will be open to the community, on Tues., Dec. 19 ("5:00 or 5:30," they said). I know that the neighbors will present a petition in opposition to the projects at that time. This letter probably makes my point of view clear, and of course, like other working people, my free time is very limited, but I would also be happy to speak with you further, on the phone or via "Zoom," or to meet with you personally.

I know that it's the job of the city government to consider and to balance many competing interests so I appreciate your time and attention.

Good Morning,

I am a resident of Los Gatos that lives on Lynn Avenue between Union Avenue and Pinehurst Avenue. I am on a street that is a major cut through to 4 prominent schools. On the Union Avenue side you have Leigh High School and the Stratford School, on Pinehurst side you have Union Middle School and Alta Vista Elementary. We get about 1000+ students and parents going both directions 2x a day for just school drop off and pick up, that doesn't include sporting events that happen at Union Middle School on the daily and all weekends. There is limited parking and no sidewalks and no speed humps. I have asked the city repeatedly for speed humps, at a bare minimum to slow these drivers and motor bikes down, especially when we have additional kids walking to school and on bicycles. Sadly we do not have speed humps. I would really like to see speed humps on Lynn Ave and Pinehurst Ave. I would also like to see a proper stop light at the intersection of Union Ave and Lynn Ave to alleviate the massive traffic during school drop off, pick up and on weekends, and it will slow every one down.

I am not in favor of the Pinehurst Community Garden as it will just invite more people and traffic that our streets can't handle already. In addition, it will invite critters, raccoons, coyotes, wild turkeys, squirrels, moles, etc to eat the fruits and veggies in the garden. It will put unnecessary noise in the backyards of my neighbors, whom live on Pinehurst and Blossom Valley. It will put a strain on our already strained parking and frequently the people who are tending the gardens won't be able to park near their gardens because of school traffic and sporting events. It also will put an additional strain on our already strained water supply in our area. There isn't water there, so they will have to drill down to find or create a water source. We already get asked not to water our plants and get high fees if we do for our own yards, it doesn't seem logical to put in another area in our neighborhood that would add to that strain. Finally, what happens if it isn't rented and who handles the maintenance and keeps it clean and beautiful. It may end up just a lot with raised planters that are uncared for and overgrown. All of the neighbors that want to grow fruits and vegetables already have enough yard space to do so.

I am not in favor of the Lynn Avenue Pedestrian Path. The negatives outweigh the positives and without living on these streets, it is hard to understand because it looks like a great idea on paper. It will create better flow on Lynn Ave, but you will see many more problems and accidents on Pinehurst between Blossom Valley and Lynn Ave. The amount of foot traffic and bicycles that are going to pour out of that pathway and into the streets to get to Alta Vista Elementary and Union Middle School will create a huge bottle neck. Kids are going to ride there bikes right out into the street cutting left or right and into traffic depending on where they need to get to. We have a shortage of crossing guards already so I don't know how you would create an orderly way of streaming out of the pathway and into the streets they need to

get where they are going. The neighbors that back to the Pathway and I are not in favor of the pathway because there will now be noise in their backyards, trash, lights streaming in, possibly homeless, and who is going to tend to it and maintain any plants, trash cans, etc? Privacy fences were mentioned but that may block views of the mountains, which we so love. Most of these people have lived here a long time because they love it. I don't think they moved to those homes to have a park behind them. Light poles will shine into their yards no matter how low you make them. What about safety at night, what time does the pathway close, who is going to police it if needed? We know teens will hang out there til all hours, we don't really want to invite that either.

If you do decide to go ahead with the pathway, please put a separate pedestrian lane and separate bike lane. The amount of traffic won't be able to handle both without people getting knocked into. Additionally, the kids will just ride their bikes on any grass, tearing it up.

Please keep us all informed of you proceedings.

We already have a big parking problem at Lynn Ave and part of Pinehurst due to sports going on at Union Middle School. Sometimes I can hardly get out of my driveway. I do tolerate it since I think it is a good idea for kids to do sports.

I have a hard time to see that we need a community garden since everybody around here have there own garden. It will create more parking problems plus attract young kids and homeless people.

If the town wants to do something for the neighborhood why can we not have a little Park like the one on Thomas Drive. I walk there often with my dog and it is a very peaceful place.

What we really need on Lynn Ave is a speed bump like the one on Longridge. Only 50% of the cars that come from Blossom Valley Dr. to turn right respect the stop sign. They come flying around the corner and I admit it is hard not to speed when the stretch is a straight line.

These lots include easements with Valley Water and PG&E. Given their close proximity, staff is developing concept plans for both of these projects concurrently. - The presentation was given by the contracted designer of the garden and the contracted designer of the pathway.

- Outreach Round Two: Multiple Concepts 2 to 3 for Each location around December 2023/ January 2024. Goal: Seek feedback on concepts refine each plan
- Outreach Round Three: Present Final Concept of each location March/ April 2024
- The proposal for the garden stated that there was an expressed interest in the community, that it was something to give back to the community, provide education, create a community and get to know your neighbors.
- The proposal for the pathway expressed that would be a safe place for pedestrians and bicyclists to use as there is no sidewalk or bike path on Lynn Ave.

Comments from the Board

- Is there parking available for the garden?
 - Response: Have not discussed parking yet.
- Who is this for? Who is going to regulate and maintain? What is the plot size? How big of planters?
 - o Response: This is for the neighbors and the community. Whomever signs up for a planter box the community will maintain. Designate a community garden lead. They do not know the plot size yet. They do not know how big of planter boxes yet. To maintain tools and supplies a nominal fee will be collected from the gardeners who are participating.
- Who's idea was this?
 - o Gentleman from the public introduced himself. He said he grew up in Los Gatos and loves the area. Moved away and came back. Used to live behind Howes playlot. Said he wanted to give something back to the community and came up with the idea.
- Who manages the garden and thoughts about safety?
 - o Possibly putting a fence around the garden to keep vandals and undesirables out.
- Who manages the pathway?
 - o The town?
- Since this was an Arts Commission meeting there was a lot of discussion about how to incorporate a lot of public works of art in the community garden.

Comments from the Public

- Estimated about 12 people from the public attending. 6 to 8 people spoke, mostly Lynn Ave residents. Most were not in favor of the garden or pathway. One landlord was okay with it but had concerns about privacy. Only two in favor, one of them being the gentleman who started the idea, and the other representing the senior citizens (did not state address).
- Public Comments were not mentioned in the meeting minutes, except from the commission. However, two emails opposing the projects were included. https://www.losgatosca.gov/AgendaCenter/Arts-and-Culture-Commission-1

Public Comments:

- o Major concerns about parking, traffic, and safety related to school and soccer games. Overall feeling from the group is that there is no places to park already, a garden will only compound the issue. If a parking lot is built for the garden, people guarantee soccer folks will use it and will be unavailable for gardening.
- Suggested speed bumps and a bike lane instead of a pathway behind homes for Lynn Ave.
- o Concerns about light pollution. If a pathway is to be, make short knee-high pathway lights that are only solar powered that turn off at night when they run out of power.
- Concerns about privacy, strangers walking behind backyards.
- Quality of life with choice of living area. With the idea of planting trees on the path, and a shed and trees in the garden, what happens to our view of the mountains?
- o Who is this for? The area is not a dense urban neighborhood which is where most community gardens are popular. Most homes in the area have their own yards.
- Local schools already have their own education gardens, can barely get volunteers parents to come and help. Who will participate in a community garden? What happens when no one wants to take care of it anymore or loses interest?
- A long-term resident of 60 plus years shared that the PG&E pathway that connects Union Ave and Pinehurst used to be open. It invited a lot of unwanted activity, pedestrians, loitering, motorcycles and even cars. It was determined a liability and PG&E fenced it off for safety. Reopening would bring back a lot of problems.
- o Concerns about where the water would come from. Residents already get penalized for watering their yards more than two days a week, but it's okay to water a community garden. (During summer months in 100-degree weather, two days a week will not be enough for a garden).
- o In favor of the garden, it would be a place where senior citizens can get together and share common interests. A place where senior citizens can congregate and visit.

Personal Commentary and Takeaway

After the meeting was adjourned a few of us personally spoke with the contractors and the originator of the idea. The contractor for the pathway stated that they are only the designers, and they take their lead from the town for design ideas. He said both projects are separate and may eventually be looked at independently from each other.

I spoke with the designer for the garden and the gentleman behind the idea. I asked when he did his door-to-door survey in 2020 how much support for the garden did he receive. He said that when he did not get support from the neighbors on Lynn Ave, and those who would be affected directly, he reached out further away from the area on Nextdoor and Facebook to gather support for his idea. The people who this garden would be affecting it seems are not in favor of it.

This meeting, and other upcoming meetings are currently for brainstorming and to hear from the public. After the final meeting, it is decided if the project will move forward or not.

My Two Cents:

I'm not convinced of the necessity of the proposed garden and walkway behind Lynn Ave. The individual championing this project is not a current resident of our neighborhood, and their stated motivations, such as "just because" and "to give back to the community," appear somewhat insubstantial, particularly given their non-resident status. If the objective of the walkway is to enhance pedestrian safety, it would be prudent to consider more pragmatic alternatives, such as the addition of sidewalks to our streets. Our neighborhood is not characterized by the density of an urban area, where gardening opportunities for youth are limited. All of our local schools already offer garden access for students interested in horticulture,

and the properties in our area typically feature spacious yards, affording residents the opportunity to establish their own gardens. Importantly, it appears that there is limited, if any, support from the residents directly affected by this project, with potential adverse effects on their quality of life and property values. It is essential to acknowledge that not every open space needs to be developed. In an environment with homes

positioned closely together, yards adjacent to one another, and two-story residences overlooking their neighbors' backyards, having a serene, unoccupied space is a cherished and refreshing aspect of our neighborhood, which is one of the reasons people choose to reside here.

I respectfully urge you to contemplate voicing your concerns about this project at the upcoming local meeting. By doing so, we can ensure that future community developments consider the desires and concerns of our residents.

RE: Lynn Avenue Pathway and Pinehurst Community Garden

We live on Lynn Avenue. Our property backs up to the proposed Lynn Avenue Pathway in the P.G.&E easement. The Pathway will severely impact our quality of life and use of our property. We are opposed to both it and the Pinehurst Community Garden. We have a paid permit from P.G. & E. to use the easement from our back fence to thirty feet into the easement.

We feel the residents of the Lynn Avenue neighborhood should have been informed about these two proposed plans before it reached the advanced planning stage that it has now. We think whoever planned these two projects knew that the residents who would be impacted by this would oppose it. Hence, we were bypassed in the initial planning stages. Since the first meeting, there has been no alternative proposed other than that these two projects be completed. We don't feel like the town is really listening to our concerns and objections and taking them seriously. We have not been given the option of these two projects being abandoned. Our neighborhood doesn't support either of these projects. Support from others who don't live in the neighborhood and won't be impacted by them should not have a say in what happens. We feel there are better places for the town to spend this money than disrupting the lives of those living in the Lynn Avenue neighborhood. We reiterate again that the person bringing this before the Town Council in the first place did not and does not live in the Lynn Avenue neighborhood. He did not have support from the neighbors even though he polled us more than once.

We were at the December 7th meeting for the Lynn Avenue Pathway and the Pinehurst Community Garden projects, as well as the October 18th meeting. At the last meeting all that was presented were 3 different options for each project. There was not an option for us to opt for neither project to go forward. The town representatives reporting on this from our discussions at the December 7th meeting didn't adequately convey the fact that most everyone was against the Pathway and Community Garden. The one man who was in favor doesn't live in our neighborhood.

Scheduling the next meeting on December 19th right before the holidays when people are either going out of town or preparing for the holidays, seems like a ploy to keep the attendance and opposition to these projects low. We are so upset and saddened that the town we have lived in and loved for over 60 years could be so unconcerned about our objections to these projects and our quality of life.

- 3. **Maintenance and Responsibility:** A public garden requires ongoing maintenance, and there may be concerns about the responsibility for upkeep falling on nearby homeowners or the local community.
- 4. **Safety Concerns:** Depending on the design and usage, a public garden could potentially attract undesirable activities or individuals, raising safety concerns for the residents. Public gardens tend to be used at first, and then, with time, they fall apart, which brings in some of the least desirable visitors.
- 5. **Property Value:** Some individuals worry that a public garden behind their house may impact property values. While well-maintained public gardens can be nice, poorly-maintained ones might have the opposite effect. *This neighborhood has ample yard space for each home; this is not a dense urban area. Is this garden*

being reserved for those who live in apartments? What is the justification for this need?

- 6. **Environmental Impact:** Public gardens might affect local flora and fauna, particularly if the garden includes non-native plants or heavy use of pesticides, which could impact the local ecosystem.
- 7. **Parking and Traffic:** The garden may lead to increased traffic in the area, and visitors may struggle to find parking, which could be frustrating for homeowners. (see soccer plus garden impact)
- 8. **Property Access:** Access to your property may become more challenging due to increased foot traffic and parked cars. It may also affect your ability to use your outdoor space.
- 9. **Conflict of Use:** The public garden might lead to conflicts over its use, such as disputes over noise, hours of operation, or events hosted in the garden.
- 10. **Changing Character of the Neighborhood:** Some homeowners may worry that the addition of a public garden will fundamentally change the character of their neighborhood and the reasons they initially chose to live there.

Overall, for the people living behind the proposed garden (none of our neighbors have expressed any enthusiasm for this project, sadly, it is the exact opposite on our street), there will be a reduction in Quality of Life: This can manifest in various ways, such as the loss of a peaceful and private outdoor space, increased stress due to noise and activity, or a sense of discomfort and intrusion caused by strangers regularly accessing the area behind our house. These factors will contribute to a decrease in our overall well-being and satisfaction with our living environment.

Now, compound that with a major soccer field/facility across our front yard (with several hundreds of kids daily), already impacting parking and our quality of life. This raises several concerns that are further exacerbated by the addition of a public garden behind our house.

- 11. **Parking Challenges will Grow:** The presence of a major soccer field and its associated facilities across our front yard has already led to parking challenges in our neighborhood. With limited parking options, residents already struggle to find suitable spots for their vehicles, and the addition of a public garden behind our houses will exacerbate this issue. As a result, people may be more prone to double park, illegally park, or block driveways, making it difficult for actual residents to access our properties and maintain a sense of order in the community.
- 12. **Increase in Traffic Congestion:** The combination of the soccer field and the public garden will likely result in higher levels of traffic and congestion in our neighborhood. This could lead to more delays and potential safety hazards, especially if traffic rules and parking regulations are not adequately enforced.
- 13. **Increased Noise and Activity:** The soccer field and its events have brought increased noise and activity to the area. Adding a public garden will compound these disturbances, making it more challenging to find peace and quiet at home, ultimately impacting our quality of life. Why must the residents of Lynn Ave be asked to make an additional sacrifice when this garden could be placed elsewhere where the burden can be shared?
- 14. **Loss of Privacy:** The garden's installation behind our house will further compromise your privacy on top of the vast amount of soccer players and families that already impact the neighborhood. With people frequently passing by or using the garden, the sense of solitude and security that a backyard typically provides will diminish, impacting every resident's overall comfort and well-being.
- 15. **Impact on Property Value:** The cumulative impact of a soccer field and a public garden may affect property values in the area. The potential downsides of these facilities can make the neighborhood less attractive to potential buyers or tenants, which can have a negative influence on property values.

I am writing to voice my <u>strong support</u> of the initiative to create a pedestrian pathway and community garden between Pinehurst and Union Avenue. I've been tracking this project for a long time and have been eagerly anticipating its commencement and completion. I've discussed it with many of my neighbors, and everyone I've talked with is at least as enthusiastic as I am. Many of them who abut the affected area have even talked about expanding the project scope.

So I was unpleasantly surprised to find a letter in my mailbox from an anonymous "neighbor on Blossom Valley Drive" that presented the effort as some sort of shadow project that had been conducted without community involvement. I've been aware of it and following its progress for a long, long time. Yet the author claims "The project has been in the works for years without our knowing about it..." and "almost all of us were utterly dismayed by what we saw and heard (at the community meeting)", and "We are only now finding out about something that has been in the works for years, so it's time to get involved",

as though it had been intentionally kept a secret. It went on to say that plans for "a large public park ... far exceed anything tailored to fit a residential area."

I have no idea where the author expects a public park to exist if **not** within a residential area.

What I can say is that the project addresses a challenge that has existed for a long time. My children grew up in the neighborhood and attended Alta Vista Elementary, Union Middle, and Leigh High schools. When they started at Leigh, they had to cross Union Avenue every day by going down Lynn Avenue. With cars parked along the street and no sidewalks, Lynn is a hazardous throughway for all the student pedestrian and bicycle traffic. This makes the PG&E alleyway – which directly abuts the crosswalk at Union Avenue – an ideal place for a pedestrian walkway. And rather than leaving it as a dirt path, adding a community garden is a great idea.

The letter I received is NIMBY-ism (literally) at its worst. (The irony is that the result would likely *increase* the author's property values.)

I urge you to not let a small-but-vocal minority undo a very worthy project that will provide significant benefits to the community. Please vote to proceed with the Pinehurst Community Garden project.



I'm writing to provide feedback (from a utility point of view) about 3 separate concept drawings for the Community Garden.

- (1) <u>Lot Size</u>: 10x20 might be a bit too big per lot. I have a backyard veggie area of 175 sq ft, and that can feed a family of 4, for 90% of the summer veggie need. I'd vote for lots of at least 2 different sizes to fit in different people's needs. One size fits all may not work for all.
- (2) <u>Bed Size</u>: ideally should be 4 ft, 8 ft, 12 ft, etc. in the standard lumber size. The most popular hardware cloth (for protection) is 4 ft also. Otherwise, we're going to have lots of cut/waste/labor during construction.
- (2) The <u>Compost</u> staging area is great, assuming that's for ready-to-use compost. It would also be great to plan a "composting area" where people dump the trimming from the garden to just compost on the spot, rather than having to take them away. A typical size will be 3 section bin systems like this. An easy and great way to do sustainable gardening.

We have read feedback from all the community members who are directly sharing a fence with the current plot and here are some of my observations living and working and sending my kid to school in the area.

Noise and Traffic

Given the proximity to Union Middle School, the noise is typically on game nights, school events etc and that doesn't feel like the same demographic who would create additional noise and traffic at a community garden. Same follows for the traffic. When we bought a home close to a school, this was actually a pro for us - our kids can now walk to school. Of course, if you no longer have school going kids, I can see how this may not appeal to you. And most folks who seem to vehemently oppose this plan are probably in this camp.

As for the passthrough, this is essential for the safety of our children going and coming from school. 

I applaud your commitment to community progress and sincerely hope that we can address these specific concerns constructively, fostering a dialogue that respects all viewpoints.





- 1. Good Evening, I'm Kay Van Kirk, a resident of Lynn Ave's duplexes, residing right beyond the cherry tree in the middle—a spot earmarked for the Pinehurst Community Garden. As a devoted gardener and mother of two young children, nurturing my own garden with ten thriving blueberry bushes, my heart beats for green spaces. I'm also deeply involved as a parent volunteer at Alta Vista Elementary School Garden.
- 2. In these discussions, contrasting perspectives surface regarding our natural havens. To some, this proposed site might appear as mere overgrowth, dismissing its inherent value. Yet, to my neighbors and I, it's a sanctuary where children pedal their bikes, where neighbors stroll with their pets, and where budding naturalists explore. Many folks look at these open spaces as a rare opportunity to live in an area away from dense crowded homes and be closer to nature. It's under our watchful eyes and care that have preserved this space, ensuring safety and serenity for our families and homes.
- 3. There seems to be a fog around the origins of support for this garden and pathway. Social media buzz predominantly showcases backing from outside our community. Curiously, data on local opinions remains undisclosed. Shouldn't decisions impacting our neighborhood prioritize the voices within? Outsider endorsements, while well-intentioned, might overlook the nuanced impact on our immediate surroundings.

- 4. Transforming this natural space into a bustling hub and trail might erode safety and privacy. It risks inviting unforeseen elements and poses a challenge in regulation for neighbors. With the proposed garden as a pay-to-play model, accessibility becomes exclusive, effectively privatizing what should be a communal asset, alienating some residents from this shared opportunity.
- 5. But what happens when folks are too busy, lose interest, 200 kids have soccer practice, or its 107 degrees out. Despite dedicated efforts, commitments to maintaining a community garden falter. As a parent garden volunteer at Alta Vista, despite our efforts of recruitment, many parents are just too busy to commit even an hour. While urban areas thrive with community gardens, our neighborhood boasts ample yard spaces for creating a garden of their own.
- 6. Our stance isn't against community gardens or bike paths—my family cherishes outdoor activities, we bike and skateboard every weekend. Could enhancements to our current infrastructure, like a dedicated bike lane on Lynn Ave with speed control measures such as speed bumps be an option? With the community garden, could we explore a more suitable location, resonating with genuine local support? Instead of developing a natural open space consider beautifying the area with native wild flowers to maintain its natural untouched beauty while simultaneously ensuring safety and privacy for all residents.





Dear Town Council,

My name is Steve Hammack. I am a long time resident of Los Gatos- my family moved here in 1964 when I was 8 and I have lived here most of my life. Several years ago I retired after teaching for 35 years in the science department at Los Gatos High school.

What I have loved about living here all these years is the small town, community atmosphere. And one of the things I noticed when I was a member of the science department was how wonderful the school's garden was- it was used by both the students in our agroecology class and also by members of the community. It was great for our kids- they thrived in the agroecology course and it was great for the community. However, what always made me sad was the fact that the community members could only use the garden during summer vacation.

When I heard about Kevin Arroyo's efforts to start a year-round community garden for the town of Los Gatos I was so pleased to see that this missing element was being pursued- a garden that community members could use all year long. Over the past few years I have been impressed to see all the work that has gone into carefully planning the garden and I am saddened to see community members opposing this project.

I did a little research and discovered that we are one of the only communities in Santa Clara county that doesn't have a year-round community garden. It turns out there is a year-round community garden in Saratoga, Cupertino, Sunnyvale, Campbell, Santa Clara, Mt. View, Palo Alto, Morgan Hill, Gilroy, San Jose has 18.

If most of our neighboring communities can provide a year round community garden for their residents it seems reasonable that we should be able to do so too.

I want to encourage you to support the establishment of this wonderful addition to our community.

Hello, town council,

I'm a resident and vice-chair of the LG Parks and Sustainability Commission. I'd like to comment in support the community garden and Lynn Avenue pedestrian path projects, which we reviewed at our recent Commission meetings. I feel that these are important and attractive additions to the parks and outdoor features in the town. The garden will offer opportunities for people living in apartments or otherwise without access to yard space to work with the land and gain benefits in healthy living and eating. The pathway will create a new, attractive open space with more native vegetation which will attract native insects and birds. While these projects will no doubt have some negative impacts to neighbors, I can't think of any area in town or nearby that hasn't had a net improvement due to the addition of well-kept parks and open space. I believe it's always a net positive to offer people more access to nature close to home.

With respect to the pathway area and the areas of the garden outside of the plots themselves, I strongly support appropriate native plantings which will provide better habitat. Along with this I would prefer the pathway area to have as natural a feel as possible, for example using shapes that mimic nature rather than angular features.

Regarding neighbors' concerns, I strongly support an option that includes a small parking area integrated into the garden site. In most cases, gardeners will be able to park there, avoiding any issue with increased on-street parking. It will also be convenient for gardeners who are bringing plants, amendments, tools, etc. to their plots. Another suggestion is to engage with neighbors as a stakeholder group to identify any features that would improve the pathway area for locals. I suspect in the long run many local people will be primary users of the space, and they could participate in shaping it in whatever way they prefer – for example if a shade structure and/or picnic tables would make it a better neighborhood gathering place.
