She also reported that she presented a two-part art exhibition, that Africa Day Los Gatos is on May 24, and that Africa Day San Jose is on May 25.

Chair Yamate reported that he reached out to the Library and NUMU regarding the Constitution transcription project, attended the inter-faith clergy group, returned a call from Annalise Friemarck from San Jose Spotlight, and attended the May 6 Town Council meeting to express concerns about the proposed Commission Code of Conduct Policy.

Vice Chair Fisher reported that she attended the interfaith clergy outreach discussion, that May is both Jewish American Heritage and Asian American Pacific Islander Heritage Month, she attended a Jewish book festival, and she will attend the May 27 AAPI Heroes luncheon honoring Chair Yamate.

Commissioner Lamborn reported that she hosted a very diverse neighborhood birthday luncheon and went to a symposium on future-proofing museums in the world.

Commissioner Lo reported that she expressed concerns with the proposed Commissioner Code of Conduct at the Town Council meeting and she also discussed it with Jeff Suzuki. She also

BACKGROUND:

Symphony in the Park is a free, family-friendly event hosted on July 4 at Oak Meadow Park and features a traditional San Jose Wind Symphony concert with flag raising and Yellow Ribbon ceremonies, food trucks, a beer and wine garden hosted by community service organizations, children's activities (past examples have included crafts, bounce houses, magicians, face painting, etc.), a bike valet, and a partnership with Billy Jones Wildcat Railroad for train/carousel rides and snack bar treats.

The Town's Boards, Commissions, and Committees are invited to participate in the Town's annual 4th of July Symphony in the Park 2025 event.

On April 21, 2025, the DEI Commission unanimously voted to participate in the Town's 4th of July event and created an ad hoc subcommittee to plan for the event. The ad hoc subcommittee consisted of Vice Chair Fisher and Commissioners Kane, Gentile, and Lamborn.

On May 15, 2025, the DEI Commission unanimously voted for the Commission's participation in the event to consist of a children's book giveaway, children's bookmark coloring activity, world map activity where attendees place a pin on the map showing where they were born, and a banner where attendees can take a photo of themselves and attach it to the banner resulting in a visual representation of the community. The Commission authorized spending the remaining FY 24/25 budget amount of \$1,906.56 on the supplies including the purchase of the books, map, camera film, bookmarks, and colored pencils.

DISCUSSION:

Vice Chair Fisher and Commissioners Kane, Gentile, and Lamborn volunteered to manage the Commission's booth at the event. The event will occur between approximately 10:00 a.m. and 1:00 p.m. The Vice Chair and Commissioners should plan to arrive between 8:30 and 9:00 a.m. to set up and stay until the event concludes at 1:00 p.m.

The Commission volunteers will provide all of the booth activities, including setup, display, distribution, and cleanup.

Staff has ordered the following supplies:

- Camera film

The Town will provide the Commission with one six-foot table (including the Commission's tablecloth), two folding chairs, and one 10x10 pop-up canopy.

Please note that all community members who participate in the photo banner activity must sign a photo release. For those under 18, consent from a parent or guardian is needed. The Town will provide copies of the photo release at the event.

At the Commission's request, it will be acceptable to bring one additional table as long as setup and takedown of the additional table is handled by the Commission.

Parking is limited at Oak Meadow Park. There will be a drop-off zone in the Oak Meadow Parking lot by the sidewalk entering the park where Commission volunteers may drop off items to walk into the park. Escorts will be on standby to help transport items to the booth location if needed.

Report on the Interview Between Los Gatos DEI Commissioners and LGSUHSD Board President & District Officers

Overview

The interview between the Los Gatos DEI Commissioners and representatives from the Los Gatos-Saratoga Union High School District (LGSUHSD) provided valuable insights into concerns, efforts, and opportunities related to diversity, equity, and inclusion (DEI) within the district and the broader community. Notably, the district does not express concerns about DEI within its schools but is uncertain about DEI initiatives and challenges outside of the school environment within the Town of Los Gatos.

DEI Concerns

Does your district have concerns about the issues of diversity, equity, and inclusion in the Town of Los Gatos?

LGSUHSD does not have concerns about DEI within its schools, as they believe students are supported adequately. However, district representatives are less familiar with the extent of DEI efforts in the broader town community.

Current Efforts:

What initiatives or practices have already been implemented to address these concerns, and how effective have they been?

- LGSUHSD has implemented DEI-focused programs within schools, including curriculum enhancements and student-led initiatives.
- They believe their efforts within the district have been effective and well-received but are unsure of what efforts exist beyond the school setting.

Community Involvement:

Are there particular groups (students, parents, staff) that you feel are underrepresented or underserved in the district?

- While the district continuously evaluates representation, they do not currently identify significant gaps in inclusivity within their schools.
- The district formerly identified English learners as an underserved group, but has made significant strides recently to bolster the strength of the program.

Hopefulness About DEI

What are you most hopeful for relative to these concerns?

- The district acknowledges ongoing student-led efforts and inclusive curriculum updates as positive steps.
- They express optimism that their schools have cultivated an inclusive culture for students.

Vision

What does an ideal diverse, equitable, and inclusive school environment look like to you?

- A space where all students feel safe, heard, and respected, with access to diverse perspectives in education.
- Continued engagement with students and staff to ensure inclusivity remains a priority.

Promoting DEI

Do you see opportunities for the Town to do more to promote and ensure diversity, equity, and inclusion?

- The district is open to collaboration but does not see pressing policy gaps within its schools.
- They express interest in understanding what the Town is doing to promote DEI outside of schools.

Collaboration

Are there local organizations or community groups the district could partner with to advance DEI efforts?

- LGSUHSD is interested in potential collaborations but would need more insight into existing community DEI efforts before committing to partnerships.
- Potential initiatives such as a **Diversity Week throughout the town**, beginning with high schools and expanding to families, were discussed.

Support Needed

What type of support could the Town and the DEI Commission provide to your district to create a more inclusive community?

- The district does not identify immediate needs but is open to learning more about town resources that could supplement school efforts.
- The district continues to support student-led initiatives and believes student voices are already well-represented within their schools.

Conclusion

LGSUHSD remains confident in its DEI efforts within schools and does not express concerns regarding inclusivity among students. However, the district acknowledges a lack of awareness about broader DEI efforts in the Town of Los Gatos and is open to further dialogue. Potential areas of collaboration, such as a town-wide Diversity Week and increased communication with local DEI initiatives, could strengthen efforts to create a more inclusive community beyond the school environment.

February 12, 2025 Meeting Notes

Dlane Fisher and Rev. Eric Swanson of Westhope Church, Saratoga

Diane collected information on the history and organization of the Celebration of Light, a multicultural winter celebration in Saratoga, to use as a model for a prospective similar event in Los Gatos. Rev. Swanson runs the annual event on behalf of the Saratoga Ministerial Group.

This version of Saratoga's winter celebration began 6 years ago. Previously there was an event co-sponsored by the Chamber and the Ministerial Group. Mayor Manny Cappello and Rev. Swanson conceived and planned the first city-sponsored event, which has continued annually.

As a partner with the Saratoga Ministerial Group, the Town of Saratoga handles the following aspects of the event:

- 1. The town promotes the event on it's website.
- 2. The town provides candles and a sound system.
- 3. The mayor and council members speak at the event.
- 4. There is no overt security used.
- 5. The Town reserves the space in Blaney Plaza, which is a central area at the beginning of the main downtown street.
- 6. Town staff members John Cherbone and Leslie Arroyo manage the event, by receiving the diverse symbols brought to the office, pre-decorated with lights, and installing them in Blaney Plaza.
- 7. Each symbol is discussed in the interfaith service.
- 8. The symbols stay in Blaney Plaza for 2-3 weeks.
- 9. The event is held the 2nd Saturday evening in December, after sunset to accommodate the Jewish sabbath.
- 10. Several public school choirs participate in the event, bringing out their families and friends.

Rev. Swanson has been told that the Town is very glad this event is held, and that it is very important for inclusion and belonging in Saratoga.

The event organization will be changed in 2025. Instead of the town staff collecting the display and installing it, the town has given a \$2,500 grant to the Saratoga Ministerial Group to implement all of the event organizing. But the event will still be co-sponsored by the Town of Saratoga, with council participation. The grant will cover rental of a sound system and the candles, and alleviates the work load of town staff.

Hand *Righting* the Constitution: A Public Exercise in Contemplating Our Democratic Rights

Summary: This proposed project consists of a series of community-based, participatory, conceptual art events that was inspired by an article in the April 21, 2025 online issue of the *New Yorker* magazine¹. The project is relatively simple: provide one or more public spaces in various venues across the Town of Los Gatos, where a handful of individuals working independently transcribe by hand the U.S. Constitution. An online scheduler would allow participants to sign up for a one-to-two-hour time slot. A log would be created to track participants' efforts, specifically identifying where in the Constitution each individual begins and ends the transcription, the date and time of that event, and perhaps space for comments from that participant. Subsequent participants would start transcribing where a previous individual has ended. A set of guidelines and rules of conduct would be developed to set expectations for participants and to ensure that individuals are respectful of each other, that there is no "political" proselytizing or coercion, etc. Various online community standards may provide guidance on this.

Who would be project sponsors, organizers and hosts? This proposed project contemplates a collaborative effort among relevant Town commissions led by the Diversity, Equity and Inclusion Commission. Other Town Commissions would be invited to participate, particularly the Arts and Culture Commission, the Community Health and Senior Services Commission, the Parks and Sustainability Commission and the Youth Commission. In addition, the Los Gatos Library, the New Museum Los Gatos and Los Gatos High School would be ideal collaborators.

Who would be invited to participate in the project?

This project would be open to all residents of Los Gatos, owners and employees of businesses in Los Gatos, and visitors to Los Gatos. The target age population would be high school and older, although middle school students could be eligible if they have had some exposure to the Constitution. Younger students might be able to contribute, but should be accompanied by an adult for safety purposes. Ideally, each session would include a variety of ages to encourage intergenerational engagement, conversation, interaction, rapport and exchange of perspectives.

How and where would the project be staged?

Transcribing sessions could be offered in a conference room at the Los Gatos Library, space within the New Museum Los Gatos, as an activity at the Adult Recreation Center, and perhaps selected public venues, indoors or outdoors, throughout the Town (e.g., coffee shops, picnic tables at local parks, etc.). In addition, sessions might be hosted at Los Gatos High School (to the extent that they can also accommodate non-student public participants) and maybe some private organizations like senior living facility The Terraces of Los Gatos. Materials needed for the

project can be purchased at a relatively modest cost: white archival (acid free) foam core boards and ink pens for participants to transcribe the Constitution in its entirety.

How many participants would be anticipated?

It is hoped that the project would be embraced by more than an insignificant number of community members, and that all interested community members would have an opportunity to participate. Participants can attend multiple transcription sessions, depending on availability.

Do these transcribing sessions need to be supervised?

At the outset, it might be helpful to have someone available to greet participants, answer questions and generally get the project rolling, and then collect materials and get feedback at the end. It is not anticipated that someone would need to be available during the entire transcription process.

What would be the goals and desired outcomes of the project?

One obvious tangible outcome would be the production of transcriptions of the U.S. Constitution that could be assembled into a single work and publicly displayed. However, that might also be the least important outcome. It is hoped that individual participants will interact with other individual participants, even though the project setting would otherwise offer a relatively quiet and somewhat meditative opportunity to do the actual transcription. Through such interactions, participants may develop a deeper familiarity with the U.S. Constitution and reflect upon its meaning. The transcription activity is designed to foster conversations between strangers—for example, participants might ask each other about the meaning of various provisions of the Constitution, share personal perspectives on how a specific provision impacts or guides their life or thinking, or question how a provision operates or is supposed to operate.

This project is designed to connect individuals with other individuals with whom they might not know, and more importantly may never have had an opportunity to engage with but for this project. If the Constitution is a common bond for our community and society overall, how can it be utilized to create a more cohesive community within the Town of Los Gatos?

The collection and organization of the written transcriptions would be supervised by New Museum Los Gatos, using staff, curators and artists to create an artistic presentation of the transcriptions for physical display in the reception area of the Town Chambers, a space within the New Museum or other selected venue and/or online on the Town website. One suggestion for organizing the transcribed works might be to hinge them together with tape on the reverse side in accordion style

What is the conceptual art component of the project?

Aside from the creation of a tangible work from the transcription efforts, this project would have a conceptual art component. The title of this project plays on the word "handwriting"—is there an element of "righting" the Constitution that might be uncovered through the project? Participants would be encouraged to ask and respond to the following questions and questions that arise during a transcription session:

- What rights are guaranteed and/or restored by the Constitution?
- Is there a need to restore and/or elevate the Constitution in the minds of the American public?
- What behavior is the Constitution designed to redress?
- Are there portions of the Constitution that need to be "righted"—that is, corrected, redressed, or strengthened?

To capture the impact of the transcription project, participants would have an opportunity to share what they experienced and learned by participating in the project. Feedback could be collected via written questionnaires or short interviews. In addition, professional photographers and/or videographers could be hired to help document the project. If a budget does not allow for such recording, volunteers could be enlisted for this purpose. Curators, either hired or volunteer-based, would review and organize the collected input in a manner that can be shared with the public with the displayed transcription.

To increase the level of awareness of the Constitution as raised by this project, this project could be supplemented by various public speaker programs designed to educate the public about the Constitution.

How long would this project last?

Initially, the project will have a pilot phase, perhaps 4-6 weeks (or shorter) to allow the participating sponsors/organizers/hosts to evaluate and modify the project and project guidelines, as necessary. Depending on the level of interest generated by this project, it could be extended to accommodate participants and/or supplemented by related activities.

How does this tie to the DEI Commission's workplan?

This project would qualify as a program and series of events designed to foster unity and diversity with the Town of Los Gatos as intended under the enabling resolution for the DEI Commission² and Work Plan Discussion Item C. Related to DEI Plan Goal A.2.a. (Discuss Ways the DEI Commission Can Make Visible the Equity Issues that Matter to the Larger Community, Including Action Items to Promote the Safety and Inclusivity of its Community Members)³.
