SUBJECT: GFOA Presentation – Budget and Financial Reporting

DATE: May 19, 2025

In continuing the knowledge development and collaboration between the Town Council and Finance Commission, both bodies have requested a joint meeting to discuss topics of mutual interest. This previously included pension and other post-employment benefits, investment strategies, as well as a better understanding of the Town's budget and annual financial report.

This joint meeting will introduce government budgeting and financial reporting, and staff intended to agendize the remaining topics at a future meeting.

#### **DISCUSSION:**

The main presenter will be Katie Ludwig from the Government Finance Officers Association (GFOA). Katie Ludwig is currently Director of Resource Development in GFOA's Research and Consulting Center. At GFOA, her work is focused on helping local governments develop policies and procedures and implement systems to improve their efficiency and effectiveness and promote financial sustainability. Katie also presents on many government finance topics including the GFOA's premier Budget Analyst Academy which trains hundreds of analysts to understand the local government budget processes and systems.

Prior to joining GFOA, Katie worked for four and a half years at the Chicago Housing Authority, where she was responsible for the management and operations of the Housing Choice Voucher program. She also worked for the City of Chicago for more than 13 years, serving in a variety of roles in the Office of Budget and Management, the Department of Housing, and the Chicago Public Library. While at the Department of Housing, Katie was responsible for implementing the City's Neighborhood Stabilization Program, a \$170 million federal grant program aimed at putting vacant, foreclosed homes back into productive use.

Katie received her B.A. in English and Political Science from DePaul University. She received her Master of Public Policy from the Harris School at the University of Chicago.
