    - Myers also on website bike price plus \$2.00 city license fee advertised also states this under burley / tagalong, however the City does not charge these and this is a misrepresentation of fees collected / charged by the City

      - Myers still a misrepresentation as the City does not collect or charge those

  - City attorney Mike Cavanaugh informed the Council that both Shepler's Ferry & Arnold Transit have submitted rates, fees, and schedules for 2026 season. However, both lines have indicated that these were submitted as a "courtesy notice" and do not appear to be seeking the Council's approval
  - The presented resolution acknowledges the "courtesy notice" and allows the Council to place the submittals from both companies on file, but also gives the City the right to reject the presented rates, fees, & schedules at a later date
  - O The presented 2026 rates show a \$1.00 increase on top of last year's \$2.00 increase for round trip adult ticket prices, among other rate & fee increases for both companies

Motion made by Myers, seconded by St. Onge, to adopt City of Mackinac Island Resolution No. 25-015.

- Request from the Tourism Bureau to have fiber run to their leased building (owned by the City) located at 7274 Main St.
  - Council commented that they were in favor of the project, but more information is needed
  - Building Inspector Dave Lipovsky will need to be involved with the step by step boring / construction project as it is intended to have the line bored from Market Street, presumably through the City's walkway / park

Motion made by Myers, seconded by Moskwa, to approve the Tourism Bureau personnel to proceed with the installation project for fiber, but that City Building Inspector Dave Lipovsky needs to be involved with the project.

Motion made by Moskwa, seconded by Corrigan, to approve the vehicle permit. Voting Yea: Chambers, Corrigan, Moskwa, Myers, White, St. Onge
- (5) vehicle & (1) trailer permit, submitted by Darrow Brothers, for excavation work for Nancy Porter at her Hoban Hill property. Vehicles & trailers are to arrive December 9<sup>th</sup> and will be in use for 15 days.
  - o Christmas Bazaar restrictions apply

Motion made by St. Onge, seconded by Moskwa, to approve the vehicle & trailer permits with the Christmas Bazaar vehicle operation restrictions.

- (2) vehicle & (1) trailer permit, submitted by Darrow Brothers, to move an excavator to the Pierson build – Ironwood Ln, Unit 8, Stonecliffe Manor I – for stump removal. Excavator will be delivered on December 4<sup>th</sup> and will be in use for one (1) to three (3) days.
  - Vehicles cannot move on the streets during Christmas bazaar dates, but can operate on property
  - o Cannot work after dark
  - Councilman St. Onge requested that Darrow call him prior to arrival to discuss the new service lines that were recently run so they don't get run over

Motion made by Moskwa, seconded by Myers, to approve the vehicle & trailer permits with the applied restrictions.

  - o Would like to make sure that Brad Chambers is in attendance for discussion

Upon the approval of Dwayne Miedzianowski's Chief of Police Employment Contract earlier in the meeting, Michael Gruits' time served as the Chief of Police has ended.

- Council thanked Mr. Gruits for his service as Chief, and noted that they look forward to having him back on the force as an Officer
