I. Call to Order

Mayor Doud called the meeting to order at 4:00 pm

II. Roll Call

IV. Approval of Minutes

- Mayor Doud stated that the minutes stood approved as presented.
- Minutes of the Special City Council Meeting, held on August 12, 2024
 - Mayor Doud stated that the minutes stood approved as presented.
- Minutes of the Special City Council Meeting with Hoffman Marine, held on August 14, 2024
 Mayor Doud stated that the minutes stood approved as presented.

VIII. Committee Reports

- The Social Media Policy & City Computer Use Policy were discussed
 - Discussed at the last I.T. Committee meeting
 - Councilman Corrigan feels that the policies should go to the Policies and Contracts Committee for further discussion and review
 - Would like input from the Fire Department, Police Department, and Recreation Department as they all have public Facebook pages – want to make sure everyone is comfortable with what is trying to be implemented

Motion by Corrigan, second to the motion by Chambers, to send the Social Media Policy and the City Computer Use Policy to the Policies and Contracts Committee.

IX. Correspondence

- An email was received from Pete Deckert of Ryba's Bikes regarding the Shepler's passenger lines blocking businesses on Main Street as they wait to load the boats
 - Lines have been blocking entrances / exits of businesses as well as sidewalk access points
 - Lines begin forming around 3:00 pm and are lasting sometimes until 7:00 pm or 8:00 pm
 - Chris Shepler of Shepler's Ferry
 - Acknowledge that this is an issue and apologized for the lines interrupting businesses
 - 300 people can fit from top of the dock to end of the line for Mackinaw City this number fills the Miss Margie. From the top of the dock to the Iroquois is another 150 to 180 people, which requires a second boat to accommodate
 - \circ $\,$ The wait is, at maximum, 30 minutes when all 4 boats are running
 - $\circ~$ Councilman St. Onge noted that he feels the main concern here is the people blocking the businesses
 - Councilman Moskwa commented that he has seen some instances where there is a 30 plus minute wait on busier days
 - Concerning, and it is creating a problem
 - Do not want guests to have this problem
 - Have been hearing that commuting employees are late for work
 - Mr. Shepler responded that if a customer has a a commuter ticket or pass, they should be able to get to the front of the line or to the commuter area

- Councilman Moskwa commented that he understands that that is policy, but that these are complaints he has been hearing from commuters. Shepler's should be running more boats and looking at using other docks included in the Mackinac Island Ferry Company (MIFC) assets
- Councilman Corrigan noted that he recently received a complaint that customers boarded a 3:00 pm boat from Mackinaw City and they were not able to get off the boat until 4:00 as the boat was waiting in the harbor for dock space
 - Have also heard from others that they have waited in the harbor for 10 to 15 minutes waiting for the boat to have space to dock
 - Do not think the 30-minute turnaround time is feasible
- Councilman Moskwa commented that there are other assets like the MIFC Ryba dock, and hopefully soon MIFC's Joliet and Cadillac, that could be utilized to alleviate the issues of longer wait times.
 - Season is beginning to slow down some, but we will also soon be seeing larger group tours coming in
- Councilman Sehoyan inquired how many ramps Shepler's has on their island dock
 Mr. Shepler responded that there are three (3) ramps for use
- Councilman Chambers inquired if it was feasible to use the MIFC Ryba dock as a queuing area to help get passengers off the street
 - This has the potential to help alleviate some of the line, but does not help Mr. Deckert and his bike shop as well as the other businesses located between the Shepler and MIFC Ryba dock
 - Chief Gruits commented that the lines have been long, but the people are moving at a reasonable pace that could be expected in this situation.
 - Moving people to the MIFC Ryba dock while they wait for a Shepler could be a good idea, but it would take coordination and more personnel to make it happen
- Mr. Shepler asked that if a Council member or Mackinac Island community member has an issue with how something is being done, please do not take the complaint to a Shepler's dock staff member. Staff members are already overworked and stressed – if someone has an issue, please contact himself or a main office to have the issue addressed.
- Councilman Moskwa commented that, it was mentioned that Shepler's would be running three (3) boats to accommodate the larger amount of people, however he has witnessed that only two (2) ramps are being used at a time, leaving boats sitting in the harbor with passengers waiting to dock
 - Mr. Shepler noted that, to use all three (3) ramps at once would end up in the lines of customers departing and boarding the boats crossing, which interrupts foot traffic on the dock and stops the further loading and unloading of the third incoming boat, leaving people waiting anyways.
- Councilman St. Onge noted that he understands that growing pains will happen, but what the City needs is a plan of assurance for the upcoming Labor Day holiday weekend status quo is not going to cut it. Is there a better plan or more boats coming on line to help with the influx of people that will be coming to the island?
 - Mr. Shepler responded that he had a report to share with the Council. Not sure if it
 will answer all of the questions, but will provide some information
 - Mayor Doud noted that this will be discussed after correspondence is wrapped up
- Councilwoman Myers noted Mr. Shepler's earlier comment about being able to accommodate 300 people on their dock, and asked if that was queuing for both Mackinaw City and St. Ignace?
 - Mr. Shepler responded that this was the number of people that could be accommodated in just the Mackinaw City line and queuing area on the dock, and that Mackinaw City's line is what contributes most to the line forming down the sidewalk
 - Councilwoman Myers commented that she has observed comingling of departing St. Ignace and Mackinaw City customers in the line that forms down the sidewalk – there is no push to get customers down to the correct line if there is room on the dock
 - Chief Gruits commented that when he is in the area and sees a line forming, he traverses the line and speaks with customers to try and move them down to the dock if there is space in the appropriate line
 - Mr. Shepler noted that his Dock Master communicates with Chief Gruits or whichever officer is working to provide help if needed
 - Chief Gruits noted that Shepler employees have always checked in with him
- Councilwoman Myers inquired how many employees Shepler's had scanning tickets as there is usually just one person performing this task

- Mr. Shepler responded that at most, there are three (3) employees scanning section when it is busy. However, it is the time of year where they are starting to lose employees. Working to onboard and training MIFC employees to make up for the Shepler's cast members that they have recently lost
- An email was received from Susan Odgers regarding concerns about the ADA compliance of Shepler's boats
 - Mr. Shepler commented that the access to the lower and upper seating areas for five (5) of their vessels are stairs
 - Mr. Shepler noted that he sat on the Federal Passenger Vessel Access Advisory Board from 1998 to 2001 where he assisted in writing code and the definition of accessibility for all passenger vessels. This applied to vessels ranging from a Carnival cruise ship down to a fishing charter boat.
 - There is nothing that can be done and passed through the United States Coast Guard to change the accessibility on these five (5) vessels, which were building in the 1980s or before. These five (5) vessels are grandfathered in and are lawful in their ADA compliance as they currently stand
 - However, the vessels William Richard and Miss Margie are handicap assessable from the first level
 - Mr. Shepler commented to the Council that he will respond to the email directly, which was emailed to him by the City Clerk during the meeting.

Motion made by Moskwa, seconded by Corrigan, to place the emails from Pete Deckert and Susan Odgers on file.

X. Old Business

Discussion of Ferry Boat Matters

- Chris Shepler of Shepler's Ferry gave the Council a report on where they are with ferry operations
 - Vessels Cadillac and Joliet, from the MIFC fleet, are looking like they will be ready to be back in service some time mid next week – however this is all dependent on the vendors that area taking care of all the damages that the vessel sustained prior to the Hoffman purchase
 - Waiting on the shaft and the propeller, coming from Detroit
 - Having issues with a piece of welding equipment prior administration from MIFC was using a steel welder to weld aluminum
 - Hoffman has now allocated \$70,000.00 to purchase a new aluminum welder for the Mackinac Marine Service – this will speed up the process of repairing cracks and such on the Cadillac
 - After these repairs, the next step is obtaining certification from the US Coast Guard, but they are very busy and Mr. Shepler can not guarantee how quickly the inspections can be scheduled
 - Mayor Doud noted that she will work with Bergman's office to help get the inspections scheduled quickly once the boats are ready
 - Engineering on the MIFC Main Dock (Mackinac Island)
 - Mr. Shepler met with Dennis Dombroski, Dave, and Brad Peterson yesterday regarding the repairs to the supports and the engineering of the dock
 - There is a roughly 15 to 20-ton engine sitting in one of the buildings on the dock
 - Prior administration of MIFC had moved the engine to the center of the dock as the previous placement towards the outside of the building was causing the dock to sag due to the weight
 - Mr. Shepler just learned about the engine bout a week ago from Brad Peterson no idea where it came from or the true weight
 - There was also a fuel tank discovered in one of the buildings that is filled with rough 150 to 200 gallons of some type of liquid
 - Met with Veronica Dobrowolski of Arnold Freight, Tim Plutchak of Plutchak Cranes, and Moran Ironworks to put together a plan to remove the engine and fuel tank
 - General plan is to put Plutchak's crane on the Senator to remove the engine and fuel tank from the building and ship them off island
 - Tomorrow there will be two (2) kayaks under the Main Dock throughout the day these are engineers from OHM that need to take pictures and get detailed notes about the necessary repairs needed under the dock
 - BP Construction will complete the lateral work in two (2) weeks. Brad Peterson will remain on site to help Michael's once they can begin phase II, which is the repairs and reconstruction of the vertical supports under the dock (900 of the 1,006 pilings under the dock require repairs or replacement)
 - Michael's will not being phase II until they have stamped drawings from the engineers
 - Hope to get the drawings some time soon after Labor Day

- Engineers are moving as fast as they can with drawings, however the do historic structure and is in serious disrepair
 - Councilman Corrigan inquired what the timeline for completion was
 - Mr. Shepler responded that he won't know until he receives the drawings form the engineers and they can plan based off the necessary work
- Dennis Dombroski reminded the Council that they are dealing with a significant historical resource, and from prior experience when repairing the Coal Dock, for Hoffman to obtain permits needed through EGLE and the Marine Corps of Engineers, they will require a sign off from the State Historic Preservation Office (SHPO) before permits can be issued
 - Also, since this structure is located within a Historic District, the City's Historic District Commission will need to review all plans
 - These processes will all add to the timeline for repairs
- Councilwoman Myers commented that the Historic District Commission could certainly schedule a special meeting to review the plans when they are ready if it falls outside of the timing of a regular meeting
 - Mr. Dombroski responded that this could certainly be done, but until plans are finalized, there is no way to know when anything could be scheduled
- Councilman Moskwa noted that the structural integrity of the MIFC Main Dock has been something that everyone has been concerned about over the last ten years as we have seen how little work MIFC put in to it – grateful for the work that Hoffman is currently putting in to the dock
- Mr. Dombroski noted that we will probably need some help in Lansing to get SHPO to turn the matter around quickly
 - Mayor Doud responded that she will work on this
- Mr. Shepler informed the Council that he and his Dock Master met with Mackinac Island Carriage Tours (MICT) to discuss the upcoming arrivals of tour groups and how that influx of people will be handled
 - Have 59 diamond tours coming to the island between now and the end of the season
 - Using the MIFC Ryba dock to stage tour groups
 - Once they come off the Shepler's boat at groups will be directed to the Ryba dock where they will be loaded on to carriages.
 - Departing guests will be staged at the Ryba dock and will be moved to the Shepler dock when their departing vessel is ready
 - Working to get Joe Herscher of MICT a Shepler's radio so he is able to communicate directly with dock staff and boat captains for this to run as smoothly as possible
- Just completed a 24-hour PR campaign with eight (8) radio stations and three (3) TV stations to discuss current operations
- Mayor Doud thanked Mr. Shepler and his crew for all of their hard work and cooperation through this difficult situation
 - Councilman St. Onge inquired about Shepler's plans for Labor Day weekend
 - If Hoffman is able to get the two (2) MIFC boast back on line, what is the plan for those boats? Will they come in to the Ryba dock? What's the plan if the vessels are not able to be used for Labor Day weekend?
 - Mr. Shepler responded that is they are able to move to another dock, there is still a communication issue with the public if Shepler's can find time (hopefully next week) they would like to check out the Ryba dock to see if the Shepler fleet can fit in there this is something they are looking in to but do not have an answer to at this time
 - Each boat could take two (2) to three (3) hours to check for fitting
 If this works and it helps, Shepler's will do it
 - Mayor Doud asked that Mr. Shepler get a plan in place for how they will handle Labor Day
 Mayor Doud would like this plan presented to the Council at a special meeting next
 - Wednesday, August 28th

 \cap

- Mr. Shepler responded that he could have a plan in place to present at a August 28th meeting he will be out of town on that date but can have Jason Wiley at the meeting to represent Shepler's and present their plan
- Councilman St. Onge inquired if there were any updates on the Ottawa and the Huron
 - Mr. Shepler responded that he has no updates at this time, however he will have a report to provide to the Council at their first meeting after Labor Day
- Councilwoman Myers inquired about the sale of third-party tickets
 - It is mentioned in the Shepler / Hoffman's press release that "tickets will no longer be sold through hotels and other third-party vendors. Shepler's will honor discounted third-party tickets through August 31. After that, customers may seek refunds through the hotel or third-party vendor where they purchased the ticket."

- This is not something that the City agreed to, nor was it part of to be a solution of the made at the August 14th Special Council meeting the Council wanted their lawyer to look in to this more before making any decisions regarding third-party tickets
- Mr. Shepler responded that Hoffman has suspended the sale of third-party tickets that MIFC was selling – trading them out for Shepler's, but will stop trading them out beginning August 31st and customers will have to seek refunds through the third-party vendor
 - Councilwoman Myers noted that this was not agreed to at the last meeting
 - Jenny Gezella of Hoffman Marine noted that Mr. Shepler had added a line to the revised press release stating something to the effect of, "per City Council this is still a matter that is still outstanding and can change at any time."
- Attorney Evashevski noted that there was no agreement from the Council on this matter and they were looking for further advisement
- Mr. Shepler responded that their intent was to inform the public that they can no longer purchase a third-party MIFC ticket
- Councilwoman Myers stated that she does not approve of the language published by Shepler's with the date of August 31, 2024
 - Would like attorney Evashevski to discuss wording with Mr. Shepler

Third-party tickets will be further discussed at the August 28th Special meeting
 Franchise Agreement Deviation Amendment

- The motion made at the August 14, 2024 Special meeting put in to an agreement form to be signed by all parties (MIFC, Shepler's, City of Mackinac Island)
- Franchise Agreement Deviation Amendment with Mackinac Island Ferry Company & Shepler's Mackinac Island Ferry

Motion by St. Onge, second to the motion by Sehoyan, to authorize Mayor Doud to execute the Franchise Agreement Deviation Agreement on behalf of the City of Mackinac Island Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

- Councilman Corrigan commented that he feels the City needs to put out a statement regarding whether or not the current boat situation is a monopoly or not, and reassure the public that the City controls the fees, rates, and schedules
 - There is a lot of stress in the public about ticket prices being raised and severely reduced schedules
 - Councilman St. Onge agreed to this many news outlets are running false information
 - Councilwoman Myers agreed as well, and asked that Attorneys Evashevski and Cavanaugh come up with something to be released
 - Attorney Evashevski responded that she and Attorney Cavanaugh would work on something and will also work with Tim Hygh of the Mackinac Island Tourism Bureau

Motion by St. Onge, second to the motion by Moskwa, to authorize Attorneys Evashevski and Cavanaugh to create a statement on the City's behalf regarding the regulating authority that the City holds, per our Charter, over the rates, fees, and schedules of any and all franchised boat lines providing service to Mackinac Island, and to work with the Mackinac Island Tourism Bureau to get the information to the public.

Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

- Councilman Moskwa inquired about the bonds for phase III of the Forest Way Townhomes
 - Sale went very well
 - Was purchase by Baird & Company
 - Treasurer is working on finalizing all paperwork
 - All monies should be transferred of the City by September 5th
 - O'Boyle will be submitting their necessary permits for the project for the next regular Council meeting
- Councilman Moskwa inquired about the status of the Huron and Ottawa
 - Mayor Doud has been in touch with the US Coast Guard and Mr. Shepler should have an update at the August 28th special meeting
 - Main problem is that MIFC was given a list of repairs that the US Coast Guard wanted done to the Huron, but none of the repairs were ever completed
 - Councilman St. Onge commented that when he went across yesterday, you could actively see people working on the MIFC fleet

XI. New Business

- Michigan Municipal League (MML) on-site training program for City boards and elected officials & discussion of possible funding through the Mackinac Island Community Foundation
 - Pete Olson has been working with MML for Open Meetings Act and Freedom of Information Act on-site training

- Signup information should be provided to the Historic District Commission, Pla Commission, City Council, Cemetery Board, Library Board, Mackinac Island Transportation Authority, Mackinac Island Police Department, and Mackinac Island Department of Public Works
- Training will take place on September 12th from 5:00pm to 8:00 pm
- Mr. Olson also talked to the Mackinac Island Community Foundation about apply for grant funding to cover the \$1,800.00 cost of the training

Motion made by Myers, second to the motion by St. Onge, to authorize the Clerk's office to apply for funding from the Mackinac Island Community Foundation for the on-site training with the Michigan Municipal League for Open Meetings Act and Freedom of Information Act. Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

Motion by Myers, second to the motion by Moskwa to have the Clerk, Mayor's Assistant, and Building Department Secretary Katie Pereny to send out a notification to all board, commission, and authority members.

Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

- Least privilege access hardening the network with further protections to limit lateral movement
 - No cost to the City as it is provided by Empiric Solutions
 - Councilman Corrigan noted that there has been a lot of hacking of utilities around the country. This is mainly a DPW issue, but since we share the same hardware we want to have protection on all ends
 - Will limit access to employees and council members using City computers
 - Will be restricted on what can be done on the network
 - Councilman St. Onge inquired if this would affect things like downloading applications and such
 - Councilman Corrigan responded that this will not affect things like that what is public will remain public. This tightens up what employees have access to.

• Our municipality is not under any legal obligation to enact this software like larger cities Motion made by Corrigan, Seconded by Moskwa, to engage the services of Empiric Solutions to implement the necessary software.

Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

- Application firewall security services
 - \circ \$1,300.00 per year, still need the three (3) year quote which should not exceed \$4,000.00
 - \circ $\,$ Money to cover this will come from the IT budget / account
 - \circ $\,$ Recommended by the IT Committee to proceed

Motion made by Myers, second to the motion by Moskwa, that on the recommendation of the IT Committee, the City contracts for the firewall security services for a three (3) year contract not to exceed \$4,000.00.

Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

- Fudge Festival Events
 - Same submissions as previous years
 - Wests Michigan Bootscooters dancing in the street will take place on Friday closing Market Street during this event – Competitive Event Application submitted
 - Have been communicating with emergency services and horse companies on that
 Requesting permission to hang banners at the Tourism Bureau building and at the Stuart
 - Dennis Dombroski has given his approval for the banners

Motion by St. Onge, second to the motion by Schoyan, to approve the Competitive Event Application for the West Michigan Bootscooters and requests for banners on the Tourism Bureau and Stuart House buildings.

Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

- Resolution to continue the Fitness Court project and discussion on how the project can move forward
 - Priority Fitness has granted the City \$40,000.00 for the project
 - Resolution states the city will cover the remaining project cost of \$170,000.00. In addition to that, there needs to be a cement pad installed (\$25,000.00), and assembly needs to be completed (\$25,000.00)
 - Could have the Maintenance Department complete the assembly, but if we have the company complete it we do not have to worry about any complications
 - Dr. Patay did speak with the Community Foundation about writing a grant for the remainder of the cost (\$220,000.00)
 - If we do not get the grant, then the project does not happen
 - Grant may not be issued all at once as it may be split between two (2) fiscal years for the Community Foundation. However, if we purchase the equipment this year, we would avoid possible cost increases implemented in 2025

- Councilwoman Myers and Councilman Sehoyan inquired where this fitness part Section IV, Itema. located and how much space it will occupy
 - Two possible locations at Turtle Park
 - Between the pickleball court and soccer field
 - Between the basketball court and the green shed
 - Councilwoman Myers asked if actual dimensions and a site plan could be brought to the MIRD Recreation Board to further discuss the placement
 - A bit more information needs to be provided before a grant application can be submitted to the Community Foundation

- Email from Susan Odgers regarding ADA compliance of Shepler's boats
 - Mayor Doud noted that the City does not have jurisdiction over boats and their compliance. Shepler's is a private company and has to adhere to US Coast Guard regulations.

Motion made by Moskwa, Seconded by Sehoyan, to direct the letter to Hoffman Marine for further follow up.

Voting Yea: Chambers, Corrigan, Moskwa, Myers, Sehoyan, St. Onge

VII. New Business

- Discussion regarding plans for Labor Day weekend ferry services
 - US Coast Guard (USCG) inspections for Mackinac Island Ferry Company (MIFC) boats Joliet and Cadillac scheduled for Thursday
 - The Joliet was put in the water today and new cracks were foundUSCG needs to determine what further work is needed
 - Next step will be to maneuver all boats to all docks / ramps to figure out compatibility - Ryba Dock or Shepler's docks
 - At this point Shepler's does not have clarity from USCG on if the boats are ready for passenger service, and the do not know where the boats will be compatible with for docking.
 - Still actively working with the USCG to get the boats certified
 - Joliet sits higher than all Shepler boats so need to see if the ramp hydraulics at the Shepler dock can go high enough
 - Councilman St. Onge commented that Shepler's already knows that the Joliet will fit at the MIFC docks, so why not just run it from there?
 - Jason Wiley of Shepler's Ferry responded that using the MIFC docks comes down to possible operational issues - need to make sure traffic can be safely directed between the docks. Communication becomes an issue if using another dock.
 - Mr. Wiley met with Dennis Dombroski, Misty from the Bicycle Street Inn, Pete Deckert, and Todd Callewaert to discuss staging people waiting in line on the Ryba dock
 - Plan is to stop the line at the head of the Shepler's dock, then have staff to direct people down to the alleyway to MIFC Ryba Dock (between Ryba's Fudge and VanDusen's), to alleviate people waiting on the sidewalk.
 - All parties involved in this discussion were in agreeance to this plan
 - Councilman Chambers noted the further cracks in Joliet, and inquired if there had been any further issues encountered with the Cadillac?
 - Mr. Wiley responded that they were waiting on the USCG inspection on Thursday to see if any further issues were found
 - Councilwoman Myers inquired when Shepler's planned to implement their staging strategy
 - Mr. Wiley responded they he had just spoke with the group mentioned before today, but would like to begin implementing this idea as soon as possible. Shepler's will need to start a new daily routine with their employees to implement this processes and get guests used to it

- Councilman Moskwa commented that he saw lines down to the Library this past weekend and noted that it will only get busier. People are worried about wait times to get on the boat
- Mayor Doud noted that if the lines become a problem, she gave Chris Shepler permission to stage waiting guests on Windermere Point
- Chief Gruists noted that he has been updated on the Shepler's plan for the weekend,
 He has also been offered additional assistance from the Fire Department, and
 - the Police Department will have extra officers on for the weekend
- Ira Green inquired why Shepler's was not using the MIFC Main Dock
- Councilman Moskwa inquired if there were any updates on the main dock
 - Mr. Wiley replied that he has no updates on the Main Dock yet, it will be addressed at the regular Council meeting on September 4th meeting
 - Not using the Main Dock for the safety and welfare of the guests. Many repairs that need to happen to the dock.
- Discussion regarding the Shepler's schedule after October 6th
 - Mr. Wiley noted that, during this time frame, Shepler's typically paired their schedule down to run every hour throughout the day. Looking to take all of MIFC's departures and adding to the Shepler's schedule, which turns in to running to every half hour from October 7th through October 27th.
 - If needed on the weekends, will run every 15 minuets
 - October 26th, foot race day, will be adding 8:15, 9:15, and 10:15 boat to accommodate larger amounts of people
 - After October 27th shifting to run every hour out of both ports
 - Councilwoman Myers asked to discuss the schedule presented for October 28th through October 31st
 - Departing every hour with the last boat leaving the Island at 5:00 pm and the last boat leaving the mainland at 4:30 pm
 - The originally approved schedule from MIFC has later boats to both ports 5:30pm and 6:00 pm and the Council would like to see Shepler's stick to that schedule, especially since that was what the community was anticipating as most of them ride MIFC
 - Councilman St. Onge and Councilman Sehoyan both agreed
 - Councilman St. Onge noted that he felt that when the Council approved the suspension of MIFC, that it was the understanding that all MIFC trips would be adopted by Shepler's to cover the originally presented and approved trips
 - Councilman Moskwa noted that these later boats make a huge difference to those who are commuting to the island for work
 - Mr. Wiley responded that Shepler's has no problem adding the 5:30 pm departure from both mainland ports and the 6:00 pm departure from the Island for October 28th through October 31st
 - Councilwoman Myers noted further concerns about the employers who will have larger gourps of employees leaving during this time and getting that coordinated along with the regular departing guests
 - Keep in mind that people will most likely not want to sit on the top deck at this time and that there will be a lot of luggage
 - Councilman St. Onge suggested the possibility of utilizing the Anna May at this time due to the larger amount of luggage and carts that will be leaving with the departing employees
 - Councilman Moskwa noted that we should be asking the Island businesses to coordinate the trips for these larger groups with Shepler's so that they can arrange for any additional trips needed
 - Mr. Wiley asked that businesses contact Shepler's administration offices to coordinate departures of larger groups of employees so that they are able to ensure a smooth departure
 - Possibly work through Tim Hygh of the Mackinac Island Tourism Bureau to communicate with the employers the need to communicate larger groups of departing employees with Shepler's

• Schedule for October 7th through October 27th

0

- Based on the schedule originally approved for MIFC, the last boat to the Island on Fridays and Saturdays was 7:00 pm and the last boat leaving the Island was 7:30 pm
 - Shepler's most recently presented schedule shows the last departure on Fridays and Saturdays as 6:30 pm from the mainland ports and 7:00 pm from the Island. Council would like to see the 7:00 pm mainland departures and 7:30 pm Island departure time adhered to
 - Council woman Myers noted that this would cover what this Council had already approved for transportation for the 2024 season
- Mr. Wiley responded that for October 7th through October 27th, Shepler's would have no problem adding the 7:00 pm mainland departures and the 7:30 pm Island departure for Friday's and Saturday's
 - Would like to keep Mackinaw City and St. Ignace schedules the same (no later boats to and from Mackinaw City like there used to be)
- Discussion regarding miscellaneous ferry boat matters
 - Mayor Doud noted that the Council and Shepler's will discuss winter service at the regular Council meeting on September 4th.
 - Know this is a concern and it will be addressed. Working very hard with Shepler's to make sure there is a reliable winter service. It is very unfortunate that Jerry Fetty did not take care of the MIFC assets, especially the Huron, but that is what we have to work with at this time.
 - Councilman St. Onge commented that this Council needs to work on the here and now, not on the then. It is unfortunate that MIFC left us the City and the residents in a lurch, but the Hoffman company is who decided to grab the ball and run with it.
 - Councilwoman Myers reminded Shepler's that the third-party ticket language they have published was never approved by Council and Shepler's needs to continue accepting those tickets
 - Councilman Moskwa noted that this is not the best situation, not one we thought we would find ourselves in, but that we appreciate the effort that Shepler's is putting in, however the City and residents need more answers
 - Councilman Corrigan pointed out continued operational issues people have been complaining about shipping over unattended small freight items. They are being told by Shepler's employees that they will be charged \$40.00, with some actually being charged the fee if they still choose to send over the items.
 - Per what was previously agreed upon, there should either be no charge or the charge should be \$4.95 per item up to 100 pounds
 - Mr. Wiley agreed with this and noted that Shepler's will continue to work with their employees on this. This is a pressing matter and we will get a handle on it.
 - Mr. Wiley proposed that Shepler's could come up with some language regarding the shipping process and prices and will send it to council for approval before publishing just like we did previously for the parking and pass trade in
 - Once approved, this can be published by Shepler's and the City

Mayor Doud and members of the City Council,

On Wednesday, August 21st, 2024, at approximately 1920 hours, Mackinac Island Police Officers were dispatched to assist Mackinac Island EMS with an injured, unconscious elderly male who had fallen and struck his head. It was immediately clear that this was a serious situation and the patient required immediate, advanced medical attention.

Once Mackinac Island EMS personnel were in a position to transport the male, the Shepler's ferry to St. Ignace had just departed the dock, meaning that the next available ferry for St. Ignace was scheduled to leave in 30 minutes.

An officer with the Mackinac Island Police Department noticed that a Shepler's ferry for Mackinaw City had remained at the dock. That officer made contact with the captain of that vessel and advised him of the severity of the situation. According to this officer, the captain did not hesitate to hold the ferry and reroute his course, stating that he would transport the patient to St. Ignace before resuming service between Mackinac Island and Mackinaw City. This compassionate act undoubtedly saved precious minutes and was instrumental in getting the male advanced medical attention as quickly as possible.

This incident served as a needed reminder of the exceptional service that Shepler's has provided the residents, workers and visitors of Mackinac Island and the surrounding area for the decades of their existence as a company. It would have been far easier, present circumstances considered, for the Shepler's captain to recite policy or point to their current scheduling and transportation demands as reasons why they could not deviate from their assignment. Instead, they deviated, and did so with selfless enthusiasm.

We thank Shepler's for the outstanding service they continue to provide this community.

Dufina confirmed that nothing will be stored on the beach once the deck is installed. Dufina also asked if racks were going to be used. OLD BUSINESS

Bicycle Inn Deck - Ira Greeninio C17-062-026(H) Ð Neumann stated that it was pointed out to him, that after the Shepler's Dock expansion is done, the beach will be less visible than what it is today. Neumann posed the question to the Commission of the significance of the beach as a defining characteristic of the site and whether the visual impact of the project would be consistent with the site's historic maritime ambiance. Neumann feels the gravel beach is part of the marine character of the district. Straus stated she read the description of the harbor that was written in the application of historic district status and the presence of the beach and the fishermen history was mentioned in the Commission's original document, as something that made the water side of Main Street historic. Barry Polzin stated the intention of the storage deck was to clean up the untidiness present today. The deck is set down 2' to diminish the visual impact. Polzin submitted photographs to the table showing the gravel beach as it is today. The same amount of beach will be visible with the deck in place. No bikes will be on the beach. Doud asked Neumann if the deck was on the seawall and brought out, would he feel better about it. Neumann stated no. He feels the proposed application is a better solution. He prefers the open deck underneath rather than a seawall. In addition, the deck would be easier to remove in the future. Finkel asked if at the current lake level would there still be beach for ducks. Per Polzin, yes there would be. Straus informed Polzin that the description of tidier, is not a description she likes, or the goal of the water front. Historically the shore was not tidy. Polzin stated he understood what she was saying but they are trying to make it look organized; look like it is supposed to be rather than spreading things all over the beach. Doud asked Straus if she was opposed to the project. Straus stated she is troubled by the fact that the encroachment of commercial activity that close to the water's edge is a false sense of historic development. Straus is more interested in having the shore remain mixed up and disorganized, the way a water front was and can be. Doud stated he disagreed. Doud feels it is natural progress. Green presented the Shepler's dock plan to the table. The drawing reflected the shoreline view from the dock. A person must be at least 150' out on the dock to see the shore. Motion by McCallum, second by Finkel to approve the storage deck. Roll call vote: Ayes: King, Doud, Finkel, McCallum. Nays: None. Straus abstained due to the fact she was not present for the entire discussion. Majority in favor. Motion carries.

The proposed project would allow for repairs to be done in the building next door, with the rental of the bikes on the vacant lot located at the aforementioned address. The drawings show a fence to surround the property that is proposed to be vinyl. The property owner would be willing to use wood or Azek material if the commission so chooses. There are two sets of drawings, one with a boardwalk and one without. The boardwalk will take some additional work and would be in conjunction with what the City would like to do. The City Architect did suggest that the one canopy that is on the east side of the property be made into two separate units to be more consistent with what is going on with the other canopies. The canopies are also proposed to be metal which the commission shows some concern over.

The application was forwarded on to the City of Mackinac Island Zoning Board of Appeals for a variance request for three separate variances pertaining to the front and rear setback, lot coverage and setback to an

File No. C07-063-35: Ira Green - Shepler / Iroquois Bike Shop Renovations

Application has been made by Ira Green to renovate the Shepler dock and Iroquois Bike Shop, located at 7425 & 7431 Main Street. Exhibits B-C were presented to Commissioners for approval.

Dennis stated that Mr. Green is looking to remove the wall between the bike shop and the ferry dock, renovate the restrooms, and build an additional dock behind the bike shop for a luggage area for the bike shop.

Mr. Barry Polzin explained to the Commissioners what the details in the plans would mean. Both buildings would remain intact, just the removal of the common wall of the buildings on the first floor. The idea would be that when tourists left the ferry, the bikes would be right there in their view. The additional dock space behind the bike shop building will help clean up a lot of congestion that happens toward the street, by moving the freight and luggage area away from the traffic area of the ferry dock. They are proposing to do an aluminum frame, stretched skin canopy over the luggage area, similar to what Sheplers already has on the dock. The door that comes out towards Main Street to access the housing above will be eliminated, but there will still be a door on the waterside of the building to access that housing.

Commissioners noted that Mr. Green is not currently the owner of the bike shop building and no information has been received from Sheplers regarding their involvement in the proposed project. The additional dock space on the rear of the bike shop building will require DEQ involvement. Commissioners would like a better legal description of the property and some documentation from the current property owners agreeing to the proposed project.

Motion by Dufina, second to the motion by Finkel, to table the request of Ira Green to renovate the bike shop and Shepler buildings, until the next regular meeting of the Planning Commission to provide additional information that the Commissioners have requested. All in favor. Motion carried.

The boat slips will stay the same, but will have new pump out facilities, and new decking installed. The bubblers will be replaced with quieter, more efficient models. Restrooms will become barrier free, and electrical panels that are outside of the building will be moved inside. Ryba Marine will do the construction, and the project is expected to begin in September of 2007 and finished by June of 2008

Commissioners are concerned about the new trash building that is proposed to be built. The building would be nonconforming because of the setbacks. The trash building is proposed to be built in the same location as the trash is currently stored in cans.

Commissioners are also concerned about the actual progress of the project. Where will the construction materials be stored, where will any necessary motor vehicles be stored?

Motion by Dufina, second to the motion by Finkel, to table the Commission's approval for the presentation by the Department of Natural Resources, Waterways Commission to remodel the Mackinac Island Marina until the regular meeting of the Mackinac Island Planning Commission in June to allow the Commissioners to review the proposed plans in more detail.
