Gordan Layman Informed the Commission of upcoming needs of our power grid that will be needed to be addressed this fall. OMPA representative Alex Dobson requesting some repairs and upgrades. A mobile sub will be needed to make repairs at a cost of 100,000 depending on length of time needed. Guessing 130,000 to 175,000 for the mobile sub and the suggested repairs needed. Trying to get more years out of the 50-year-old transformer in place now. If repairs are not done and transformer goes out, then it could cost over a million. Commissioner Hooley asked if a grant might be available Mr. Layman stated he hasn't checked into a grant as of yet. Mr. Kendall stated he thought there was assistance available from OMPA. Mr.Layman stated that a relay has already failed and was replaced by Alex on Thursday with a spare he had and took ours to send in for repairs which is out of warranty but stated they would try to help. Mr. Layman stated he hasn't heard of cost of repair on our relay yet.Mr.Layman stated we need to do preventative maintenance before things get worse.
