2. Discussion and possible action to approve the request from the Mangum Housing Authority to retain the P.I.L.O.T (Payment in lieu of Taxes) funds in the amount of \$5,999.03 for this year, or at least the the amount of \$1,670.00 for the upkeep of the Mangum City Property located west of the Ml-IA's facility. The Housing authority is requesting \$1\$70.00 which includes 16 mowing's at \$75.00 per mow = \$1,200.00, 2 sprays at \$235.00 = \$470.00, this would leave a balance due to the City in the amount of \$4,329.03.

Current city manager is wanting to go forward with what previous city manager promised Mr. Lively. City manager is wanting to use ARPA funds for this cost. Mr. Lively agrees to cover some costs as well as the city. The city has some materials now.
