## **REMARKS**

Tammy Zecca with the library board spoke on the promises of budget amendments for the library books, computers, and materials. Stating that it was promised to be amended and it was just kicked down. She stated that it was important because the budget was cut almost by half stating that if we don't show that the city doesn't spend enough money on the library then the state doesn't think that we care about our library and we lose state funding. She stated her concerns that there were two new positions created, a safety officer and an assistant city manager. Her concerns were where is the money for those positions coming from if the city couldn't give the library the money that it deserved.

Gary Kerbo spoke next stating that last September he came and spoke about the dirt pile next to his property wanting it shut down and the taco stand next to him wanting it shut down as well. Stating that these properties are not commercial properties. He stated that he came back in November, and the city said they would have it done by the end of the year but nothing has still been done. After discussion by the Mayor and Attorney Kendall it was stated by attorney Kendall that he will get with the City Clerk and the city should be able to have a special zoning board meeting mid May or at the June meeting.

## **REPORTS**

### 8. Financial Report for February 2026 by the City Manager

Revenue February: Sales Tax: \$50,386.00 down .9%, Use Tax: \$20,400.00 up 36%, Alcohol Beverage Tax: \$6,075.00 down 13.8%, Franchise Tax: \$7,924.00 increased from last month, Fine & Forfeitures: \$1,150.00, down 35%, Transfers In: \$93,015.84 vs \$93,016 (≈0%), Easement Lease: \$15,355 vs \$15,355 (0%), Water Revenue: \$49,832.00 down 12%, Electric Revenue: \$175,732.00 down by 15%, Wind Power Revenue: \$21,125.00 down 37.1%, Sanitation Revenue: \$42,821.00 staying the same, Recycle Center Revenue: \$270.00 up 121%, Penalty Revenue: \$4,519.00 up 40.3%. \$790,000.00 currently in our bank right now there are \$39,000 in outstanding purchase requests, \$22,970 in outstanding checks, \$2,453.50 in Hospital insurance money, \$194,333.15 in insurance money.

### 9. Police Report by the Chief of Police

Chief Taylor presented his report stating that for the month of March they had 616 calls for service breaking down to 43 911 transfers, one abandoned vehicle, 3 different accidents, 6 business alarms, 25 animal calls, 1 body found, 18 BOLO's, 6 disturbances, 4 domestic disputes, 2 drunk drivers, 5 EMS assists, 9 extra patrols, 3 different types of fire assists, 22 follow ups, 3 foot patrols, 311 requests for information, 2 intoxicated persons, 1, motorist assist, 1 noise disturbance, 5 open doors, 3 reckless drivers, 33 requests to speak with an officer, 1 shoplifting, 3 calls of shots fired/heard, 1 stolen property, 1 stolen vehicle, 5 suspicious persons, 2 suspicious vehicles, 9 welfare checks. Out those we ended up with 25 reports consisting of 1 aggravated assault, 2 DUI's, 1 drug narcotic equipment violations, 1 public drunkenness, 2 different types of fraud, 1 homicide, 1 public peace mental case, 2 different sexual assaults, 1 stolen motor vehicle, 1 threat of intimidation, 1 vandalism, 1 warrant for other agency, 1 weapon law violation.

10. Fire Report by the Fire Chief

Chief Gambill stated the Fire Department had 28 calls breaking down to 6 helicopter standbys, 10 lift assists, 8 grass fires, 1 smoke alarm, 2 gas leaks, and 1 smoke investigation. Chief Gambill stated the some of the grass fires did last numerous days.

City Manager Mora stated that we have been having a lot of complaints regarding citizens using other citizens and business dumpsters. Attorney Kendall stated that the ordinance as it was previously written allows you to put trash in an authorized private receptacle so we defined authorized private receptacle.

City Manager Mora stated that she wanted to let the commissioners know that we have received the Police truck that we purchased and it was paid out of the general government capital improvement fund.


