5. Financial Report from City Manager for September 2020.

City Manager Dave Andren gave his report as follows.

Sales Tax is down by 23.31% from last month and down by 3.15% from the same month last year. The use tax is down by 9.43% from last month and up by 15.67% from the same month last year. Other revenues are up by 28.20% from last month and up by 47.35% from the same month last year. Transfers-in from MUA are the same as last month and down 27.90% from the same month last year.

Overall revenues are \$170,870.87, which is down by 2.90% from last month and down 8.33% from same month last year. Expenditures are \$144,921.28 which is up by 14.57% from last month and down by 18.79% from the same month last year. Leaving the fund balance for the month at a positive \$25,958.59.

MUA Revenues were \$495,746.16 which is down by 9.92% from last month and up by .36% from the same month last year. MUA expenditures were \$422,750.77 which is down by 12.39% from last month and down by 8.51% from the same month last year. Leaving the fund balance for the month a positive \$72,995.39.
