REPORTS

5. Financial Report by the City Manager.

Dave went over the financials. We are in good shape.

Sales tax is down by 3.03% from last month and up by 7.18% from the same month last year. The Use Tax is down by 17.54% from last month and down by .90% from the same month last year. Other revenues are up by 145.25% from last month and up by 114.95% from the same month last year. Transfers-in from MUA are the same as last month and up by 4.82% from the same month last year. Overall revenues are \$195,642.36, which is up by 21.42% from last month and up by 26.15% from same month last year. Expenditures are \$204,983.43 which is up by 25.50% from last month and up by 26.67% from the same month last year. Leaving the fund balance for the month at a negative \$9,341.07.

MUA Revenues were \$359,564.30 which is down by 22.41% from last month and up by 7.58% from the same month last year. MUA expenditures were \$360,755.15 which is down by 17.29% from last month and up by 7.97% from the same month year. Leaving the fund balance for the month at a negative \$1,190.85.

Balance of Revenues vs Expenditures from July 2021 to November 2021.

General Government: \$43,558.18 Mangum Utility Authority: \$147,587.44
