#### **REPORTS**

8. City Managers Financial Report.

City Manager gave his monthly financial report for the month of May 2021.

Sales Tax is up by .54% from last month and up by 4.90% from the same month last year. The Use Tax is up by 75.40% from last month and up by 80.19% from the same month last year. Other revenues are up by 18.67% from last month and up by 17.18% from the same month last year. Transfers-in from MUA are the same as last month and up 748,041,500.00% from the same month last year. Overall revenues are \$170,670.57, which is up by 7.23% from last month and up 106.76% from same month last year. Expenditures are \$147,783.25 which is up by 5.85% from last month and up by 15.20% from the same month last year. Leaving the fund balance for the month at a positive \$22,887.32.

MUA Revenues were \$181,133.35 which is down by 44.14% from last month and down by 38.70% from the same month last year. MUA expenditures were \$321,397.05 which is down by 7.26% from last month and up by 49.62% from the same month last year. Leaving the fund balance for the month a negative \$140,263.70.

The Housing authority is requesting \$1,985.00 which includes 21 mowing's at \$75.00 per mow = \$1,575.00, 1 spray at \$350.00 and tree trimming at \$60.00, this would leave a balance due to the City in the amount of \$3,565.23.

The board discussed the P.I.LO.T. funds and the upkeep on the Park by the Mangum Housing Authority.

### A PROCLAMATION GIVING NOTICE OF AN ELECTION TO BE HELD IN THE CITY OF MANGUM, OKLAHOMA ON THE 19<sup>TH</sup> DAY OF OCTOBER 2021.

The election by the qualified electors of said City of the following officials:

#### Commissioner of Streets and Highways

The ballots used at said election held on the 19<sup>th</sup> day of October 2021, shall set forth the names of all candidates for said above named offices, if necessary. The second election shall be held on the 2<sup>nd</sup> day of November 2021, if there should be no candidate for any office who has received an absolute majority. The names of the two candidates who receive the highest number of votes at said first Municipal election shall be placed upon the official ballot as candidates for said office at the second Municipal election.

That ballot setting out the elected offices to be submitted to the registered, qualified voters and electors of Mangum shall set out the above described candidates for each respective office.

The polls shall open at 7:00 a.m. and remain open continuously until 7:00 p.m. on said Election Day, at which time they shall be closed.

The location of the polling place for the said election shall be the City Hall Annex, 131 North Oklahoma, in the City of Mangum, Greer County, Oklahoma.
