## AUTHORIZING HOLIDAY BONUS FOR FULL-TIME AND PART-TIME EMPLOYEES AND POLICE AND FIRE DEPARTMENT VOLUNTEERS

AN ORDINANCE AMENDING ARTICLE IV OF CHAPTER 82 OF THE CODE OF ORDINANCES OF THE CITY OF MARIETTA BY DEFINING AUTHORITY OF CITY COUNCIL TO DETERMINE STREET NAMES AND ESTABLISHING PROCEDURE FOR STREET NAME CHANGES; REPEALING ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT; PROVIDING FOR SEVERABILITY; AND DECLARING AN EMERGENCY

# BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF MARIETTA, OKLAHOMA:

**SECTION 1.** Chapter 82 of the code of Ordinances of the City of Marietta, is hereby amended to reads as follows:

#### **ARTICLE IV. STREET NAMES**

#### Sec. 82-54. Street Names.

The names of streets and roads in the City of Marietta are renamed as follows:

- A. Except as otherwise may be specifically stated herein, all streets and roads traveling North and South are renamed as: Avenues.
- B. Except as otherwise may be specifically stated herein, all Northwest ("NW") streets and roads are renamed: North Avenues. As an example, Northwest 2<sup>nd</sup> is renamed as North Second Avenue.
- C. Except as otherwise may be specifically stated herein, all Southwest ("SW") streets and roads are renamed: South Avenues. As an example, Southwest 2<sup>nd</sup> is renamed as South 2<sup>nd</sup> Avenue.
- D. Except as otherwise may be specifically stated herein, all streets and roads traveling East and West are renamed as: Streets.
- E. Northeast Front Street is renamed: North Ashwood Avenue.
- F. Southwest Front Street is renamed: South Ashwood Avenue.
- G. Northeast 2<sup>nd</sup> Street is renamed: North Brentwood Avenue.
- H. Southeast 2<sup>nd</sup> Street is renamed: South Brentwood Avenue.
- I. Northeast 3rd Street is renamed: North Candlewood Avenue.
- J. Southeast 3rd Street is renamed: South Candlewood Avenue.

- K. Northeast 4th Street is renamed: North Driftwood Avenue.
- L. Southeast 4th Street is renamed: South Driftwood Avenue.
- M. Northeast 5th Street is renamed: North Elmwood Avenue.
- N. Southeast 5th Street is renamed: South Elmwood Avenue.
- O. Northeast 6th Street is renamed: North Femwood Avenue.
- P. Southeast 6th Street is renamed: South Femwood Avenue.
- Q. Northeast 6th Street from Bill Halstied to the Limits of the City of Marietta on the North is renamed: Ward Ranch Road.
- R. Southeast 6th Street that travels East and West is renamed: Choctaw Street.
- S. That part of West Cherokee Street, which travels North and South, is renamed: Glenwood Avenue.
- T. Cemetery Road from Oak to City Limits shall remain as Cemetery Road.
- U. East Wood is renamed: Wood Street.
- V. East Pine is renamed: Pine Street.
- W. East Oak is renamed: Oak Street.
- X. East Arch is renamed: Arch Street.
- Y. Love Street extending from Highway 77 is renamed: Sobe Street.
- Z. Summit Street between North 6th and North 8th is renamed: Peak Street.
- AA. Northwest 6th Avenue from Love Street to North City limits is renamed: Silo Avenue.
- BB. Southwest 5th Avenue from Ball to Mayall is renamed: Veterans Avenue.
- CC. Banks Drive is renamed: Football Way.
- DD. Ridgeview Street traveling North and South is renamed: Crestview Avenue.
- EE. All of Circle Drive will remain the same.

ORDINANCE NO.

The City Council shall have the authority to determine street names and numbers and to require changes in any proposed names. Such names and addresses may be subject to change by the City and should never be utilized in place of a legal description.

## <u>Secs 82-54 – 82-59. Reserved.</u>

#### Sec. 82-60. Street Name-Change Procedures.

Proposed street name changes, whether or not the street is part of a recorded plat, shall be subject to the following review and approval process:

- (a) Any person or firm may propose a street name change by making application on the designated forms to the City Clerk and submitting an application fee as determined by resolution of the City Council.
- (b) The proposed name shall not duplicate, or sound like, an existing street name within the service district of Love County E911 District.
- (c) The City Council may approve a street name change by resolution, with such resolution stablishing a date by which the name change shall become effective.
  - (1) Prior to approving a street name change, the planning commission shall set the matter for public hearing and give at least 15 (fifteen) days' notice of the date, time, and place of the hearing by publication in a newspaper of general circulation and by regular mail to all owners of any properties which are addressed on the street subject to the proposed name change, with the addresses of such owners as shown by the Office of the Love County Assessor.
  - (2) Protests against the proposed change shall be filed at least three (3) days before the date of the public hearing. If protests are filed by the owners of fifty percent (50%) or more of the properties which are addressed on the street subject to the proposed name change, then the proposed change shall not become effective except by the favorable vote of three-fourths of all the members of the City Council.
- (d) The City Council may require the person or firm requesting the street name change to reimburse the City for any costs incurred for the replacement of street signs.
- (e) If the City Council approves a street name change, the City Clerk shall make notification of the change to the United States Postal Service, Love County E911 District, and all owners of property which is addressed on the street affected.

**SECTION 2.** All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, repealed.

ORDINANCE NO.

**SECTION 3.** If any section, sub-section, sentence, clause, phrase, or portion of this Ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portion of this Ordinance.

**SECTION 4.** It being immediately necessary for the preservation of the public peace, health, safety, and welfare of the City of Marietta and the inhabitants thereof that this ordinance be put into full effect, an emergency is hereby declared to exist by reason whereof this ordinance shall be in full force and effect from and after its passage and approval.

**WHEREAS,** City entered into a lease agreement with the Chickasaw Nation in 2008 for occupation of a building on property located at 105 S. 3<sup>rd</sup> Avenue for use as a police station; and

**WHEREAS,** in 2016 the Chickasaw Nation donated to the City, the building and said property for continued use as a police station; and

**WHEREAS,** the said building and property are no longer needed for use as a police station or any other facility by the City of Marietta.

# NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF MARIETTA:

- 1. The property located at 105 S. 3<sup>rd</sup> Avenue, further described as Lots Fourteen (14) and Fifteen (15) of Block Twenty-Six (26) of the City of Marietta, Love County, Oklahoma, is surplus to the needs of the City of Marietta and ownership of the said property shall be transferred to the Chickasaw Nation.
- 2. The Mayor and City Administrator are authorized to sign all related documents and forms necessary to effect such transfer of ownership.
