A RESOLUTION CONCERNING CORONAVIRUS LOCAL FISCAL RECOVERY FUNDS FOR NON-ENTITLEMENT UNITS OF GOVERNMENT (ARPA FUNDS), AUTHORIZING THE ACCEPTANCE OF FUNDS, THE APPROPRIATE BUDGET AMENDMENTS, AND THE EXECUTION OF ALL NECESSARY AGREEMENTS AND RELATED DOCUMENTS

**WHEREAS,** the City of Marietta has been designated as a recipient Coronavirus Local Fiscal Recovery Funds for Non-Entitlement Units of Government (ARPA Funds), and has been designated as a recipient of the amount of \$483,445.92 for this fiscal year; and

**WHEREAS**, the City of Marietta will be required to budget said funds and to account for all expenditures in accordance with applicable federal guidelines; and

WHEREAS, authorization for the execution of all necessary agreement and related documents will expedite the receipt and expenditure of funds; and

WHEREAS, a budget amendment is necessary to properly account for the funds; and

**WHEREAS,** approval of the documents associated with the funds is in the best interest of the citizens of the City of Marietta.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Marietta as follows:

- 1. The budget amendment attached hereto as "Attachment A" is approved.
- 2. The acceptance of ARPA Funds is approved and the City hereby acknowledges all expenditures must be in accordance with all ARPA guidelines and compliance requirements.
- 3. The City Administrator is authorized to sign all necessary budget attestations, award terms and conditions, assurances of compliances, reports and all other necessary agreements and documents related to the award of funds.
