ORDINANCE NO. \_\_\_\_\_

**AN ORDINANCE BEING CODIFIED AS SECTION 94-91 OF THE MARIETTA CITY CODE, TO PROVIDE RULES AND REGULATIONS FOR ONE-WAY STREETS AND ALLEYS AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF MARIETTA, OKLAHOMA:**

**SECTION 1.** Section 94-91 of the Marietta City Code will be read as follows:

**Sec. 94-91. One-Way Streets and Alleys:**

(a) Authority To Designate: The city council, by resolution, may designate any street or alley or part thereof as a one-way street or alley. Signs indicating the direction of lawful traffic movement shall be placed at every intersection where movement of traffic in the opposite direction is prohibited.

(b) Direction Of Traffic: Upon those streets and parts of streets and in those alleys and parts of alleys designated as one-way streets and alleys, vehicular traffic shall move only in the indicated direction when signs indicating the direction of traffic are erected and maintained at every intersection where movement in the opposite direction is prohibited.

**SECTION 2.** There exists an immediate necessity in order to provide proper regulation of property within the City of Marietta, and for the preservation of the peace, health, and safety of the citizens of said City, and emergency is hereby declared to exist whereby this Ordinance shall be in full force and effect from and after its passage, as provided by law.

**RESOLUTION \_\_\_\_\_**

**A RESOLUTION ESTABLISHING GILLIAM STREET AS A ONE-WAY STREET**

**WHEREAS**, Marietta Public Schools has asked the City Council to make Gilliam Street into a one-way street for student safety and traffic control issues; and

**WHEREAS**, a public hearing was held before the City Council on 11-12-24; and

**WHEREAS**, Section 94-91 of the Code of Ordinances of the City of gives the City Council authority by resolution to designate a one-way street.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF MARIETTA** Gilliam Street is designated as a one-way street and the rules of the road as follows:

1. Gilliam Street will be a one-way street between Veterans Avenue and U.S. Highway 77 with the traffic flow traveling west.
2. Traffic signs will be erected and maintained at every intersection where movement in the opposite direction is prohibited.
3. All posted speed limits will remain unchanged.

**ORDINANCE NO. 2024-\_\_\_\_\_**

ORDINANCE AMENDING SECTION 90-33 OF ARTICLE II AND SECTION 90-56 OF ARTICLE III OF CHAPTER 90 OF THE MARIETTA CODE OF ORDINANCES CONTINUING THE TOTAL EXCISE TAX OF THREE PERCENT (3%) WITHOUT AN AUTOMATIC TERMINATION DATE; AND ESTABLISHING REPEALER

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MARIETTA, OKLAHOMA:**

**Section 1.** Section 90-33 of Article II of Chapter 90 of the Marietta Code of Ordinances shall be amended to state as follows:

Sec. 90-33. Levy.

(a) There is levied an excise tax of three percent (3%) upon the gross receipts derived from all sales taxable under the state sales tax code, 68 O.S. § 1350 et seq., including but not exclusive of the following:

- (1) Tangible personal property.
- (2) Natural or artificial gas, electricity, ice, steam, or any other utility or public service except water.
- (3) Transportation for hire of persons by common carriers, including railroads, both steam and electric, motor transportation companies, taxicab companies, Pullman car companies, airlines, and all other means of transportation for hire.

(b) All other sections of this article to the contrary notwithstanding, such tax is also levied on all sales of natural or artificial gas and electricity.

(c) The levy of excise tax of three percent (3%) will commence on March 3, 2025, without an automatic termination date.

**Section 2.** Section 90-56 of Article III of Chapter 90 of the Marietta Code of Ordinances shall be amended to state as follows:

Sec. 90-56. Excise tax on storage, use, or other consumption of tangible, personal property levied.

Ordinance 2024-\_\_\_\_\_

(a) There is hereby levied, and there shall be paid by every person storing, using, or otherwise consuming within the municipality tangible, personal property purchased or brought into this municipality, an excise tax on the storage, use, or other consuming within the municipality of such property at the rate of three percent (3%) of the purchase price of such property. Such tax shall be paid by every person storing, using or otherwise consuming, within the municipality, tangible, personal property purchased or brought into the municipality. The additional tax levied hereunder shall be paid at the time of importation or storage of the property within the municipality and shall be assessed to only property purchased outside Oklahoma; provided that the tax levied herein shall not be levied against tangible, personal property intended solely for use outside the municipality, but which is stored in the municipality pending shipment outside the municipality or which is temporarily retained in the municipality for the purpose of fabrication, repair, testing, alteration, maintenance or other service. Any person liable for payment of the tax authorized herein may deduct from such tax any local or municipal sales tax previously paid on such goods or services; provided that the amount deducted shall not exceed the amount that would have been due if the taxes imposed by the municipality had been levied on the sale of such goods or services.

(b) The levy of excise tax of three percent (3%) will commence on March 3, 2025, without an automatic termination date.

**Section 3.** Any ordinances, code provisions, or any parts thereof in conflict with the provisions of this ordinance are repealed.

**WHEREAS**, there currently is in effect in the City of Marietta, Oklahoma, the tax of three percent (3%) imposed on proceeds from sales and the storing, using, or otherwise consuming within the municipality tangible personal property purchased or brought into the municipality; and

**WHEREAS**, a special election should be called to be held in the City of Marietta on January 14, 2025, to approve or reject the question of whether the tax imposed on proceeds from sales and the storing, using, or otherwise consuming within the municipality tangible personal property purchased or brought into the municipality herein, shall continue the additional one percent (1%) sales tax, without an automatic termination date, for a total tax of three percent (3%);

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the City of Marietta, Oklahoma, that they do hereby notify the Secretary of the Love County Election Board that they will call and give legal notice of a special municipal election to be held on January 14, 2025, to vote upon the Proposition of whether proposed Ordinance No. 2024-\_\_\_\_\_ amending Section 90-33 of Article II and Section 90-56 of Article III, of Chapter 90 of the Marietta Code of Ordinances, to continue the additional one percent (1%) without an automatic termination date, commencing March 3, 2025, for a total tax of three percent (3%), and continuing thereafter, as the total tax imposed on proceeds from sales and the storing, using or otherwise consuming within the municipality tangible

personal property purchased or brought into the municipality should be approved.

**BE IT THEREFORE RESOLVED** that the exact wording of said Proposition to be submitted to the registered voters shall be as follows:

**PROPOSITION**

Shall proposed Ordinance No. 2024-\_\_\_\_\_ amending Section 90-33 of Article II and Section 90-56 of Article III, of Chapter 90 of the Marietta Code of Ordinances, to continue the additional one percent (1%), without an automatic termination date, commencing March 3, 2025, for a total tax of three percent (3%) imposed on proceeds from sales and the storing, using or otherwise consuming within the municipality tangible personal property purchased or brought into the municipality; and repealing any ordinances or code provisions, or any parts thereof, in conflict therewith, be approved?

**BE IT FURTHER RESOLVED** that the ballot setting out the Proposition to be submitted to the registered qualified voters residing in the city limits of the City of Marietta shall set out the Proposition as above set forth and shall also contain the following words:

FOR THE ABOVE PROPOSITION: ( ) YES

AGAINST THE ABOVE PROPOSITION: ( ) NO.

**BE IT FURTHER RESOLVED** that such election shall be held at the same place and in the same manner prescribed for the conduct of special municipal elections and that the designated polling places shall be open from 7:00 a.m. until 7:00 p.m.

**BE IT FURTHER RESOLVED** that this Resolution shall also constitute the proclamation calling for such special election, and the City Clerk is directed to transmit a copy of said Resolution to the Secretary of the Love County Election Board after the



Council approves of the same.
