City Administrator Scott stated BNSF showed up and performed some of the drainage work at the tracks and they are committed to finishing the work when the box is replace and other improvements done. The bids will be published this week. Working with Water Department to find a water line.

The staff is working on making a request for a Care's fund reimbursement and anticipate filing it this month.

REGULAR BUSINESS.

6. Presentation of financial audit of the fiscal year ending June 30, 2019. (Information will be presented to the governing body via teleconference.)

Chris Angel addressed the Council regarding the audit. The financial audit is to make sure everything is accurate and done correctly. Revenue is up about \$100,000.00. Everything was in good shape. The only issue was a grant that was put in as revenue rather than being put in as a grant. We have a grant fund established now. There was \$2500.00 in two (2) clearing accounts that should have cleared out to zero but over time has built up. It should clear out next year. They had a few management recommendations such as time sheets not being signed off on by employee and supervisor. The actual revenue for tickets was higher than what the software is not showing and we need to figure out why. There were a few suggestions for purchase orders and the fire department fundraising account and since we are handling grant money in house it should not be a problem.

City Administrator Scott addressed how the City plans to fix these issues.

City Administrator Scott reviewed the proceedings against this property beginning in 2017. He reviewed the engineer report of Mr. Fox from 2017 which stated it was a danger to the public. In February the Council gave the owner until June to make repairs so it would not be a danger to the public. A new engineer's report was may on August 10 by Mr. Fox stated two corners on the building are a hazard to the public. It is the City's recommendation for immediate demolition of building within sixty (60) and if owner does not comply for the City to be able to do so.

Mr. Pollard apologized for missing the last meeting. He stated he has about \$40,000 in the building and it will cost about \$30,000 to demolish it. He gave out pictures from the early 1900's, what it looked like when he bought it and today. He said the whole world shut down due to the pandemic and he stopped the process he had started because he didn't know what was going to happen. He said he has done a lot of work and clean it up. He stated it took a lot of time to get it cleaned up and keep it mowed. He has invested a lot of money in Love County and this building. He stated he bought the dental office and showed pictures of the improvements to that office.

KorDale stated we have seen all these pictures multiple times.

At 7:18 p.m. the attorney and Mayor gave him one (1) minutes.

He stated he didn't realize he was expected to work on it during the pandemic.

Attorney Cochran stated his one (1) minute was up.

City Administrator Scott stated this started in 2017 and Mr. Pollard has worked on other properties he owns during this time. He further addressed the engineer's report about the wall.

Mr. Pollard said he has moved the wall some and asked to be allowed more time to fix it.

Council Member McKinney asked if Mr. Pollard was notified of the last meeting. City Administrator Scott stated he had been given notice that he had a certain amount of time to comply with fixing the building.

Council Member Lornes stated that in 2017 we gave thirty (30) days for appeal.

WHEREAS, it is the duty of the Mayor and City Council to protect the health and safety of the City and its inhabitants, to preserve the peace, and to provide civil defense and emergency functions; and

WHEREAS, the guidelines applicable to funding from the Cares Act indicate that there is a presumption that all public safety personnel costs are related to the COVID-19 relief efforts unless the relevant municipal official determines otherwise; and

WHEREAS, approval of this resolution is in the best interest of the residents of the City.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Marietta:

SECTION 1. Pursuant to the guidelines established for the receipt by a municipality of funds pursuant to the Cares Act and the Coronavirus Relief Fund, the City Council confirm the presumption that all public safety personnel costs of the City for the period from March 1, 2020, through December 31, 2020, were substantially dedicated to the City's COVID-19 response efforts.

SECTION 2. City staff is authorized and directed to proceed with an application to the State of Oklahoma for reimbursement of COVID-19 related public safety personnel costs for the stated period. The Mayor, City Clerk and/or City Administrator are authorized to execute all documents necessary to complete the application and funding process.

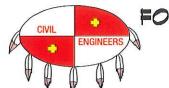
