# ORDINANCE NO. 2025-2079 AMENDING CHAPTER 36 TRAFFIC AND VEHICLES ARTICLE IV SEC. 36-122(a)(4)

WHEREAS, Mauston Common Council recognized that prohibiting parking on Mansion Street between Hickory and Union Street was originally intended to accommodate ingress and egress of large emergency vehicles, which is no longer necessary due to the relocation of the Mauston Fire Department:

**NOW THEREFORE,** on a motion duly made and seconded, the Mauston Common Council hereby adopts this ordinance deleting Chapter 36, Article IV, Section 36-122(a)(4) as follows:

### Sec. 36-122. No parking areas.

- (a) Schools. There shall be no parking on the following-described streets between the hours of 7:30 a.m. and 4:30 p.m. on days when school is in session:
  - (1) Grayside Avenue, north side, between the west side of Madden Street and 880 feet west of the west side of Buttner Street.
  - {2} Grayside Avenue, south side, between the west side of Madden Street, extended and 1,200 feet west thereof.
  - (3) Reserved
  - (4)-- Mansion-Street, both-sides, between Hickory-Street-and-Union-Street.
