Chief Patrick introduced our newest officer, Officer Sneed. She is interested in our K9 program.

Councilmember Huff asked what was going on at the Wells this weekend? Why are we paying employees overtime for this? Was Grays Harbor Environmental Health notified beings they were the lead investigators on this? Chad Bedlington said we wanted to do test holes first to see if they could find material present. Mayor Miller said they reached out to Ecology first. April Wright asked if the City knows if the asphalt out there was from the paving project or if it could be from another project. Mayor Miller stated we don't know.

Councilmember Iversen spoke on behalf of the McCleary Museum and they do not wish to move forward on asking the City to help out with their utility bills.

New Business

Councilmember Ross spoke about a City Administrator position and the goal is to have a full-time person here to run the day to day operations of the City. We'd be looking at a reallocation of funds to pay for this position. Councilmember Iversen said this does not require a vote to the voters because we are not changing the form of government. Councilmember Huff spoke in regards to a City Manager verses City Administrator. He'd like to reach out to Westport and Hoquiam for their opinion of this. Councilmember Dahl said this person is still reporting to the Mayor, that is accomplishing what we're trying to do.

Mayor Miller said that multiple people kept asking about it and they just set the record straight.
