Background

The City of Madeira Beach received approval from the Board of Commissioners (BOC) in 2023 to proceed with the design to enhance the street ends in the Boca Ciega neighborhood. Staff has proceeded with Halff, a contracted Engineering Firm who has provided designs based on staff recommendations. There are five (5) parks included in this project area. The intention of this project is to keep the accessibility to the neighboring homes, provide a designated walking path, provide a drive path and or parking area if needed, provide benches, install raised garden beds, and make these areas more aesthetic to everyone.

Each park will include a paver walkway with a designated seating area at the seawall. As you will see in the design each area will look different from the other but have the same goal. The pavers selected for these areas will be similar to 133rd Street End.

Once the project has been discussed at the neighborhood meetings staff will proceed with releasing a public bid for the project area. The bid process typically takes 3 months from the time placed out to the award of the contract. The goal is to complete this project by September 1, 2024, before the active hurricane season.








134th & Boca Ciega Ave Entering






