Inflation is predicted to continue with a cautious view of a recession to occur in 2023. There is growth potential for stock-specific situations like health care, fixed income, corporate credit and mortgage-backed securities. 10-year Treasuries have gone down and emerging market have started trending up.

The total assets as of November 28, 2022 were \$43,561,138 and were \$40,136,730 at September 30, 2022.
