Elected Officials Compensation Commission Regular Meeting Madison Heights, Michigan November 17, 2021

A Regular Meeting of the Elected Officials Compensation Commission was called to order on Wednesday, November 17, 2021, at 4:30 p.m. in the Executive Conference Room of the Municipal Building at 300 West 13 Mile Road, Madison Heights, Michigan.

Present: Commissioners: Bessler, Brunke, Fortune-Heiligh, Geralds,

Marentette, McKenzie and Wright.

Also Present: City Manager Marsh, City Clerk Rottmann

In the absence of a Chairman or Vice-Chairman, City Manager Marsh opened the meeting and the City Clerk called the roll.

21-1. Election of Chairperson.

City Manager Marsh called for nominations for the Chair of the Commission for 2021.

Motion by Commissioner McKenzie, seconded by Commissioner Geralds, to nominate Commissioner Brunke for Chair of the Commission. There being no further nominations, the vote for Chair was called.

Commissioner Angela Brunke was elected as Chair of the Commission.

22-2. Election of Vice-Chairperson.

Chair Brunke called for nominations for Vice-Chair of the Commission for 2021.

Motion by Commissioner Wright, seconded by Commissioner McKenzie, to nominate Commissioner Geralds as Vice-Chair of the Commission. There being no further nominations, the vote for Vice-Chair was called.

Commissioner Laurie Geralds was elected as Vice-Chair of the Commission.

21-3. Appointment of Secretary.

21-4. Minutes.

Motion by Vice-Chair Geralds, seconded by Commissioner McKenzie, to adopt the minutes of the Regular Meeting held on December 2, 2019, as printed.

21-5. Discussion of Salary for Mayor and City Council.

City Manager Marsh briefly reviewed the informational packets mailed to the Commission members.

City Manager Marsh explained that the Compensation Commission can only make a recommendation pertaining to Council salaries, not benefits. The recommendation is then presented to Council, which has thirty (30) days to consider or else the resolution automatically goes into effect. Council can approve or reject the Salary Order in whole or in part. She also reviewed where the City currently stands financially in relation to the budget, the rate of inflation, and other communities as surveyed by the Michigan Municipal League. She outlined the terms of the agreements with the City's bargaining groups, noting that all contracts have been extended through June 2021.

City Manager Marsh indicated that any actions taken by the Compensation Commission would cover a two-year period because the Commission meets only in odd years, traditionally following the City's General Election.

21-6. Mayor, Mayor Pro Tem and Council Salary Order.

Motion by Commissioner Wright, seconded by Vice-Chair Geralds, to freeze the current Mayor, the Mayor Pro Tem and the Councilmembers' salaries, as indicated by the following Salary Order:

ORDER OF THE ELECTED OFFICIALS COMPENSATION COMMISSION

WHEREAS, the Elected Officials Compensation Commission met on Wednesday, November 17, 2021, at 4:30 p.m. in the Madison Heights Municipal Building, pursuant to Ordinance 454 of 1972 consisting of seven members; Commissioners present: Bessler, Brunke, Fortune-Heiligh, Geralds, Marentette, McKenzie, and Wright.

WHEREAS, Ordinance No. 454 of 1972, Section 2-214 provides as follows:

"The Commission shall determine the salaries of elected officials in the City; which determination shall be the salaries unless the Mayor and Council by resolution adopted by 2/3rds of the members elected to and serving shall reject them. The determinations of the Commission shall be effective 30 days following the filing with the City Clerk of such determination unless rejected by the legislative body. In case of rejection, the existing salary shall prevail."

WHEREAS, after due consideration by the members of said Board, having been furnished with current salary statistics and after full and complete discussion of all pertinent matters, the recommended decision of the Commission is as follows:

RESOLVED, IT IS ORDERED, that the salary of the Mayor shall be frozen at \$9,498 for two years; and,

IT IS FURTHER RESOLVED, that the salary of the Mayor Pro Tem shall be frozen at \$7,321 for two years; and,

IT IS FURTHER RESOLVED, that the salary of the City Council members shall be frozen at \$6,653 for two years effective through January 1, 2023.

Secretary Wright stated that he believed that in the interest of fiscal responsibility as well as the current uncertainty in the economy, it would be prudent to recommend no increase.

In response to Commissioner McKenzie's question, City Manager Marsh reviewed the current budget revenues and expenditures. The current budget forecasts a \$995,000 use of Fund Balance.

Discussion followed on the rate and history of the internet stipend for City Council. Ms. Marsh explained that the reimbursement is a City policy to compensate Council for the requirement to have internet to conduct City business.

Commissioner McKenzie stated that it appears the Madison Heights Council is compensated fairly; it is higher than some comparable communities and lower than others.

Commissioner Fortune-Heiligh stated that she was not comfortable with a complete freeze and that Council continues to provide a service for the community.

Motion by Fortune-Heiligh, seconded by Marentette, to increase the current Mayor, the Mayor Pro Tem and the Councilmembers' salaries by 1% per annum through January 1, 2023.

Re: Elected Officials Compensation Commission (EOCC) Meeting – Monday, December 4, 2023

Dear Commissioner:

As you know, the Commission is scheduled to hold a meeting on Monday, December 4, 2023 at 4:030 p.m. in the Executive Conference Room at City Hall. The purpose of this letter is to provide background information that has been requested by the Commission in the past.

Elected Officials Compensation Commission's Authority

Attached is a copy of Ordinance 454 that established the Commission's authority and responsibilities. As you can see, the Commission's authority is limited to the salary order only and does not extend to benefits or expenses.

Historical Information

On <u>December 5, 2001</u>, the Commission proposed a two-step increase of two percent (2%) on January 4, 2002 and two percent (2%) on January 4, 2003. As a result, the Mayor's annual compensation would have increased from \$8,687 to \$8,861 in 2002 and to \$9,038 in 2003; the Mayor Pro Tem's compensation would have increased from \$6,696 to \$6,830 in 2002 and to \$6,967 in 2003; and Council's compensation would have risen from \$6,086 to \$6,208 in 2002 and to \$6,332 in 2003. City Council rejected the Commission's Order on December 17, 2001.

On <u>November 13, 2003</u>, <u>November 16, 2005</u> and <u>November 14, 2007</u>, the Commission voted to leave compensation unchanged.

On November 24, 2009, the Commission voted to decrease the annual compensation of Mayor and Council by ten percent (10%) as follows: Mayor – from \$8,687 to \$7,818; Mayor Pro Tem – from \$6,696 to \$6,026; and Councilmembers – from \$6,086 to \$5,477. On December 14, 2009, Council voted to reject the Commission's Order by a vote of five to two.

On <u>January 14, 2010</u>, Mayor Swanson authorized a voluntary ten-percent (10%) deduction from his paycheck. In April of 2010, as the City Council was considering the FY 2010-11 Budget, a request was made of staff to facilitate a voluntary five-percent (5%) deduction from City Councilmembers' paychecks for calendar year 2010 and 2011.

On <u>June 27, 2011</u>, the City Council formally adopted the attached resolution recommending that the Mayor and each member of Council voluntarily donate ten-percent (10%) of their gross annual salary, until cancellation by subsequent City Council action, to the City's General Fund or in the name of a City Departments such as the Library, the Senior Center, the Parks and Recreation Department or another City Department.

On November 29, 2011 and December 17, 2013, the Commission voted to leave compensation unchanged. On December 12, 2011 and January 13, 2014, City Council voted to receive and file the Commission's respective orders, leaving compensation unchanged.

On <u>December 1, 2015</u>, the Commission voted to increase the annual compensation of Mayor and Council by two percent (2%) effective January 14, 2016, and one percent (1%) effective January 16, 2017. The resulting wage increases are as follows: Mayor – from \$8,687 to \$8,861, and from \$8,861 to \$8,950; Mayor Pro Tem – from \$6,696 to \$6,830 and from \$6,830 to \$6,898; and Councilmembers – from \$6,086 to \$6,208 and from \$6,208 to \$6,270. On <u>December 14, 2015</u>, Council first voted on a substitute motion to reject the salary order and then voted on an original motion to receive and file the salary order (which would have resulted in the salary order becoming effective). The substitute motion failed as the four to three votes in favor was insufficient to achieve the needed two-thirds supermajority of five votes. The original motion failed with three votes in favor and four against. Because both motions failed, no Council action was taken and the salary order became effective after thirty days. Attached are the 2015 Commission order and pertinent 2015 Council Meeting Minutes.

On November 28, 2017, the Commission voted to increase the annual compensation of Mayor, Mayor Pro Tem and Council by 2% effective January 8, 2018. The resulting wages increases are as follows: Mayor – from \$8,950 to \$9,129; Mayor Pro Tem from \$6,898 to \$7,036; and Councilmembers from \$6,270 to \$6,395.

On <u>December 2, 2019</u>, the Commission voted to increase the annual compensation of Mayor, Mayor Pro Tem and Council by 2% effective January 13, 2020 with an additional increase of 2% effective January 1, 2021. The resulting wage increases are as follows: Mayor from \$9,129 to \$9,498; Mayor Pro Tem from \$7,036 to \$7,321; and Councilmembers from \$6,395 to \$6,653.

On November 17, 2021, the Commission voted to freeze the annual compensation of Mayor, Mayor Pro Tem and Council at the January 2021 rates of Mayor \$9,498, Mayor Pro Tem at \$7,321 and City Council at \$6,653.

City Employees Wages/Benefits

During this period, the City employees have accepted a three-year contract through June 30, 2025, as follows:

1. Wages

- Effective July 1, 2022 3.00% wage increase
- Effective July 1, 2023 2.50% wage increase

• Effective July 1, 2024 – 2.25% wage increase

Survey Information

Attached is a spreadsheet of the 2023-24 Michigan Municipal League (MML) Salaries and Wages Report, representing the most recent MML survey data for Mayor and Council compensation.

Cost Information

At prior meetings, the Commission has requested the financial impact of any proposed salary change. Based on the current wages, each 1% increase or decrease in City Council (Mayor, Mayor Pro Tem and Councilmember) salary is attached. Also attached is information on inflation rates that has been requested in the past.

ARTICLE VII. COMPENSATION COMMISSION¹

Sec. 2-93. Creation; appointment and confirmation of members.

There is hereby created a commission to be known as the "compensation commission" to establish compensation for elected officials of the city. The commission shall consist of seven members who are registered electors of the city and shall be appointed by the mayor, subject to confirmation by a majority of the members elected and serving as the city council.

(Code 1958, § 2-211; Ord. No. 454, § 1, 4-24-72)

Sec. 2-94. Members' terms of office.

The term of office of each of the members of the compensation commission shall be for seven years except that of the members first appointed, one each shall be appointed for terms of 1, 2, 3, 4, 5, 6 and 7 years. Members shall be appointed before October first of the year of appointment.

(Code 1958, § 2-212; Ord. No. 454, § 1, 4-24-72)

Sec. 2-95. Vacancies; eligibility.

Vacancies on the compensation commission shall be filled for the remainder of the unexpired term. Any member or employee of the legislative, judicial or executive branch of the city or members of the immediate family of such member or employee shall be ineligible to be a member of the commission.

(Code 1958, § 2-213; Ord. No. 454, § 1, 4-24-72)

Sec. 2-96. Session days; quorum; action; compensation of members.

The compensation commission shall meet for not more than 15 session days in every odd numbered year and shall make its determination within 45 calendar days of its first meeting. The majority of the members of the commission shall constitute a quorum for conducting the business of the commission. The commission shall take no action or make no determination without a concurrence of the majority of members appointed and serving on the commission. The commission shall elect a chairman from among its members. "Session day" means any calendar day which the commission meets and a quorum is present. The members of the commission shall receive no compensation but shall be entitled to their actual and necessary expenses incurred in the performance of their duties.

(Code 1958, § 2-215; Ord. No. 454, § 1, 4-24-72)

Sec. 2-97. Determination of salaries of elected officials.

The compensation commission shall determine the salaries of elected officials in the city which determination shall be the salaries unless the mayor and council by resolution adopted by two-thirds of the members elected to and serving shall reject them. The determinations of the commission shall be effective 30 days following the filing with the city clerk of such determination unless rejected by the city council. In case of rejection the existing salary shall prevail. Any expense allowance or reimbursement paid to elected officials in addition to salary shall be for expenses, incurred in the course of city business and shall be accounted for to the city.

ORDER OF THE ELECTED OFFICIALS COMPENSATION COMMISSION

WHEREAS, the Elected Officials Compensation Commission met on Wednesday, November 17, 2021, at 4:30 p.m. in the Madison Heights Municipal Building, pursuant to Ordinance 454 of 1972 consisting of seven members; Commissioners present: Bessler, Brunke, Fortune-Heiligh, Geralds, Marentette, McKenzie, Wright.

WHEREAS, Ordinance No. 454 of 1972, Section 2-214 provides as follows:

"The Commission shall determine the salaries of elected officials in the City; which determination shall be the salaries unless the Mayor and Council by resolution adopted by 2/3rds of the members elected to and serving shall reject them. The determinations of the Commission shall be effective 30 days following the filing with the City Clerk of such determination unless rejected by the legislative body. In case of rejection, the existing salary shall prevail."

WHEREAS, after due consideration by the members of said Board, having been furnished with current salary statistics and after full and complete discussion of all pertinent matters, the recommended decision of the Commission is as follows:

RESOLVED, IT IS ORDERED, that the salary of the Mayor shall be frozen at \$9,498 for two years; and,

IT IS FURTHER RESOLVED, that the salary of the Mayor Pro Tem shall be frozen at \$7,321 for two years; and,

IT IS FURTHER RESOLVED, that the salary of the City Council members shall be frozen at \$6,653 for two years effective through January 1, 2023.
