INTRODUCTION TO OUR DOWNTOWN

The Downtown at a Glance

City Council created the Downtown Development Authority of Madison Heights (MHDDA) in 1997 to eliminate the cause of property value deterioration and to promote of economic growth.

The district includes 182 parcels across an area of 104 acres. Its boundaries of the DDA area are on John Rd at Gardenia to the North to 10 Mile Rd to its South, and on 11 Mile from Exit 62 on I-75 to the West and Lorenz to the East.

The district is presently zoned B-3 General Business District and M-1 Light Industrial and is home to approximately 110 businesses.

The MHDDA board includes downtown area business owners, residents, the Mayor and the City manager of Madison Heights.

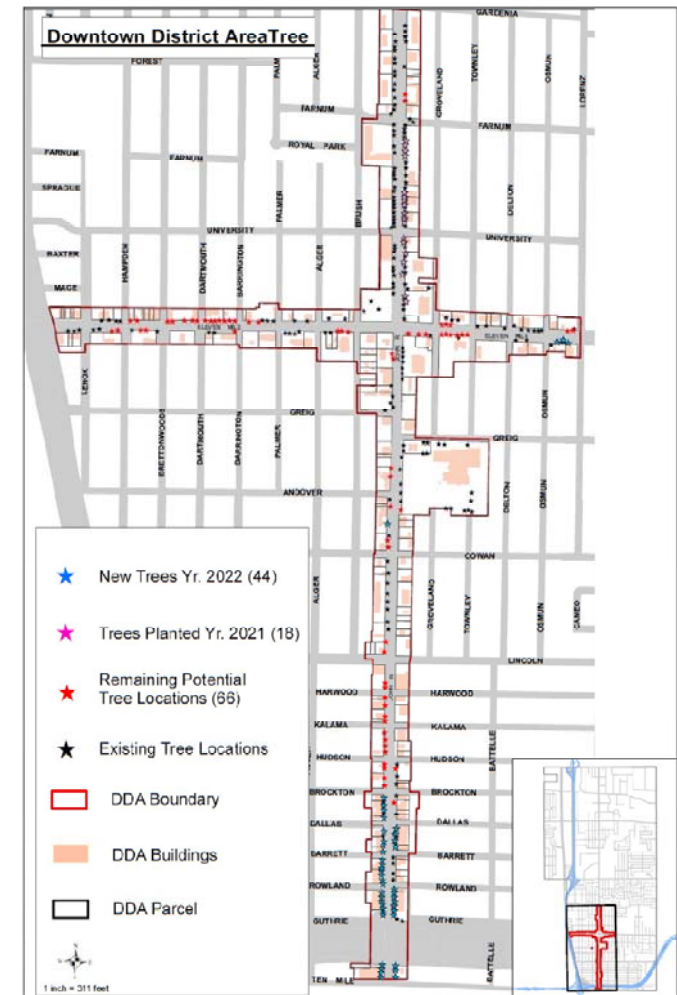

Downtown Area Tree Planting Program

The DDA and the City of Madison Heights was awarded an Oakstem grant from Oakland County. This grant enabled the Department of Public Service Dept. to plant 18 trees in 2021 and another 44 trees in 2022.

The DDA will continue contribute \$5000 per year towards tree planting until the remaining 66 remaining potential tree location are filled.



DDA Street Light Project

The DDA completed the streetlight painting for 106 posts. In addition, the DDA paid for the installation of 33 outlets on streetlights on 11 Mile Rd. The DDA received \$100o in grant funds from the Oakland County Main Street program.

Now that the project is complete, the DDA intends to put up Holiday decorations throughout the DDA area, and for the first time along 11 Mile Rd.

Diamond Jim's Façade Grant Project Complete

MHDDA board approved a \$5000 reimbursement grant for façade improvements to Diamond Jim's Jewelry store at 934 W 11 Mile Rd. This project was a part of an overall proposed \$53,000 in site improvements to the property.

The Supply House Sign Grant Approved

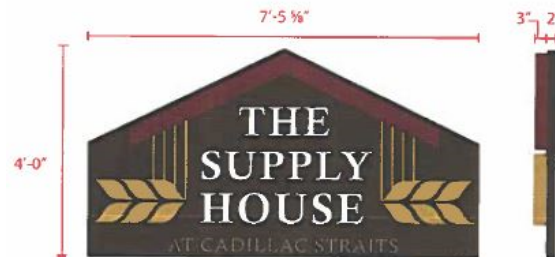

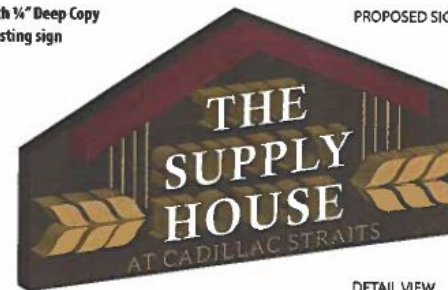

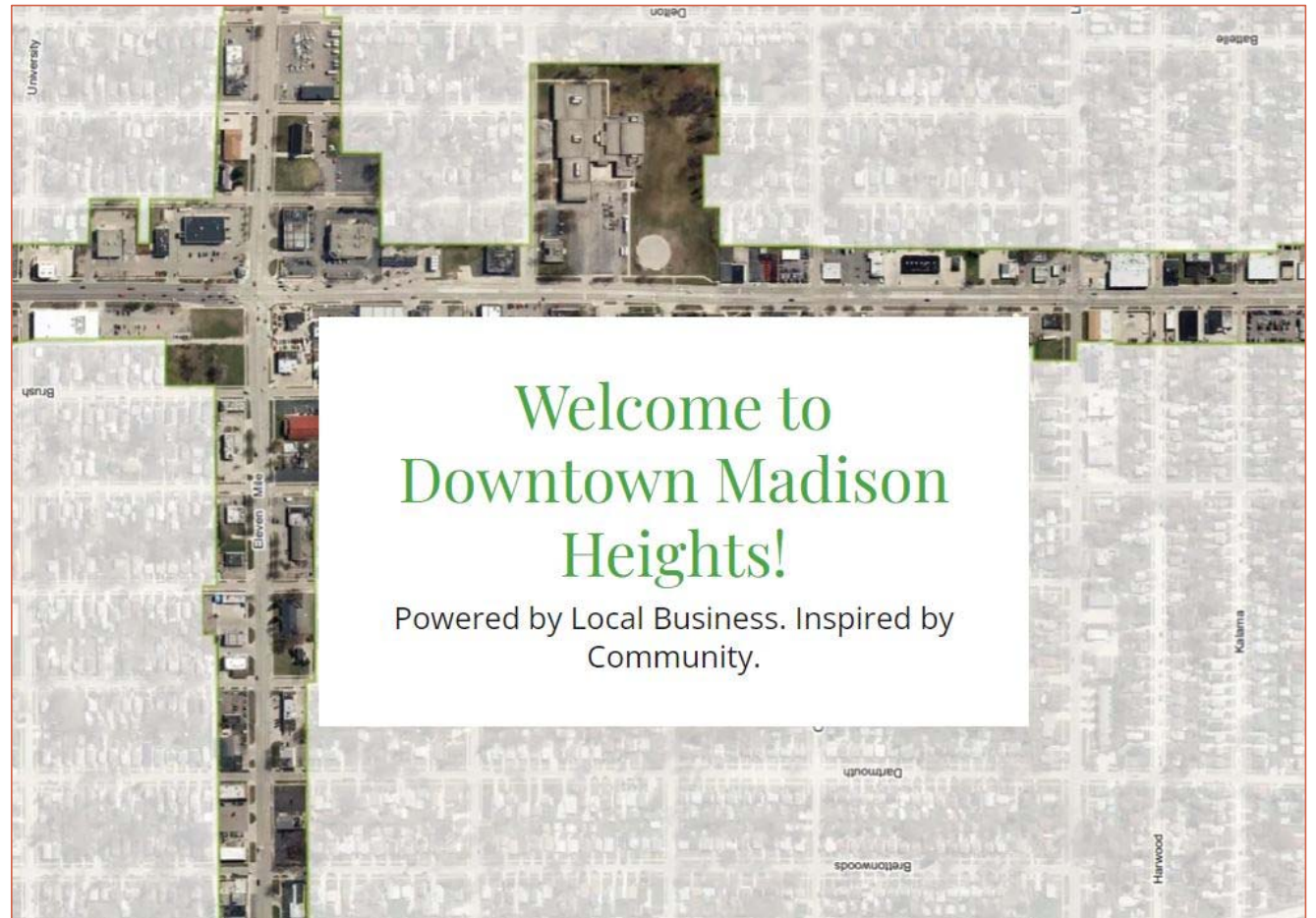

BANNER-TO-POLE PROPORTION SIZE UP YOUR BANNER

Illustrated below is an example of various light pole heights and styles with multiple banner dimensions. Work with our experienced sales staff to determine the correct banner size according to your pole height.



NOTE: Traffic clearance is a minimum of 14' from bottom of banner to ground where applicable.

The FY 22-23 DDA budget includes up to \$5000 for holiday decorations throughout the DDA from November to January. This project includes the decoration of the DDA clock tower and refurbishing and installing street light decorations throughout the DDA area.

Up to 50% of costs for eligible improvements ; 100% of
removal costs of blight removal. Max grant amount
\$10,000
