- Motor vehicle thefts on the rise.

King County Emergency Management - Nathan Bradshaw from Zone 1

- Role of King County Office of Emergency Management (KCOEM)
- WebEOC – used by Government agencies to request resources from KCOEM
- Explanation of hazards faced by KCOEM
- Emergency management notification systems (i.e., “Code Red”)
- Zone 1 Coordinator is liaison for procuring non-emergency resources

A Day in the Life of a First Responder - Interim Chief J. Sass

- Extensive law enforcement training
- Cannot plan for every individual event, but law enforcement follows a national framework that allows first responders to prepare for any foreseeable event
- National Incident Management System (NIMS) & Incident Command System (ICS) overview
- Skagit River Bridge Collapse – ICS crucial to success
- Communication is key – media will not always be able to report everything emergency responders push out to citizens
- Community residents need to sign up for all methods of communication offered by local government (i.e., GovDelivery publications, Medina E-Lert, Twitter, Facebook, etc.)
