#### **MEMORANDUM**

RE: Periodic Update to the Comprehensive Plan Overview

The Medina City Council, Planning Commission, Park Board, Staff and Consultants will work toward having a complete draft of the updated Comprehensive Plan available for public comment by the beginning of June 2024. The process will proceed in a streamlined way, due to the limited window of time left to complete this mandatory update of the Comp Plan. After initial review by the Planning Manager and the consultants, the Council will be informed at its meeting that a draft element will be reviewed by the Planning Commission (PC) at its next meeting. The Council may give direction at that time. Once an element has been reviewed by the PC at its meeting, recommended changes will be made and it will be sent to PSRC and the Department of Commerce for review for consistency with the required Comprehensive Plan Update guidelines.

This streamlined process should provide enough time, in Summer 2024, for the mandatory regulatory reviews (PSRC review, SEPA, 60-day notice to the Department of Commerce) to occur. This will ensure that the public will have ample opportunity to view and comment on the entire document, as well.

These efforts should result in the City reaching its goal of adopting the Comp Plan at the October 14, 2024, Medina City Council Meeting. This plan to adopt it prior to the December 31<sup>st</sup>, 2024, deadline will build in a nearly 2-month buffer that we can utilize and remain compliant.



Subject: Review of 2023 Goals and Priorities and Priorities with Results

On Monday, October 24th, 2022, the Medina City Council held a retreat to discuss 2022/2023 Goals and Priorities.

Council identified six City priorities:

- 1. Financial Stability and Accountability
- 2. Quality Infrastructure
- 3. Efficient and Effective Government
- 4. Public Safety and Health
- 5. Neighborhood Character

The City Council identified six goals for staff to work on in 2023. Below are the goals with results.

- Create a clear timeline and protocols for Council projects to include no new code without an enforcement plan.
  - The Medina Council approved the final draft at the December 11, 2023, Medina Council Meeting.
- Strategy for creative revenue sources, relook at fine structure and compare or calibrate with other cities.
  - Development Services Director Steve Wilcox provided an update to the City Council on February 27, 2023 covering short-term and long-term budget outlook and stabilization for Development Services.
- Implement a full HR system that covers employee lifecycle.
  - Finance/HR Director Ryan Wagner is working with vendor ADP on the draft Human Resource Manual. The manual will ensure the City is meeting all HR requirements. City staff is reviewing the initial draft and will be bringing the manual to Council in the beginning of 2024.
- Add each department's business lines and service levels on the website.

- In the first week of June, Central Services Director Aimee Kellerman, working with staff, has included business lines and service levels on the city website – under "Know Your Government" - Check Out Your Local Government and the Services We Provide | Medina Washington (medina-wa.gov).
- o Research and develop a plan for undergrounding utilities; and
  - Public Works Director Ryan Osada provided an update to the Council at the April 24, 2023 City Council Meeting.
- Research available options for reducing ghost homes.
  - Former City Attorney Scott Missall presented a report to the Council at the October 23, 2023, Council Meeting. Medina City Council members will continue to individually research ways to address this issue.

  - Street Vacation Code Update City Manager/City Attorney
- Development Services
  - Tree Management Code Amendments: Short-term Solutions as recommended by city arborist (Development Services):
    - Remove "Supplemental trees in excess of those needed to meet the minimum required tree units shall not be required."
    - Require species that can attain similar canopy size to trees being removed.
    - Expand "List of Suitable Trees" to allow select desiduous non-native species.
    - Tree preservation plan shall include a report by a qualified professional that identifies compliance with code objectives.
    - Increase minimum replacement trees to account for attrition.
    - Legacy and Landmark trees: Removes "the risk of the tree declining or becoming a nuisance is unenhanced by any proposed development."

#### Department Work Projects for 2024:

- Public Works
  - NE 12<sup>th</sup> Street Pedestrian Improvements 3-month project with utility and resident coordination – anticipated start date in March and concluding by July.
  - Medina Park Pond Dredging 3-month project with major park & community impact. Permitting and contractor coordination – anticipated to start in July and end by October.
  - Stormwater Permit Compliance all year, private storm inspection, CB inspections, sweeping, line jetting, IDDE, & reporting – this is an ongoing requirement.
- Police Department
  - The Comprehensive Emergency Management Plan (CEMP) update updated every five years and provides a framework for how the City of Medina would coordinate with other local, county, and state agencies in the event of an emergency. The Police Department will be updating the CEMP throughout 2024 and will submit the updated plan to the Emergency Management Division of the Washington State Military Department once completed. Expected to be completed by the end of the year.
- Development Services
  - Comprehensive Plan Update significant project led by our Planning Manager and city volunteers.
  - Middle Housing Legislation significant project led by our Planning Manager and city volunteers.
  - Balancing Professional Services Costs in 2024 a review of the methods of ensuring consultants' costs are fully reimbursed as a policy

- decision enacted by a potential code amendment and administrative process is needed. Building and planning permit fees will be reviewed for possible discussion in 2025.
- Development Code Text Amendments several code amendments in 2024. A few examples of potential revisions for 2024 and into 2025:
- Revised code enforcement chapter which will include new processes and new fines.
- o Construction Activity Permit
- Exterior lighting as a nuisance.
- Building code inconsistencies.
- Tree Management Code. Update the 'tree code' as possible now for improvements known to be needed. This is the beginning of an eventual review of the tree code by the Planning Commission.

#### Central Services

- Laserfiche/Records Management Project
  - In process of testing Central Services folder structure and moving documents into Laserfiche repository – anticipated completion of CS records and testing – end of March 2024
  - Build public portal for city records end of April 2024
  - Test and import records in Finance folder structure end of April 2024
  - Build folder structure for PD, PW, and DS by 4<sup>th</sup> quarter 2024
- Public Storage
  - CS staff is currently reviewing records retention of paper records and dispositioning records as required by State Archives Retention Schedule. We are looking to store records onsite and get rid of or reduce Public Storage again to a small unit.
