# **STAFF REPORT**

Sarah Bluvas, Economic Development Coordinator for the City, updated members on a new mural at the Boyd Collection in Mercer Island Town Center; fire damage at the Aubrey Davis Park picnic shelter; the annual Americans for the Arts (AFTA) Convention; and new City communications tools and upcoming meetings.

2. Arts Reset Planning: 2022 Work Plan + Budget Input

Ryan Daly, Operations Transition Team Manager, and Emily Moon, reset planning consultant, updated the board on the reset plan timeline and process as well as sought feedback for incorporating a placeholder request in preparation for the July 6 City Council reset plan presentation.

3. Arts Immediate Action Plan: Reset Committee Updates

Committee members and staff provided updates on Mostly Music in the Park, the Mercer Island Gallery, the Community Arts Project, and long-term planning proress.

4. 2021 Officer Positions and Board Recruitment

Bluvas discussed the status of board recruitment and current officer positions as well as for input on Ordinance No. 21C-13 addressing term limits and board size going to City Council on June 15, 2021. The board gave feedback on the ordinance to Councilmember Nice and also shared ideas for returning to being fully operational, including strengthening Arts Council committees, adding a youth board member or liaison position, and rebuilding partnerships with local arts and other community organizations.
