REGULAR BUSINESS

AB 6960: GMA Compliance – Comprehensive Plan Amendments (First Reading, Ord. No. 26-09)

CPD Director Jeff Thomas introduced the staff team of CPD Deputy Director Alison Van Gorp, and Principal Planner Adam Zack who presented background information on the Growth Management Hearings Board (GMHB) appeal of the updated Comprehensive Plan that was adopted in 2024. He spoke about the four issues addressed in the GMHB Order including land capacity, adequate provisions, the station subarea plan, and anti-displacement measures and the compliance deadline of July 31, 2026. Principal Planner Zack spoke about the Planning Commission process and recommendation and updates to the Comprehensive Plan and zoning and development code amendments for compliance with the GMHB Order. He also discussed the Comprehensive Plan GMA Compliance Let's Talk page that has all relevant documents posted.

Principal Planner Zack provided a summary of the updates to the Comprehensive Plan and the Station Subarea Plan contained in Ordinance No. 26-09. He noted that the City will work on Phase 2 of the Station Subarea Plan through 2029 to allow for more public input.

AB 6961: GMA Compliance – Title 19 MICC Amendments (First Reading, Ord. No. 26C-10)

Principal Planner Adam Zack provided an overview of the zoning and development code amendments in Ordinance NO. 26C-10. He spoke about comments received from the WA Department of Commerce that recommend one change to the definition of transitional housing so that it is grouped with permanent supportive housing and spoke about next steps.

Direct staff to amend the development code to group transitional and permanent supportive housing together to address the comments provided by the Department of Commerce in the June 23, 2026 letter to the City of Mercer Island.
