WHEREAS, in 1998, the voters of the Township of Middletown (the "**Township**") approved the creation and funding of the Middletown Open Space Trust Fund, pursuant to N.J.S.A. 40:12-15.7 et seq., with a collection rate of one cent per \$100 of equalized valuation; and

WHEREAS, in 2002, the voters of the Township supported an increase in the collection rate by one cent to two cents per \$100 of equalized valuation; and

WHEREAS, in 2020, the voters of the Township supported an increase in the collection rate by one cent to three cents per \$100 of equalized valuation pursuant to a ballot question authorized by Resolution No. 20-173 adopted on July 20, 2020; and

WHEREAS, the Township desires to ask voters to consider an increase in the collection rate for the Middletown Open Space Trust Fund by one cent to four cents per \$100 of equalized valuation through a proposition question on this November's General Election ballot; and

WHEREAS, the Township is authorized to submit to voters a proposition to amend the rate of the annual levy for the Middletown Open Space Trust Fund, pursuant to N.J.S.A. 40:12-15.7(d); and

WHEREAS, if approved by voters, the Township shall thereafter hold a public hearing in order to determine the allocation of the increased proceeds to the Middletown Open Space Trust Fund, in accordance with N.J.S.A. 40:12-15.7(a) and (b); and

WHEREAS, pursuant to N.J.S.A. 40:12-15.7(c), a municipality's Open Space Trust Fund shall be formally named the "Municipal Open Space, Recreation, Floodplain Protection, and Farmland and Historic Preservation Trust Fund."

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey, as follows:

- 1. The Middletown Open Space Trust Fund established by the voters of Middletown in 1998 shall hereafter be referred to as the Middletown Open Space, Recreation, Floodplain Protection, and Farmland and Historic Preservation Trust Fund.
- 2. The Township hereby requests that the County Clerk print upon the official General Election Ballot of the next General Election, to be held on November 5, 2024, the following proposition question:

Should Middletown increase the levy for the existing Middletown Open Space, Recreation, Floodplain Protection, and Farmland and Historic Preservation Trust Fund, from the currently approved and implemented annual levy of three cents per \$100 of equalized valuation to four cents per \$100 of equalized valuation, pursuant to N.J.S.A. 40:12-15.7(a), to fund additional acquisitions and improvements to open space and parkland properties.

3. The Township further requests to print on said General Election Ballot, the following explanatory statement of the proposition question presented:

In 1998, Middletown voters approved the establishment of a Township Open Space Trust Fund, with a dedicated tax levy of one cent per \$100 of equalized valuation. In 2002, voters approved an increase in the collection rate to two cents per \$100 in equalized valuation. In 2020, voters approved an increase in the collection to three cents per \$100 in equalized valuation. This referendum seeks voter approval for an increase in the dedicated tax levy by one cent to four cents per \$100 in equalized valuation. The increase will fund additional acquisitions and improvements to open space and parkland properties.

- 4. The Township Clerk is hereby authorized and directed to forward a certified true copy of this resolution to the County Clerk.
 - 5. This Resolution shall become effective immediately upon adoption.

He mentioned that he attended the 250 Event Stories Around the Campfire with the Lenape Tribes. He also welcomed Bagel Nook to Town run by a great family from Old Bridge who make 5,000 bagels a week.

PUBLIC COMMENTS:

Melanie Elmiger, 43 Green Tree Terrace, wanted to thank Ted Maloney for taking a walk to see first hand the missing road signs. She discussed the issues in town. She announced the 25th Anniversary of the Lincroft Village Green Association which was started by a group of concerned neighbors who got together to oppose development. She invited all to come out for the celebration on September 7th and enjoy music and cornhole.

Don Watson, 1 Collinson Drive, also commented on signs he said his street once had a No Parking from Here to the Corner which is gone and now township vehicles park in that spot. He also commented on the racing that has been going on for years in Belford, East Road and the Navy Road. He also inquired how much the open space tax would be due to Resolution 24-229.
