WHEREAS, the Township Committee originally contracted with Mixalia Enterprises for the Dog Park at Tindall Park in the amount of \$532,000.00; and

WHEREAS, the contractor and Township have encountered unforeseen circumstances requiring the change order as proposed; and

WHEREAS, the Township requires additional estimated quantities as listed on Change Order No. 5 increasing the contract by \$20,690.00, making the total amount of the contract to date \$690,312.45; and

WHEREAS, the amount of the change orders requested is a total net increase of \$158,312.45, which represents in total more than the aggregate maximum increase of 20% allowed by N.J.A.C 5:34-11-3(a)(9); and

WHEREAS, Colliers Engineering & Design (CED) has provided a statement per N.J.A.C. 5:30-11.9 indicating that Change Order No. 5 is required due to drainage issues; and

WHEREAS, CED also recommends the retention of the current contractor as they already have knowledge of the site conditions; and

WHEREAS, the Chief Financial Officer for the Township of Middletown has certified that free and unencumbered funds in the amount of \$20,690.00 are available for this purpose in account/line-item number(s) T-03-56-802-120-004. A copy of the said certification is attached hereto and made part hereof.

THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown that an amendatory contract for Change Order No. 5, with an increase in the amount of \$20,690.00, be authorized and executed by the appropriate officials.

<u>Resolution 24-179</u> - Resolution Authorizing Change Order No. 1 For Professional Engineering Services – 2024 Master Plan Update

WHEREAS, the Township Committee awarded a contract to Buckhurst, Fish, & Jacquemart, Inc. (BFJ) for engineering consulting services for the 2024 Master Plan Update in the amount not to exceed \$155,000.00; and

WHEREAS, the Township requires additional funds as listed on Change Order No. 1 to add the Municipal Stormwater Management Study to the Master Plan, increasing the contract by \$25,000.00, making the total not to exceed amount of the contract \$180,000.00 and;

WHEREAS, the Township may without advertising for bids, purchase any materials, supplies or equipment entered into on behalf of the Educational Services Commission of New Jersey Cooperative Purchasing System (Co-Op #65MCESCCPS) pursuant to the provision of N.J.S.A. 40A:11-11: and

WHEREAS, Nielsen Ford, 170 Ridgedale Ave, Morristown NJ 07960 has been awarded the ESCNJ Contract 23/24-11 for electric truck chassis class 5-8 and

WHEREAS, under Contract 23/24-11, **Neilsen Ford**, can provide (4) Four 2024 Ford Escape (U9G) vehicles as noted in their quote dated 5/21/24; and

WHEREAS, the Chief Financial Officer for the Township of Middletown has certified that free and unencumbered funds in the amount of \$120,083.29 are available for this purpose in account/line-item number(s) 4-01-26-315-100-205. A copy of the said certification is attached hereto and made part hereof.

THEREFORE, BE IT RESOLVED, by the Township Committee of the Township of Middletown, County of Monmouth, State of New Jersey that the Township of Middletown enter into an agreement with Neilsen Ford for the delivery of (4) four 2024 Ford Escape (U9G) AWD Vehicles in the amount of \$120,083.29.

<u>Resolution 24-181</u> - A Resolution of The Township of Middletown Authorizing the Sale of Surplus Personal Property No Longer Needed for Public Use on An Online Auction Website

WHEREAS, the Township of Middletown has determined that the compost pile located at the compost site is no longer needed for public use; and

WHEREAS, the Department of Public Works has provided an estimated fair market value for the remainder of the compost, and

WHEREAS, the Purchasing Agent recommends the award of the contract to USGovBid (Auction Liquidation Services), located at <u>USGovBid.com</u>, as they provided the lowest rate for the requested service.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown, County of Monmouth, State of New Jersey as follows:

<u>Resolution 24-182</u> - Resolution Authorizing Renewal of Lease Agreement with County for Belford Leaf Compost Site

WHEREAS, the County of Monmouth (the "County") owns property located at Block 306, Lot 66 (the "Property") in the Belford section of the Township of Middletown (the "Township"); and

WHEREAS, the Township has for many years used a portion of the Property for leaf composting (the "Compost Site"); and

WHEREAS, the County has consented to such use in the past and had previously entered into a formal agreement with the Township governing the rights and responsibilities of the County and the Township regarding the uses of the Compost Site; and

WHEREAS, the latest agreement between the parties expires on August 31, 2024, and it remains in the interests of the County and the Township to continue the existing relationship with regards to the Compost Site.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that it hereby authorizes and directs the Mayor to execute a new Lease Agreement pursuant to the terms and conditions contained herein as **Exhibit A** for a new term extending through August 31, 2029.

Resolution 24-183 - Resolution Authorizing Shared Services Agreement with The Borough of Keyport for Municipal Court Services

WHEREAS, the "Uniformed Shared Services and Consolidation Act," <u>N.J.S.A.</u> 40A:65-1, et seq. (the "**Act**"), authorizes local governments to enter contracts with other local governments for the joint provision of municipal services which any party to the agreement is empowered to render within its own jurisdiction; and

WHEREAS, N.J.S.A. 2B:12-1(c) allows two or more municipalities to share courtrooms, chambers, equipment, supplies and employees for their municipal courts without establishing a joint municipal court; and

WHEREAS, the Township of Middletown ("Middletown") and the Borough of Keyport ("Keyport") desire to share facilities, equipment and court staff, in accordance with

- N.J.S.A. 2B:12-1(c), in order to conserve resources and to provide for a more efficient and economically sound municipal court system; and
- WHEREAS, at this time Middletown and Keyport desire to maintain their right to appoint their own judge, prosecutor and public defender at their own expense; and
- **WHEREAS**, pursuant to the Shared Services Agreement to be entered, Keyport shall pay Middletown \$147,000 annually, plus an additional day rate for special court sessions.
- **NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that it hereby authorizes and directs the Mayor to enter into a new Shared Services Agreement with Keyport for the provision of municipal court services pursuant to the terms and conditions of a Shared Services Agreement included herewith as **Exhibit A**.
- **BE IT FURTHER RESOLVED** that the Municipal Clerk shall transmit a copy of this Resolution and the executed Shared Services Agreement to the Division of Local Government Services at the New Jersey Department of Community Affairs for informational purposes pursuant to N.J.S.A. 40A:65-4b.
- <u>Resolution 24-184</u> Resolution Designating Avalon Middletown Urban Renewal, LLC As Redeveloper of a Portion of Block 1131, Lots 31 And 32 Within the River Centre South Redevelopment Plan Area and Authorizing Entry of Redevelopment Agreement
- **WHEREAS**, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1, et seq., as amended and supplemented ("LRHL"), provides a process for municipalities to participate in the redevelopment and improvement of areas in need of redevelopment; and
- **WHEREAS**, the governing body of the Township of Middletown (the "**Township**") serves as an instrumentality and agency of the Township pursuant to the LRHL for the purpose of implementing redevelopment plans and carrying out redevelopment projects within the Township (the "**Redevelopment Entity**"); and
- **WHEREAS, N.J.S.A.** 40A:12A-8 authorizes the Township to enter into contracts or agreements for the planning, construction or undertaking of any development project or redevelopment work in an area in need of redevelopment; and
- **WHEREAS,** on February 7, 2022, pursuant to Resolution No. 22-75, the Township directed the Planning Board to conduct a preliminary investigation to determine whether Block 1086, Lots 29 and 30; Block 1089, Lots 1 and 2; and Block 1131, Lots 30, 31, and 32 (the "**Area of Investigation**") is an area in need of redevelopment for non-condemnation purposes according to the criteria set forth in N.J.S.A. 40A:12A-5; and
- **WHEREAS**, on May 4, 2022, the Planning Board held a properly noticed public hearing at which the planner presented the findings of his preliminary investigation report

resulting in a determination to recommend that Block 1086, Lots 29 and 30; and Block 1131, Lots 30, 31, and 32 be designated as an area in need of redevelopment; and

WHEREAS, on May 16, 2022, pursuant to Resolution No. 22-153, the Township determined that Block 1086, Lots 29 and 30; and Block 1131, Lots 30, 31, and 32 (the "**Redevelopment Area**") is an area in need of redevelopment for non-condemnation purposes under the LRHL; and

WHEREAS, on November 20, 2023, pursuant to Ordinance No. 2023-3396, the Township adopted the River Centre South Redevelopment Plan for Block 1131, Lots 30, 31, and 32 (the "**Redevelopment Plan**"); and

WHEREAS, the property subject to this Redevelopment Agreement consists of portions of Block 1131, Lots 31 and 32 that will be subdivided and merged (the "**Project Site**"); and

WHEREAS, consistent with the Redevelopment Plan the Redeveloper intends to redevelop the Project Site into one apartment building comprising 340 residential apartment units including inclusionary and supportive affordable housing units with associated parking and amenities (the "**Project**"); and

WHEREAS, on or about December 5, 2023, Avalon Middletown Urban Renewal, LLC (the "**Redeveloper**") filed an application to be designated the redeveloper of the Project Site and to seek a long-term tax exemption with the Township that is still under consideration (the "**Application**"); and

WHEREAS, the Township recognizes the credentials, experience and financial capability of the Redeveloper to design and construct the Project; and

WHEREAS, pursuant to N.J.S.A. 40A:12A-9, the Township wishes to formally designate the Redeveloper as the redeveloper of the Project Site and enter into a Redevelopment Agreement with the Redeveloper, which shall further define and memorialize the respective obligations of the parties with regard to proceeding with the redevelopment of the Project Site.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey, as follows:

- 1. The foregoing recitals are hereby incorporated as if set forth at length.
- 2. The terms and conditions contained in the Redevelopment Agreement by and between the Township and Redeveloper are hereby accepted and approved.
- 3. The Mayor is hereby authorized and directed to execute the Redevelopment Agreement, substantially in the form attached hereto and made part hereof, immediately upon adoption of this Resolution by the Township Committee.

- 4. Upon the adoption of this Resolution and the Redeveloper's execution of the Redevelopment Agreement, the Redeveloper shall be deemed the Redeveloper of the applicable portions of Block 1131, Lots 31 and 32 as will be subdivided and merged for all purposes under the LRHL.
- 5. All prior resolutions, or parts thereof, that are inconsistent with this Resolution are repealed to the extent of such inconsistency.
- 6. This Resolution shall become effective immediately pursuant to law.

Resolution 24-185 – Resolution Authorizing the Payment of Bills for June 10, 2024

PUBLIC COMMENTS:

Melanie Elmiger, 43 Greentree Terrace, expressed her concern regarding the number of serious accidents and speeding along Route 520. She requested the Township reinstate the Route 520 Task Force that was in place years ago. She also asked the Mayor to speak with the County Engineers and review accident reports. Mayor Perry responded that he would speak to Director Arnone.
