WHEREAS, pursuant the New Jersey Constitution (the "<u>State Constitution</u>"), the New Jersey Council on Local Mandates (the "<u>Council</u>") is charged with determining whether any statute, rule or regulation constitutes an "unfunded mandate" in violation of Article VIII, § 2, ¶ 5 of the State Constitution and <u>N.J.S.A.</u> 52:13H-2 imposed against a local government entity; and

**WHEREAS**, since the enactment of the bail reform law in January 2017, motor vehicle thefts and associated crimes in Monmouth County have increased by 40% with more than one-third of those being arrested and released committing the same crime again; and

**WHEREAS**, the Township of Middletown (the "<u>Township</u>") has been forced to increase police patrols and significantly increase expenditures to combat the surge in auto thefts and associated crimes that statistically correlates with the enactment of the bail reform law; and

WHEREAS, since the bail reform was enacted, the Township's taxpayers have been forced to cover hundreds of thousands of dollars of unfunded costs associated with combating and investigating auto thefts and associated crimes on an annually reoccurring basis; and

**WHEREAS,** the bail reform law, therefore, violates <u>N.J.S.A.</u> 52:13H-2 because the State has "not authorize[d] resources to offset the additional direct expenditures required for the implementation of the law . . ."; and

**WHEREAS,** under the State Constitution, the Council is empowered to act to eliminate such unfunded mandates imposed upon municipal governments by the State.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that it hereby authorizes and directs the Township Attorney to file a Complaint with the Council to address the above-recited unfunded mandate that the bail reform law has imposed upon municipal governments.

WHEREAS, the Township and Jeffrey Paris and Linda Paris (the "<u>Owners</u>") entered into an Affordable Housing Agreement, Declaration of Covenants, Conditions and Restrictions of Accessory Apartments (the "<u>Agreement</u>") dated May 11, 2012, effective November 1, 2012 (the "<u>Effective Date</u>"), relating to certain real property located at Block 178, Lot 2 on the official tax map of the Township of Middletown, County of Monmouth, and more commonly known as 25 Nevada Avenue (the "<u>Property</u>") owned by the Owners; and

WHEREAS, the Agreement was recorded in the Office of the Monmouth County Clerk on October 25, 2012 in Deed Book: OR-8978 at Page 2087&c against the Property; and

**WHEREAS**, pursuant to the Agreement, the Owners were restricted to rent the accessory apartment (the "<u>Accessory Apartment</u>") situated on the Property to certified modified income households only in order to maintain the affordability controls for a period of no less than ten (10) years from the Effective Date; and

WHEREAS, pursuant to Agreement, the affordability controls, covenants and restrictions set forth in the Agreement (the "<u>Restrictions</u>") expired on November 1, 2022 (the "<u>Expiration Date</u>"); and

**WHEREAS,** the Expiration Date has passed, and the Owners have requested that the Restrictions be discharged and released from the Property's title; and

**WHEREAS,** it is the recommendation of the Township's Director of Planning and Township Administrator to release the Restrictions on the Property by executing a Quit Claim Deed Releasing Ownership Unit from Affordability Controls attached hereto as <u>Exhibit A</u> as the Owner is not required to and/or was not willing to renew the Property's affordability controls.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that the

Township's Administrative Agent is hereby authorized in accordance with N.J.A.C. 5:80-26.5(i) to take all necessary actions required to release the affordable housing restrictions on the Property.
