I also want to extend a special thanks to the Deputy Mayor, as he and I have now served as Mayor and Deputy Mayor together for four consecutive years. Last year, when Travel and Leisure magazine named Middletown as one of the top 10 best places to live, I shared the same excitement with many of you, yet I was not surprised. Our collective and tireless efforts have been dedicated to making Middletown an exemplary place to live and raise a family. I see it everyday in the conversations I have, the phone calls I receive and the spirit that exists here in town.

But this is not just a credit to the Township Committee alone. It's a testament to our countless volunteers, to those who work tirelessly advocating for our students, and to every individual who does the small things that quietly transform Middletown into that shining city on a hill. I'll never be able to thank all of you enough for your service, sacrifices, and commitment to making our town the envy not only of New Jersey but of our entire nation.

While many of our departments had already moved into Town Hall by this time last year, several others were in the midst of relocating. But last summer, on what was undoubtedly one of the hottest days of the year, thousands of residents braved the heat to join friends and neighbors in a community gathering to unveil this beautiful building. That event was perfectly described by the media as 'A Night in Middletown, but Morning in America.'

Because it described a moment where Middletown's residents, our small businesses, sports teams, lifelong residents, and new neighbors came together, celebrating the best of our town and adding yet another chapter into Middletown's history.

For most of us, history is both shared and personal. It is made, nurtured, and preserved here in Middletown. And in this year as we reach 360 years since our founding – a history stretching back to the days of Sachem Pompora, Richard Hartshorne, and Leni Lenape tribes – we continue to make history while never neglecting our solemn duty to celebrate it. This year promises to be no different.

In April, Middletown will proudly welcome the USS New Jersey, a Block IV Virginia-class submarine. This vessel, the third United States Navy ship to be named in honor of the state of New Jersey, will be commissioned at the historic Naval Weapons Station Pier right here in Middletown. This event not only celebrates the strength and prestige of our military but also offers an opportunity for Middletown to open its doors to people from across the county – and once again the eyes of the nation will be on Middletown as we celebrate this unforgettable moment in our history. I hope all of you will join me, my family, and our neighbors in experiencing this extraordinary Middletown moment.

Last year, the Township Committee continued to deliver on its promise to preserve open space and protect our historically significant properties. We are now preparing to fully restore the Murray Farmhouse, a local landmark located at Poricy Park. This governing body has now authorized \$350,000 in capital and grant funds for this restoration. This project preserves a window into Middletown's rich Revolutionary history. It not only highlights the early stages of our country's development but it also commemorates Joseph Murray's legacy of rebellion against tyranny.

As one of New Jersey's original towns, we are thrilled to announce that Middletown will once again play a pivotal role in the American epic with the formation of our America 250 Committee. This venture, celebrating America's 250th anniversary in 2026, is a remarkable opportunity. And we look forward to collaborating with the Monmouth County Commissioners and County Clerk, to honor our County and town's significant contributions to the American Revolution and acknowledge the enduring impact of our people on the nation's past, present, and future.

We have continued our efforts to protect properties throughout the township from development and destruction. While our success and capabilities of preserving land has dramatically improved since our open space referendum in 2020, this fight is far from over but our commitment will never waver.

We are also actively challenging Trenton's hypocritical stance on housing mandates, which unfortunately incentivizes the destruction of undeveloped and environmentally sensitive land. While this struggle is not unique to Middletown, we are once again prepared to lead the charge for change – a change not just for Middletown but also for the state of New Jersey, and a fight we are willing to take all the way to the New Jersey Supreme Court if we have to.

As I look back on my years serving this town I have experienced many truly 'Middletown Moments' that will forever remain with me.

One event stands out distinctly: a naturalization ceremony in the shadow of the Sandy Hook Lighthouse last September. Being there with 40 individuals from 23 different nations, patiently – and some nervously – waiting to recite the oath of allegiance as they became new citizens, was profoundly moving.

As I looked out at them I reflected on the essence of the American identity. This question, often posed to middle school history classes, took on a new significance for me. Perhaps it's a realization that emerges over time, but I've come to understand that words, ceremonies, and the very pomp and circumstance of such events are saturated with deep meaning. The genesis of the American experiment, born from the ashes of our revolution, was a watershed moment in human history. Much like the experiences of these 40 new Americans out on Sandy Hook, there is a life before and a dramatically altered life after embracing America.

For many of these families, my responsibility as Mayor is to steadfastly uphold the solemn duty that defines us as Americans: to ensure that not only their liberties are protected, but also that their hopes and dreams are realized through an honest and accountable government. This commitment empowers individuals to achieve limitless heights of human progress, embodying the true spirit of American potential.

But during this reflection, I reached the age-old question we all eventually face: what America are we leaving behind for our children?

Because beyond the title of Mayor, "husband" and "father" are ones that drive me to serve. Building a family is one I get to do with my incredible wife, Alannah right here in Middletown. I thank her for her patience, her sacrifice, and her love – as being in the public eye is the undertaking of a family, one that she has met with grace and dignity. Everyday I am reminded why I chose to serve and it is for Reagan, Grant and Kennedy. Those three amazing little kids who have literally grown up here in Town Hall.

But I pose the same questions to you all: *what does it mean to be American? What are we leaving to future generations?*

I'm willing to bet you reach the same answer that I did, because the answer is – quite literally–right here with us.

We have often heard that leaving a place better than you found it is the ultimate success of any public servant. I've spoken much about our history, but Middletown is no stranger to being front and center. When we were met with one of America's darkest days in September 2001, the light of our community overpowered the grief and agony that came to Middletown.

When Superstorm Sandy came years later, we did what came natural to Middletown: we supported and uplifted our neighbors despite our own personal losses.

Now, I inherited this history when I became Mayor, and thanks to the leaders before me and their wisdom, I made sure that my legacy would be to leave Middletown better than I found it, and I knew that it would not be possible without leaning on the storied strength of our community.

Then came March of 2020. It was now my turn as Mayor to navigate this third event horizon in our history. Middletown, once again, answered the call and we led. We lead the way despite the seemingly endless punches thrown at us.

We have witnessed our strength, our resilience, our fortitude – I think America can take a page or two out of Middletown's history.

Because we watched what happened in our schools and how our children were pawns in political gamesmanship and we took action.

It's easy to say that you're for preserving history and our environment yet never yield to those who make overdevelopment their religion.

It's easy to say you'll head to Washington or Trenton to fight, but when politicians spend years, sometimes decades in office, and not deliver results for our communities, we the people need to tell those who are not willing to fight to hang up their gloves and put someone in who can take on the punches of the world and deliver them right back.

Here in Middletown, the spirit of America has been thriving for 360 years, and it continues to flourish. As I contemplate the legacy we will leave for future generations, I am filled with confidence. Because Middletown is poised to be a model of American progress for another 360 years, exemplifying growth, community, and resilience.

So, my fellow residents the answer, as I have said, is right here with us: *what does it mean to be an American? What do we hope to leave for future generations?*

The answer is not found in halls of power, nor will it come from any edict out of Trenton or Washington: the answer comes from Middletown, where our families are the building blocks of our community, where history is preserved and celebrated, and where the worst of the humanity never wins, because it is always met with the best of ourselves.

So, as we stand today in the heart of Monmouth County, in the heart of New Jersey, let us realize that we are not just a part of the state's fabric but a beacon of hope and progress. Our actions here set a precedent, a template for the revival of New Jersey. We cannot, and will not, remain passive observers in our own future. We must lead, not just in words, but through resolute actions.

Our town is more than a place on a map; it is a home, it's a community with a rich legacy and an even brighter future. A future where our children can not only dream but achieve, where they can not only hope but thrive. It is upon us to lay down the stepping stones for their success, to create

an environment ripe with opportunities that fosters growth, innovation, and a sustainable way of life.

So as we embark on this journey to spearhead the great New Jersey comeback, let us remember that the strength of Middletown lies in each of us. Every small business owner, every student, and every volunteer contributes to the success of our community. Because together, we are an unstoppable force. Together, we can transform the challenges we face into triumphs and our aspirations into realities.

So, let us pledge today to not just live in Middletown but to thrive in it. To not just be residents but active architects of our destiny. Let us embrace our role at the forefront of New Jersey's renaissance, forging a path of prosperity, not just for ourselves but for generations to come.

At all regular and workshop meetings of the Middletown Township Committee formal action will be taken on any matter subject to compliance with the Open Public Meetings Act respecting issuance of the "48-hour notice" containing the agenda for such regular and workshop meetings, to the extent known.

2. Executive Sessions will be held at 6:00 p.m. preceding each Regular Meeting and Workshop Meeting in 2024 to discuss personnel matters, labor relations, pending litigation and other matters permitted for closed session under N.J.S.A. 10:4-12. At 7:00 p.m., prior to each Executive Session, the Township Committee will convene in open session at which time an Executive Session Resolution specifying the general nature of the items to be discussed in Executive Session will be adopted in accord with N.J.S.A. 10:4-13. All such meeting sessions will be held in the Conference Room, Town Hall, One Kings Highway, Middletown, N.J., unless otherwise noted as per the law.

3. The following newspapers are hereby designated as the newspapers to receive any and all notices required or permitted to be given under The Act, shall including but not limited to Annual Notice and 48 hour notices, as needed:

a. The Two River Times and Asbury Park Press, which are hereby designated and determined to be the official newspapers which have the greatest likelihood of informing the public within the area of jurisdiction of this Township of its meetings.

4. Copies of this Resolution and any revisions or modification thereof, certified to be true copies by the Clerk of this municipality, be disseminated and distributed as required by The Act as follows:

- a. The Two River Times and Asbury Park Press which are hereby designated and determined to be the official newspapers which have the greatest likelihood of informing the public within the area of jurisdiction of this Township of its meetings; and
- b. Filed with the Municipal Clerk of this municipality; and
- c. Mailed to such other person as may be entitled thereto under the terms of the Act and this Resolution.

5. Pursuant to N.J.S.A. 10:4-19, the Municipal Clerk is hereby authorized and directed to mail such notice as may be required and authorized under the Act to any person requesting the same providing that person has first complied with the following terms and conditions:

a. Any and all request for notice under the act shall be made in writing either by letter or by signing a request list to be maintained in the Office of the Municipal Clerk.

6. Resolution 24-37 - Resolution Establishing Standing Rules of The Township Committee

WHEREAS, pursuant to section 7-6 of the Township Code, the Township Committee wishes to establish rules of order for Township Committee meetings; and

WHEREAS, it is the desire of the Township Committee to provide for effective and productive Township meetings, to hear from its residents in a timely manner, and to conduct the

large volume of township business within the time constraints available at public meetings in a more orderly, productive manner.

NOW, THEREFORE, BE IT RESOLVED that the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey hereby adopts the attached Standing Rules for Meetings of the Township Committee governing the conduct of all meetings of the Township Committee for 2024.

STANDING RULES FOR MEETINGS OF THE TOWNSHIP COMMITTEE

- 1. The Mayor or other Committeeperson acting as the Mayor shall act as the Chair of meetings of the Township Committee.
- 2. Any persons desiring to speak on either an ordinance or during the public comment section shall raise their hand and must be recognized by the Chair before speaking. All comments by the members of the public shall be made from the podium after first having been recognized by the Chair.
- 3. As to the public comment portion of the meeting, all persons recognized to speak may speak once for a maximum of five minutes.
- 4. Any speaker who exceeds these time limits shall be ruled out of order and subject to removal. Each five minute period is personal to each speaker and made not be ceded to another person.
- 5. No profanity shall be permitted. Any person who uses profanity may be ruled out of order and subject to removal.
- 6. Questions or comments of the public should be directed to the Chair. If appropriate, the Chairperson may direct and recognize a staff employee or professional of the Township to respond. The Chair may request that any question asked of the Township Committee or its staff or professionals which, due to its complexity or need for research or factual investigation cannot be answered immediately, be placed in writing by the inquirer and directed to the appropriate Township official and that an answer be provided to the inquirer as soon as possible.
- 7. Any of these Standing Rules may be suspended for a particular matter by vote of a majority of the Township Committee present at the meeting.
- 8. As to Township Committee meetings, members or invited guests may participate via telephonic or video conference. Members of the Township Committee are permitted to vote through these electronic means.

9. These rules may be supplemented by the adoption of additional rules required to be adopted by law during a declared State of Emergency for the conducting of remote meetings of the Township Committee by electronic means.

Resolution 24-38 - Resolution Authorizing Pre-Payment of Certain Bills For 2024

WHEREAS, the Township of Middletown has budgeted funds for payment of obligations including, utilities, payroll, debt service, governmental fees and other statutory payments, insurance, and for the advertising, printing and mailing costs of the Township; and

WHEREAS, the payment of these items occasionally arrives out of time for placement on the next available list of bills and claims, thereby inadvertently placing these bills and mailings in arrears because of the schedule of meetings; and

WHEREAS, the Township's Chief Financial Officer and Township Attorney have advised that the governing body may provide for the pre-payment of these items, so that they may be paid in a timely manner without penalty.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that the Chief Financial Officer be and is hereby authorized and directed to make pre-payment of the following items prior to the same appearing on the next meeting's list of bills and claims:

- 1. Utilities (electric, gas, water, sewer and telephone, cellular telephone, gasoline, diesel fuel, internet providers, etc.).
- 2 Township payroll and payroll agencies.
- 3. Debt service as evidenced by pre-authorized bonds and/or notes.
- 4. Health, dental and other insurance premiums and/or claims.
- 5. Governmental fees and other statutory payments (school, county, sewage authority, state and county fees).
- 6. Bills pertaining to the advertising, printing and mailing costs of the Township.
- 7. Third party fees collected through pre-authorized credit/debit card processing.
- 8. Bills where vendor discounts are granted for timely payment. Example 2% discount for payments made within 10 days. Maximum dollar amount allowed is \$20,000.
- 9. Inter-fund Obligations

- 10. Purchase of Investments
- 11. Town Hall Lease Payment
- 12. Other items with written authorization of the Township Administrator.

<u>Resolution 24-41</u> - Setting Grace Period and Interest Rates for Taxes For Calendar Year 2024

WHEREAS, N.J.S.A. 54:4-67 permits the Governing Body to fix the rate of interest to be charged for nonpayment of taxes or assessments subject to any abatement or discount for late payment of taxes or assessments as provided by law; and

WHEREAS, any unpaid taxes and municipal charges constitute an unfair burden on those taxpayers who pay their taxes and municipal charges in a timely manner and delinquent taxpayers should be required to carry their share of the tax burden; and

NOW, THEREFORE, BE IT RESOLVED by the Governing Body of the Township of Middletown, County of Monmouth, State of New Jersey, that the property taxes shall be due and payable quarterly on February 1st, May 1st, August 1st and November 1st for the year 2024, with a ten day grace period, after which dates, if unpaid, shall become delinquent, with interest charges as set for below and reverting back to the due date on any quarterly installment of taxes. The Tax Collector is hereby authorized and directed to charge, subject to any abatement or discount for the late payment of taxes as provided by law:

1. Eight percent (8%) per annum on the first \$1,500.00 of taxes delinquent after due date; and

- 2. Eighteen percent (18%) per annum on any amount in excess of \$1,500.00 of taxes delinquent after due date; and
- 3. Any 2024 municipal charges remaining unpaid on the 11th day of the 11th month of the fiscal year will be subject to Tax Sale.
- 4. If the delinquency is in excess of \$10,000.00 and remains in arrears beyond December 31, an additional penalty of 6% shall be charged against the delinquency.

<u>Resolution 23-42</u> - Resolution Of The Township Committee Of The Township Of Middletown Authorizing An Accelerated Tax Sale

WHEREAS, NJSA 54:5-19 permits a municipality to sell liens on delinquent municipal charges prior to the close of the Calendar Year 2024 and

WHEREAS, the Township of Middletown has realized an exceptional tax collection rate through this process, and

WHEREAS, the Township of Middletown CY 2024 Budget has anticipated continuing an Accelerated Tax Sale;

Meeting <u>Resolution 24-43</u> - Resolution Authorizing Tax Collector to Process Certain Small Tax Refunds and Cancellations

WHEREAS, <u>N.J.S.A.</u> 40A:5-17.1(a) authorizes the Township Committee to appoint a municipal employee to process property tax refunds of less than \$10.00 without further action of the governing body; and

WHEREAS, <u>N.J.S.A.</u> 40A:5-17.1(b) authorizes the Township Committee to appoint a municipal employee to process the cancellation of any property tax refund, delinquency, or charges and fees imposed by the municipality of less than \$10.00 without further action of the governing body; and

WHEREAS, in order to realize efficiencies for the benefit of its residents, the Township seeks to appoint and authorize its Tax Collector, Debra Marchetti, CTC, Tax Collector, to complete the foregoing.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown, in the County of Monmouth, State of New Jersey, that it hereby appoints and authorizes its Tax Collector, Debra Marchetti, CTC, to process certain small tax refunds and cancellations, to the full extent permitted by <u>N.J.S.A.</u> 40A:5-17.1, for the remainder of calendar year 2024.

<u>Resolution 24-44</u> - Resolution Authorizing Mayor to Execute <u>Cancellations</u> of <u>Municipal</u> Tax Sale Certificates

WHEREAS, pursuant to N.J.S.A. 54:5-55 and 54:5-58, the governing body or other officer of the municipality may act to authorize the <u>cancellation</u> of <u>municipal</u> tax sale certificates; and

WHEREAS, the Township of Middletown's Tax Collector has recommended that a resolution be adopted clarifying the Township's policy that the governing body authorizes the Mayor to execute <u>cancellations</u> of <u>municipal</u> tax sale certificates.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey that, as directed by the Township's Tax Collector, the Mayor and Township Clerk are hereby authorized to execute tax sale certificates for <u>cancellation upon redemption</u> without the necessity of the governing body passing a resolution for each individual <u>certificate</u>.

Resolution 24-45 - Resolution Authorizing Electronic Municipal Lien Tax Sales

WHEREAS, <u>N.J.S.A.</u> 54:5-19.1 authorizes municipalities to conduct electronic municipal tax lien sales, in accordance with regulations promulgated by the Director of the Division of Local Government Services in the Department of Community Affairs; and

WHEREAS, the pertinent regulation, <u>N.J.A.C.</u> 5:33-1.1, sets forth various other regulatory terms that the Township shall comply with as part of its electronic municipal tax lien sales; and

WHEREAS, <u>N.J.A.C.</u> 5:33-1.1(b) provides that electronic municipal tax lien sales shall be approved by resolution of the governing body.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown, in the County of Monmouth, State of New Jersey that it hereby authorizes the use of electronic municipal tax lien sales, pursuant to <u>N.J.S.A.</u> 54:5-19.1 and <u>N.J.A.C.</u> 5:33-1.1.

BE IT FURTHER RESOLVED that the Township Chief Financial Officer is hereby authorized and directed to take any and all steps reasonably necessary to effectuate the foregoing, including compliance with the regulatory provisions contained in <u>N.J.A.C.</u> 5:33-1.1.

Resolution 24-46 - Resolution Authorizing Fee for Issuance Of Municipal Tax Sale Notices

WHEREAS, <u>N.J.S.A.</u> 54:5-26 and <u>N.J.A.C.</u> 5:33-1.1(e)-(f) require municipalities to provide legal notice in order to conduct electronic municipal tax lien sales; and

WHEREAS, these provisions further permit municipalities to impose a fee for legal notices that issue, not to exceed \$25 per notice for a particular property, which may be added to the amount of the tax sale; and

WHEREAS, in an effort to more fairly assign fiscal responsibility for the Township's costs relating to delinquent taxpayers, the Township wishes to approve the imposition of such a fee.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown, in the County of Monmouth, State of New Jersey that it hereby authorizes and directs the imposition of a \$25 fee per tax sale notice issued, which shall be specifically assessed to the delinquent accounts that are causing the need for a tax sale.

BE IT FURTHER RESOLVED that the Tax Collector is hereby authorized and directed to take any and all appropriate steps to effectuate the foregoing.

<u>Resolution 24-47</u> - Resolution Of the Township Committee of The Township of Middletown Authorizing the Submission Of An Application To The Nj Department Of Environmental Protection – Historic Preservation Fund Certified Local Government (CLG) Grant Program FY2024

WHEREAS, the Township of Middletown desires to further the public interest by obtaining a grant from the State of New Jersey in the amount of approximately \$50,000 to fund the following project: creation of a <u>Pre-Development Project</u> for architectural design planning for improvements to the Dempsey Pump House which was approved for inclusion to the State and National Register of Historic Places on November 16th 2023; and

WHEREAS, the Township of Middletown wishes to make the Dempsey pump house usable and accessible for a variety of public uses and to restore and maintain the structure so that it's unique architecture, character and history are not lost and will remain in its place for the benefit of future generations.
