RESOLUTION AUTHORIZING TAX FORECLOSURE COUNSEL TO INITIATE FORECLOSURE PROCEEDINGS UPON THE PROPERTIES INCLUDED WITHIN THE TAX COLLECTOR'S TAX FORECLOSURE LIST DUE TO NON-PAYMENT OF DELINQUINT TAXES BY SUMMARY PROCEEDING IN REM AND IN PERSONAM AS NECESSARY

WHEREAS, pursuant to <u>N.J.S.A.</u> 54:5-104.35, the governing body of any municipality may, from time to time, determine, by resolution, to foreclose on any of the tax sale certificates held by it by summary proceedings In Rem, and as necessary, In Personam; and

WHEREAS, the Township of Middletown (the "<u>Township</u>") is the holder of several tax sale certificates as set forth within Tax Foreclosure List prepared by the Township's Tax Collector attached hereto as <u>Exhibit A</u>; and

WHEREAS, it is the desire of the Township to institute In Rem and In Personam tax foreclosure proceedings against the properties set forth within the Tax Foreclosure List.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Middletown in the County of Monmouth, State of New Jersey, that it hereby authorizes and directs its Special Tax Foreclosure Counsel Kevin I. RESOLUTION AUTHORIZING THE MIDDLETOWN TOWNSHIP TO ACCEPT A SUBGRANT AWARD OF THE FEDERAL FISCAL YEAR 2022 OF EMERGENCY MANAGEMENT PERFORMANCE GRANT AND EMERGENCY MANAGEMENT AGENCY ASSISTANCE

WHEREAS, the Middletown Township Office of Emergency Management has been awarded State Homeland Security Grant Program Sub-grant AFN #97.042, Subgrant Award #FY22-EMPG-EMAA-1332 from the New Jersey Department of Law and Public Safety, Office of the Attorney General. The subgrant, consisting of \$10,000.00 Federal Award is for the purpose of enhancing the City's ability to prevent, protect against, respond to and recover from acts of terrorism, natural disasters and other catastrophic events and emergencies; and

WHEREAS, the Middletown Township will use these funds to enhance your Emergency Management Program and that the funds will be used for Emergency Management purposes; and

WHEREAS, the award period is from July 1, 2022 to June 30, 2023; and

WHEREAS, the subgrant award incorporates all conditions and representations contained or made in application and notice of award; and

WHEREAS, the Middletown Township Office Emergency Management, designated by the New Jersey State Police, Office of Emergency Management, has submitted an Application for Subgrant Award that has been required by the said New Jersey State Office of Emergency Management.

NOW, THEREFORE, BE IT RESOLVED by the Council of the **Middletown** Township, in the County of Monmouth, State of New Jersey:
